(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design. The broken lines around the FIGURE showing a display screen or portion thereof form no part of the claimed design.
