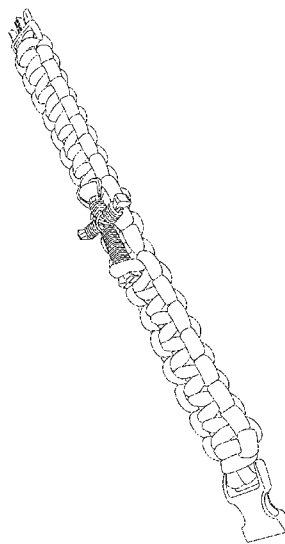
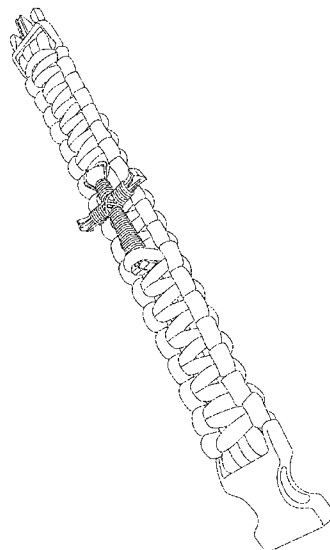

The ornamental design for a Christian bracelet, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a first embodiment of a Christian bracelet, showing my new design;

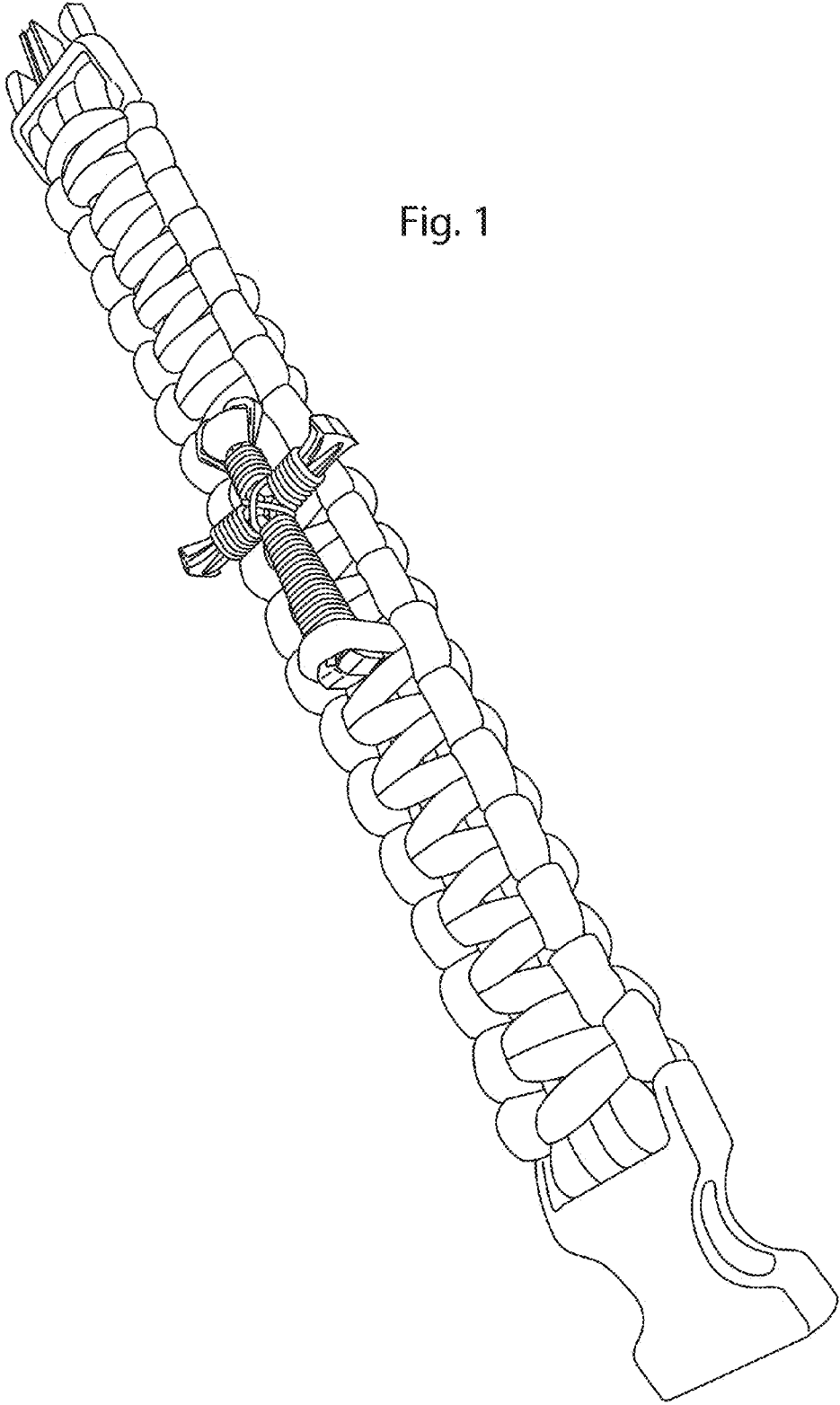

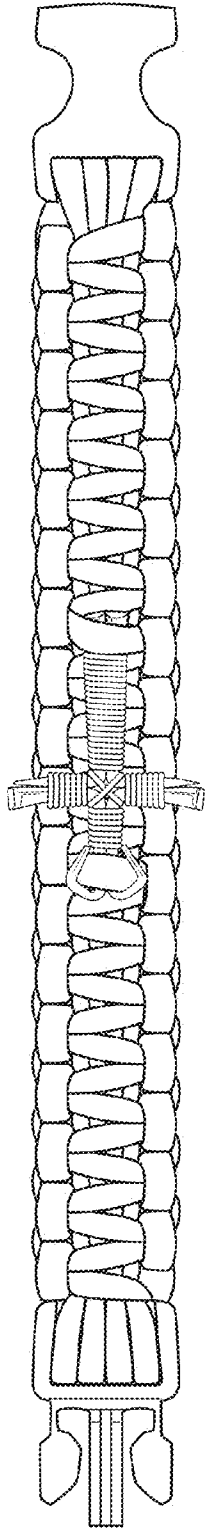

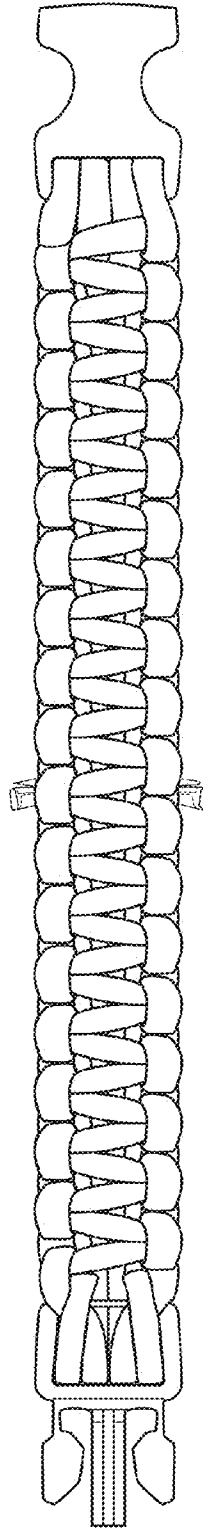

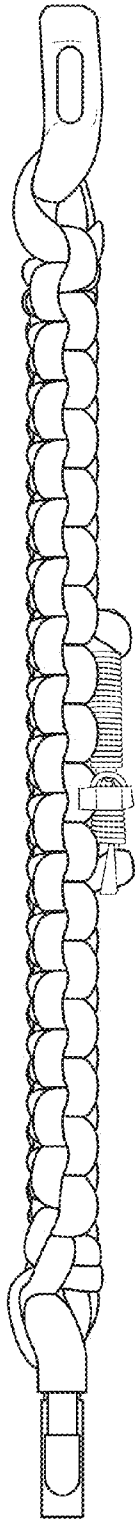

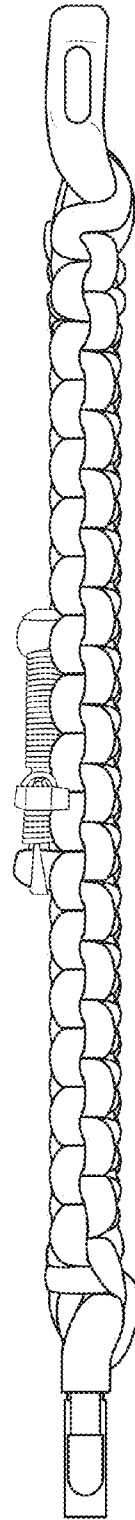

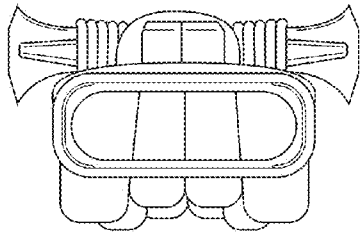

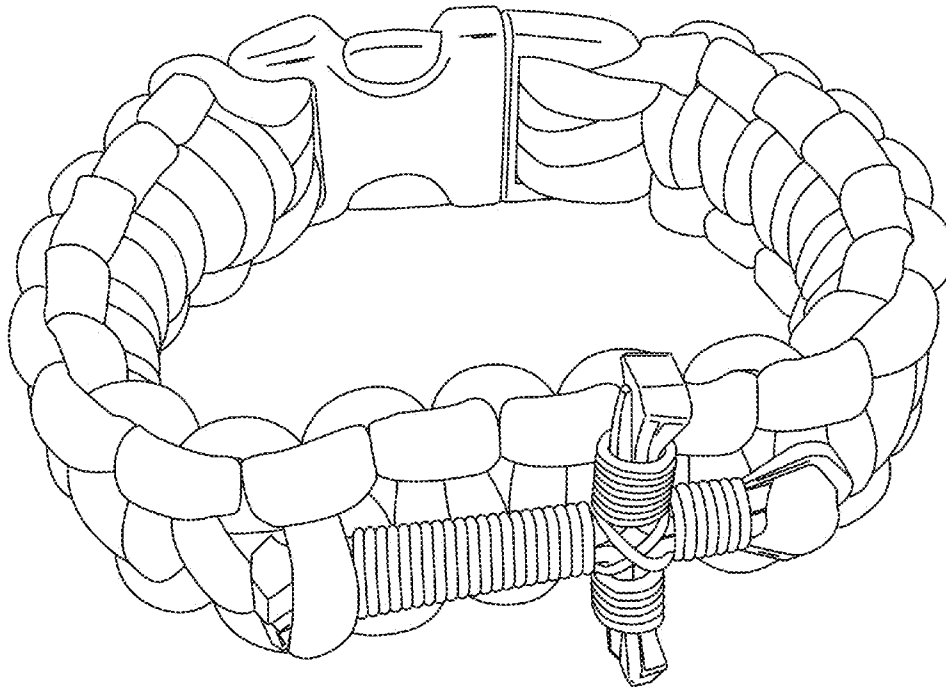
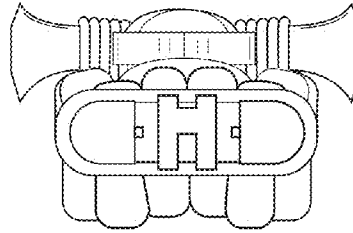

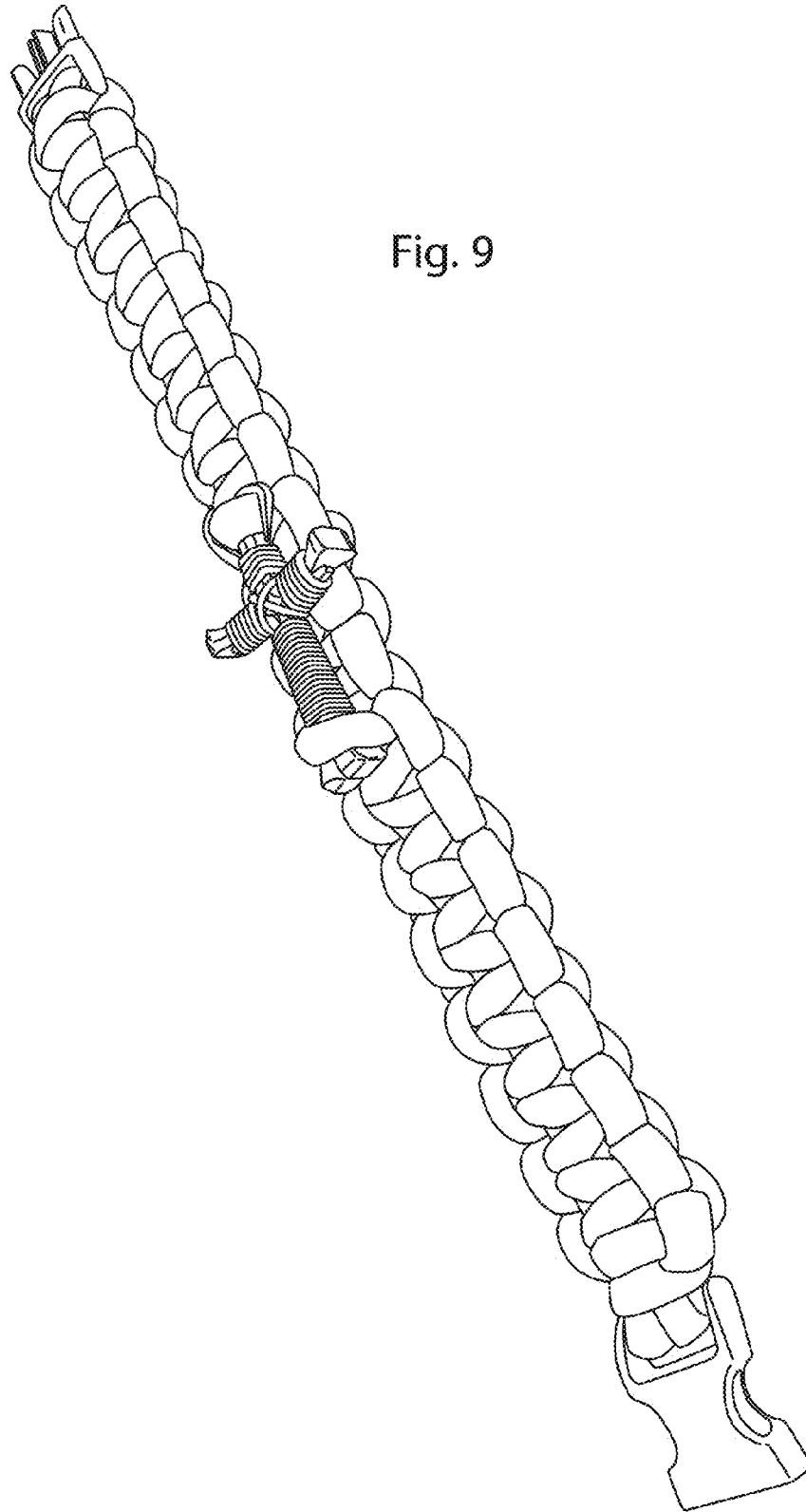

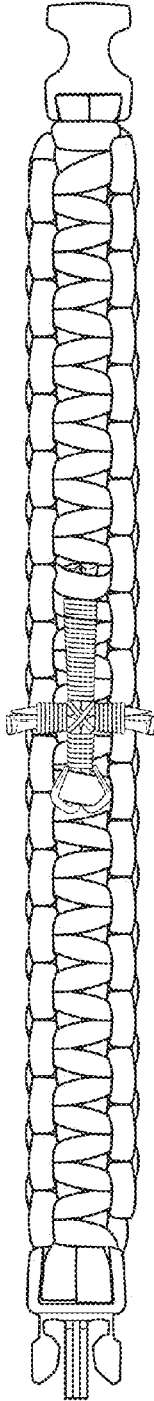

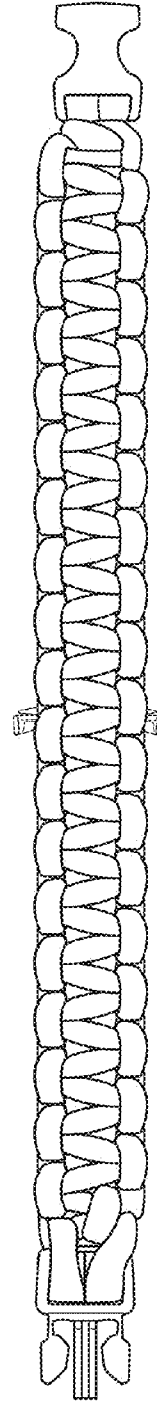

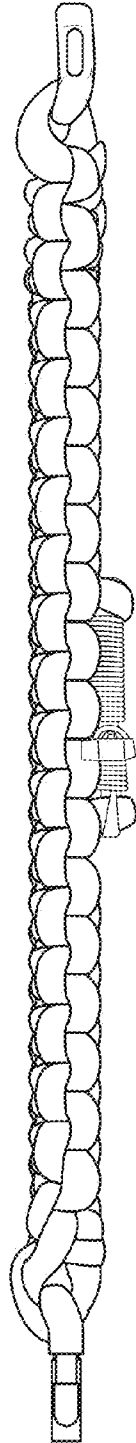

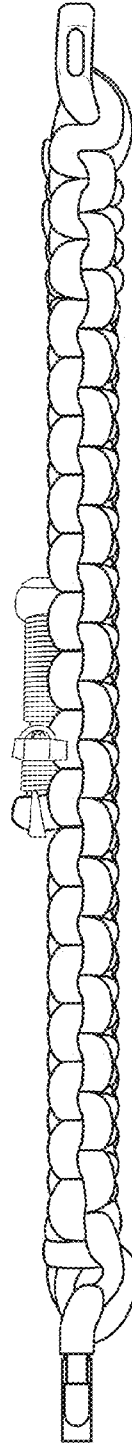

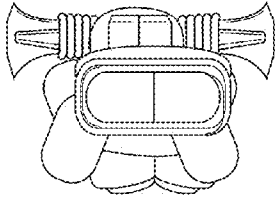

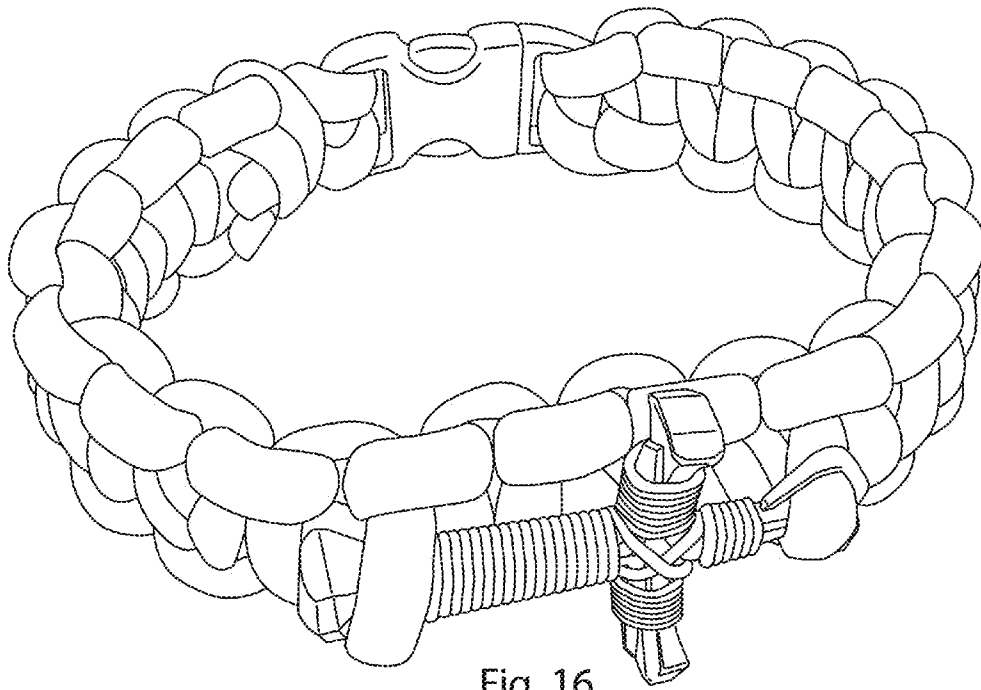
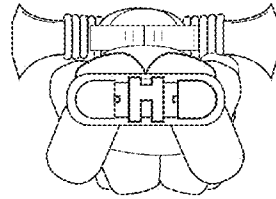
