(57) CLAIM

The ornamental design for a hinged battery cover, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hinged battery cover according to the present invention;

FIG. 2 is an alternate perspective view of the hinged battery cover in the open position of FIG. 1;

FIG. 3 is a right view of the hinged battery cover of FIG. 1;

FIG. 4 is a left view of the hinged battery cover of FIG. 1;

FIG. 5 is a top view of the hinged battery cover of FIG. 1;

FIG. 6 is a bottom view of the hinged battery cover of FIG. 1;


FIG. 7 is a front side view of the hinged battery cover of FIG. 1; and

FIG. 8 is a rear side view of the hinged battery cover of FIG. 1; and,

FIG. 9 is a perspective view of the hinged battery cover of FIG. 1, shown with its environment in phantom lines.


















