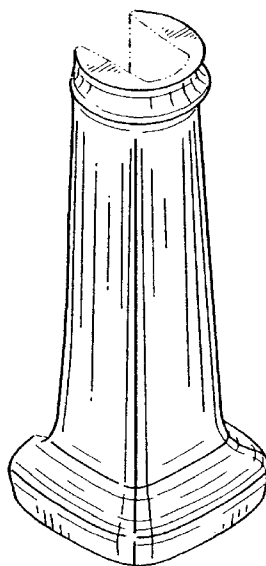
(57) **CLAIM**

The ornamental design for a lavatory pedestal, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a plumbing fixture, such as a lavatory pedestal.
FIG. 1 is a top, left, front perspective view of another embodiment of a lavatory pedestal according to my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken line representations of rear, underside, and internal structure in FIGS. 1 and 4–6 are for the purpose of illustration only, and form no part of the claimed design.

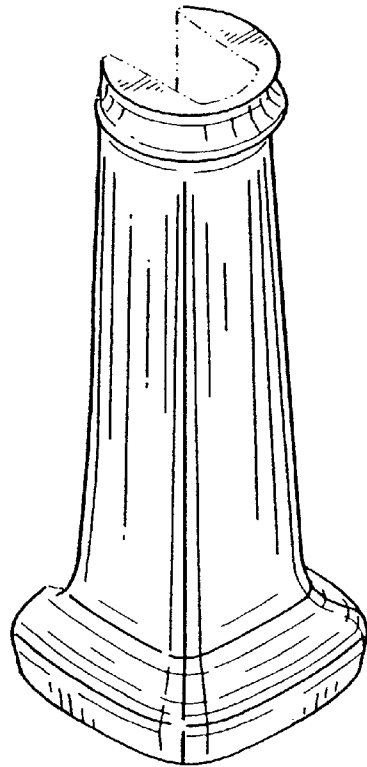

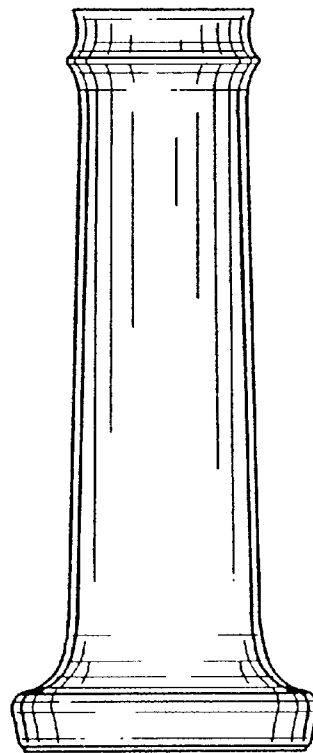

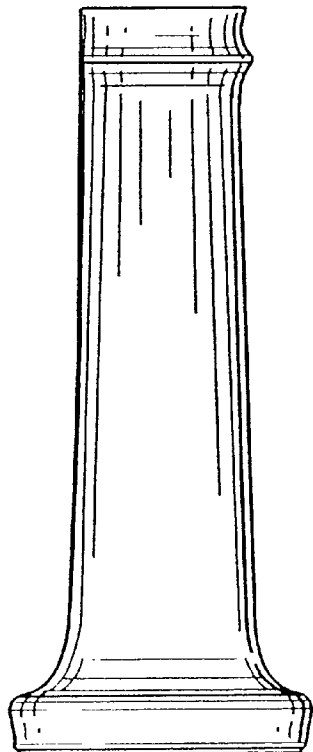

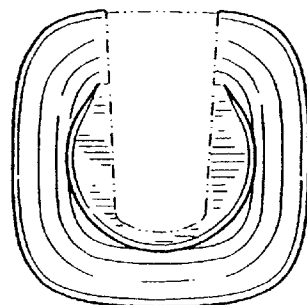

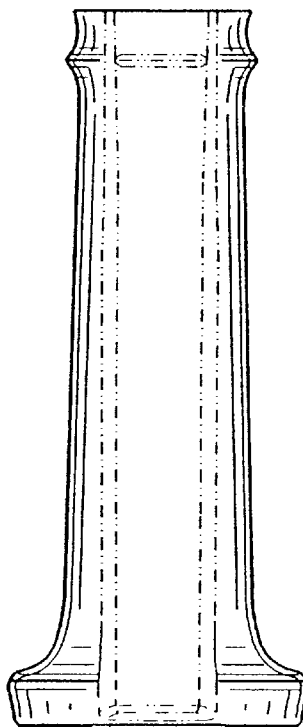
