The ornamental design for a steering wheel for an automobile, as shown and described.

DESCRIPTION

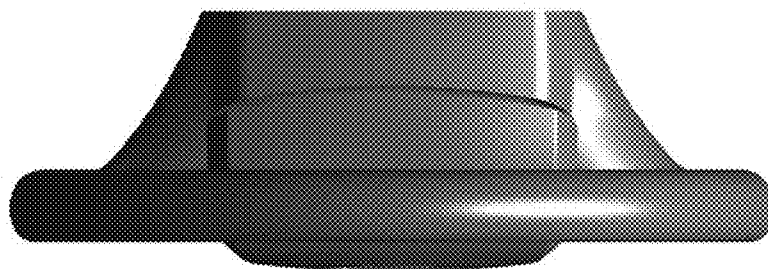

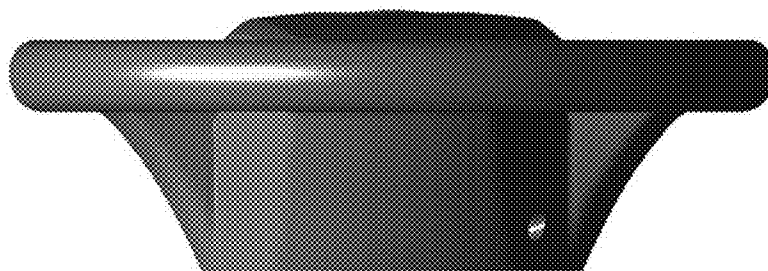

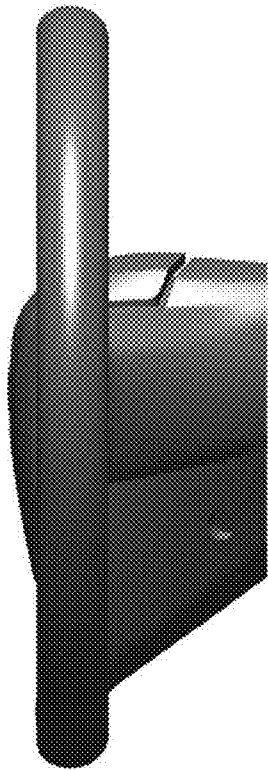

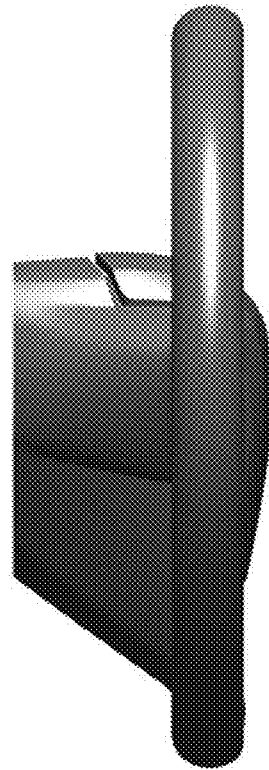
