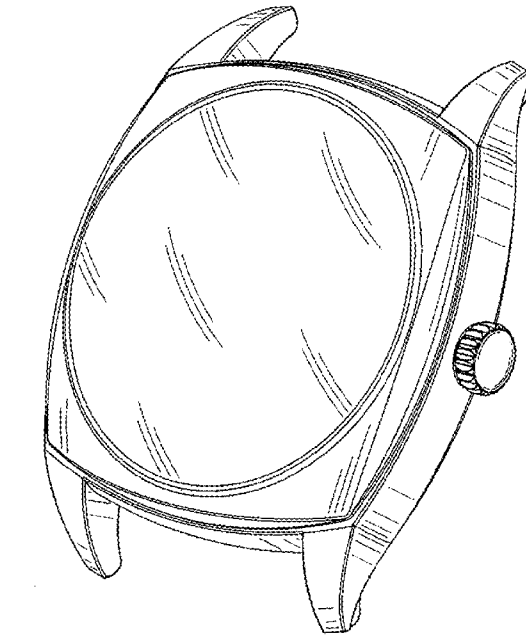

DESCRIPTION

FIG. 1 is a right front perspective view of a watch case
showing our new design;
FIG. 2 is a right side elevational view drawn to a reduced
scale with respect to FIG. 1;

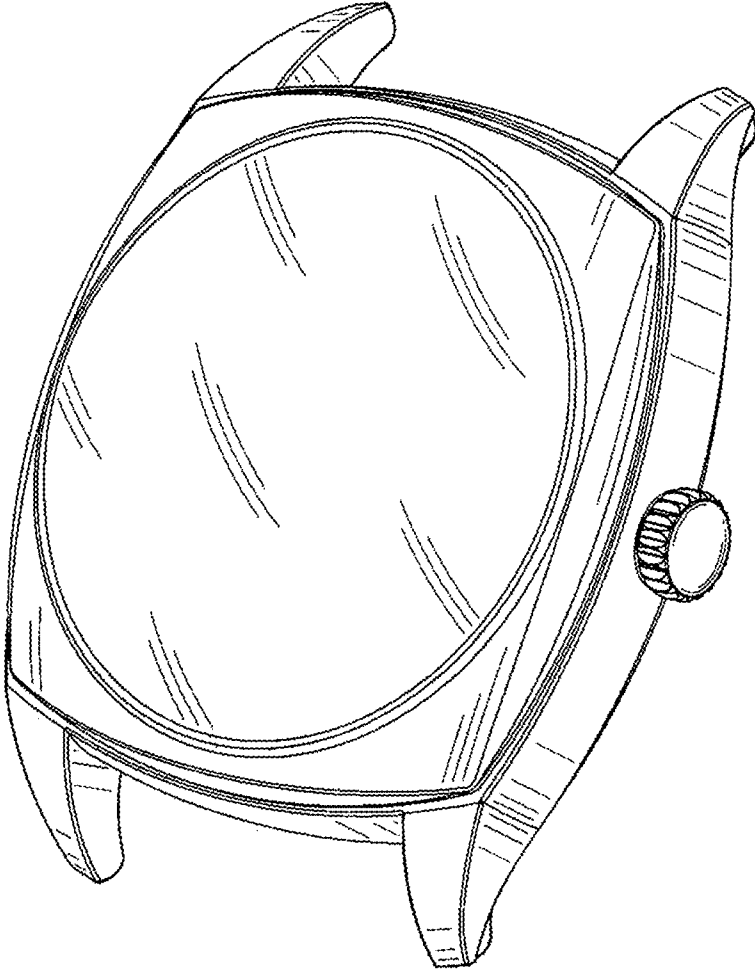

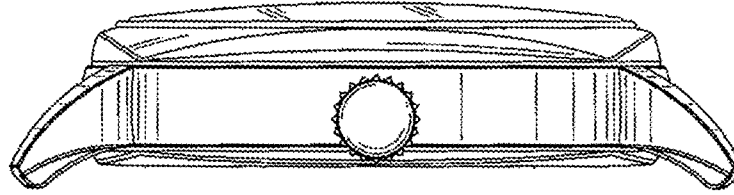

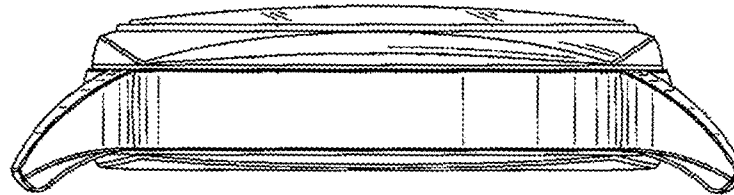

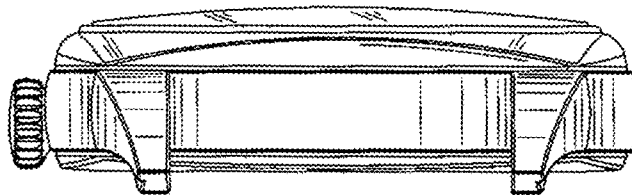

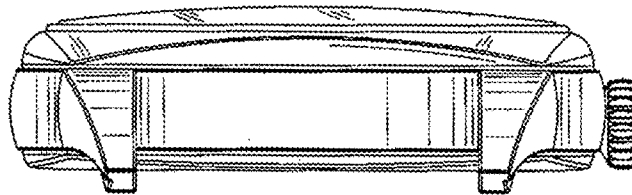

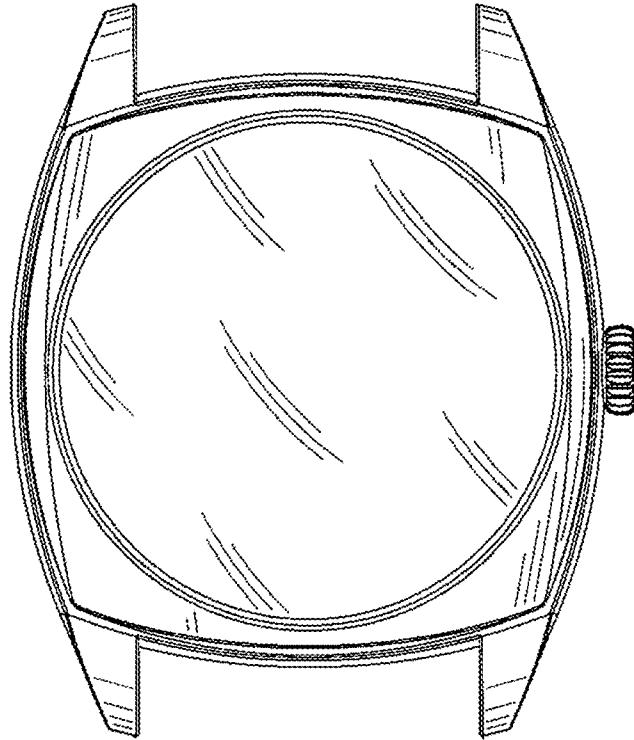

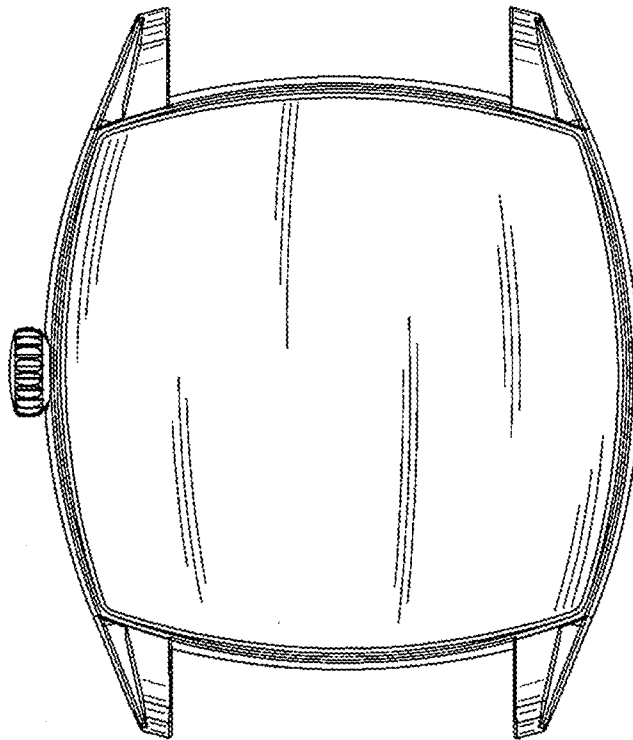
