(54) Title: NOVEL IMMUNOADJUVANT FLAGELLIN-BASED COMPOUNDS AND USE THEREOF

(57) Abstract: The present invention relates to novel peptide compounds derived from flagellin originating from *Salmonella enterica* that exhibit an *in vivo* immune adjuvant activity.
