FIG. 3 is an enlarged left view thereof;

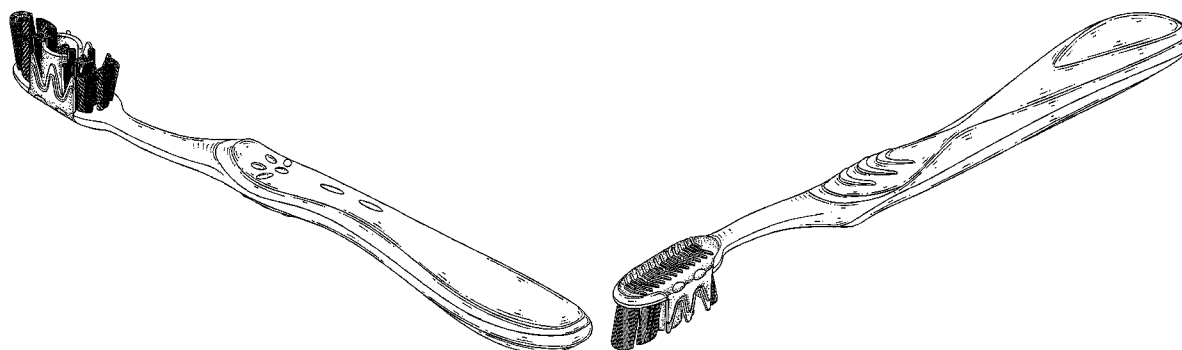
FIG. 4 is an enlarged right view thereof;

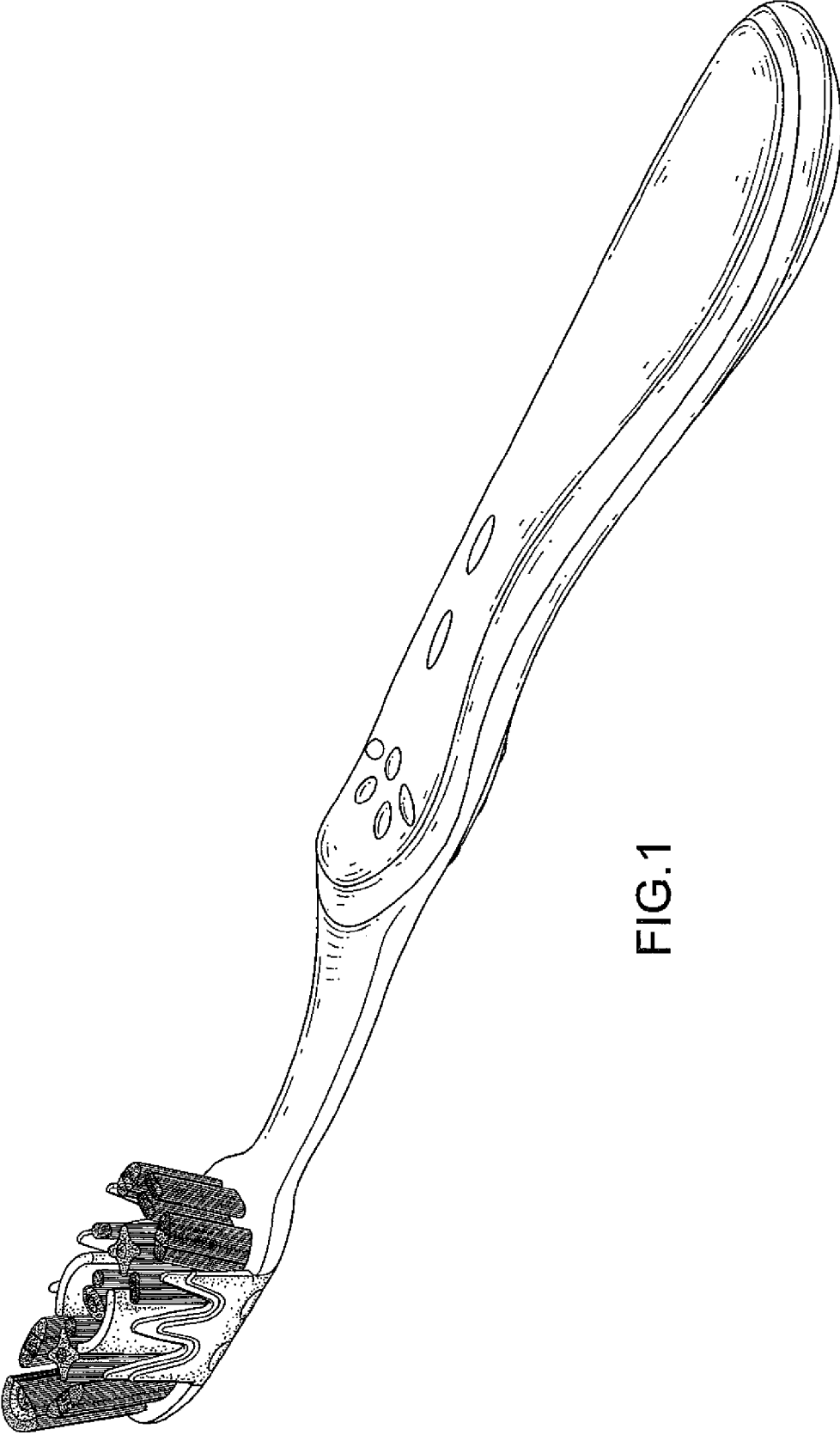

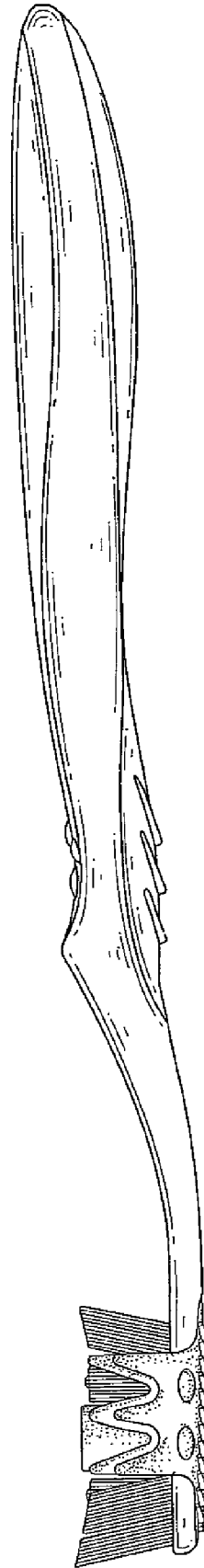

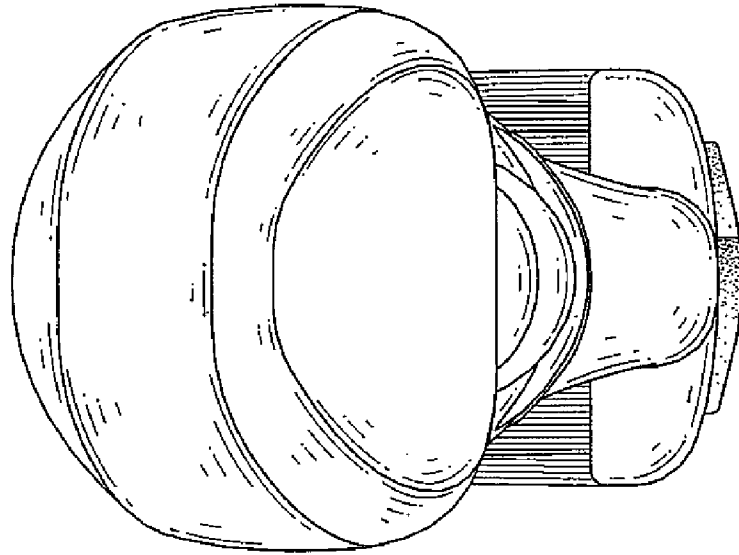

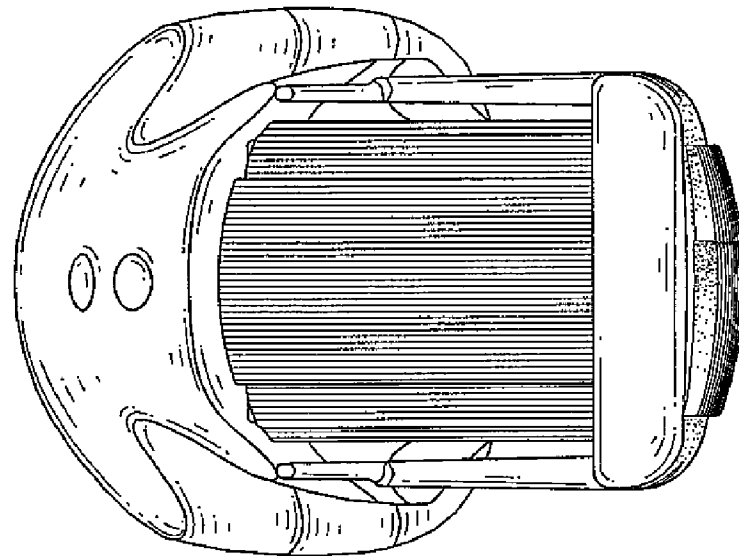

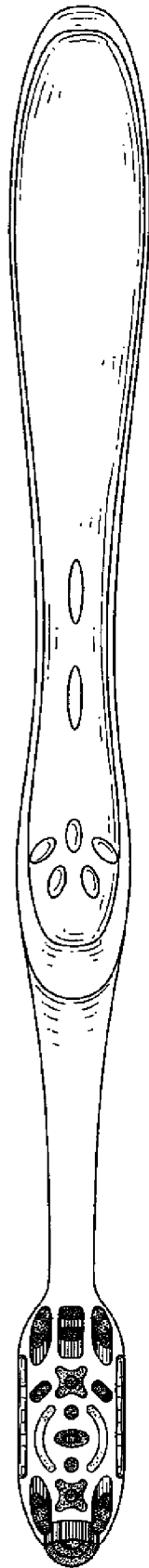

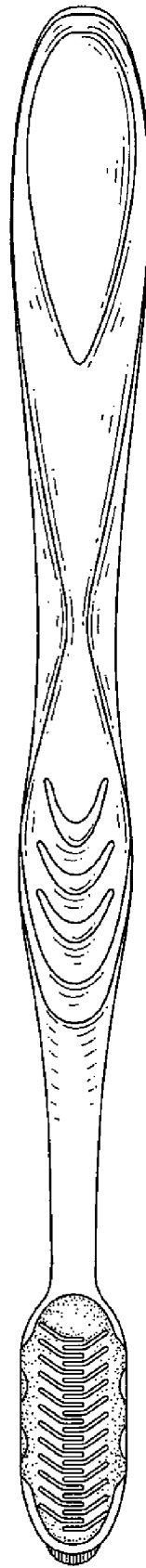

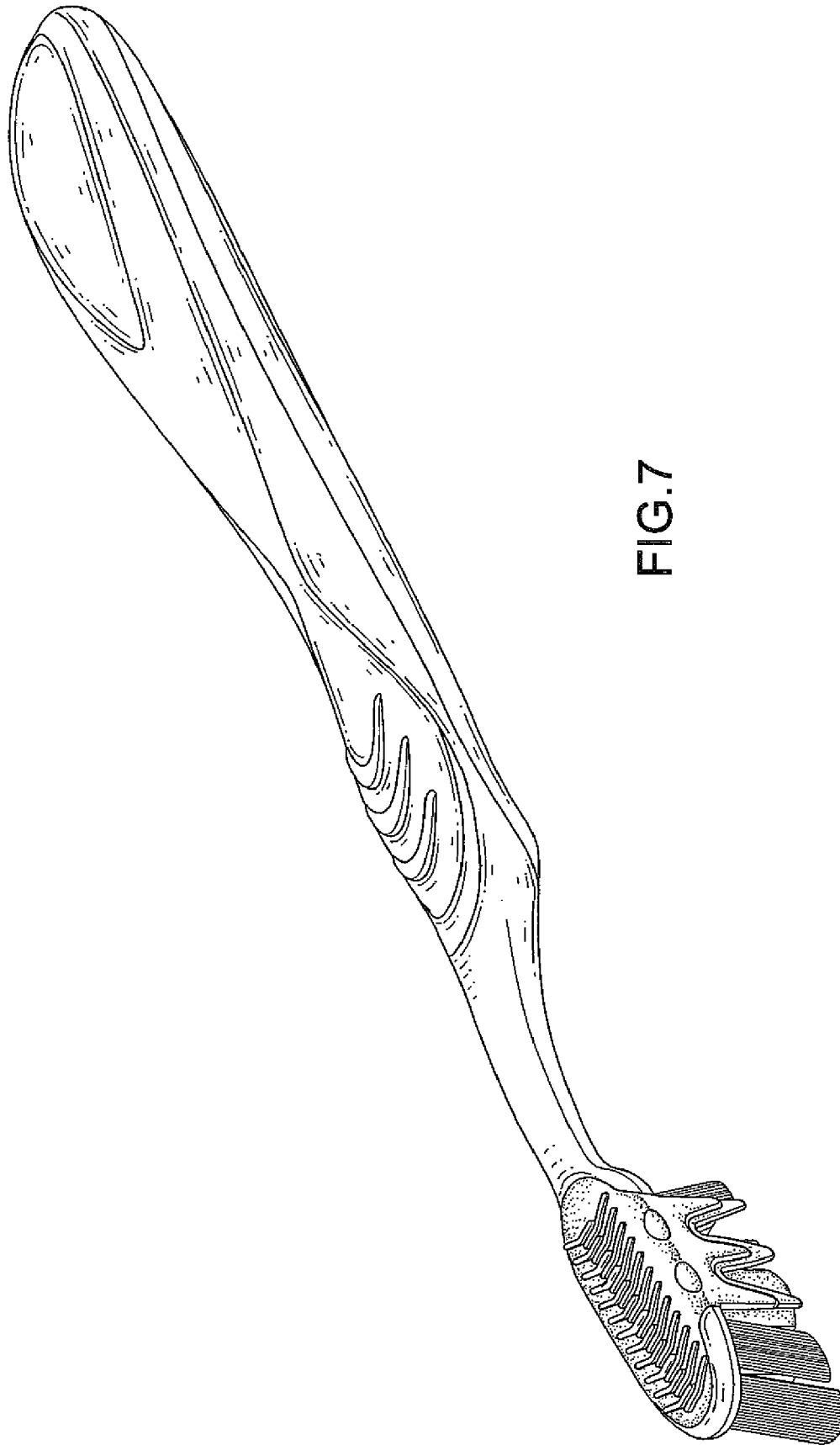
