(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a bottle, showing my new design, the rear elevational view being a mirror image of the front view shown;

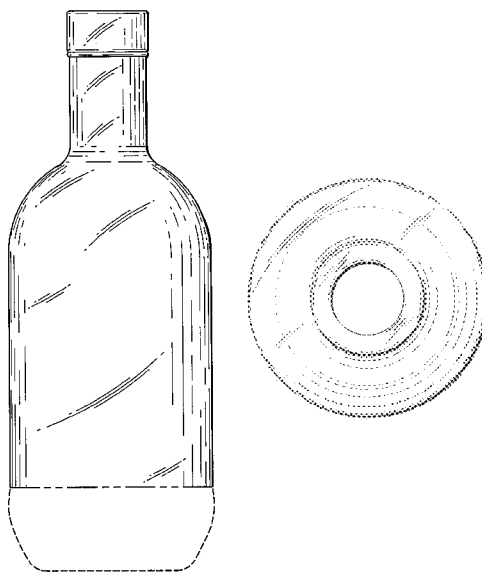
FIG. 2 is a bottom plan view thereof;

FIG. 3 is a top perspective view thereof; and,

FIG. 4 is a top plan thereof.

The dashed broken lines in the drawings depict environmental subject matter only and form no part of the claimed design. The dot-dot dash broken line in FIG. 1 is a boundary line representing the lower bounds of the claimed portion of the design.

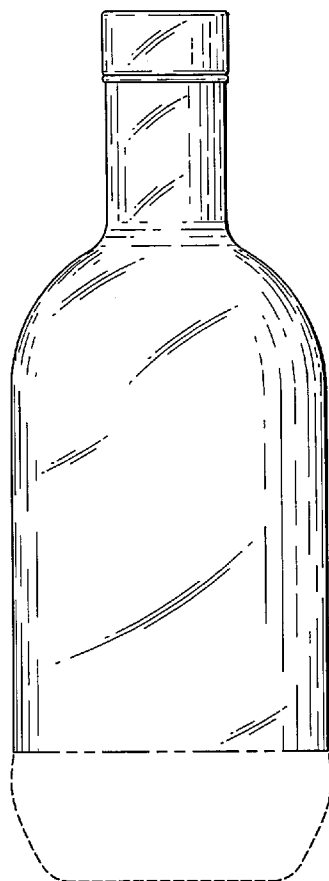

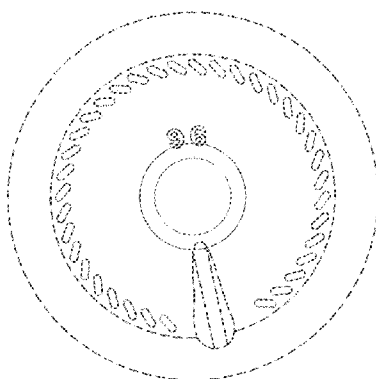

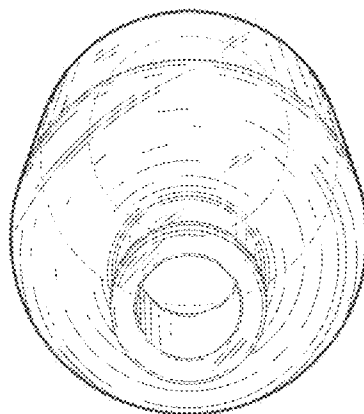

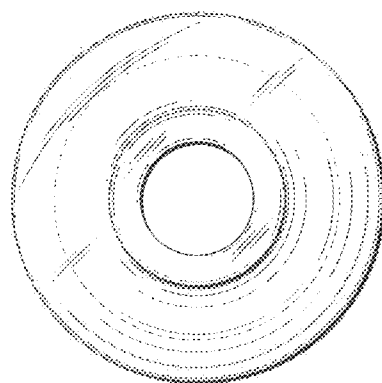
