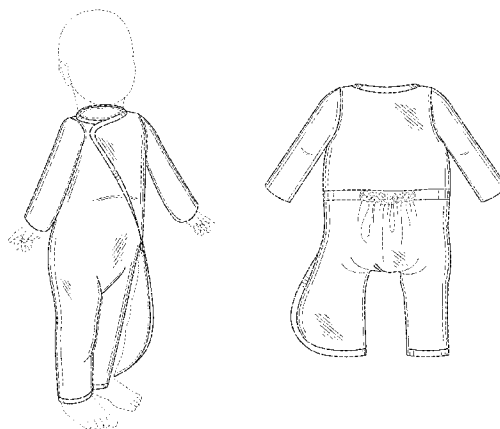
(57) **CLAIM**

The ornamental design for a child’s bodysuit having a backside opening for diaper checking, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the child’s bodysuit having a backside opening for diaper checking of the present invention;  
FIG. 2 is a front elevation view of the invention of FIG. 1;  
FIG. 3 is a back elevation view of the invention of FIG. 1;  
FIG. 4 is a side elevation view of the invention of FIG. 1; as seen from the left side of FIG. 2;  
FIG. 5 is a side elevation view of the invention of FIG. 1, as seen from the right side of FIG. 2;  
FIG. 6 is a duplicate view of FIG. 3, but for the broken-line circle that portrays the bounds of the enlarged detail view of FIG. 7; and,  
FIG. 7 is an enlarged detail view taken from element 7 as shown in FIG. 6.  
The broken lines showing a child is included only to provide context for how the design may appear when worn and forms no part of the claimed design. The broken lines illustrated in the interior surfaces of the garment represent the bounds of the claim and do not form part of the claimed design.

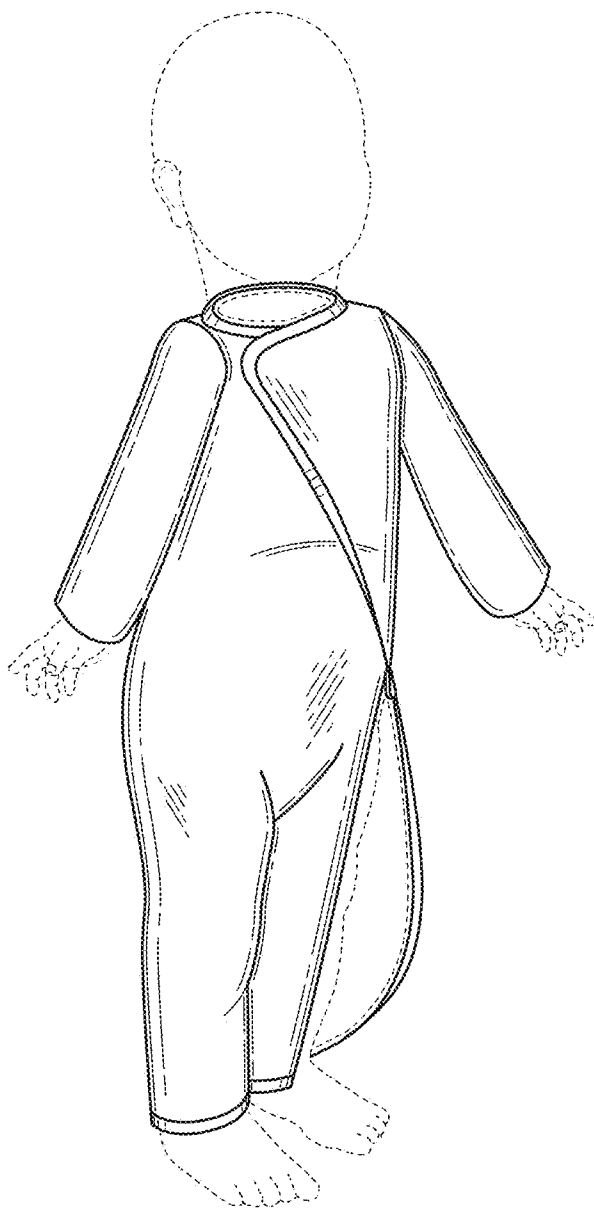

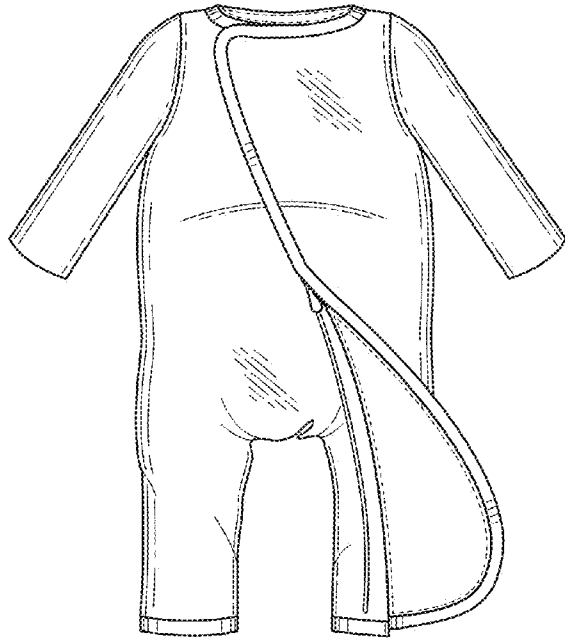

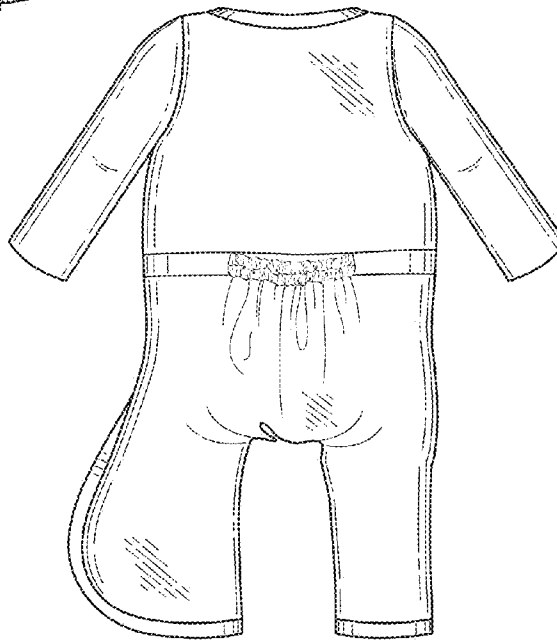

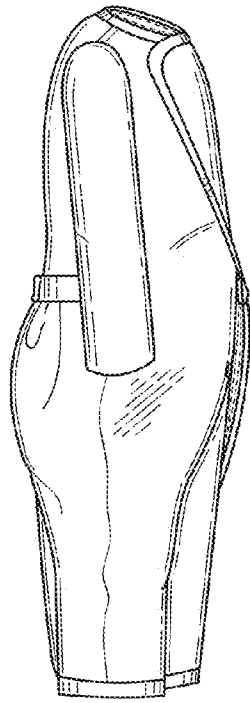

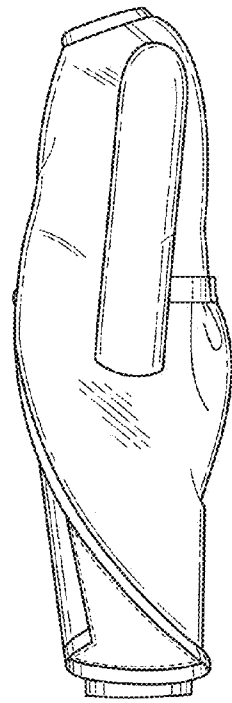

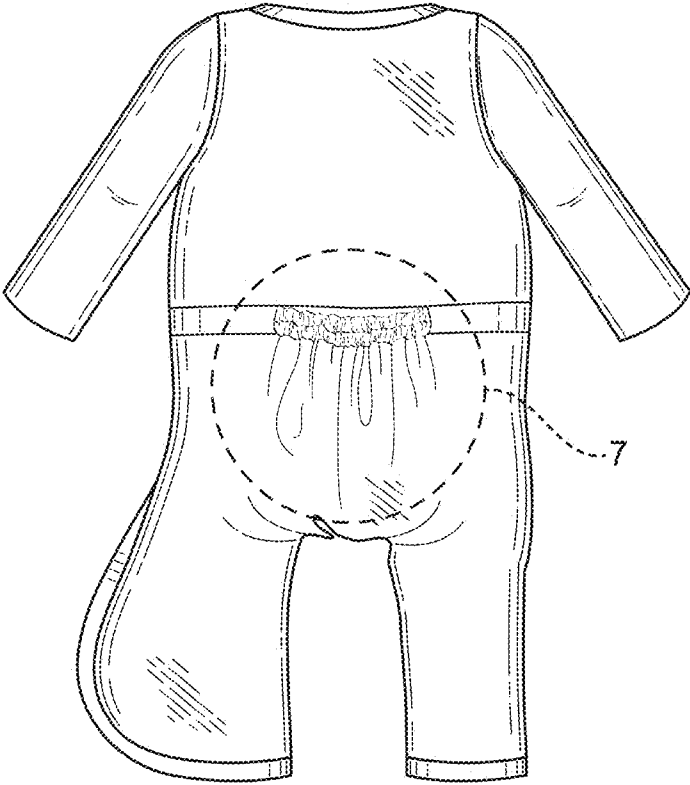

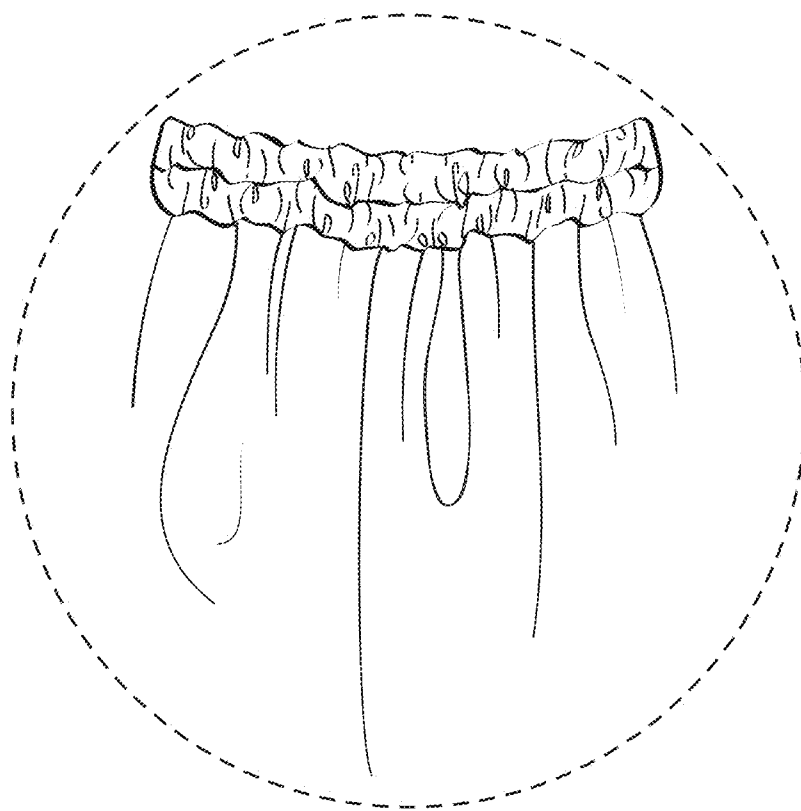
