(57) **CLAIM**

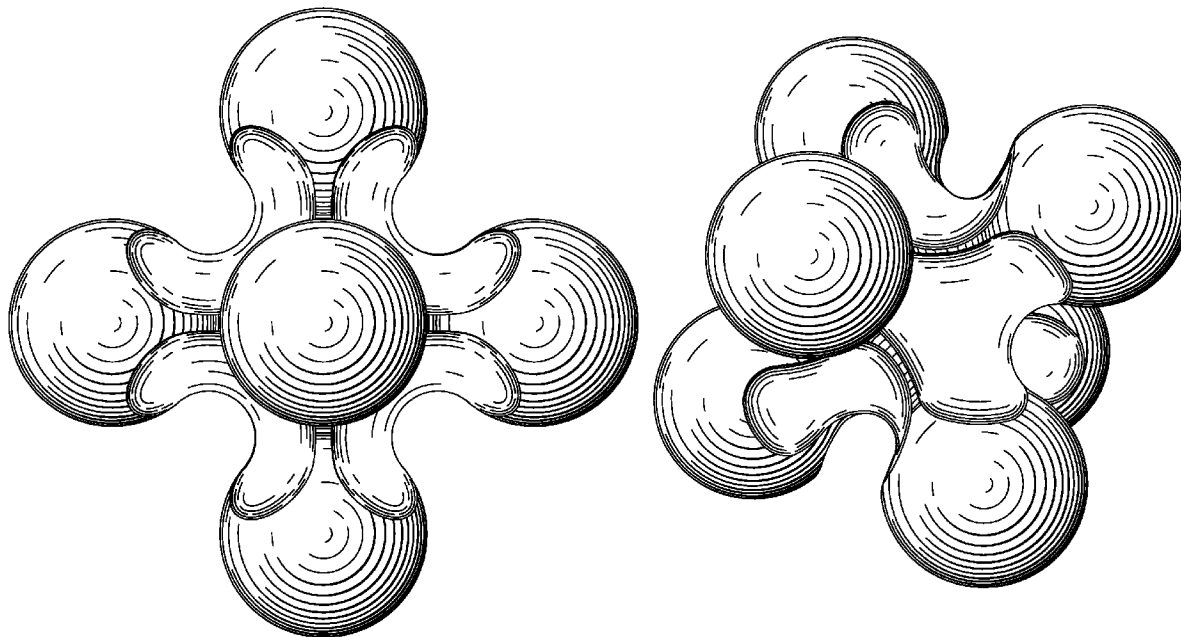
The ornamental design for a toy building unit, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of a toy building unit showing the new design, a bottom plan view, a right-side elevational view, a left-side elevational view, a front elevational view, and a rear elevational view thereof being mirror images thereof; and,

FIG. 2 is a perspective view thereof.

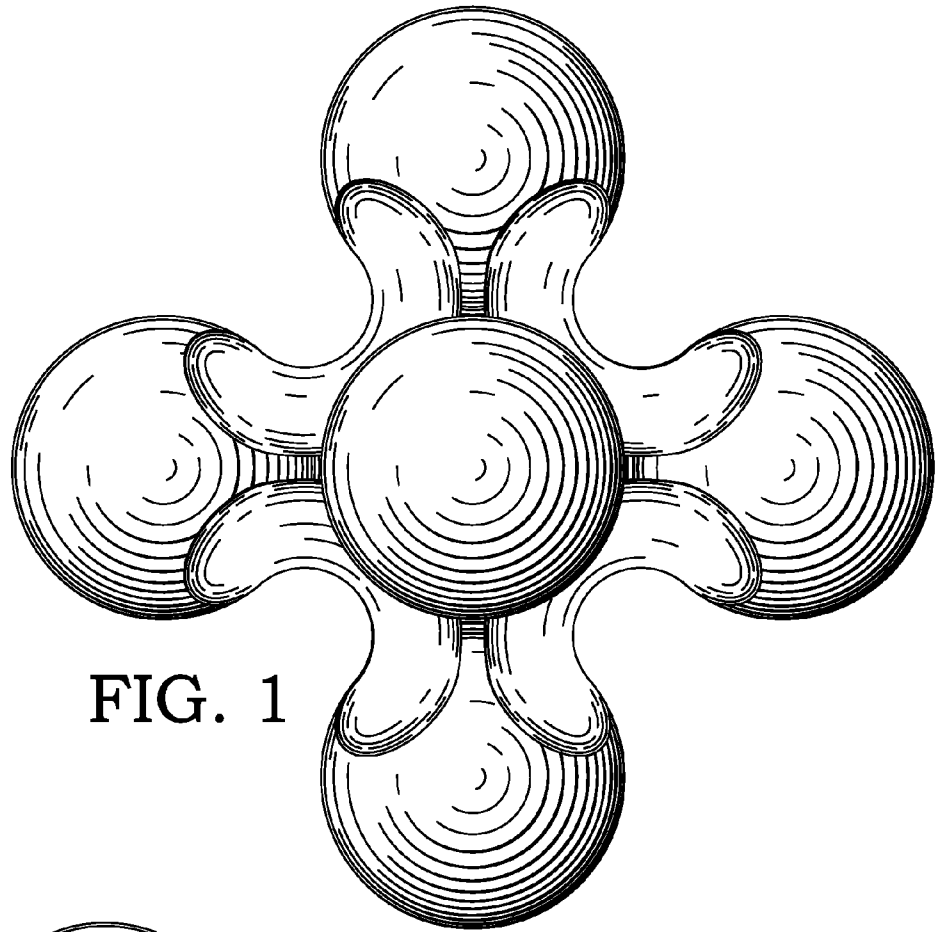

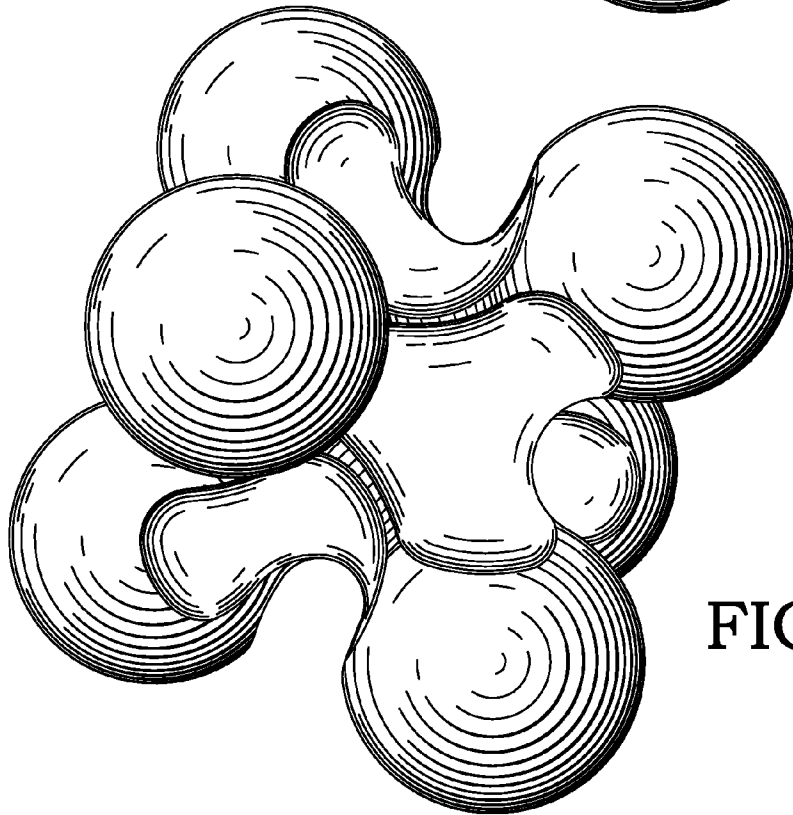
