(57) **CLAIM**

The ornamental design for a neck-worn biometric sensor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a neck-worn biometric sensor, illustrating our new design;

FIG. 2 is a front elevational view of the neck-worn biometric sensor shown in FIG. 1;

FIG. 3 is a side elevational view of one side of the neck-worn biometric sensor shown in FIG. 1, with FIG. 4 being a side elevational view of the other side of the neck-worn biometric sensor shown in FIG. 1;

FIG. 5 is a bottom plan view of the neck-worn biometric sensor shown in FIGS. 1; and

FIG. 6 is a top plan view of the neck-worn biometric sensor shown in FIG. 1.

FIG. 7 is a perspective view of a neck-worn biometric sensor, illustrating other aspects of our new design;

FIG. 8 is a front elevational view of the neck-worn biometric sensor shown in FIG. 7;

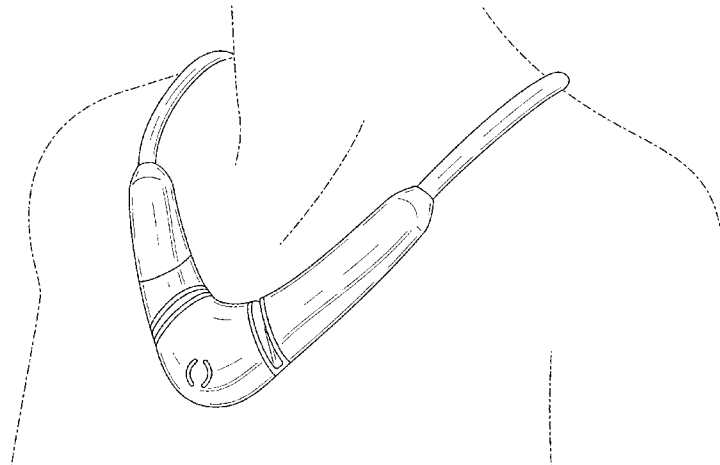

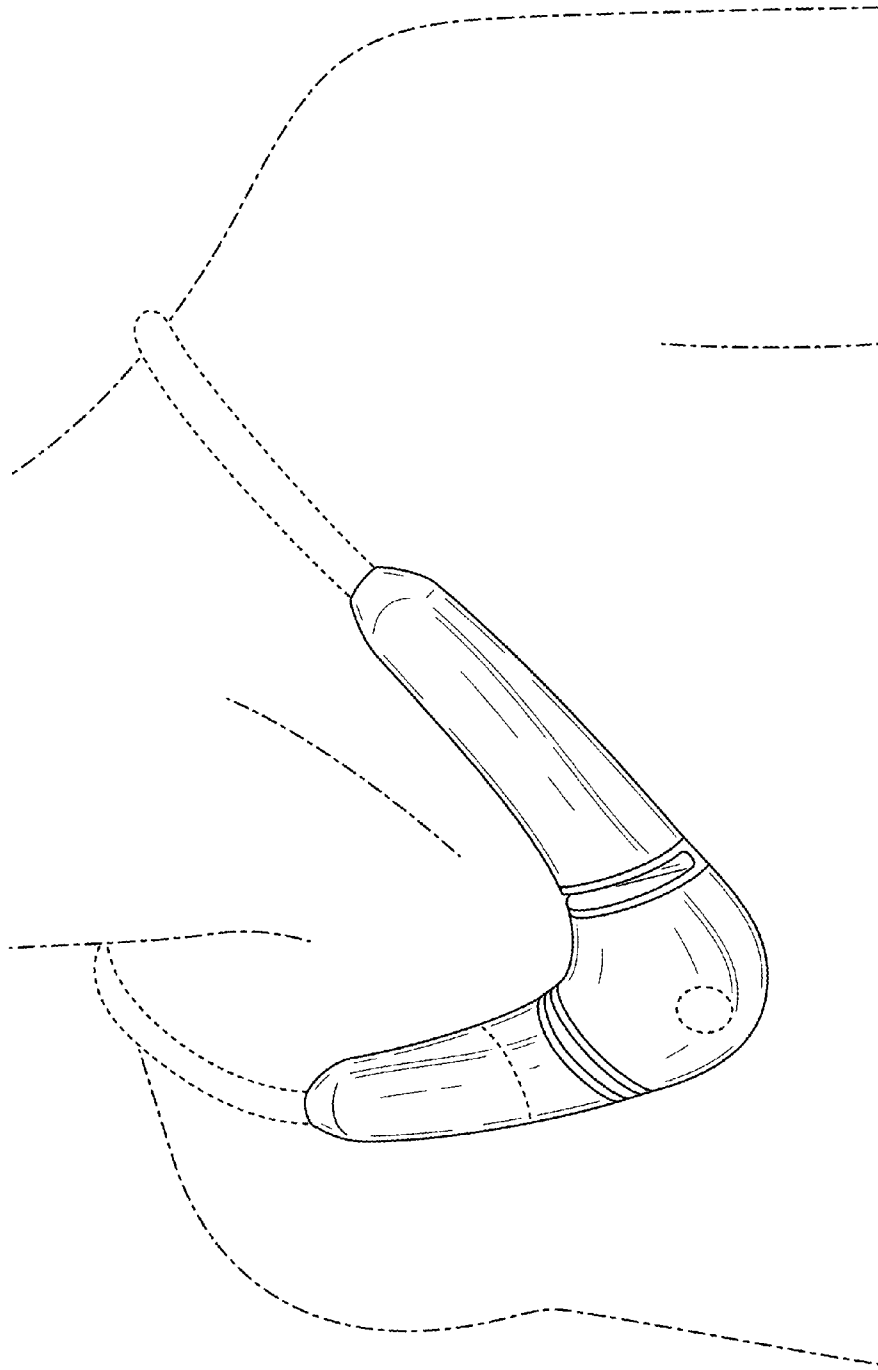

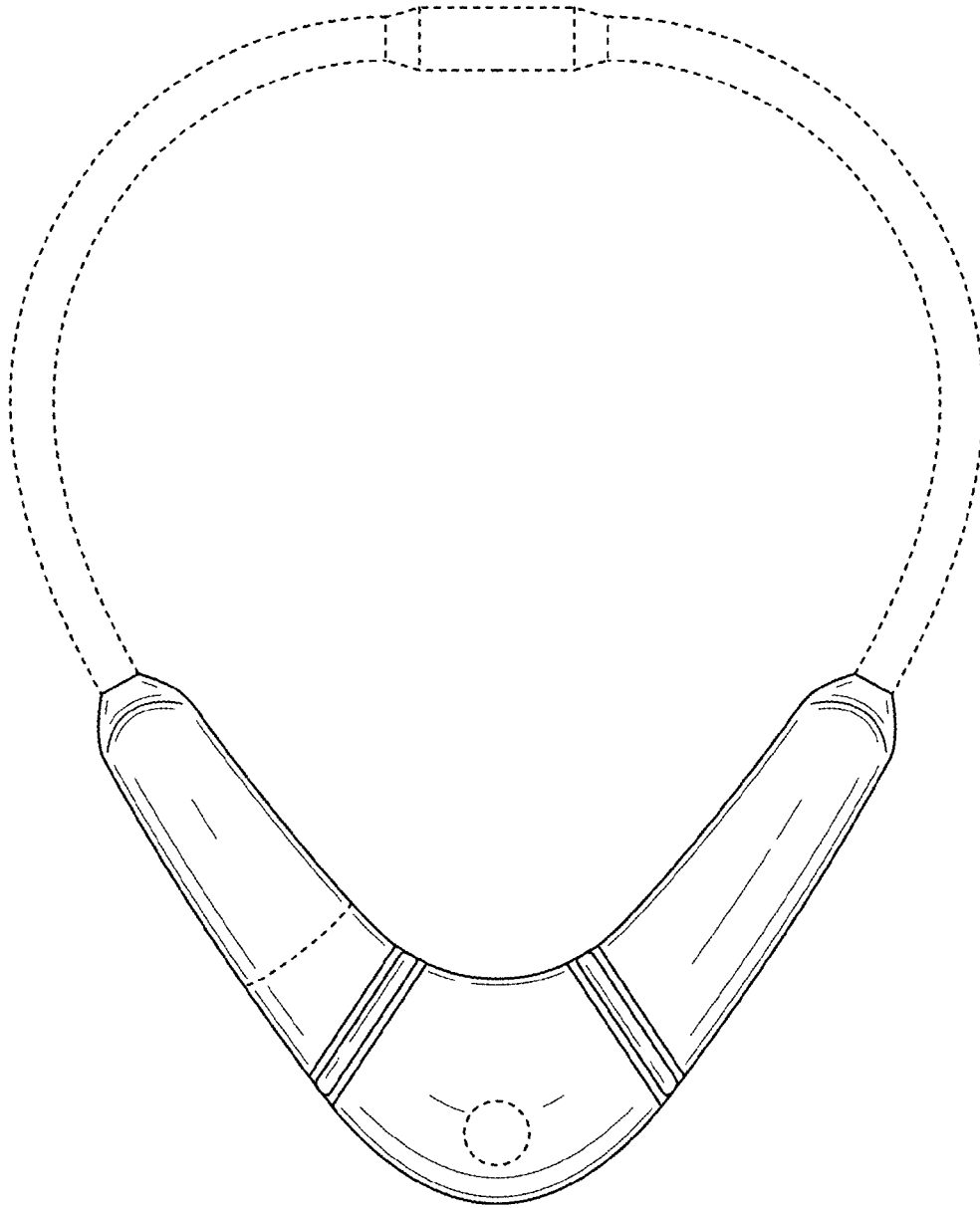

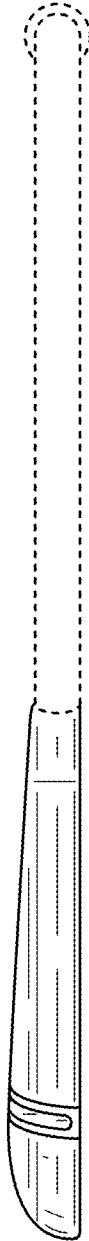

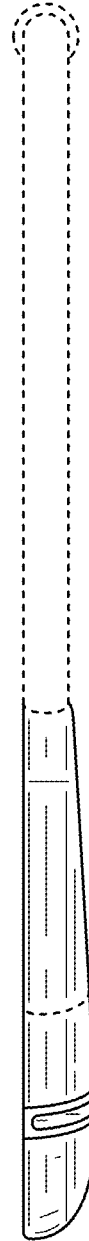

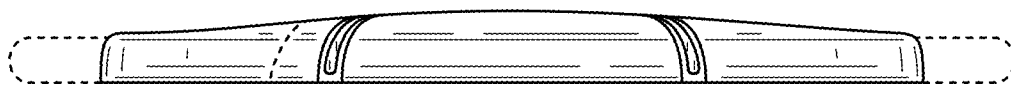

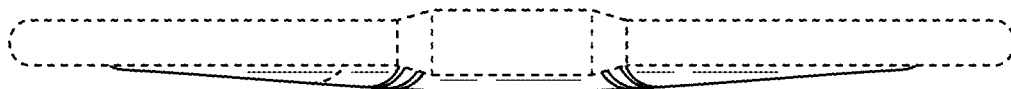

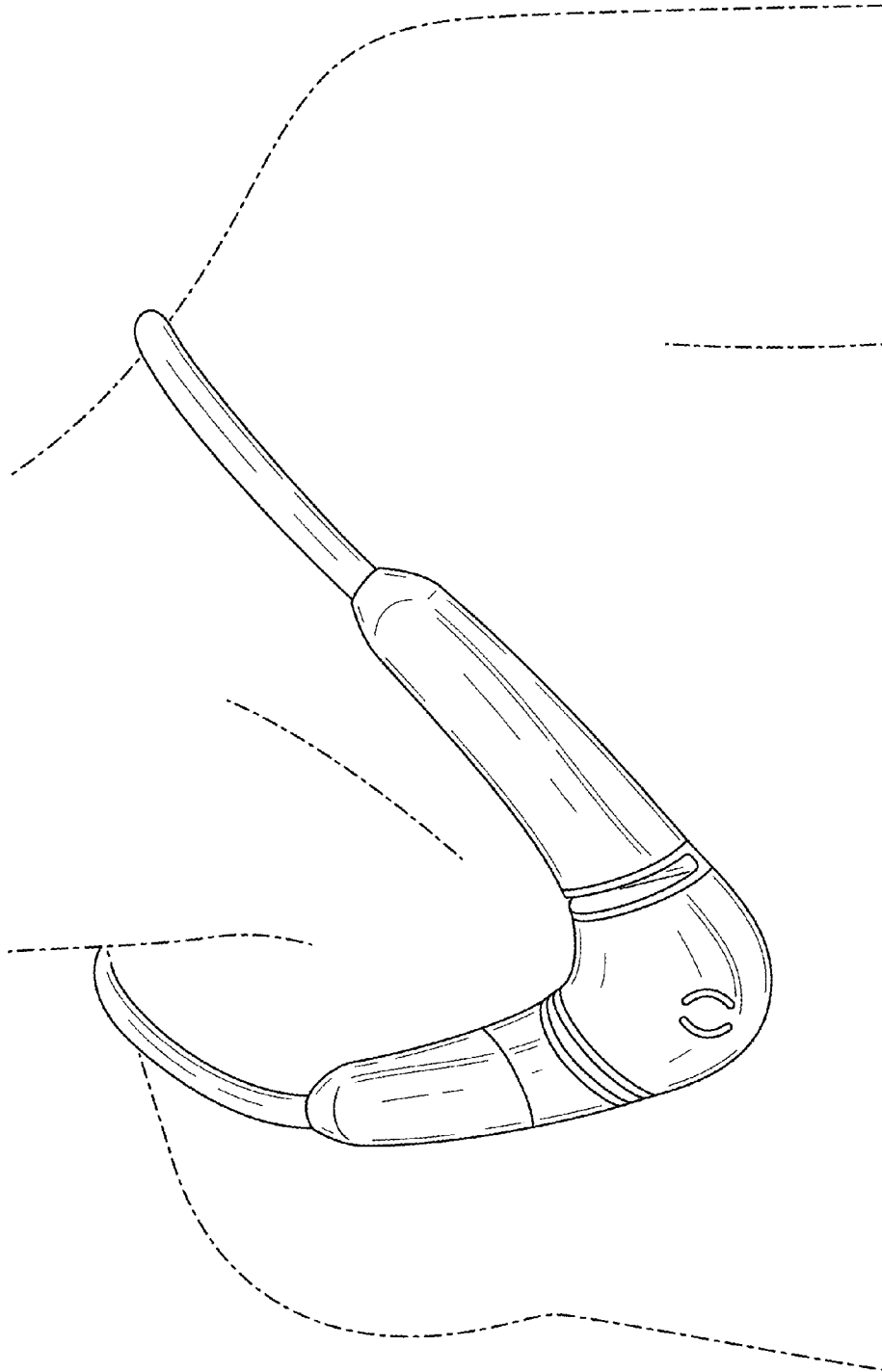

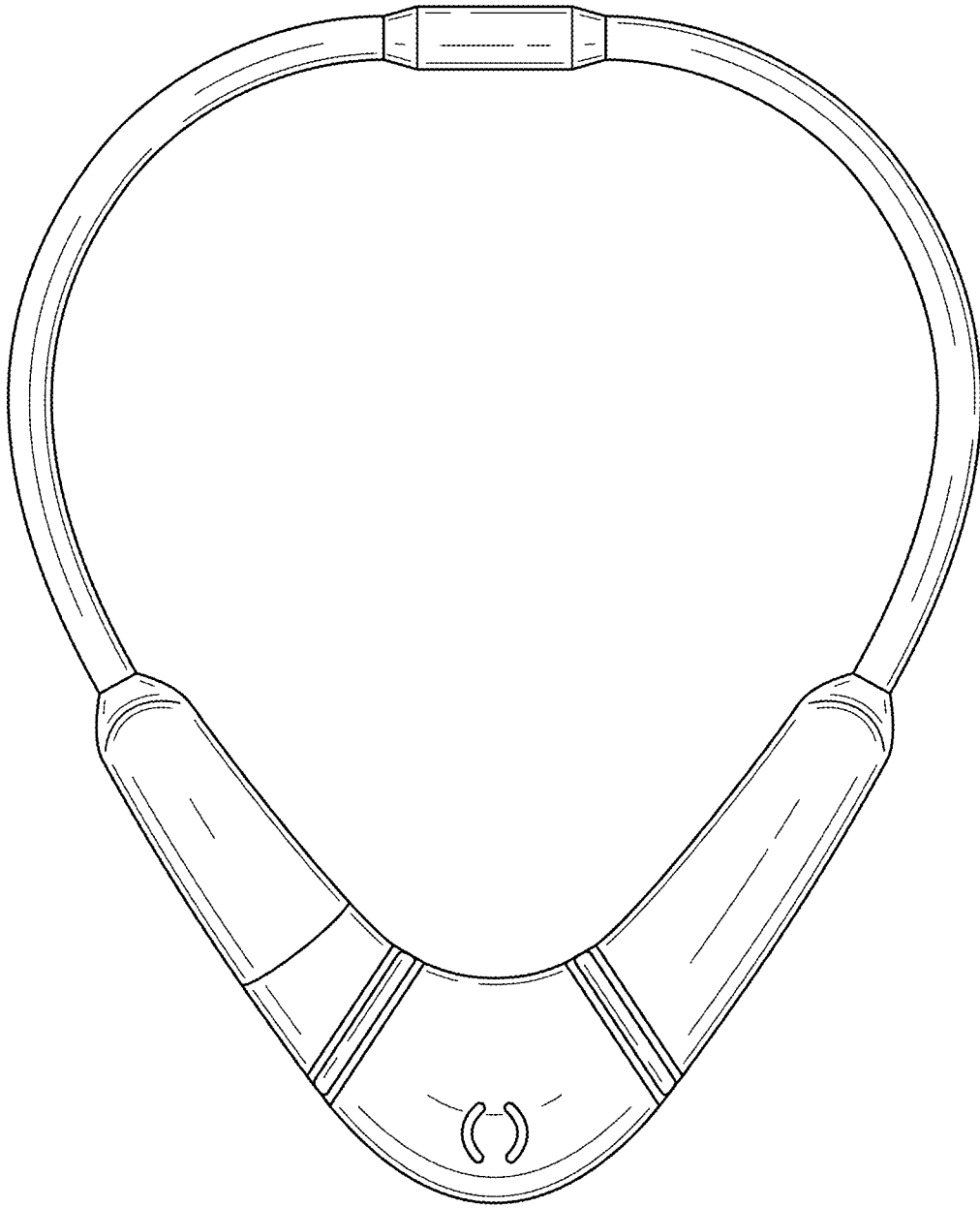

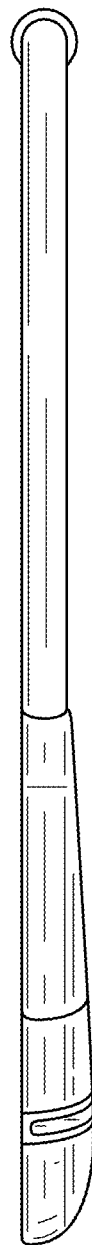
