(57) **CLAIM**

The ornamental design for a toothbrush package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view as seen from the front and left side of a toothbrush package showing our new design;

FIG. 2 is a front view of the toothbrush package of FIG. 1;

FIG. 3 is a back view of the toothbrush package of FIG. 1;

FIG. 4 is a right side view of the toothbrush package of FIG. 1;

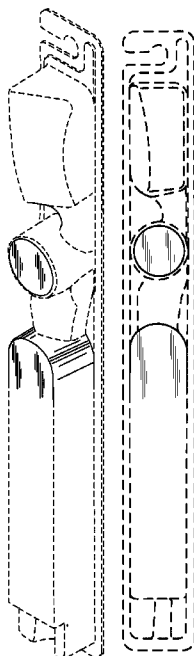
FIG. 5 is left side view of the toothbrush package of FIG. 1;

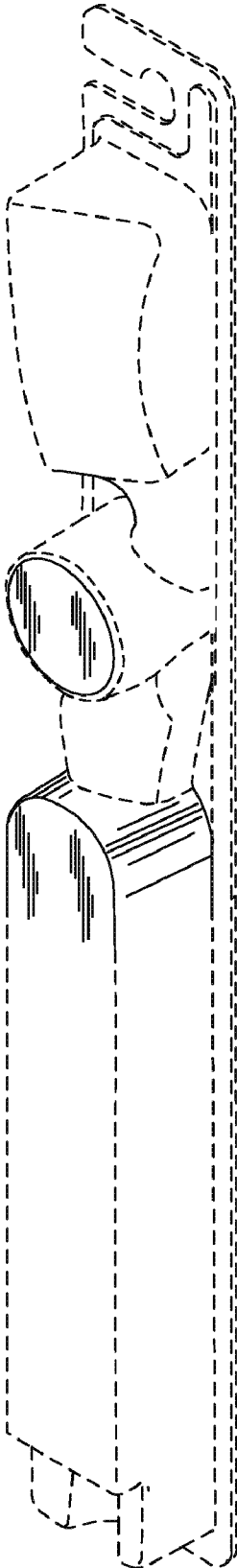

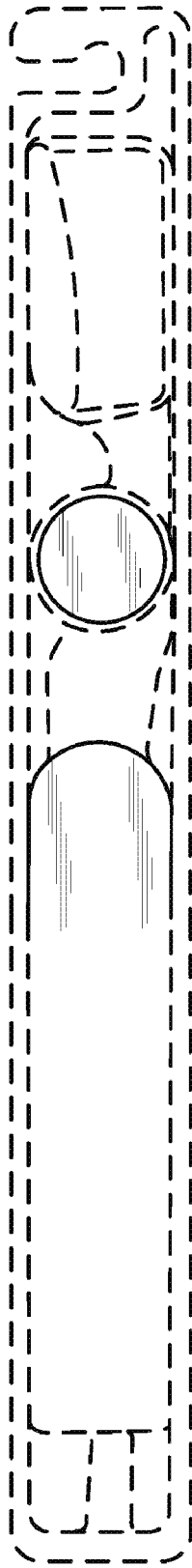

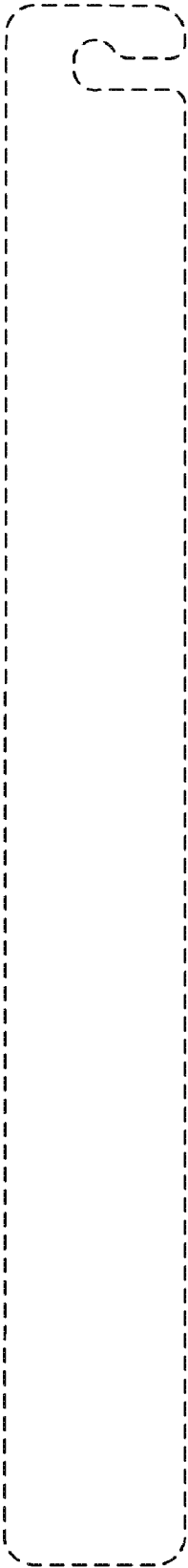

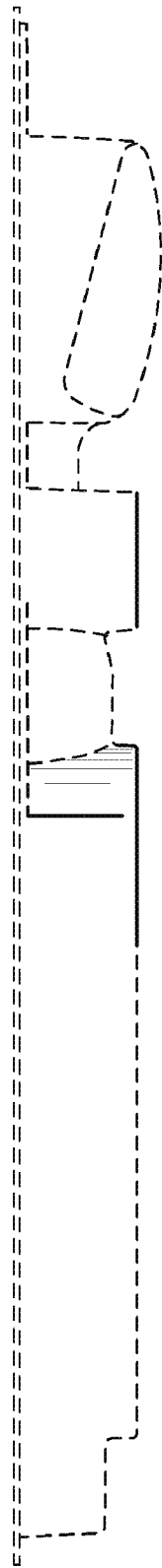

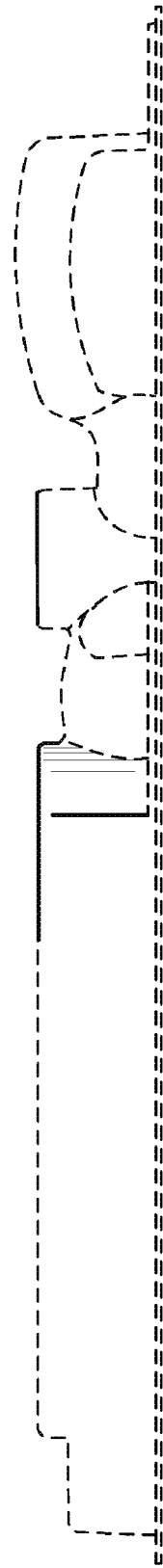

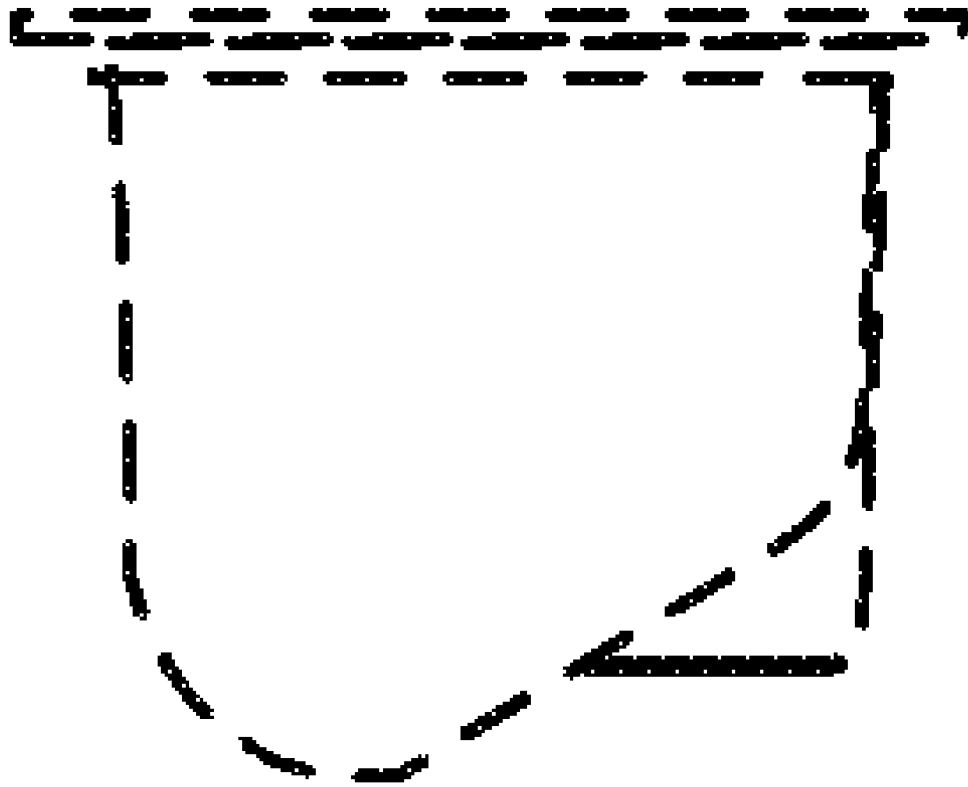
