

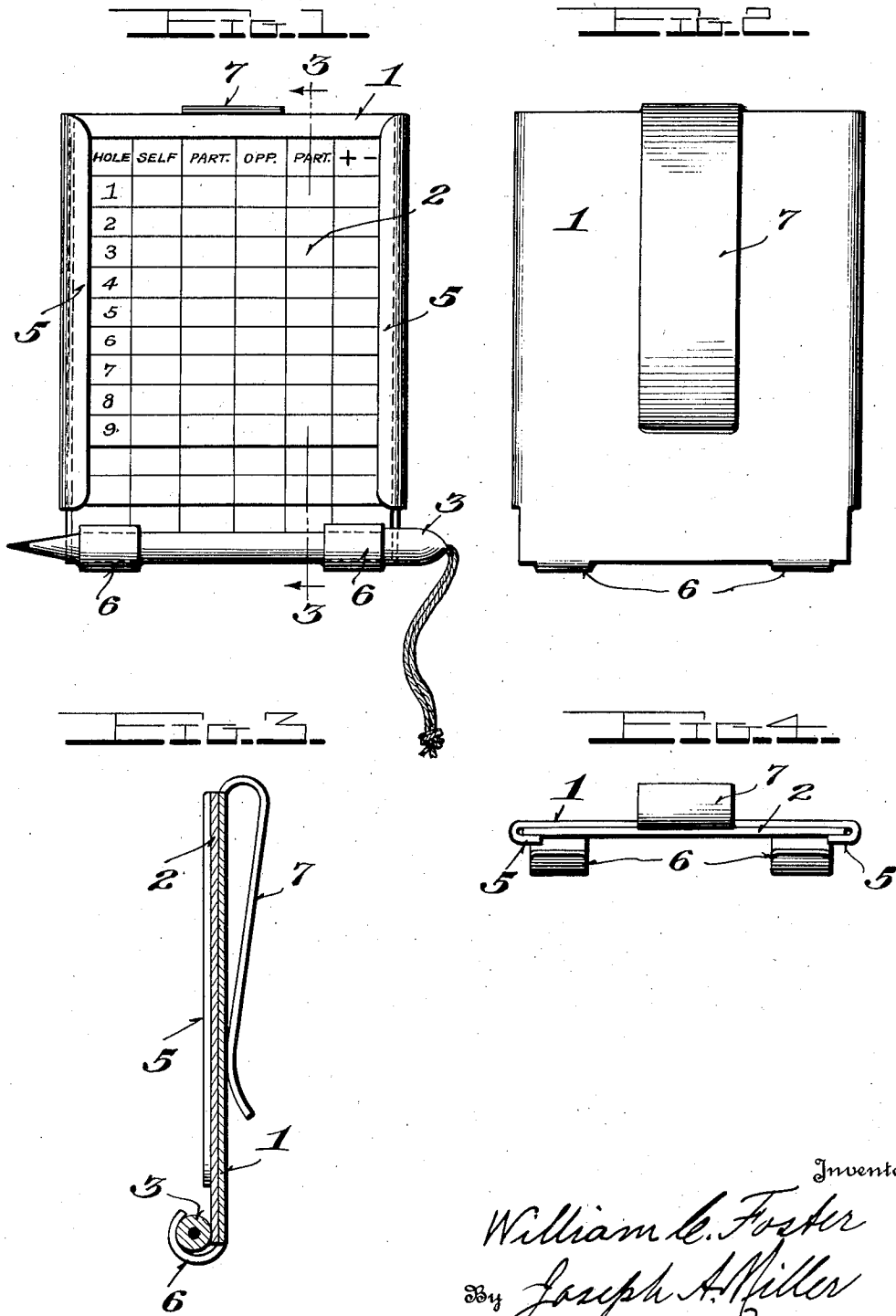

GOLF SCORE CARD HOLDER

Application filed December 4, 1930. Serial No. 499,911.

This invention relates to certain new and useful improvements in golf score card holders and has for its primary object to provide a compact, convenient, inexpensive and simple holder on which the golf score card and a pencil are secured, and which card and pencil can be easily and quickly removed as desired.

A further object of the invention is to combine the component parts so as to prevent any accidental displacement thereof;

A still further object of the invention is to provide a device which may be integrally stamped or formed from a sheet of resilient material.

In the drawings:—

Figure 1 is a front view of the present invention showing all the parts in operative position;

Figure 2 is a back view of the device showing the position of the clip;

Figure 3 is a section on line 3—3 of Figure 1; and

Figure 4 is a top view.

In proceeding according to the present invention a blank is initially formed as by stamping, in which all of the component parts are integrally related and disposed in a single plane; the blank being composed of a frame 1, side wings 5 and outwardly projecting fingers 6 and 7. The frame 1 is of substantially rectangular form and is of a material having spring properties, preferably sheet metal. Subsequently, the sides are bent inwardly to form the card holding and guiding wings 5, the fingers 6 are bent inwardly and upwardly to form the resilient pencil holding means 6 and the finger 7 is bent to form the downwardly extending supporting clip on the rear of the frame.

The score card 2 is retained in position by the side wings 5 which prevent lateral movement and further by the pressure exerted against its bottom end by the pencil 3 which thereby prevents any movement of the card relative to the holding frame.

The score card 2 is printed so as to have space for the record of 9 holes on each side and hence is reversible in its position. It is obvious that the pencil may be removed for

easy positioning of the card or that it may be left in place and the card forced into position behind it.

The pencil holders or fingers 6, being of resilient material, serve to exert a constant position pressure against the card through the pencil, as well as to hold the pencil firmly in place.

The clip 7 on the rear of the device enables the user to keep it in any convenient place, such as on a belt, the outside of a pocket, or on the top of a golf bag.

It will be readily seen that the present invention embodies a convenient means whereby the comparative scores of several players may be recorded in an open and easily accessible manner, and that the cards may be removed and kept if desired.

Having thus described my invention what I claim as new and desire to secure by Letters Patent is:—

1. In a card and pencil holder, a frame formed of a single piece of resilient material, side wings integral with the frame, upturned, inwardly extending fingers integral with said frame at the bottom thereof adapted to retain a pencil and exert a positive pressure through said pencil upon the card, and a downwardly extending clip member at the rear of said frame and integral therewith.

In a golf score card and pencil holder, a frame formed of a single piece of resilient material, means carried by said frame to guide and hold a card, upturned inwardly extending fingers integral with said frame at the bottom thereof adapted to retain a pencil and exert a positive pressure through said pencil upon the card, and means for supporting the frame from the clothing or the like of the player.

In a golf score card and pencil holder, a frame, means carried by said frame to guide and hold a card, means adjacent to the bottom of the frame and adapted to retain a pencil and to exert a positive pressure through said pencil upon the card, and means on the frame whereby said frame may be supported from the clothing or the like of the player.

4. In a golf score card and pencil holder, a frame, means carried by said frame to guide

and removably hold a card, and means adjacent to the bottom of the frame and adapted to retain a pencil and to exert a positive pressure through said pencil upon the card.
