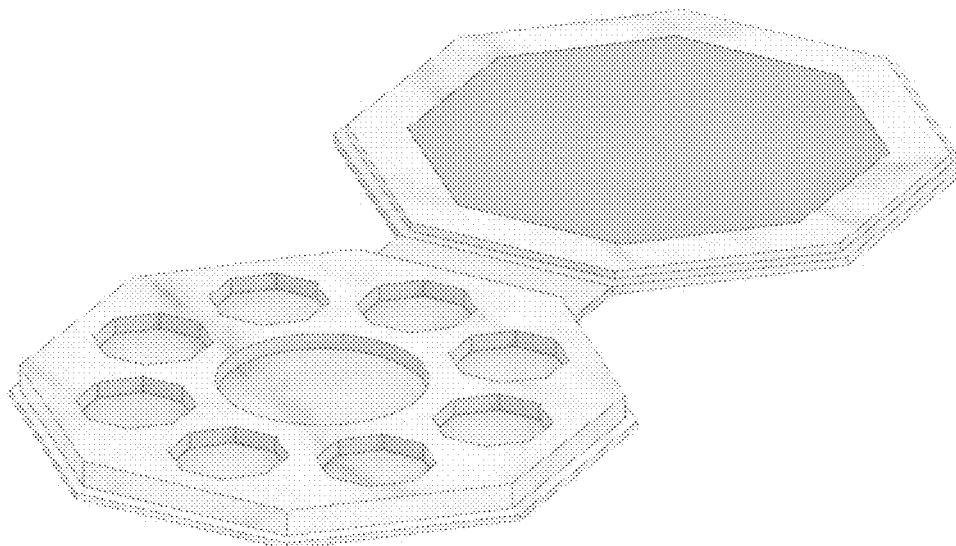
The ornamental design for an eye shadow container, as shown and described.

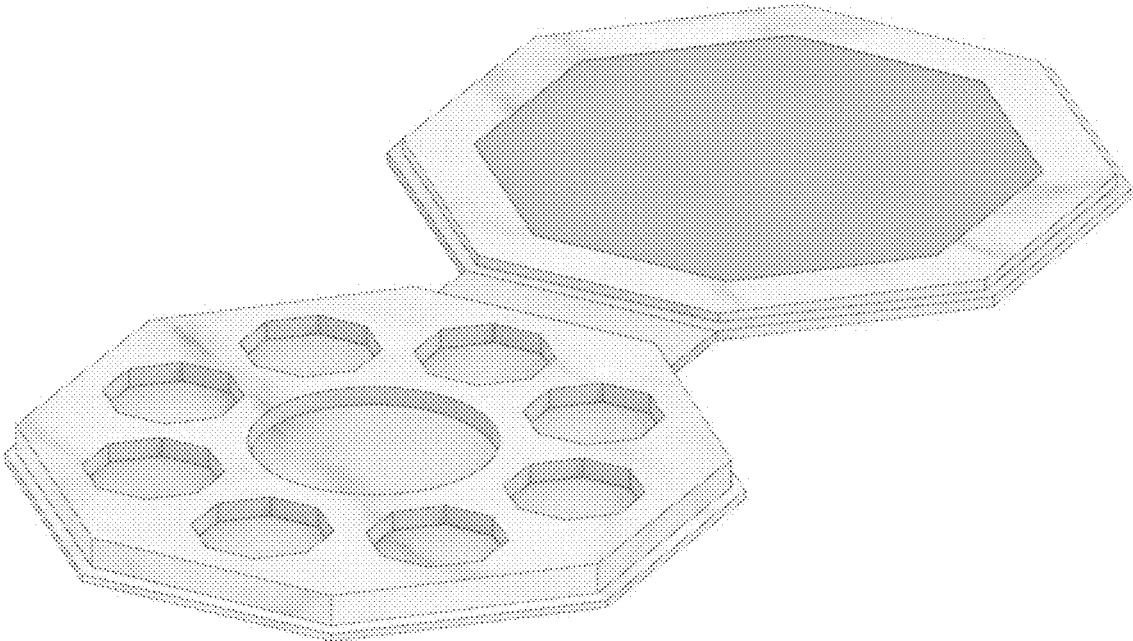

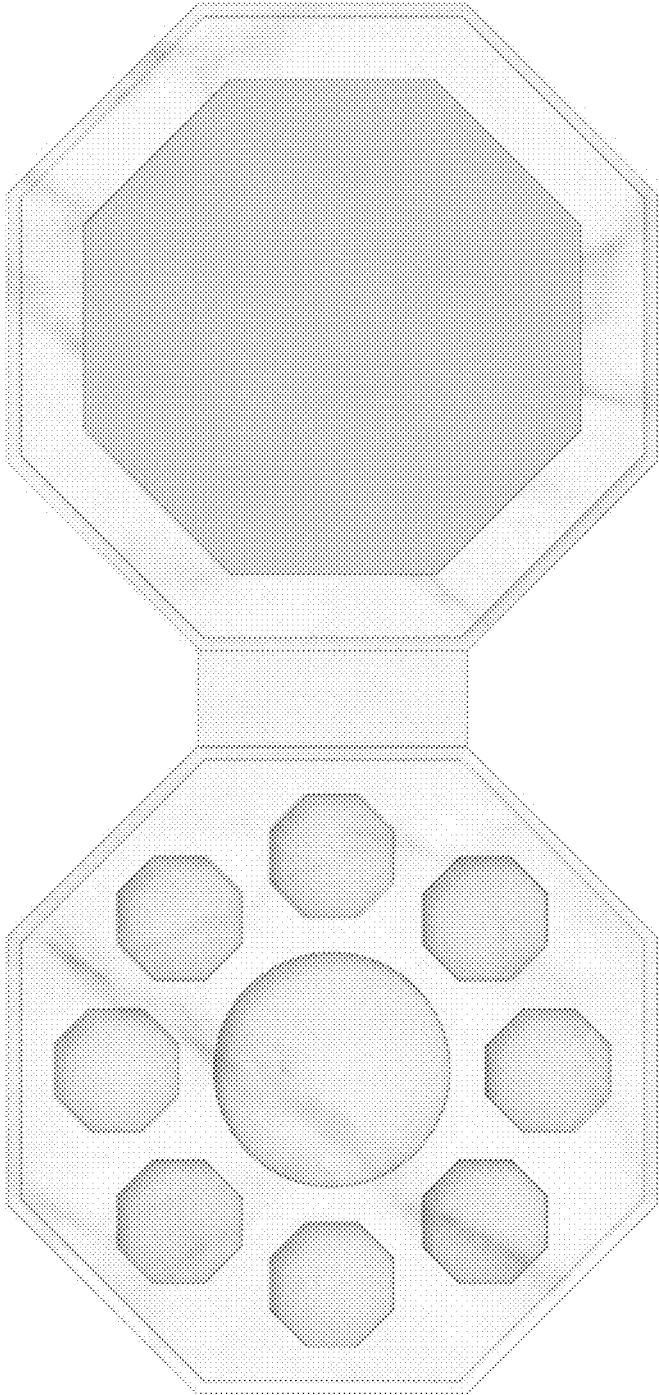
