(57) **CLAIM**

The ornamental design for a looping ride element, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the looping ride element having features in accordance with the present invention, the broken line showing along the top edge of the design is included for the purpose of illustrating unclaimed subject matter and forms no part of the claimed design;

FIG. 2 is a left side view of the looping ride element of FIG. 1;

FIG. 3 is a right side view of the looping ride element of FIG. 1;

FIG. 4 is a front side view of the looping ride element of FIG. 1;

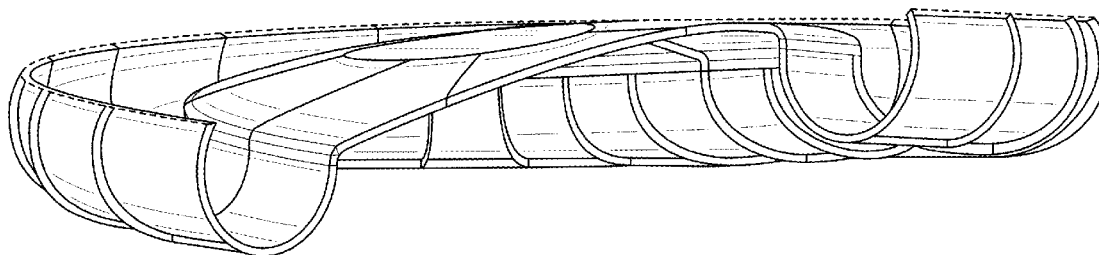
FIG. 5 is a back side view of the looping ride element of FIG. 1;

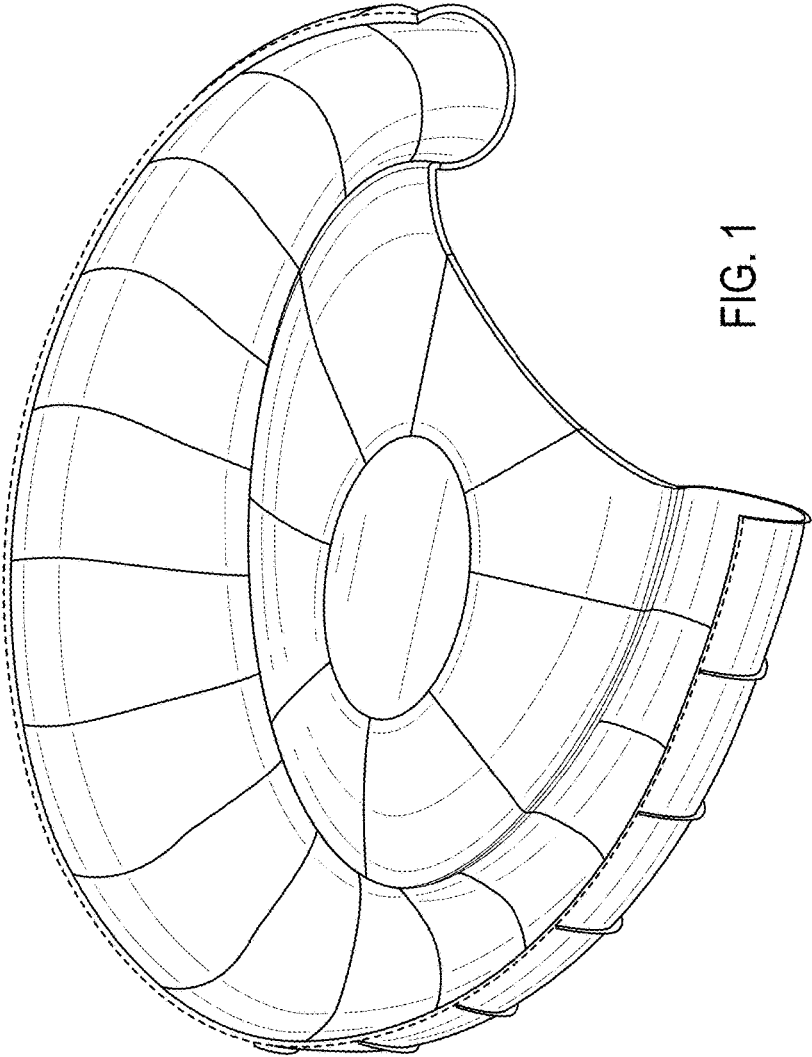

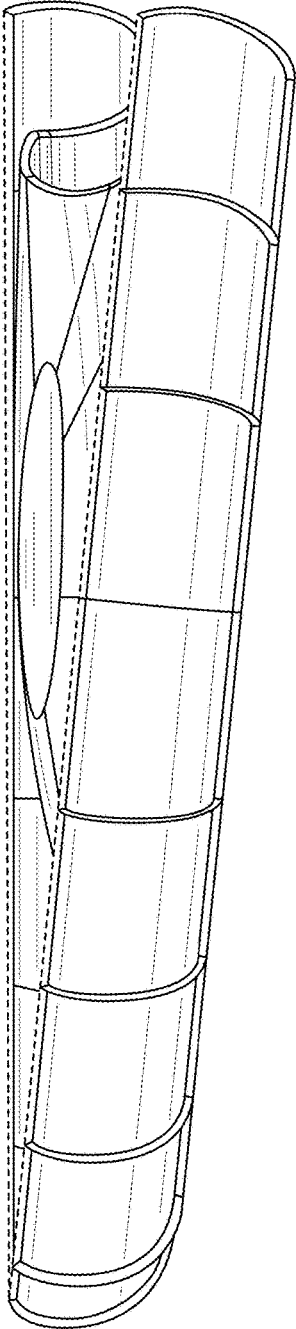

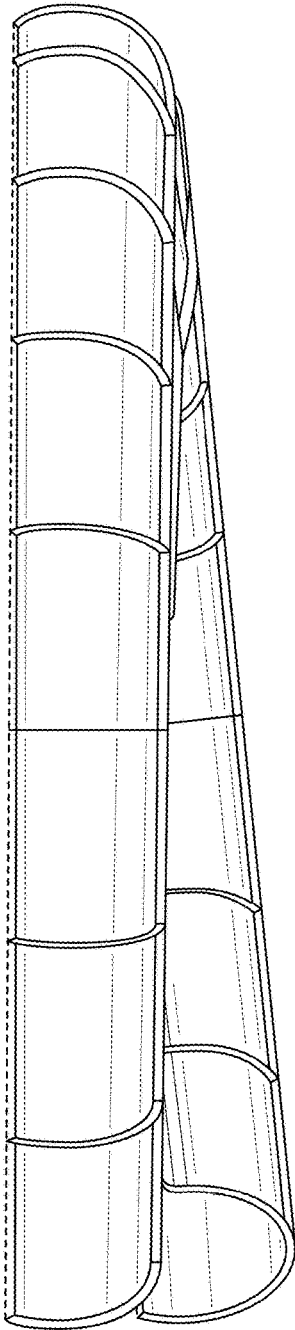

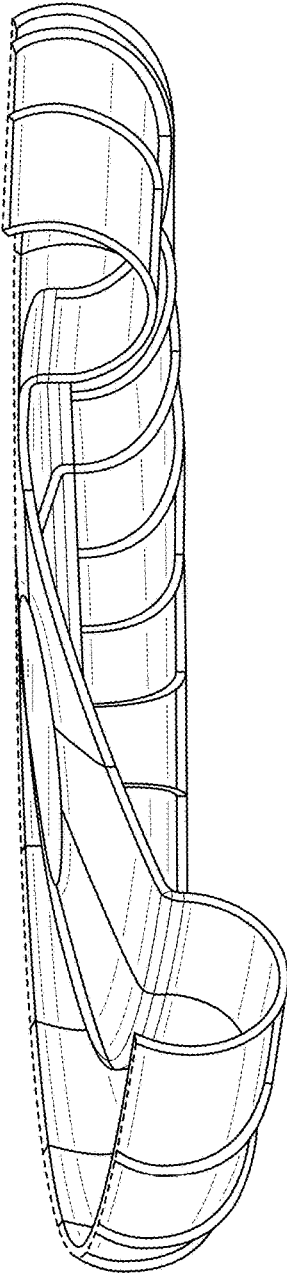

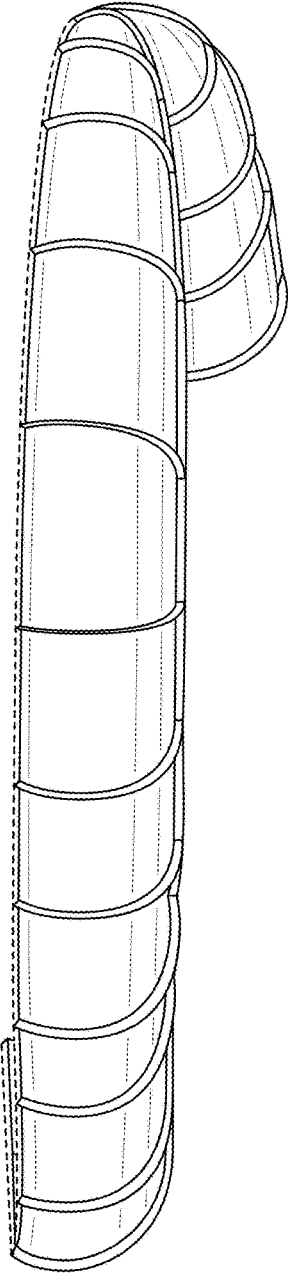

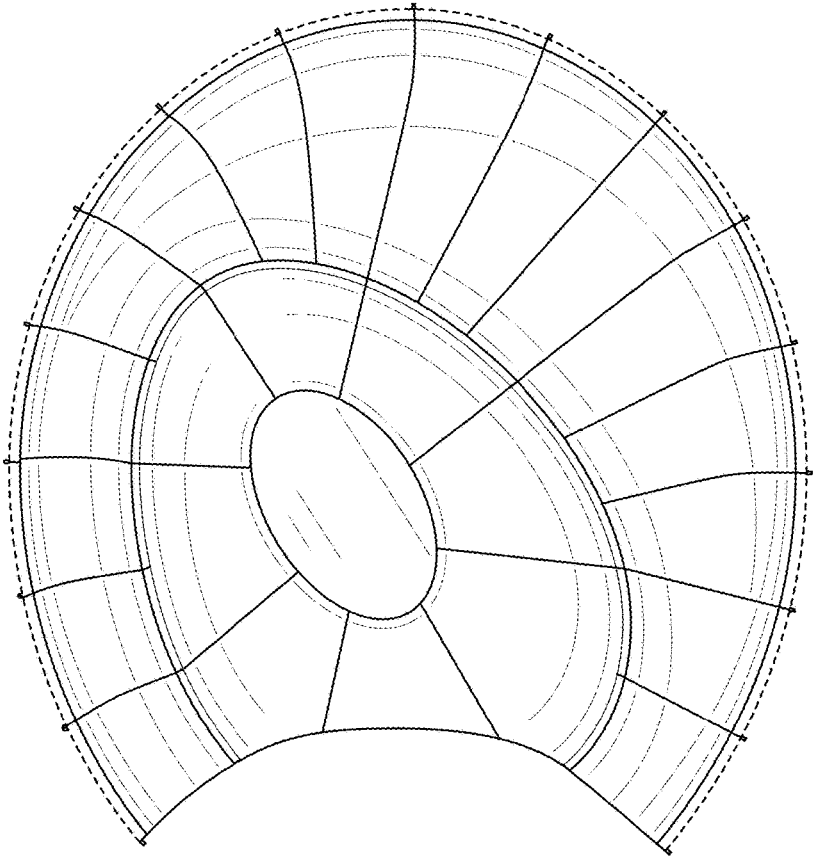

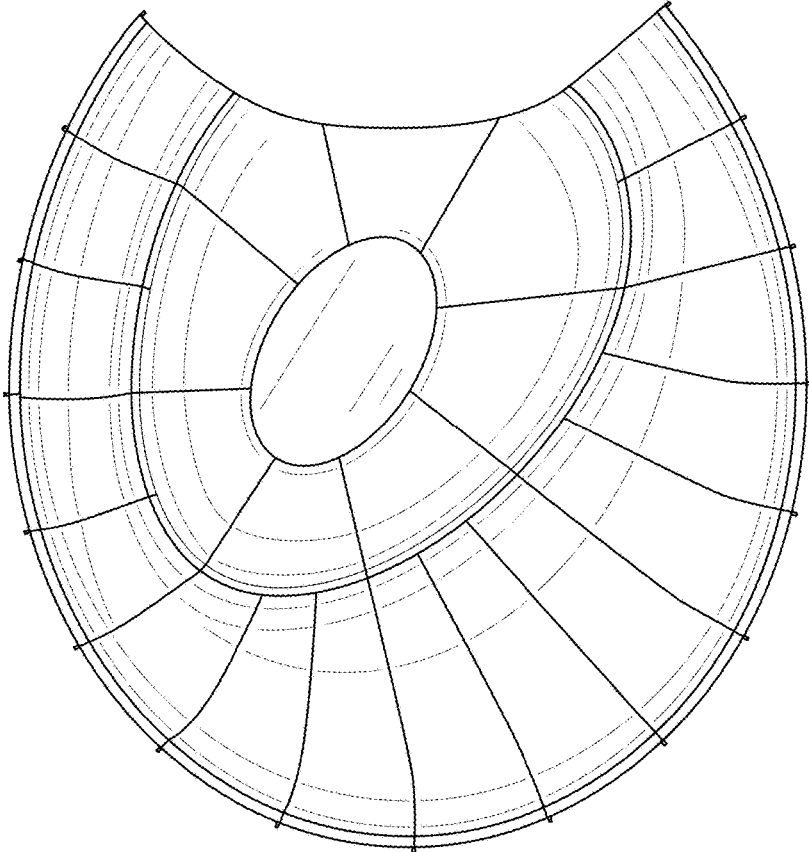
