(57) **CLAIM**

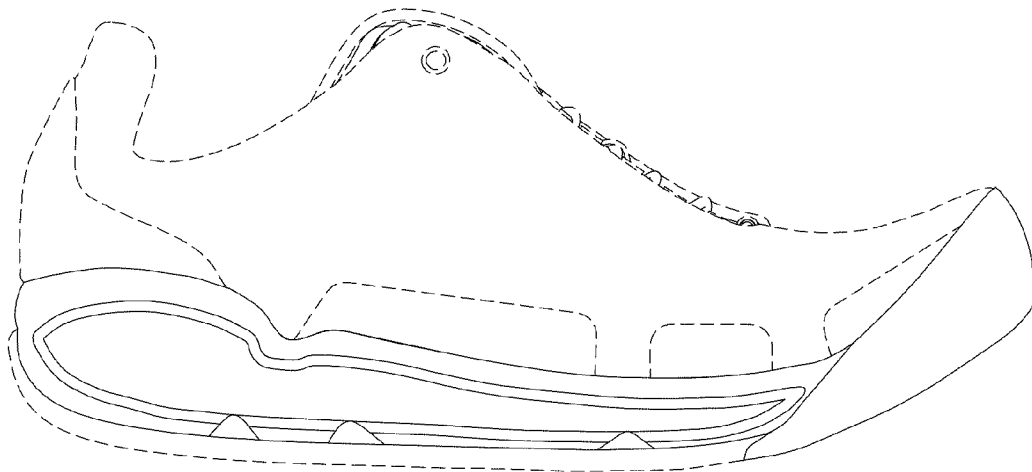
I claim an ornamental design for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the claimed footwear design; FIG. 2 is a left side view of the claimed design of FIG. 1; FIG. 3 is a front view of the claimed design of FIG. 1; FIG. 4 is a right side view of the claimed design of FIG. 1; FIG. 5 is a bottom view of the claimed design of FIG. 1; and, FIG. 6 is a back view of the claimed design of FIG. 1.

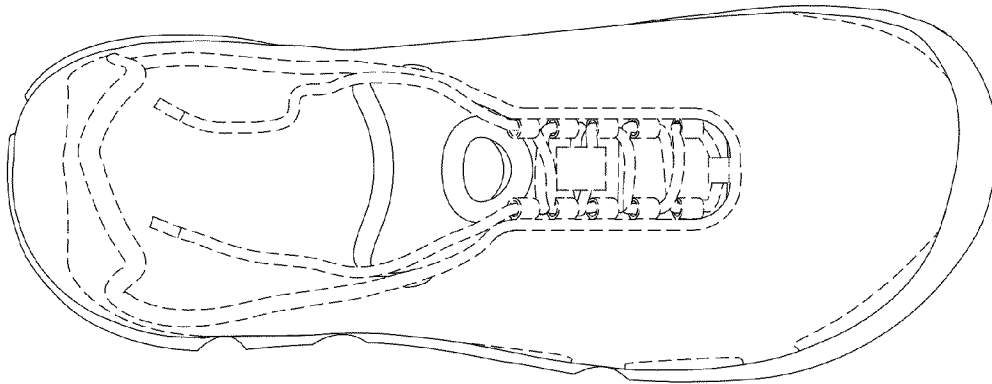

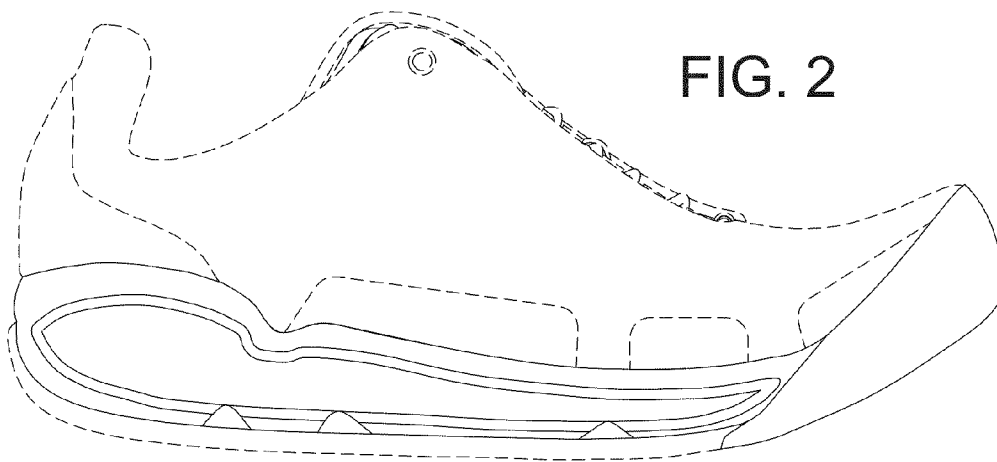

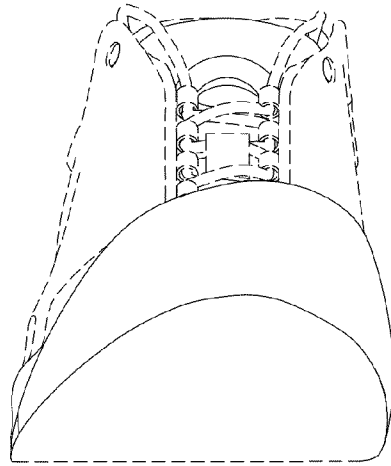

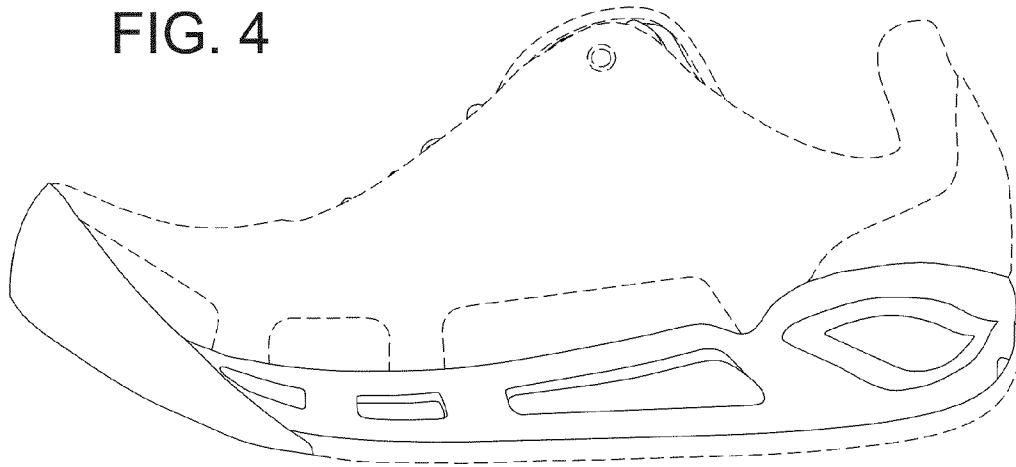

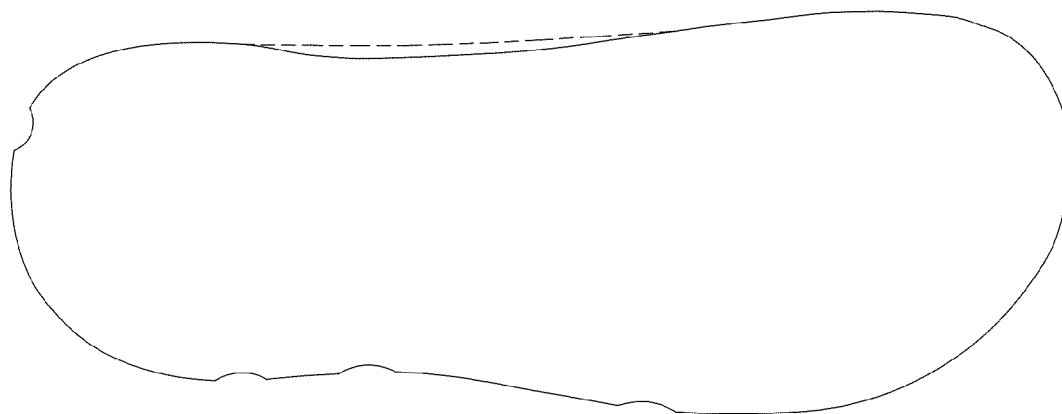
