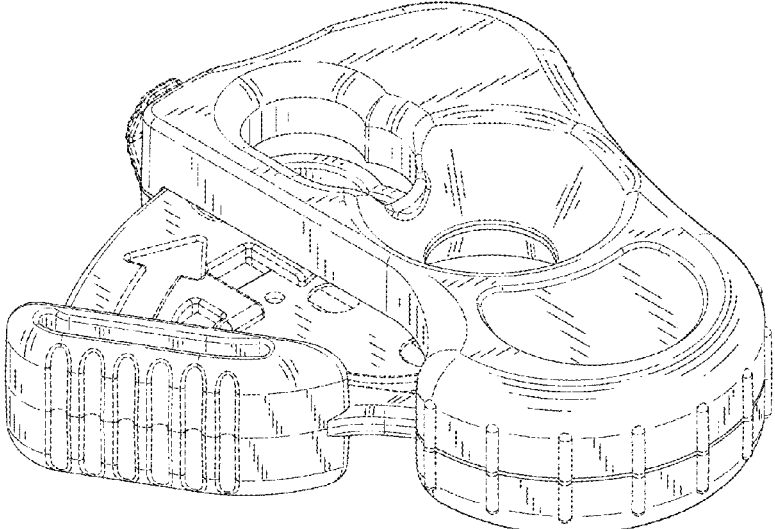

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a cutter showing my new design;

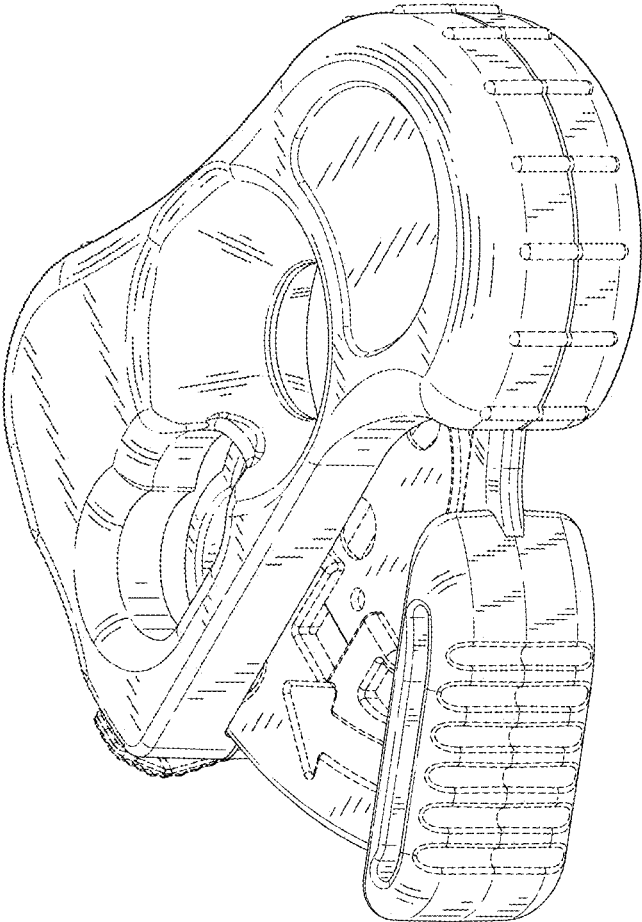

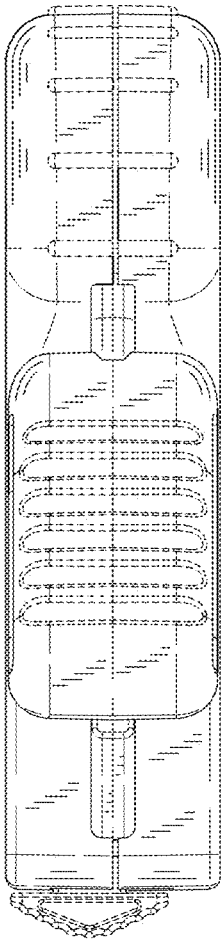

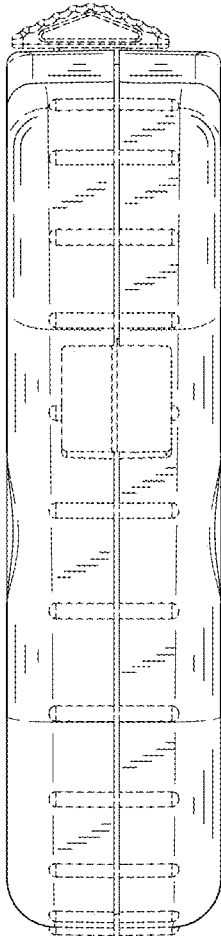

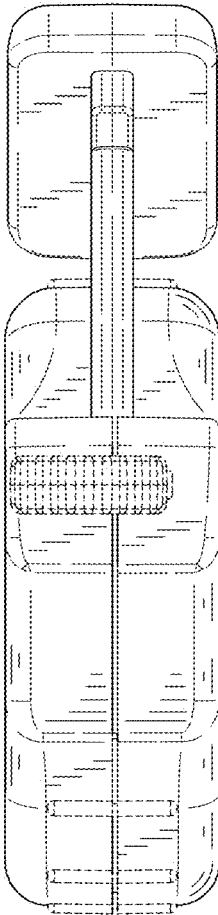

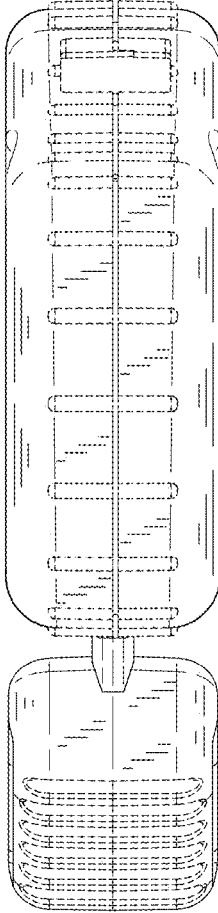

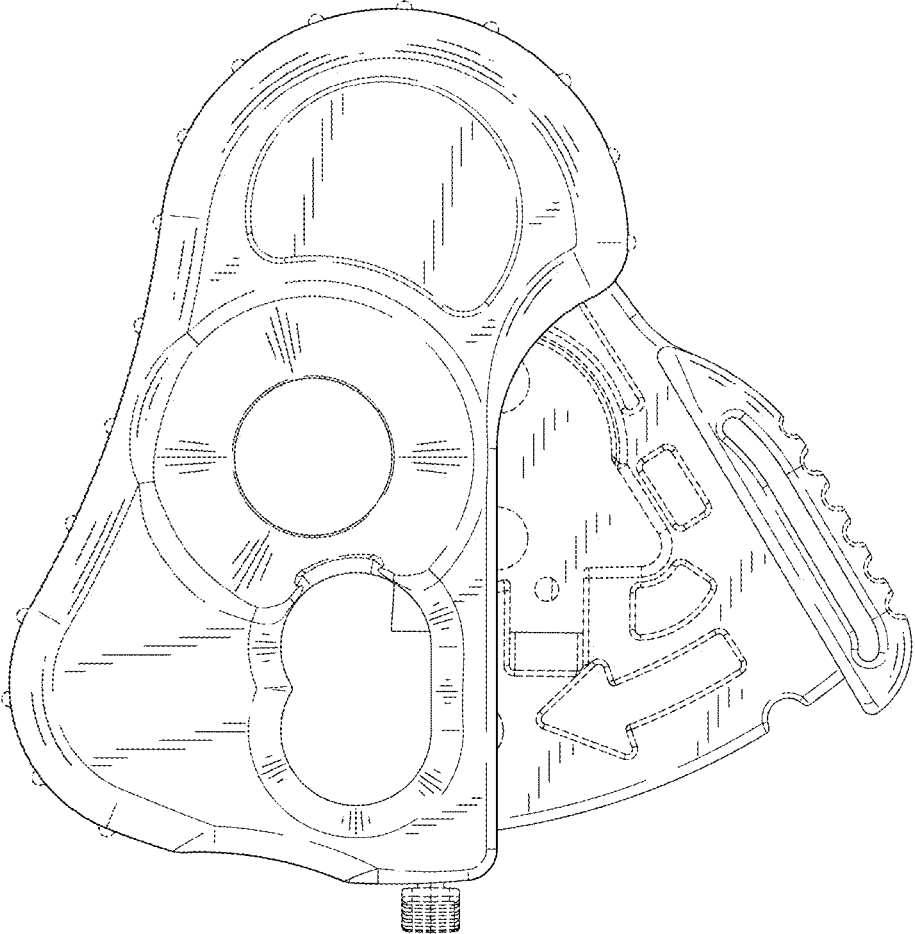

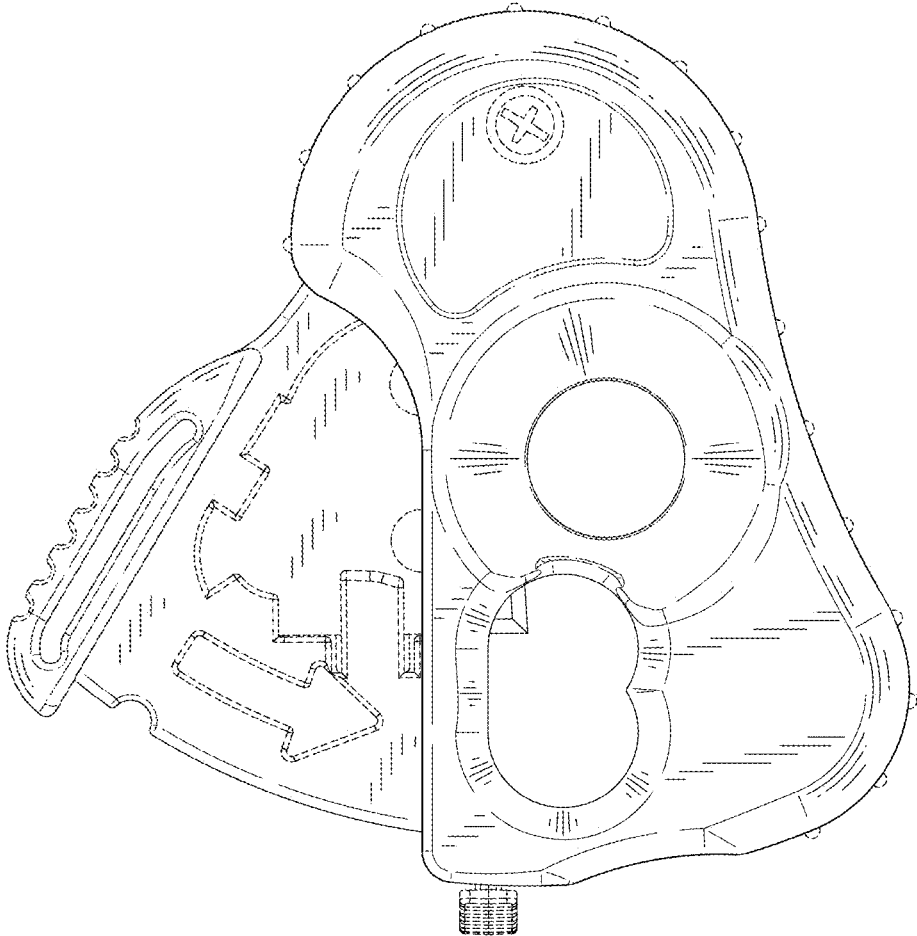

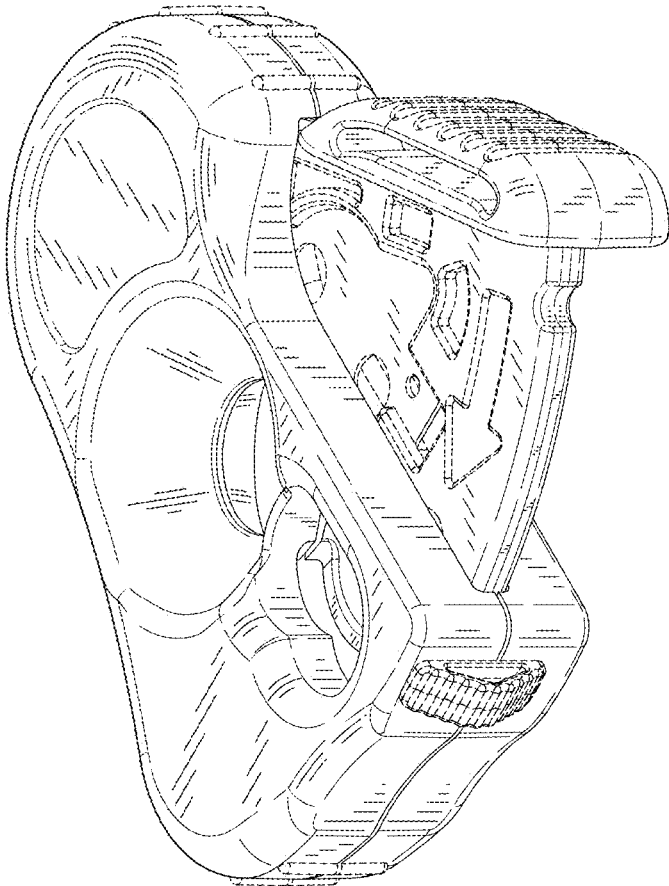

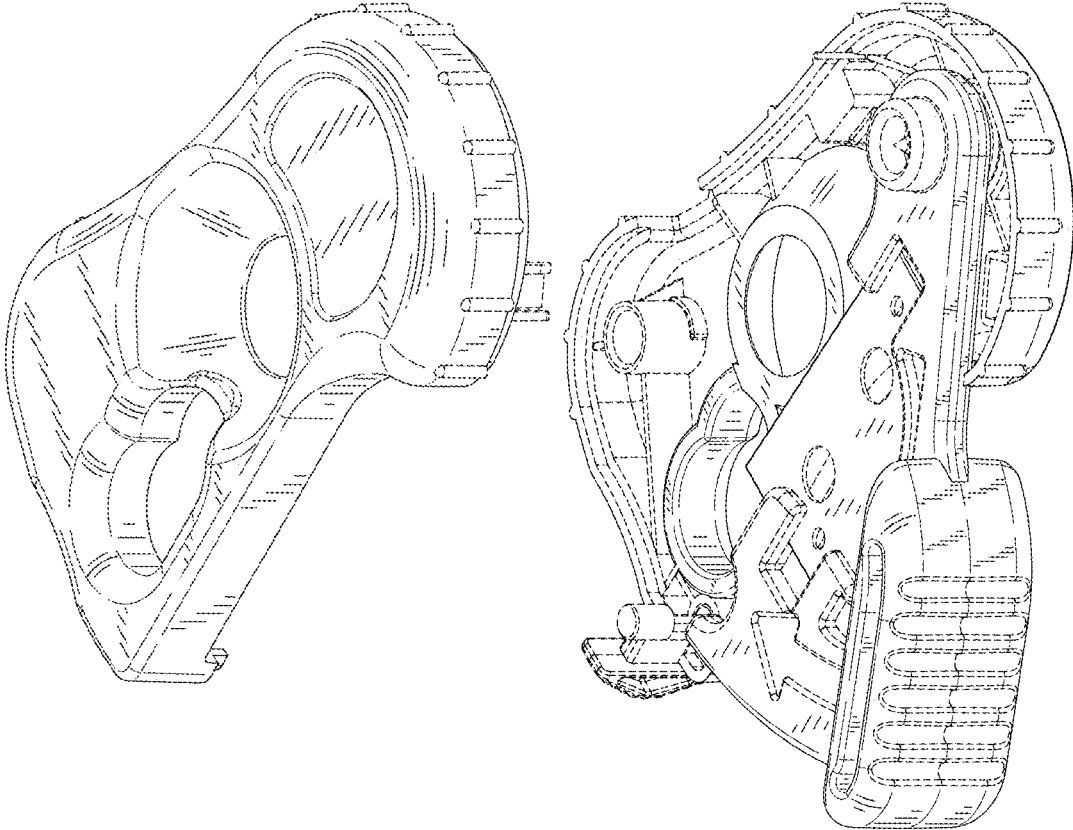
