I claim the ornamental design for a head visor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head visor, showing my new design;

FIG. 2 is a front elevational view of the invention;

FIG. 3 is a rear elevational view of the invention;

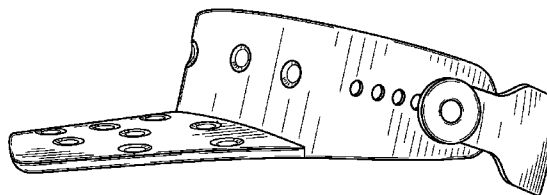
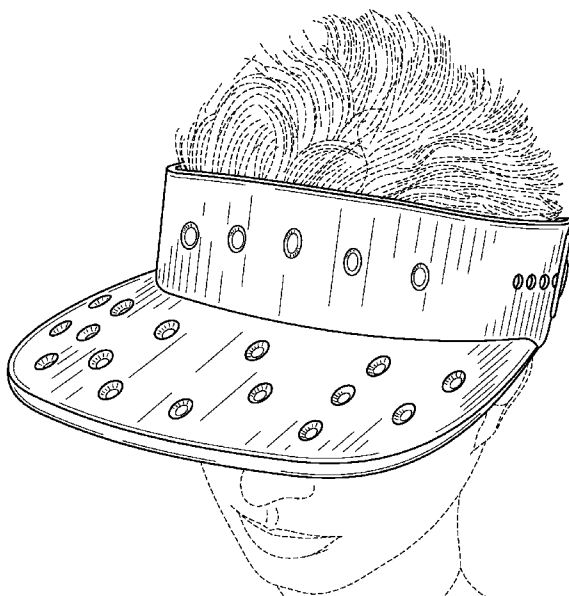
FIG. 4 is a left-side elevational view of the invention, the right-side elevational view being a mirror image thereof;

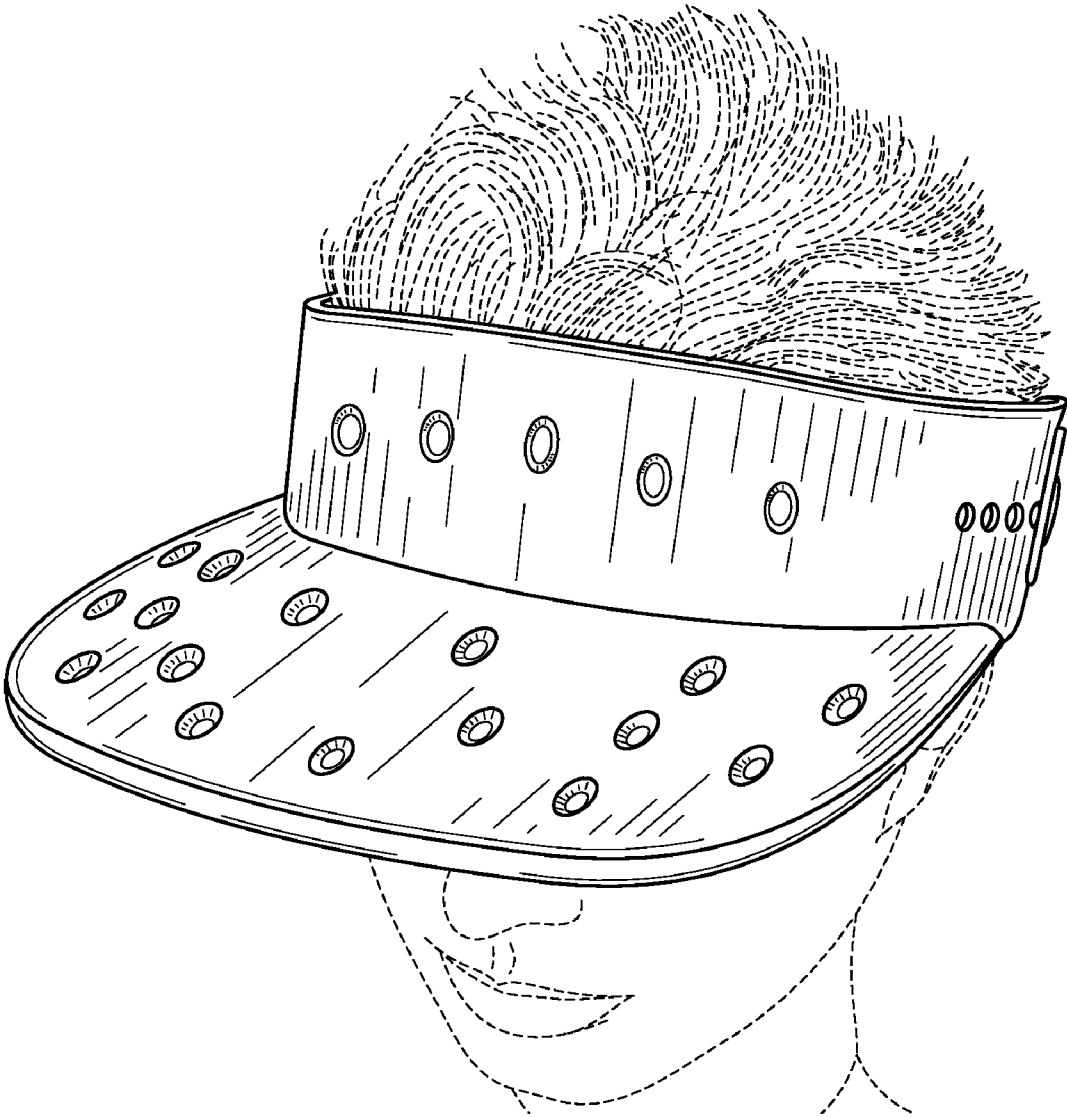

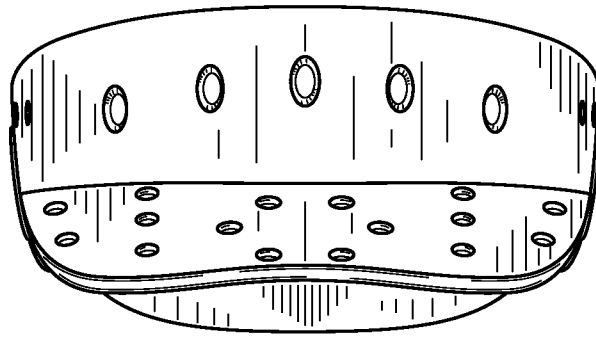

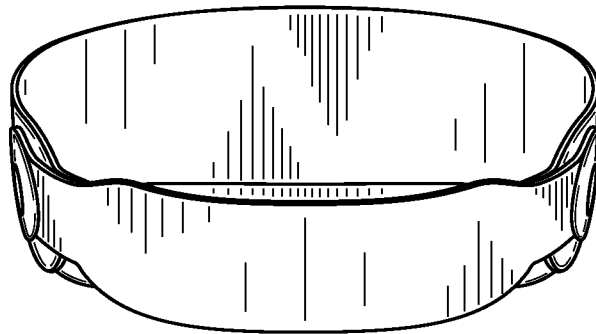

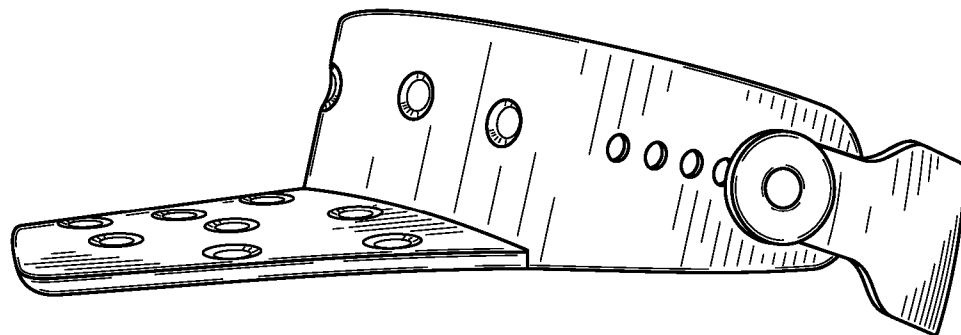

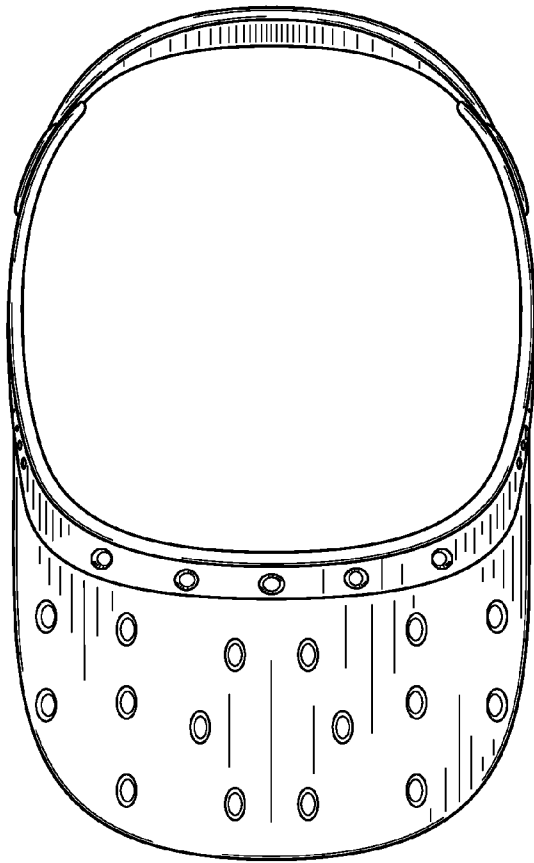

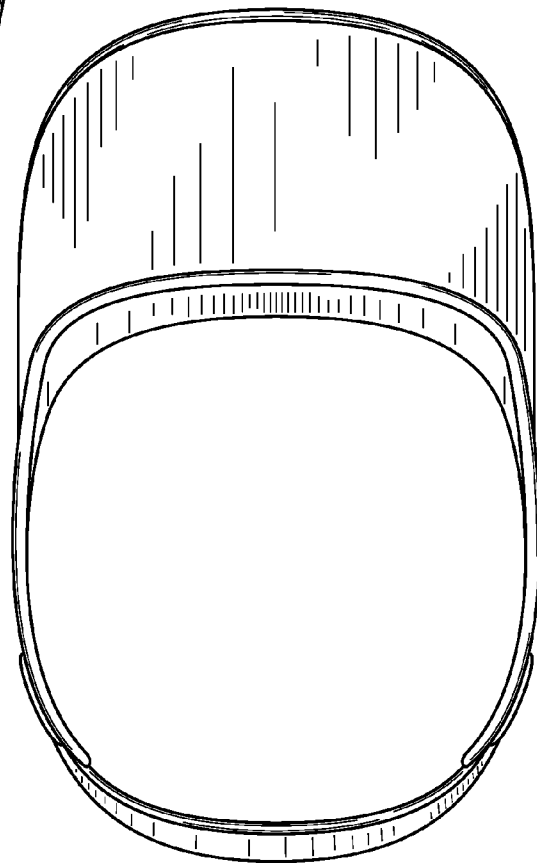
