(57) **CLAIM**

The ornamental design for an electrical drive unit for adjustable beds and slatted beds, and shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an electrical drive unit for adjustable slatted beds, with the locking device for electric cable plugs removed, showing our new design;

FIG. 2 is a bottom rear perspective view thereof,

FIG. 3 is a top plan view thereof,

FIG. 4 is an inverted rear view thereof,

FIG. 5 is a bottom plan view thereof,

FIG. 6 is a front view thereof,

FIG. 7 is a left side view thereof, and

FIG. 8 is a right side view thereof,

FIG. 9 is a top perspective view thereof, with the locking device for electric cable plugs included;

FIG. 10 is a bottom rear perspective view thereof,

FIG. 11 is a top plan view thereof,

FIG. 12 is an inverted rear view thereof,

FIG. 13 is a bottom plan view thereof,

FIG. 14 is a front view thereof,

FIG. 15 is a left side view thereof, and

FIG. 16 is a right side view thereof,

FIG. 17 is a top perspective view thereof, with the locking device for electric cable plugs in an open position and the covers at opposite ends opened;

FIG. 18 is a bottom rear perspective view thereof,

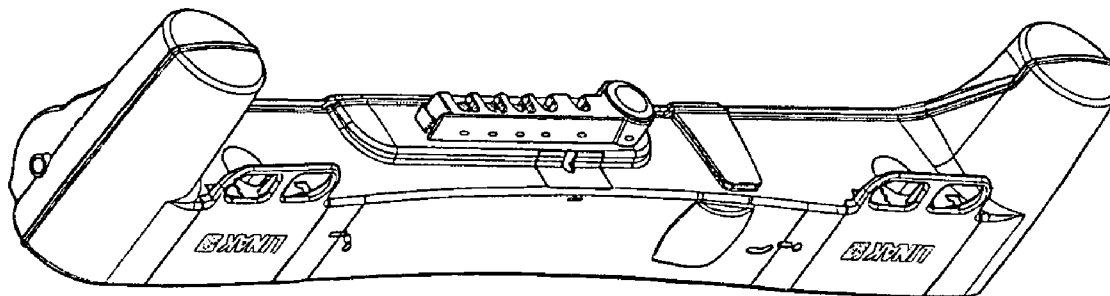
FIG. 19 is a top perspective view of a cover, shown separately for clarity, and

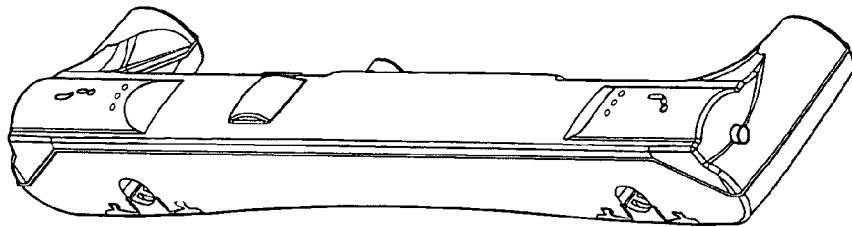

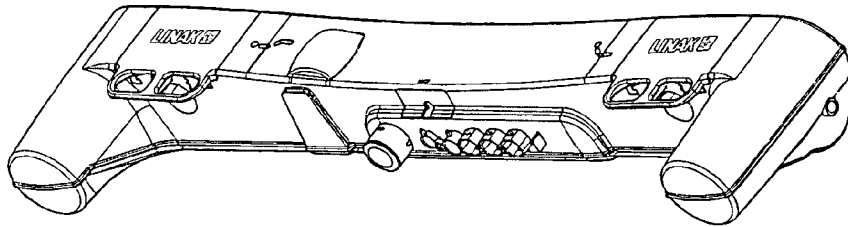

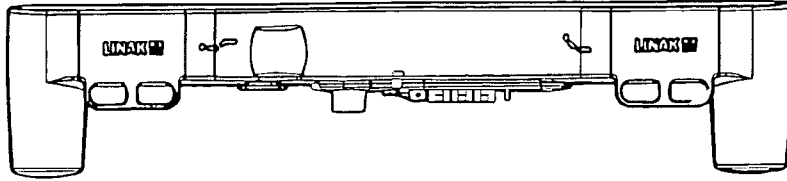

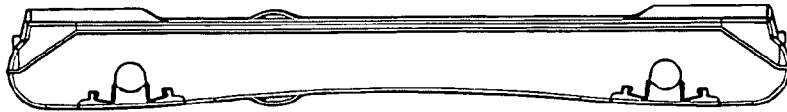

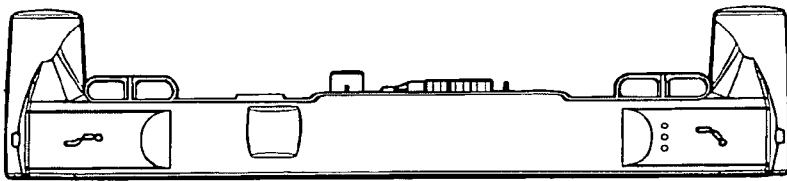

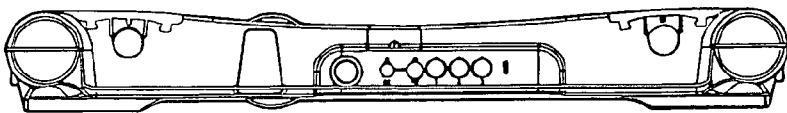

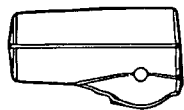

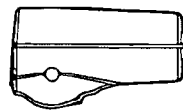

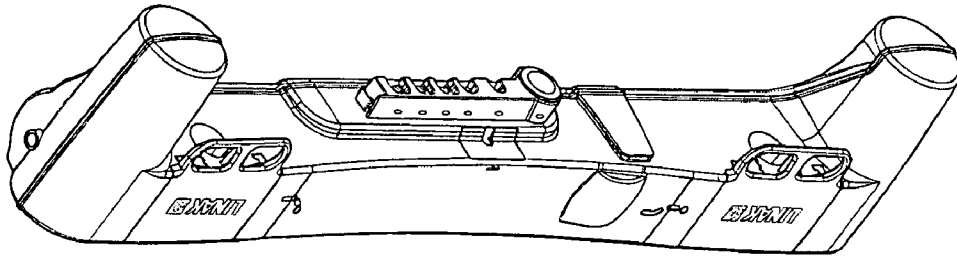

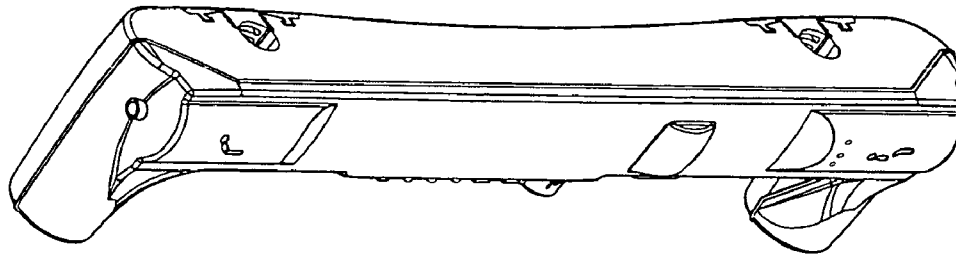

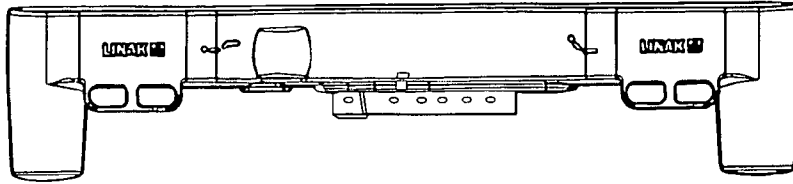

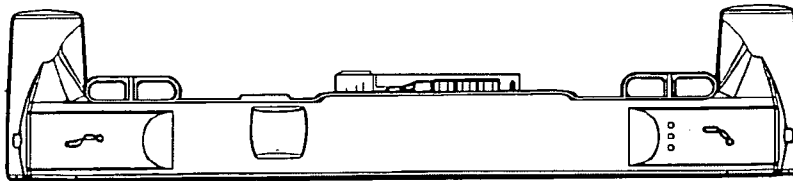

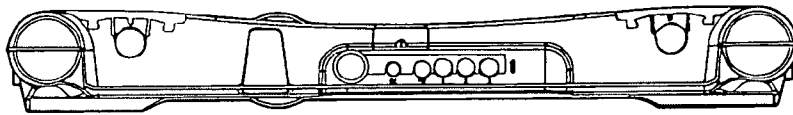

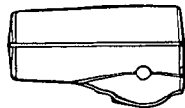

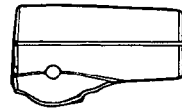

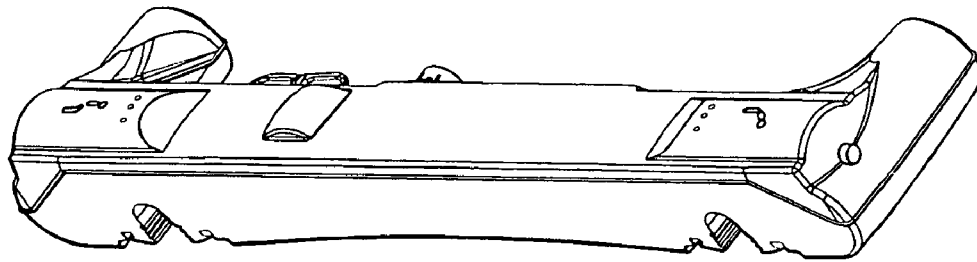

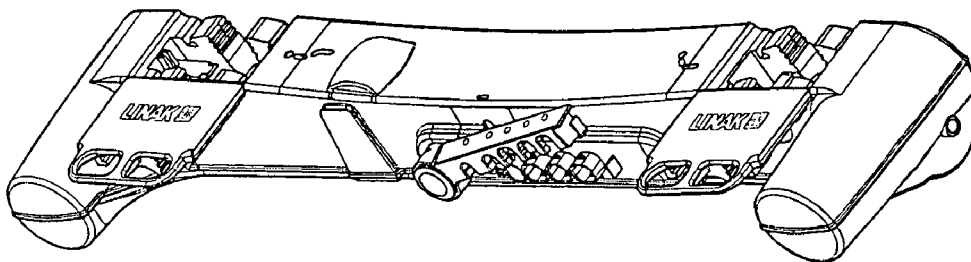

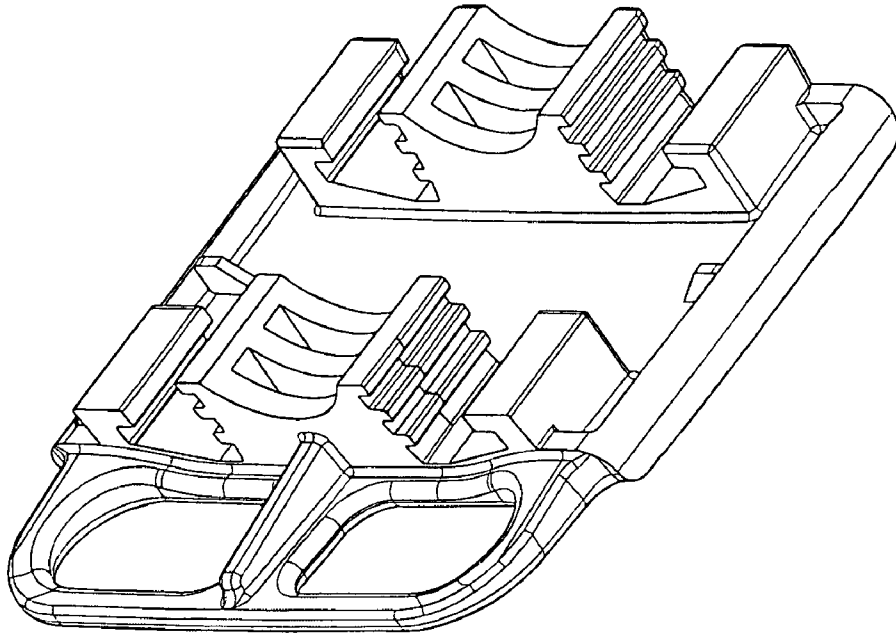

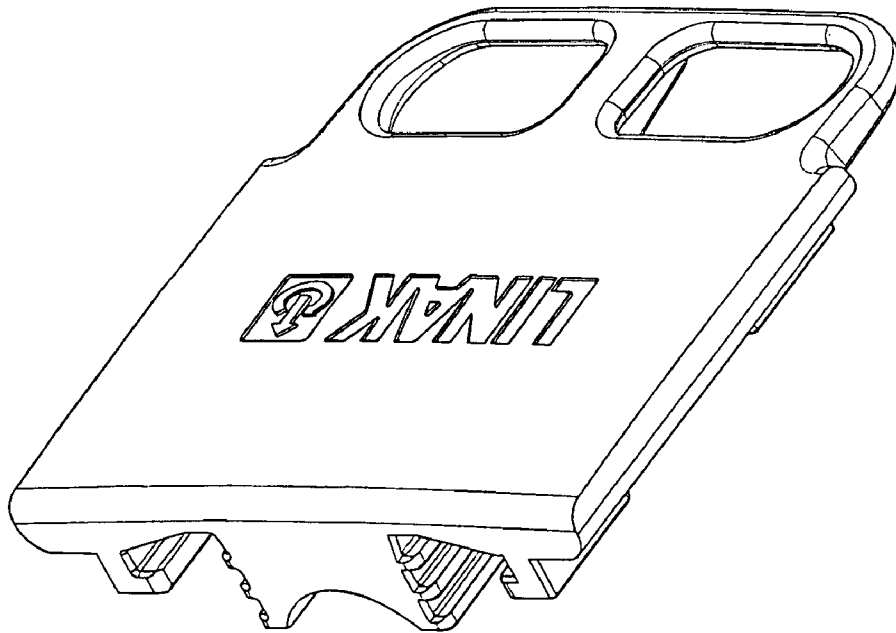

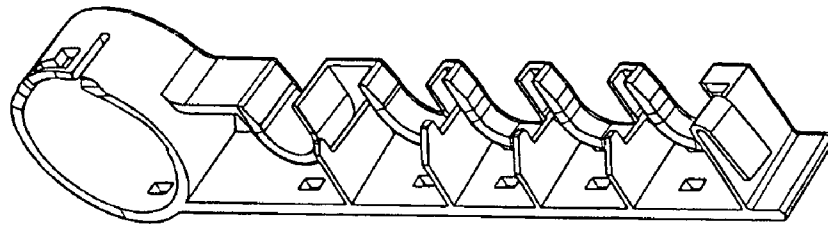

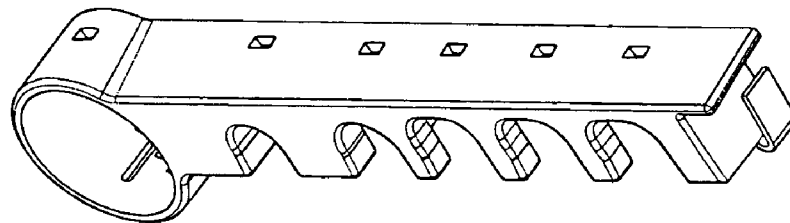
