breaker. The invention also relates to a circuit breaker including a modular and removable hydraulic/magnetic trip unit.

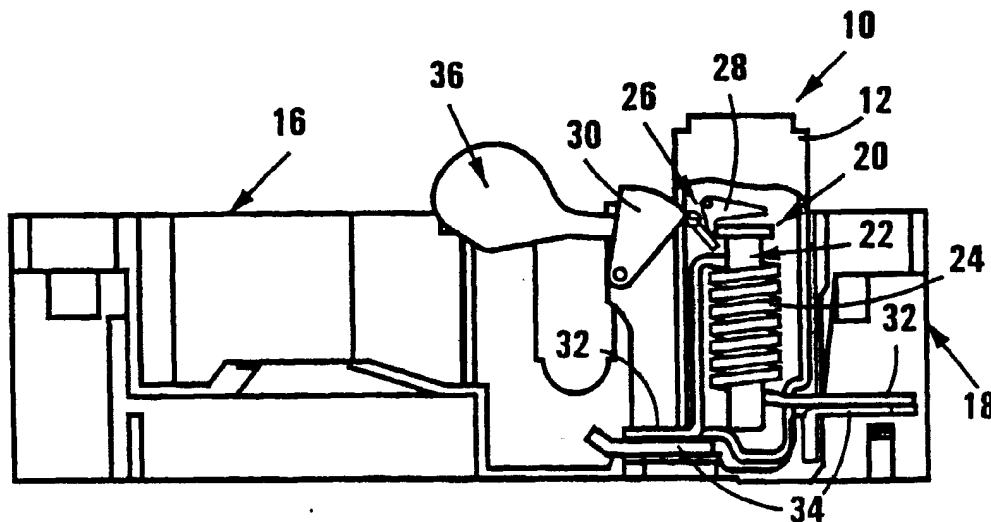
