FIG. 2 is a front view thereof, shown with the exemplary beverage container removed to show aspects of the design not visible when combined.

FIG. 3 is a rear view thereof, shown with the exemplary beverage container removed to show aspects of the design not visible when combined.

FIG. 4 is a side view thereof, shown with the exemplary beverage container removed to show aspects of the design not visible when combined.

FIG. 5 is a top plan view of the lid of FIG. 1; and, FIG. 6 is a cross-sectional view of the lid taken along line 6 of FIG. 5.

The broken lines are shown for the purpose of illustrating parts of the article as well as environmental subject matter of an exemplary beverage container. None of the broken lines form part of the claimed design.

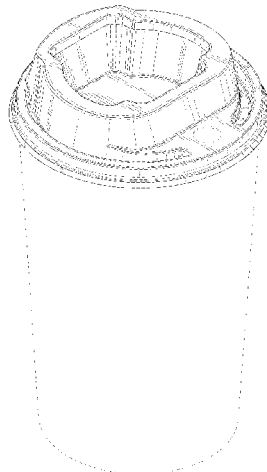

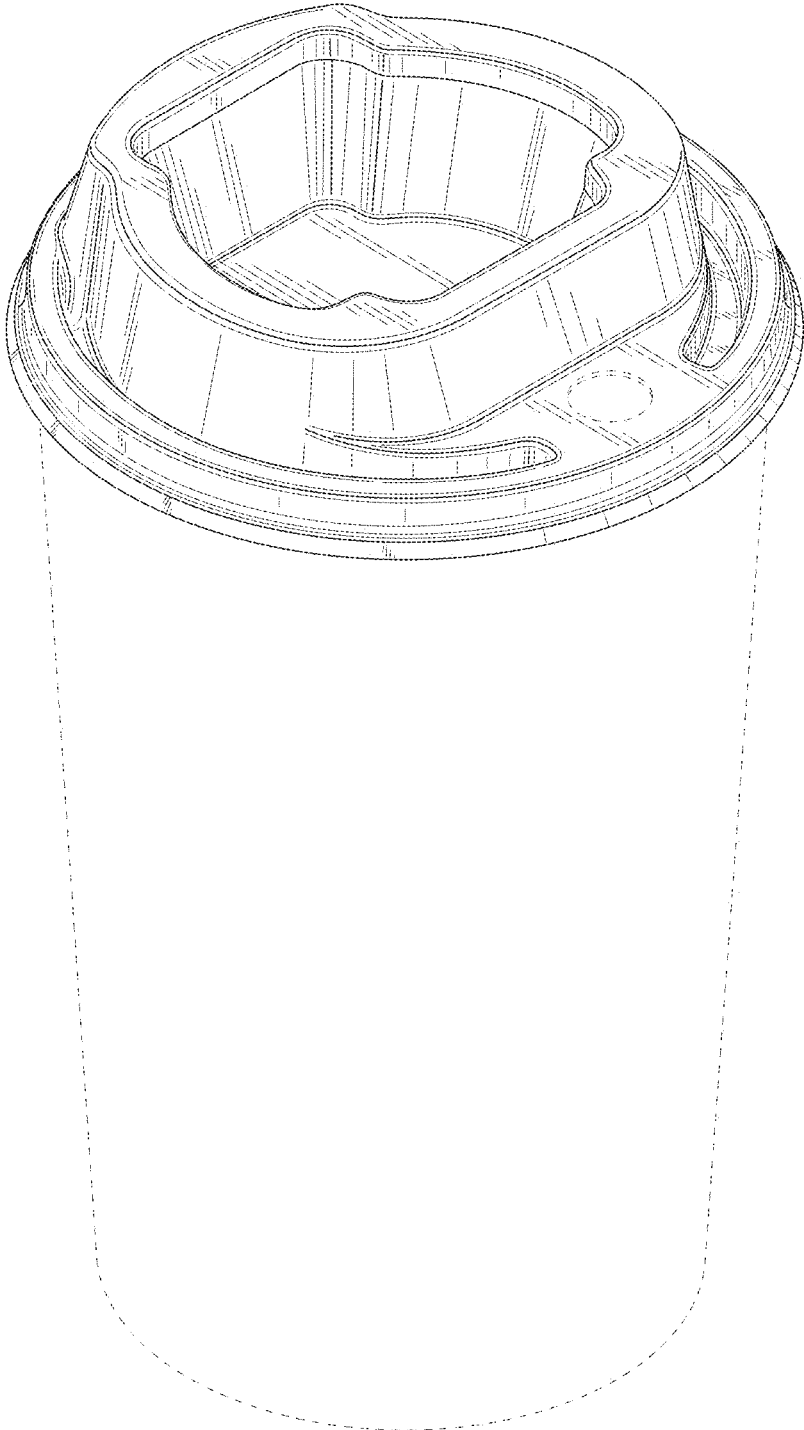

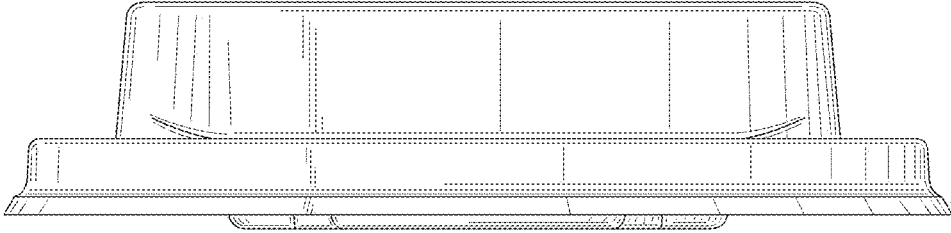

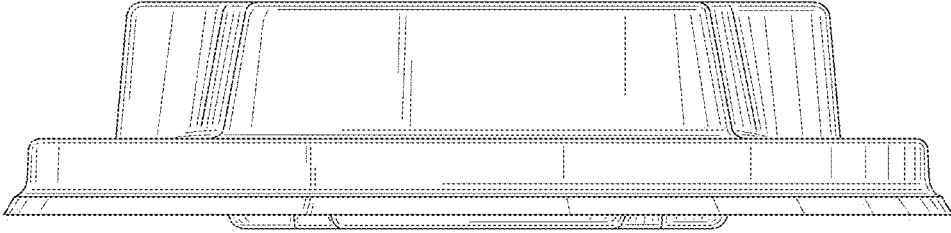

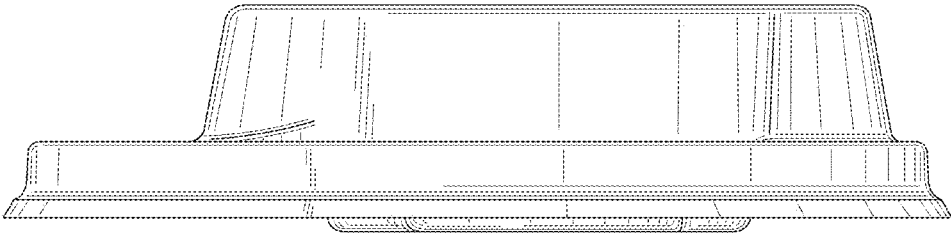

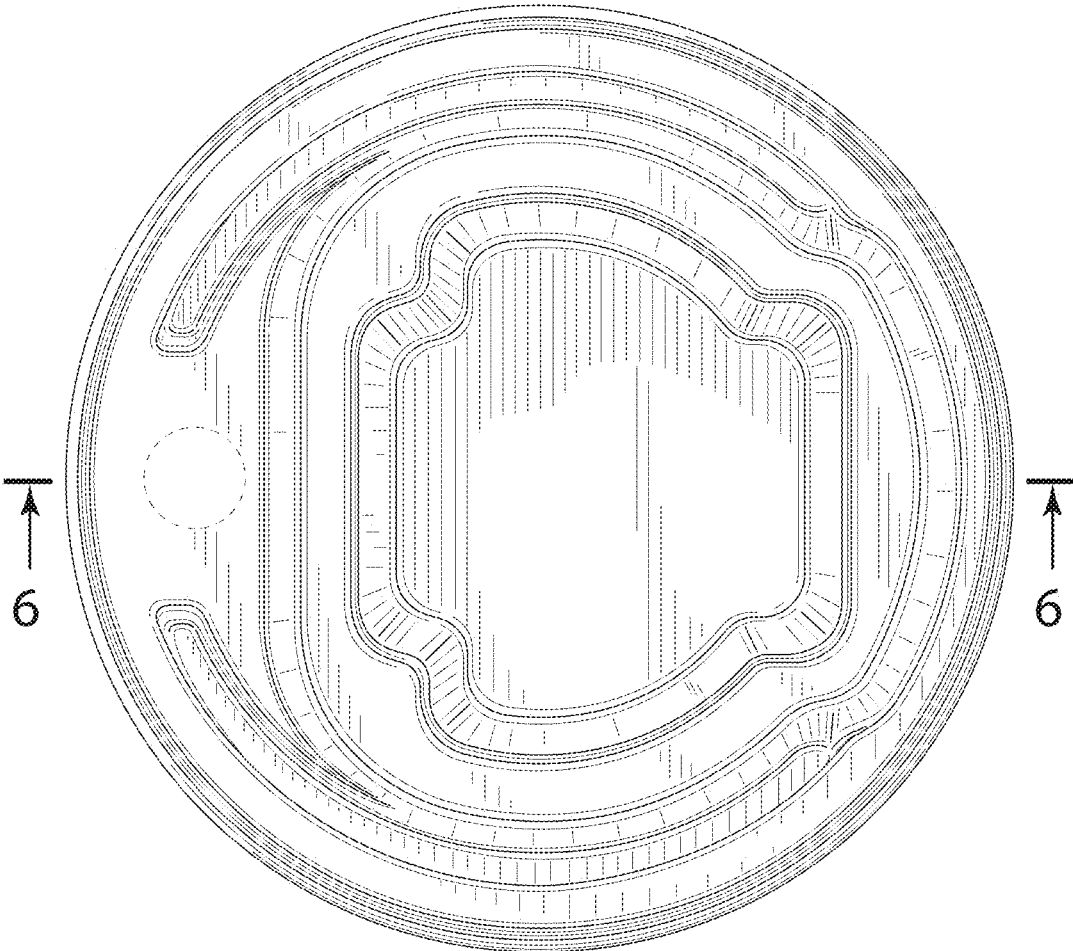

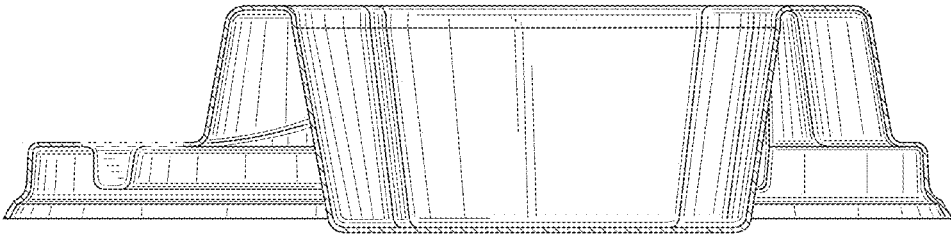
