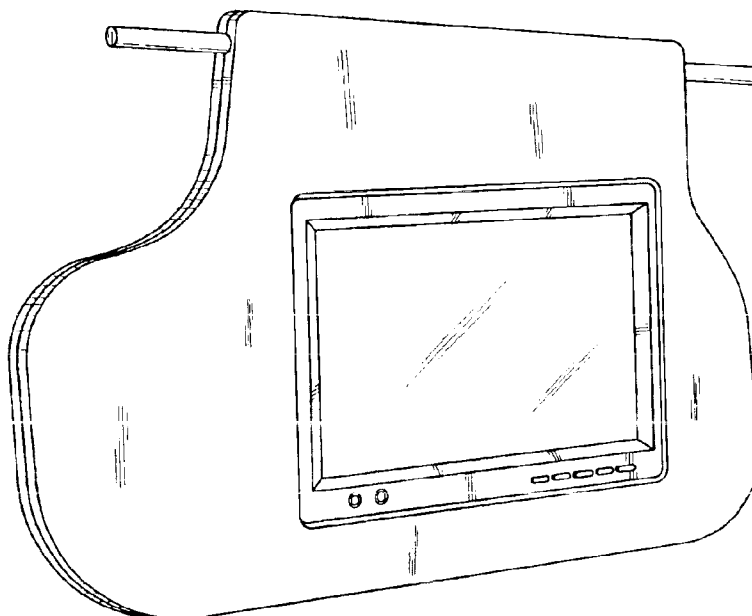
(57) **CLAIM**

The ornamental design for a video monitor for a sun visor, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a video monitor for a sun visor of the present design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a right side elevational view thereof.

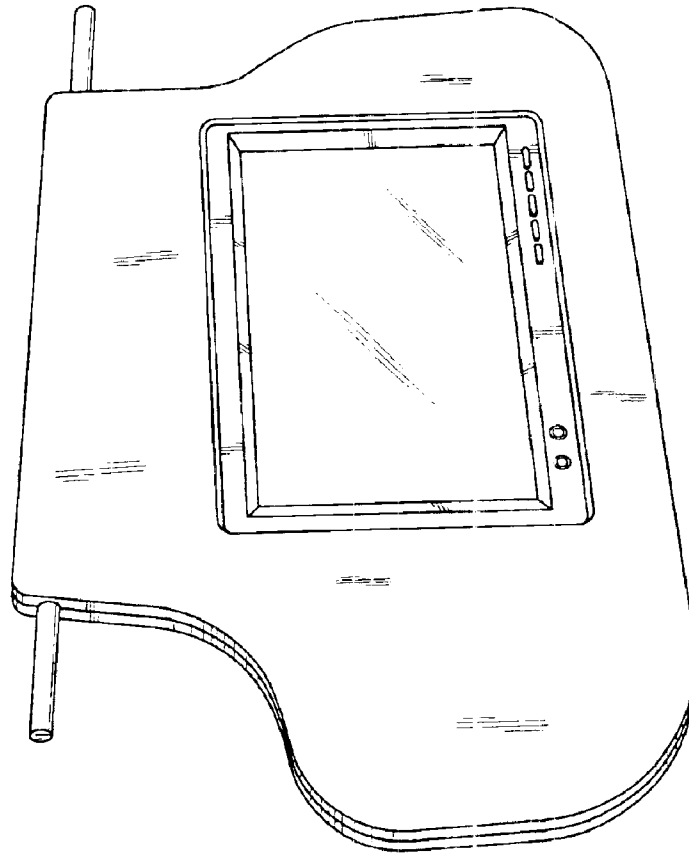

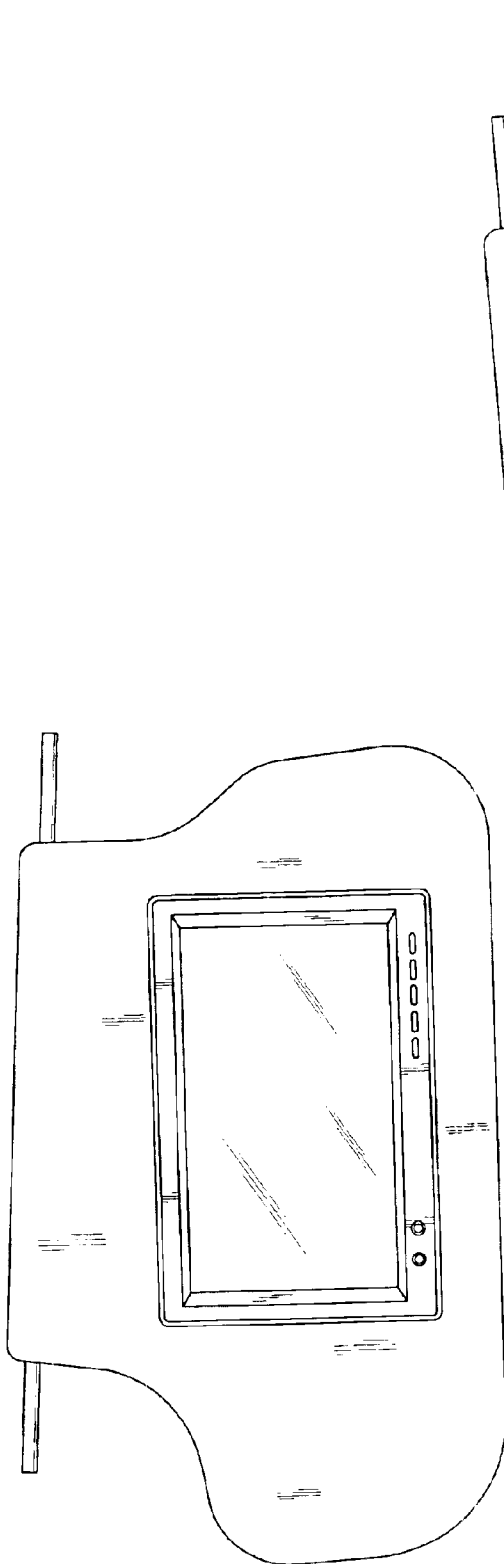

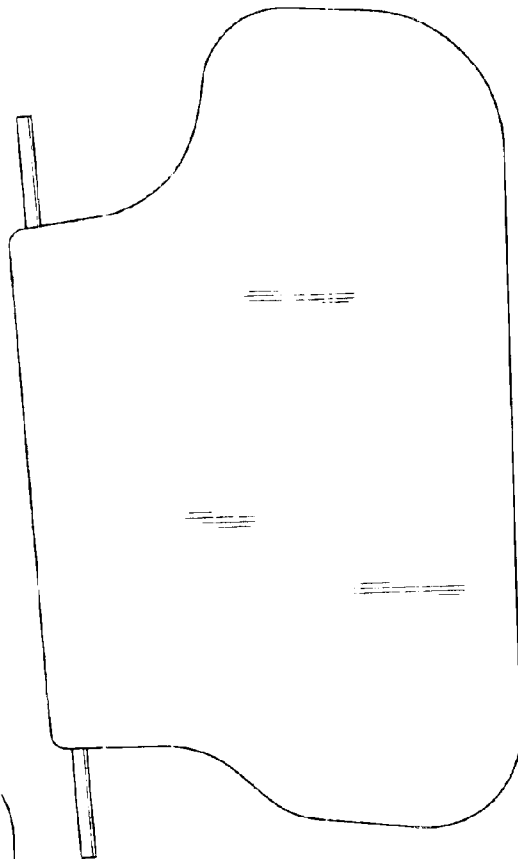

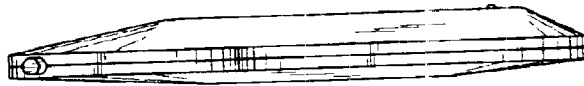
