DESCRIPTION

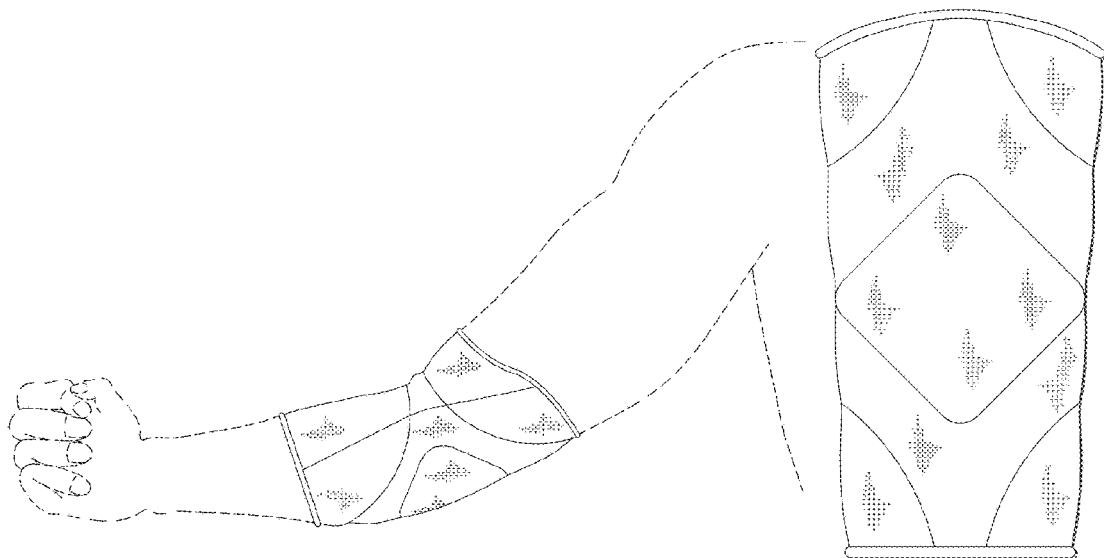
FIG. 1 is a side perspective view of a compression sleeve of the instant invention, shown in a position of use.
FIG. 2 is a front elevation view of the compression sleeve of FIG. 1.
FIG. 3 is a rear elevation view of the compression sleeve of FIG. 1.
FIG. 4 is a right side elevation view of the compression sleeve of FIG. 1; and
FIG. 5 is a left side elevation view of the compression sleeve of FIG. 1.

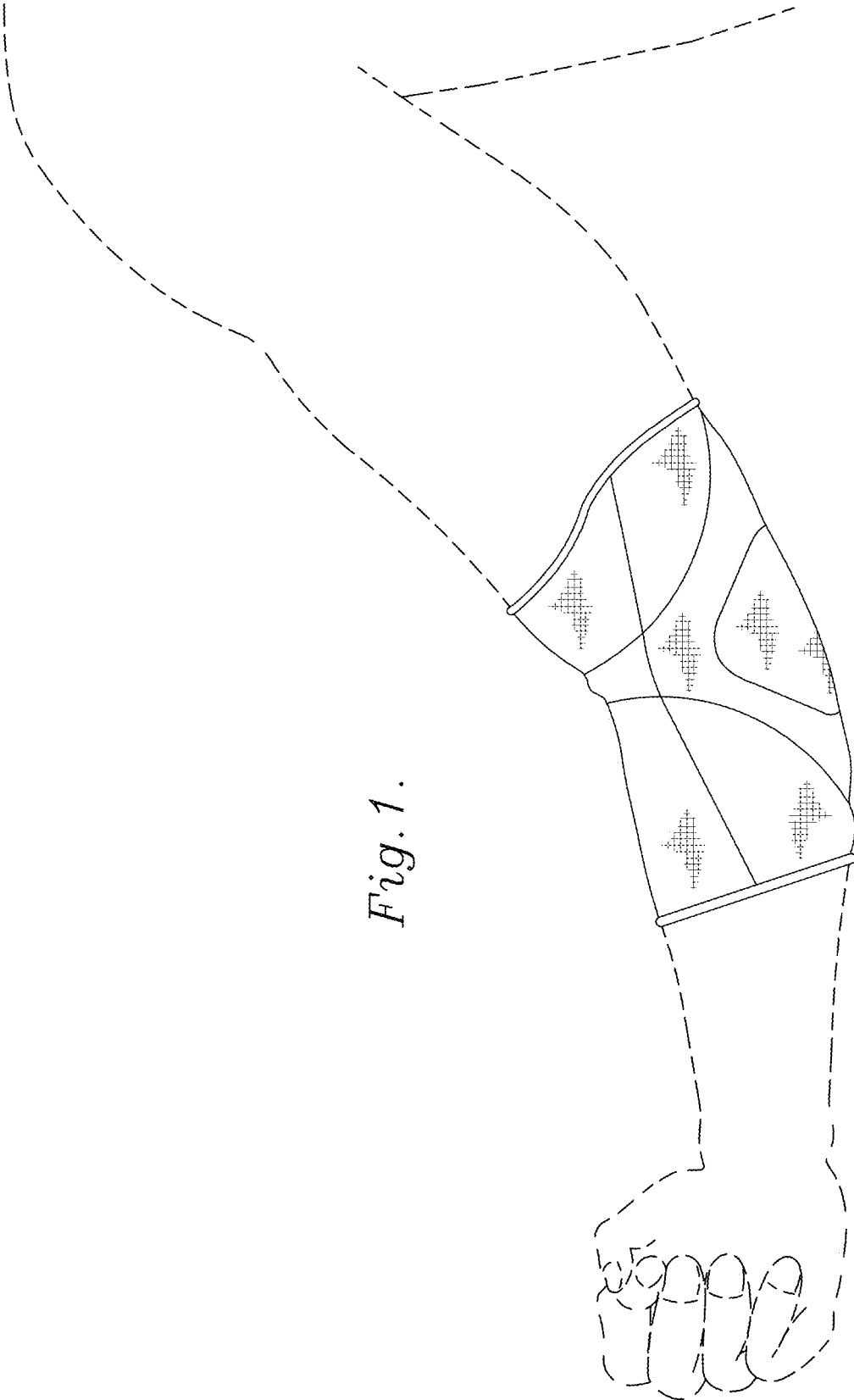

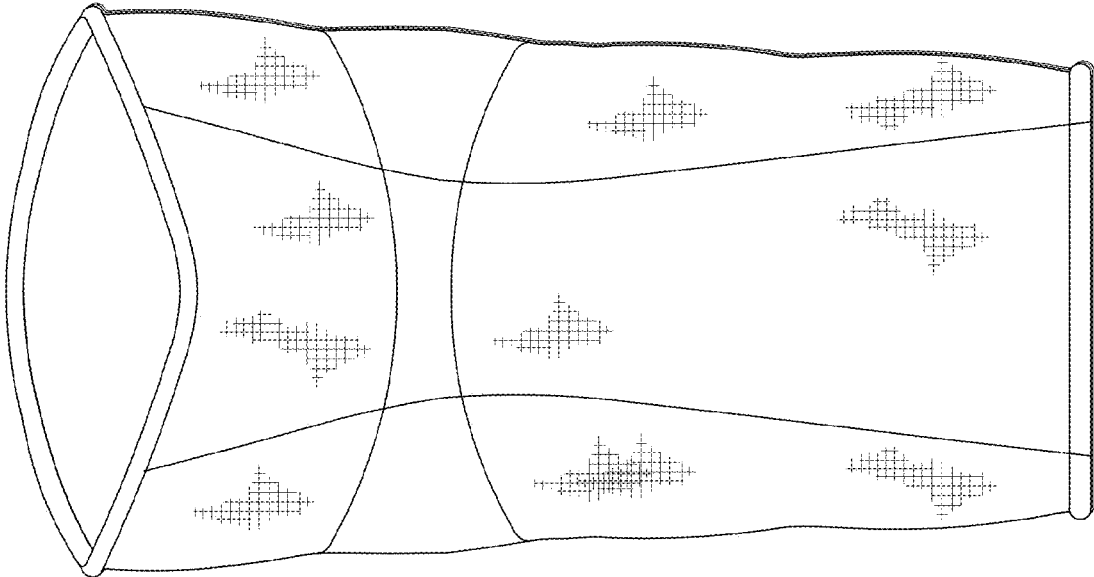

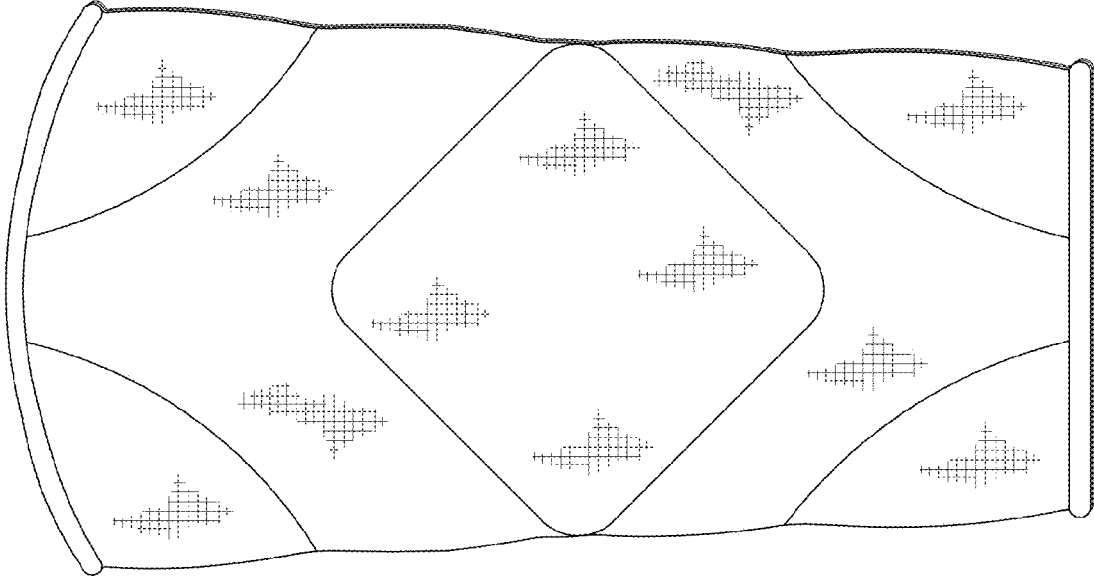

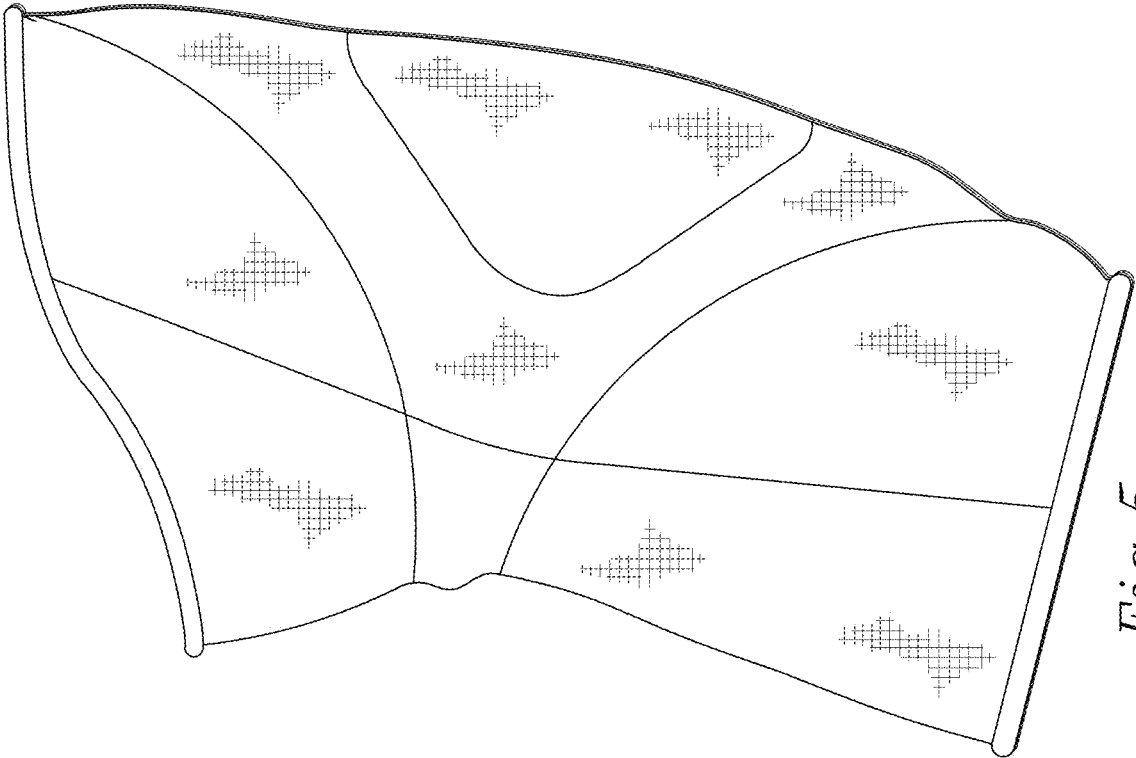

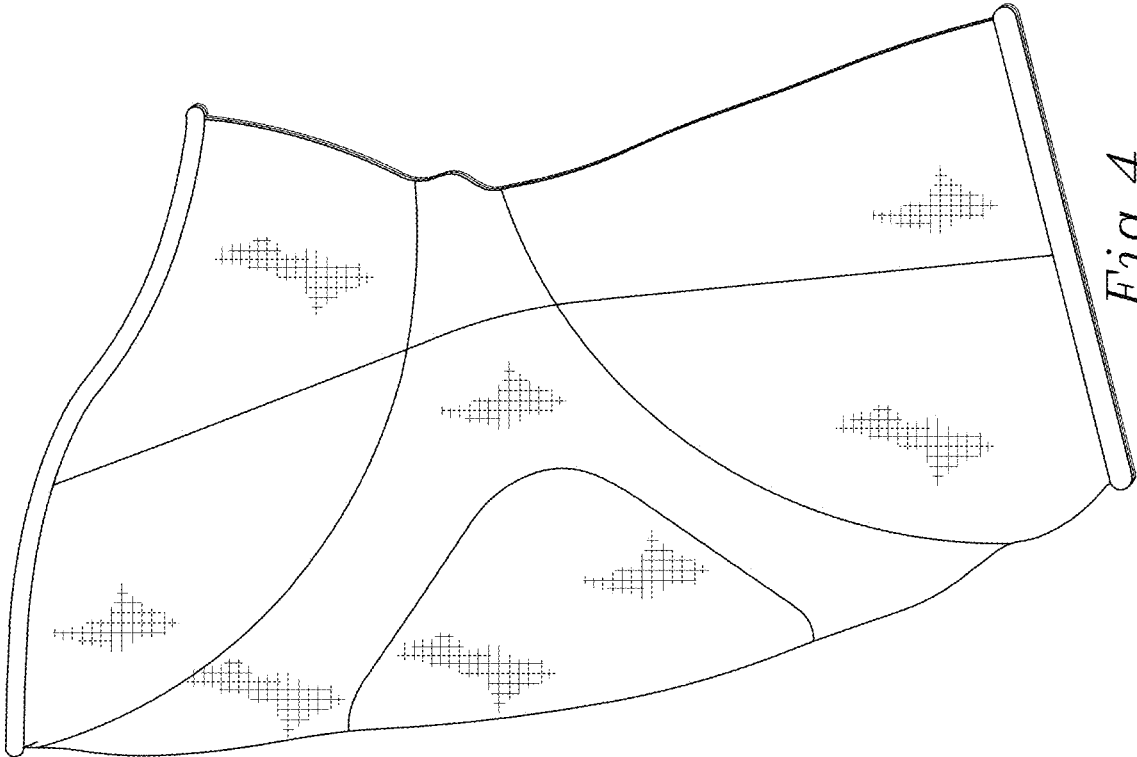
