The dashed broken lines in the drawings illustrate portions of the gaming machine that form no part of the claimed design.

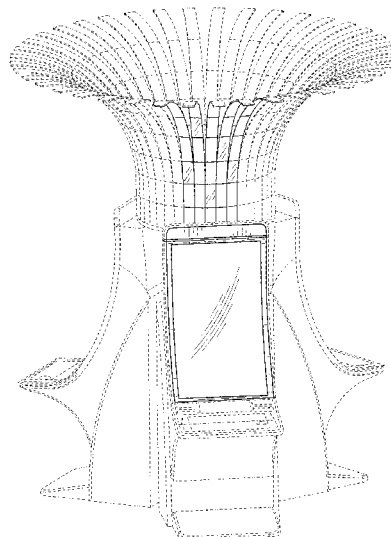

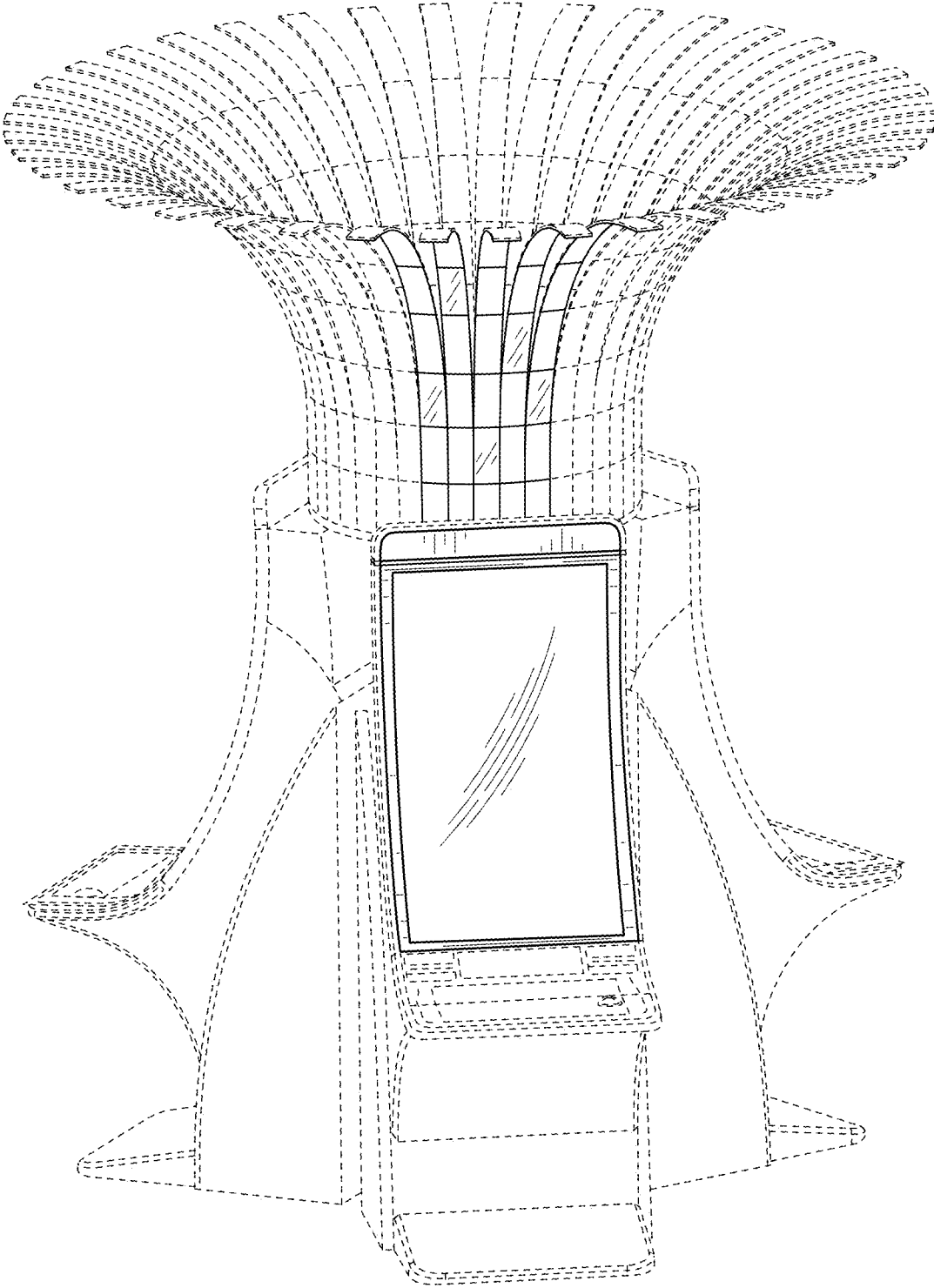

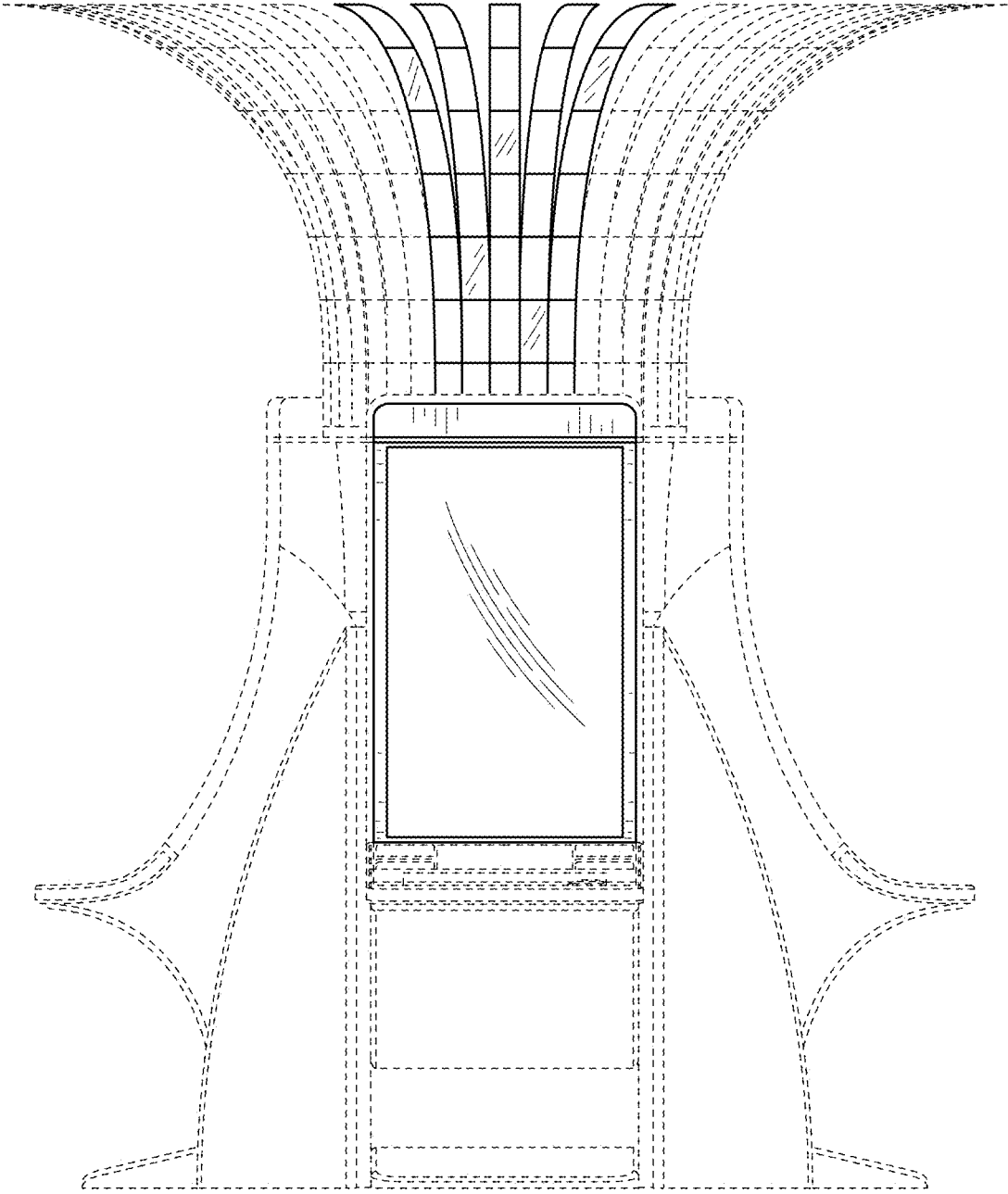

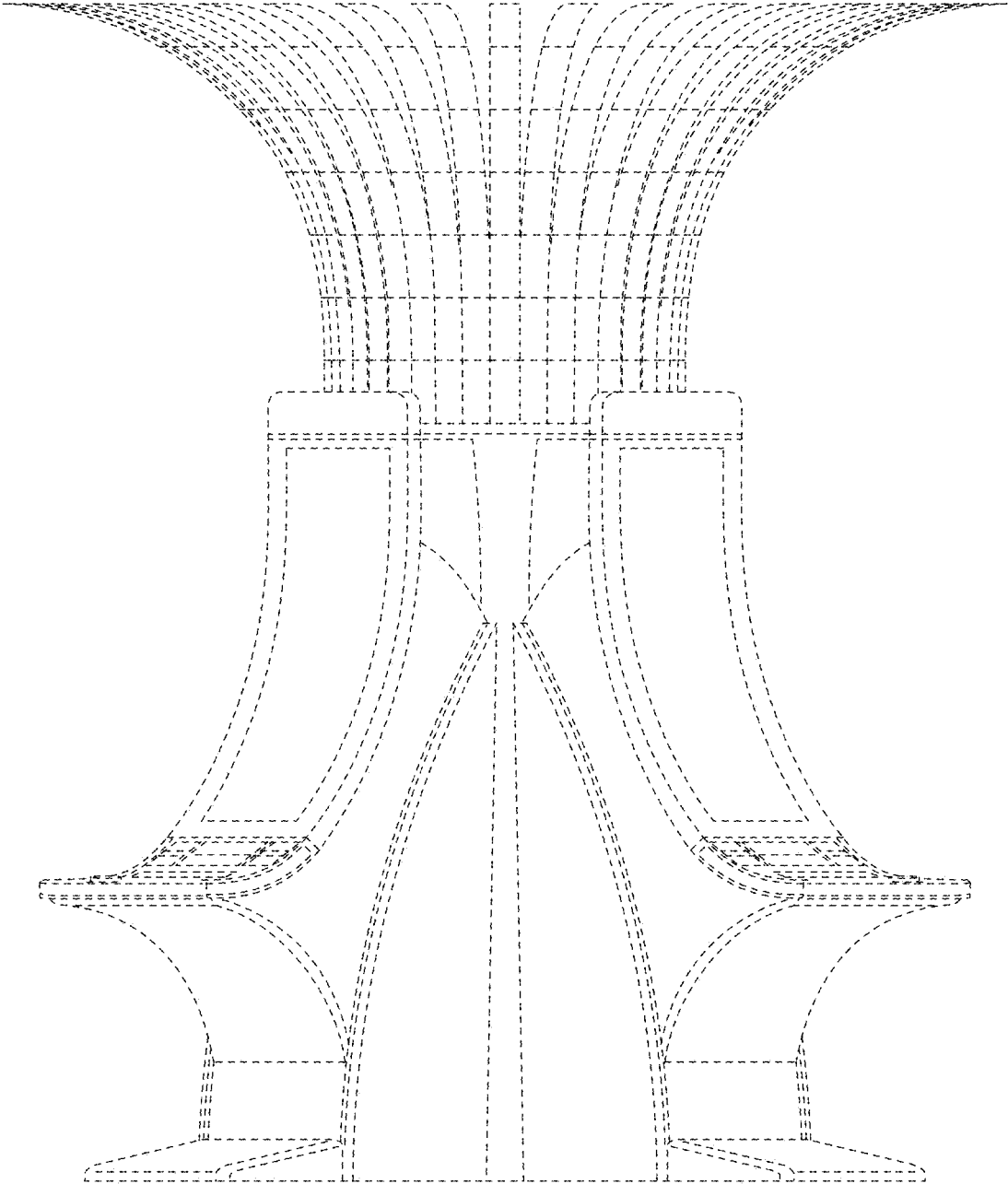

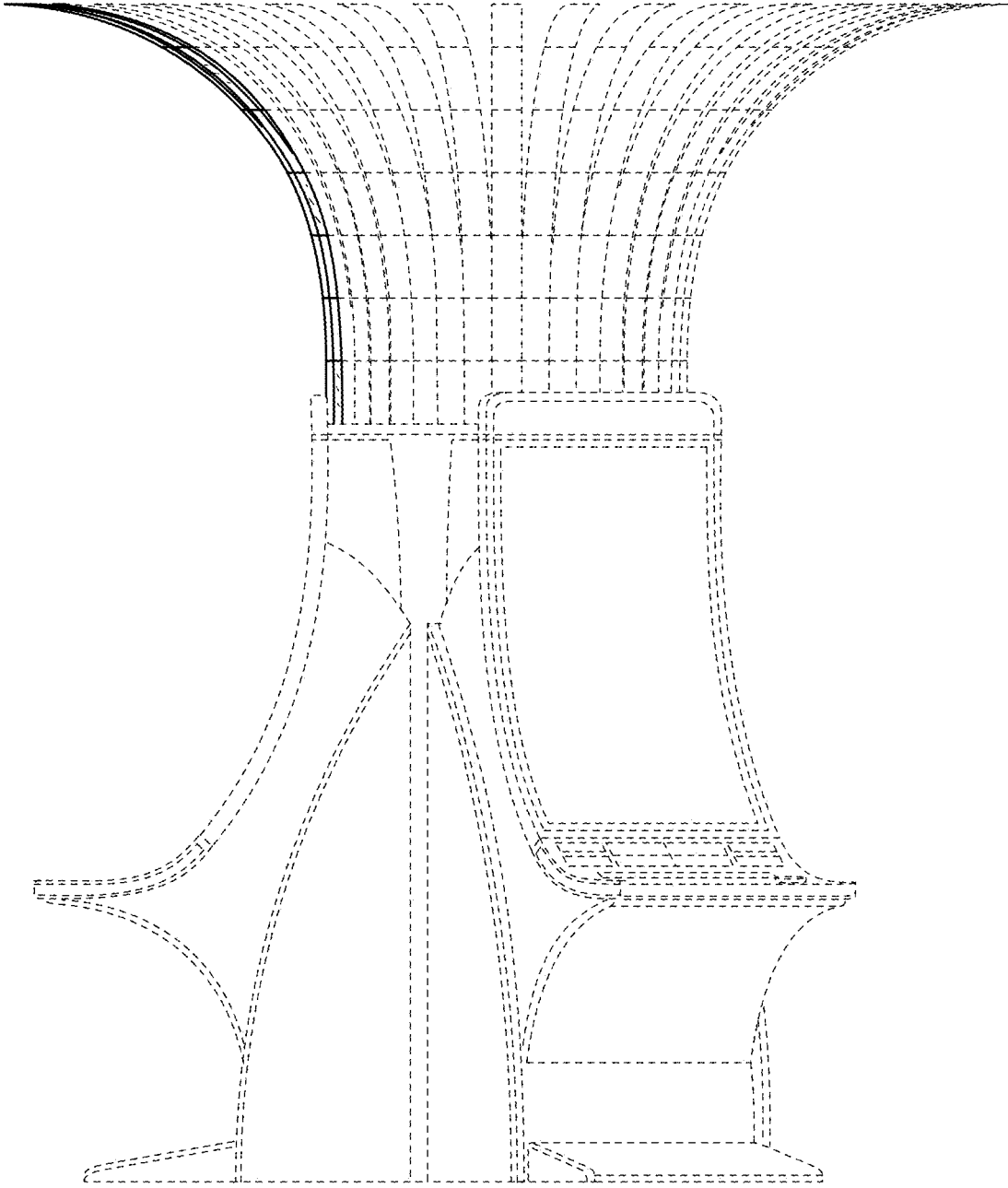

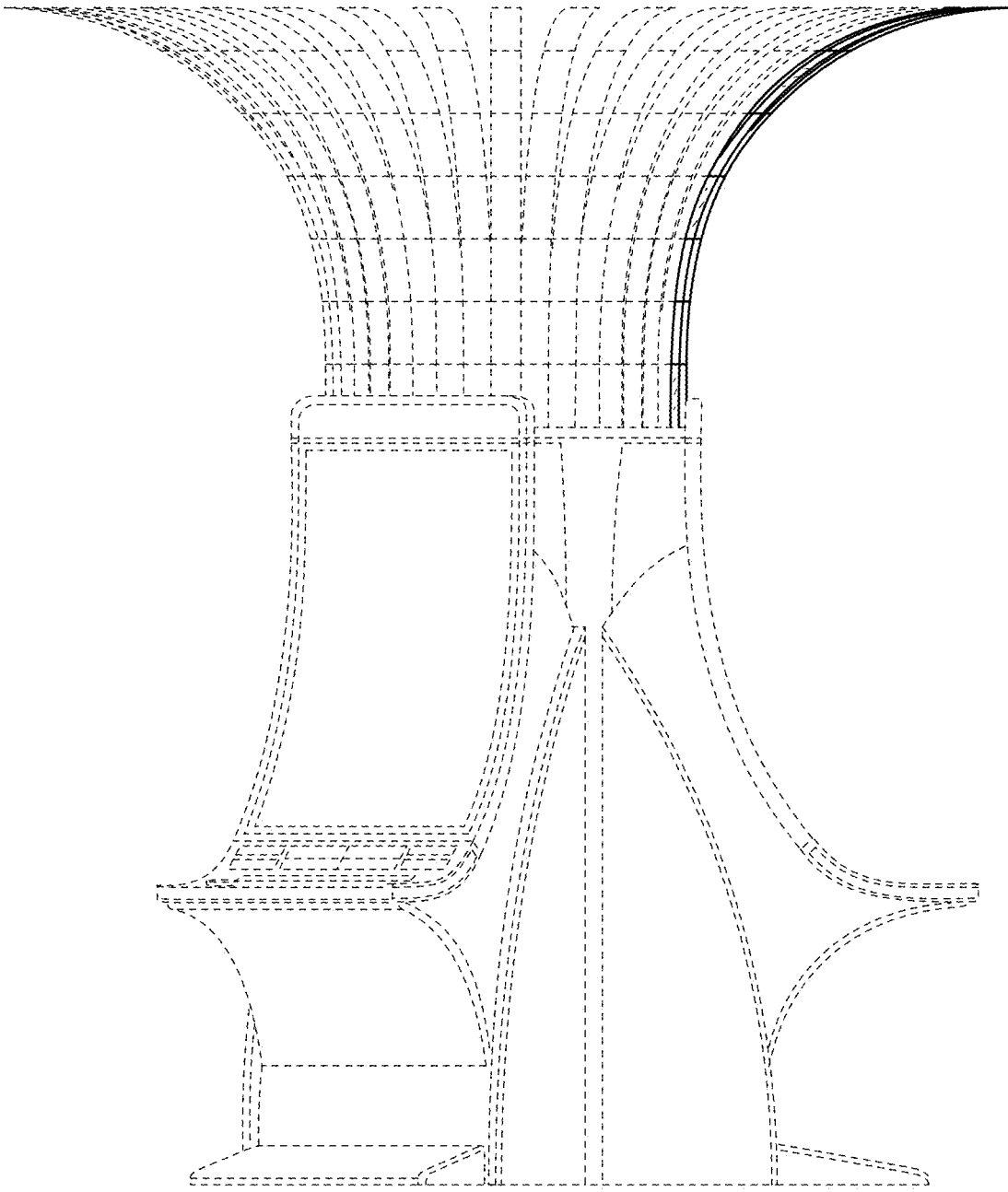

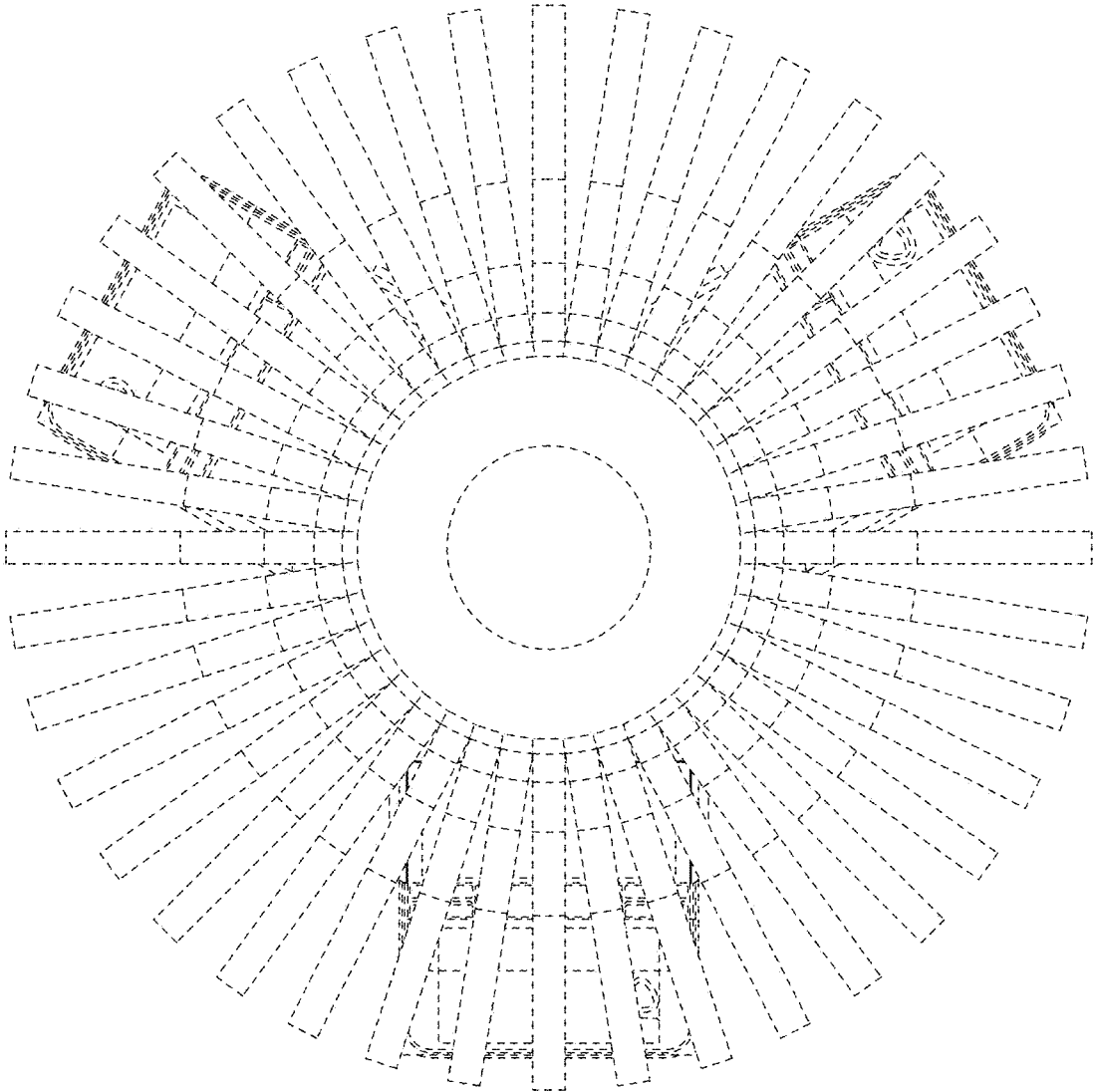

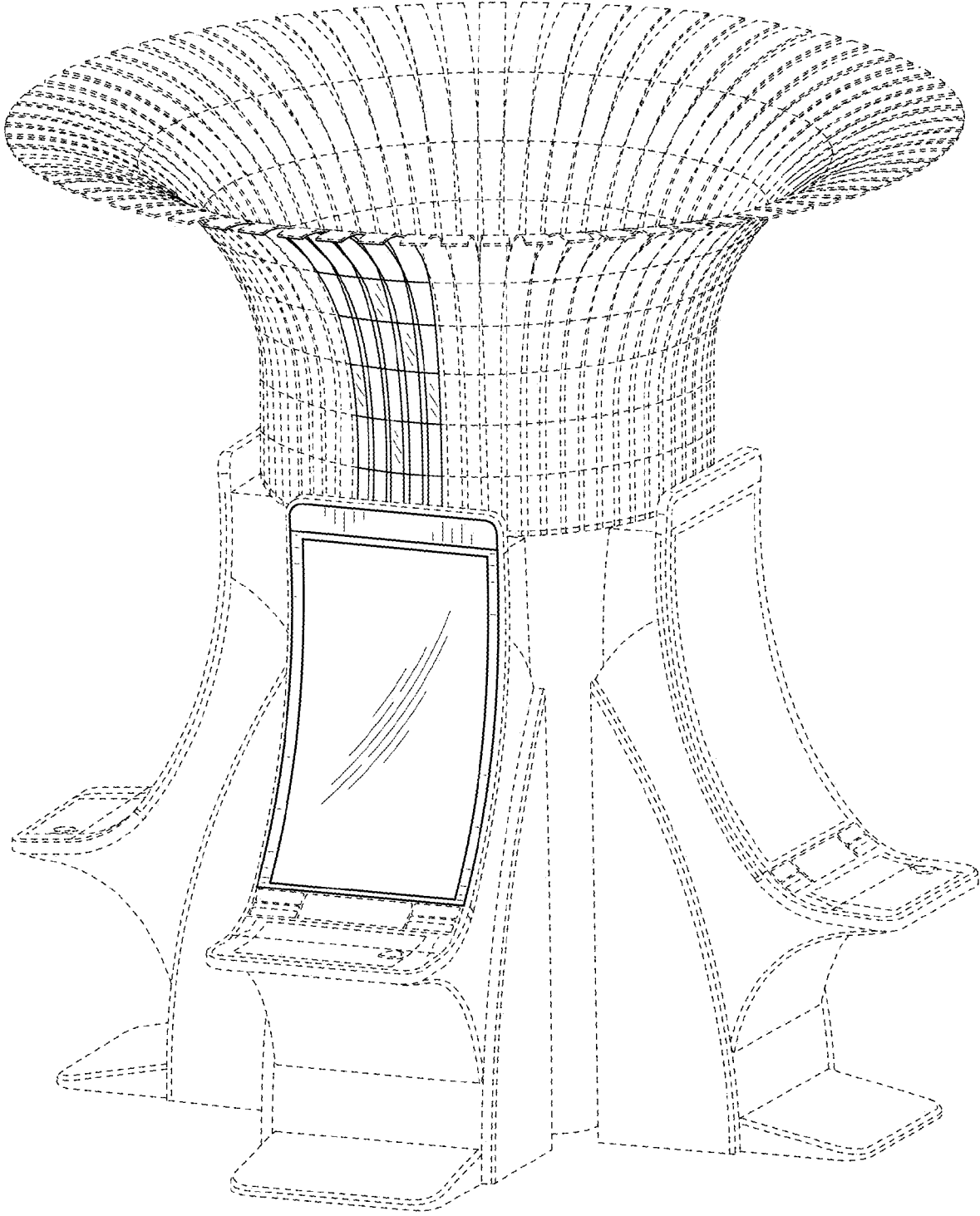

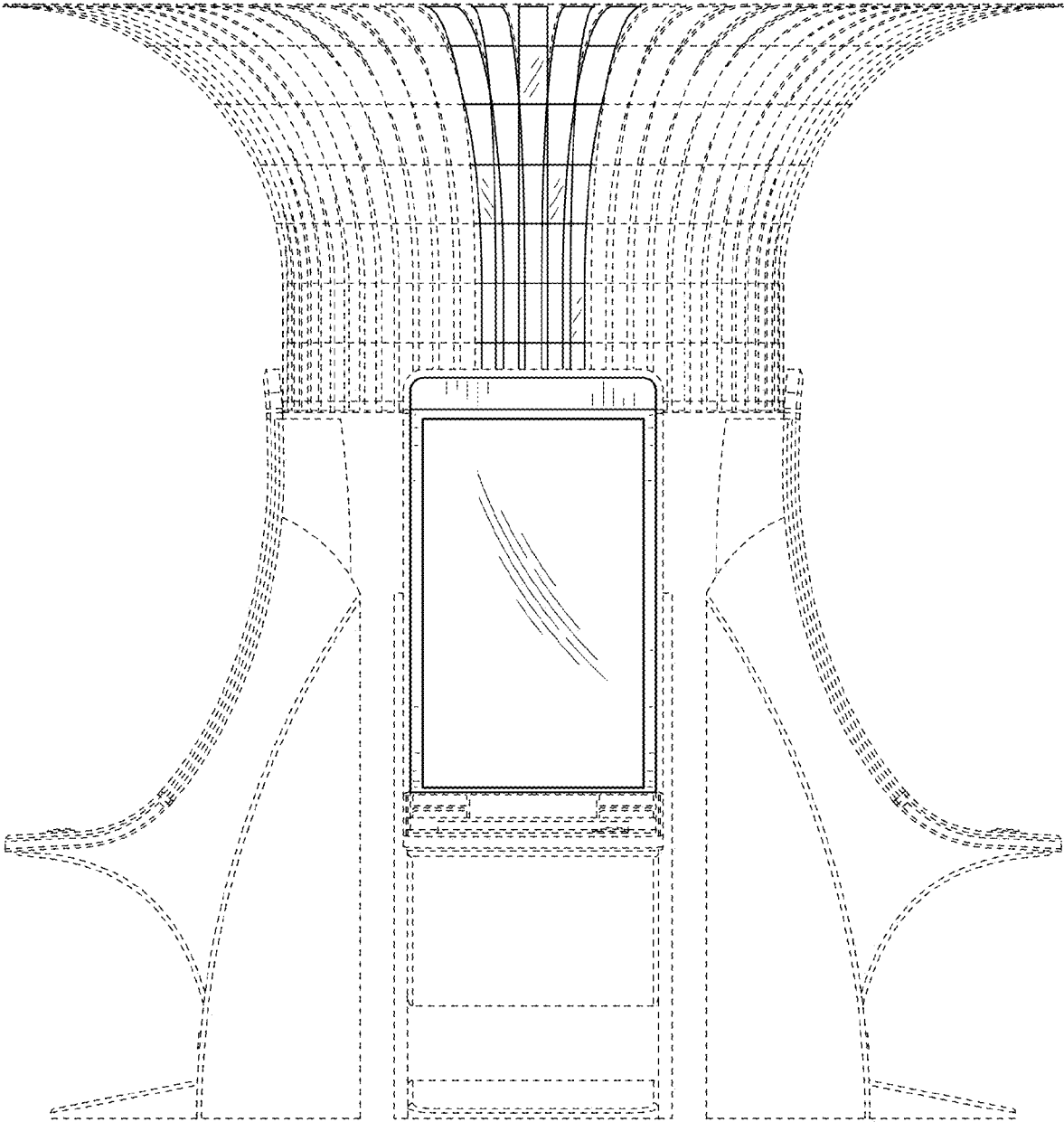

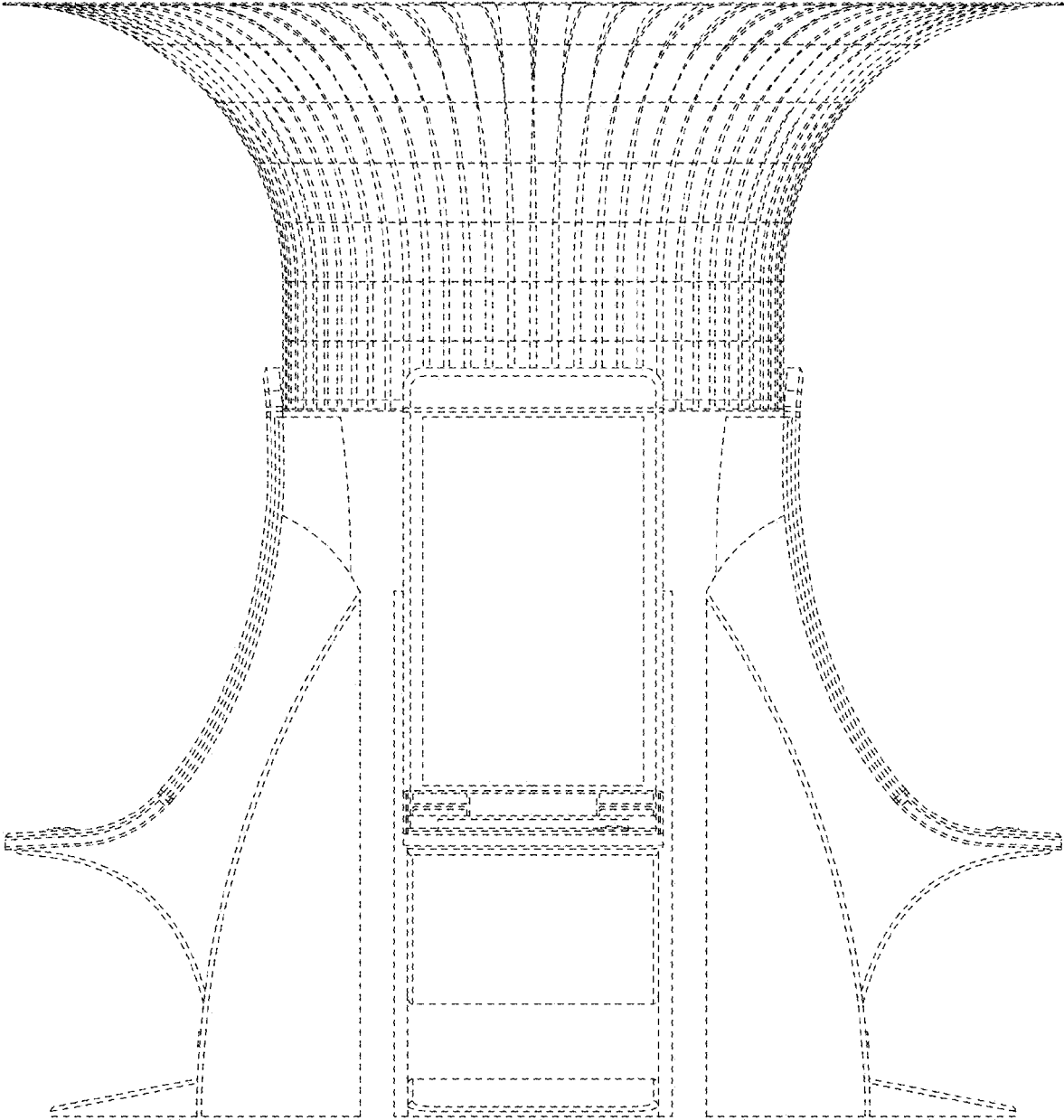

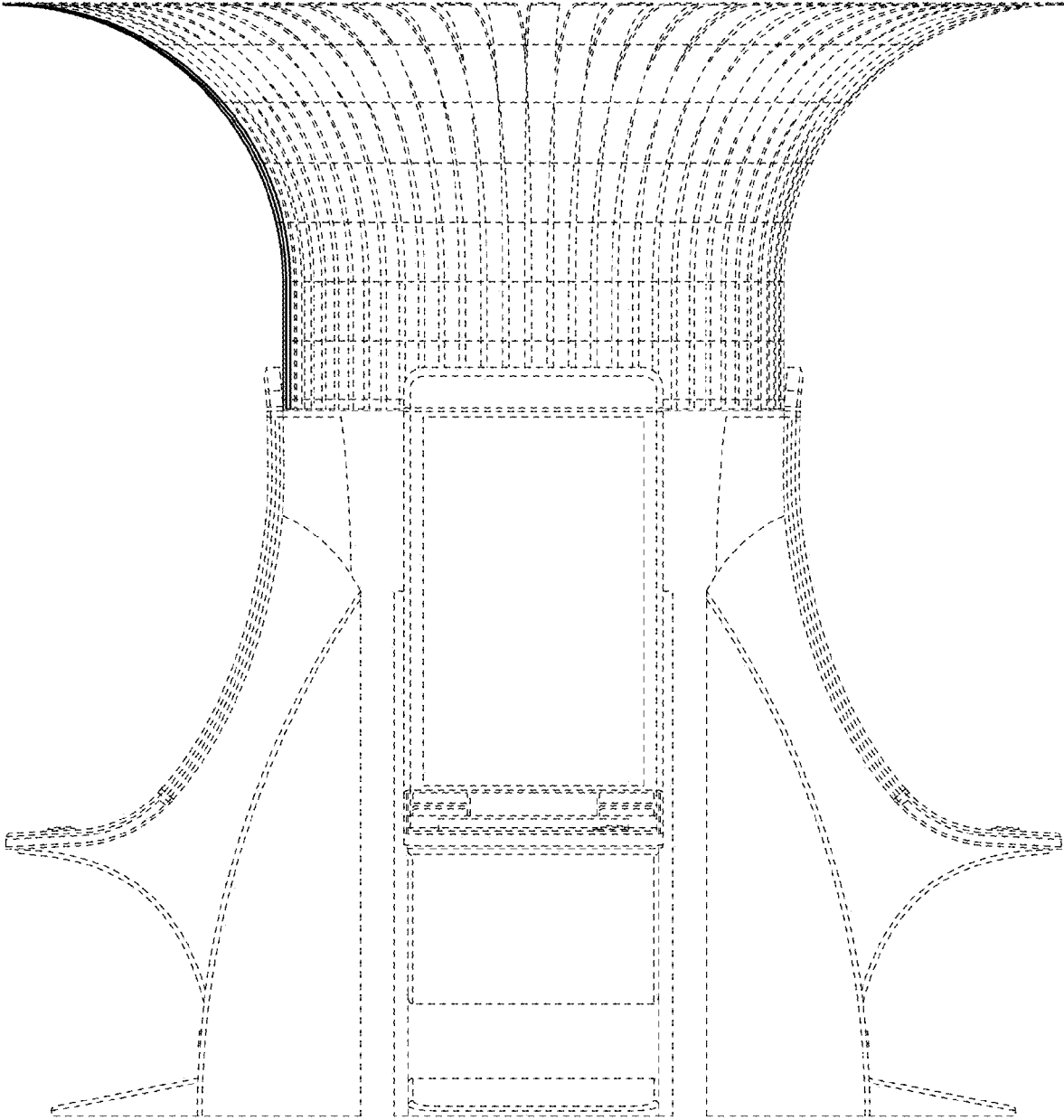

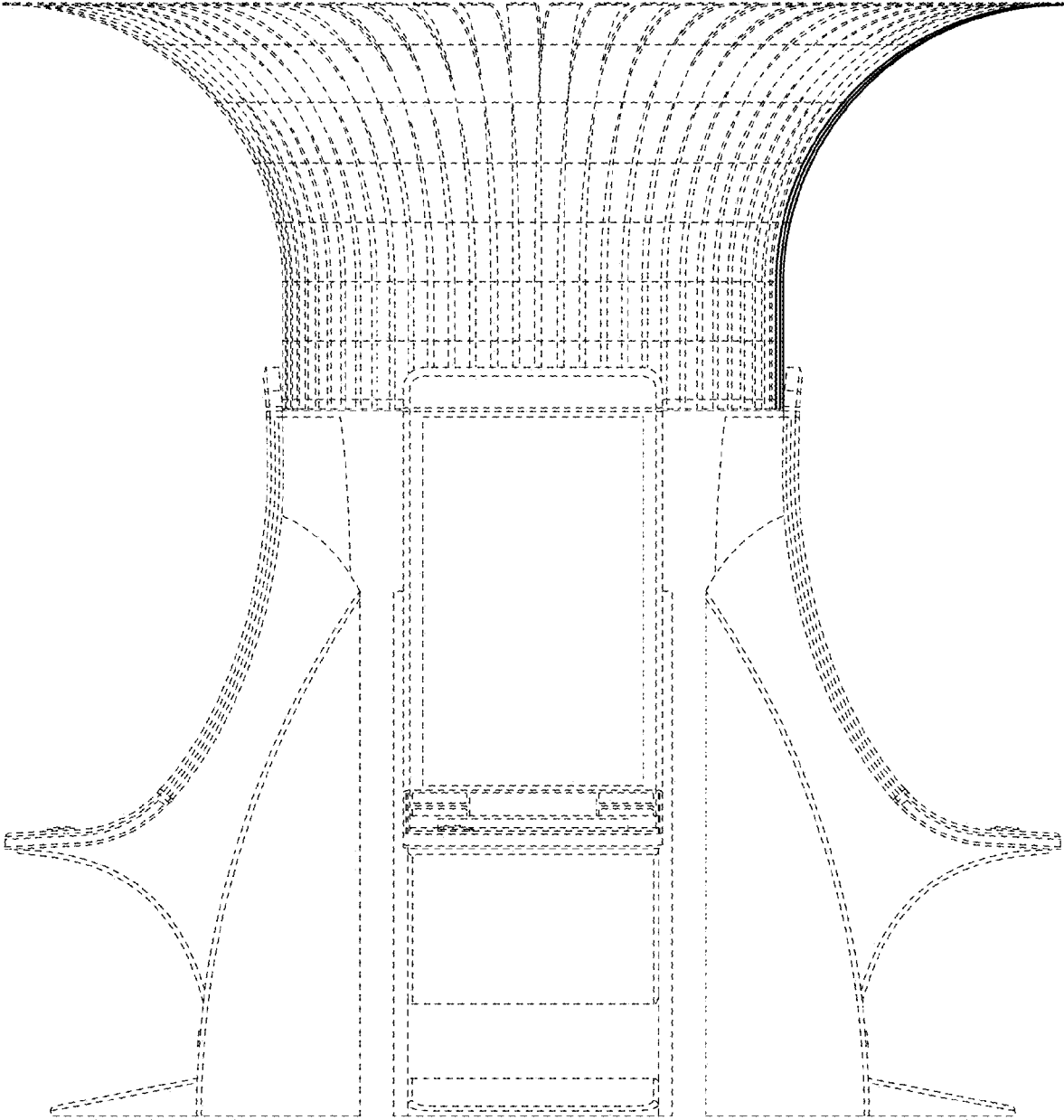

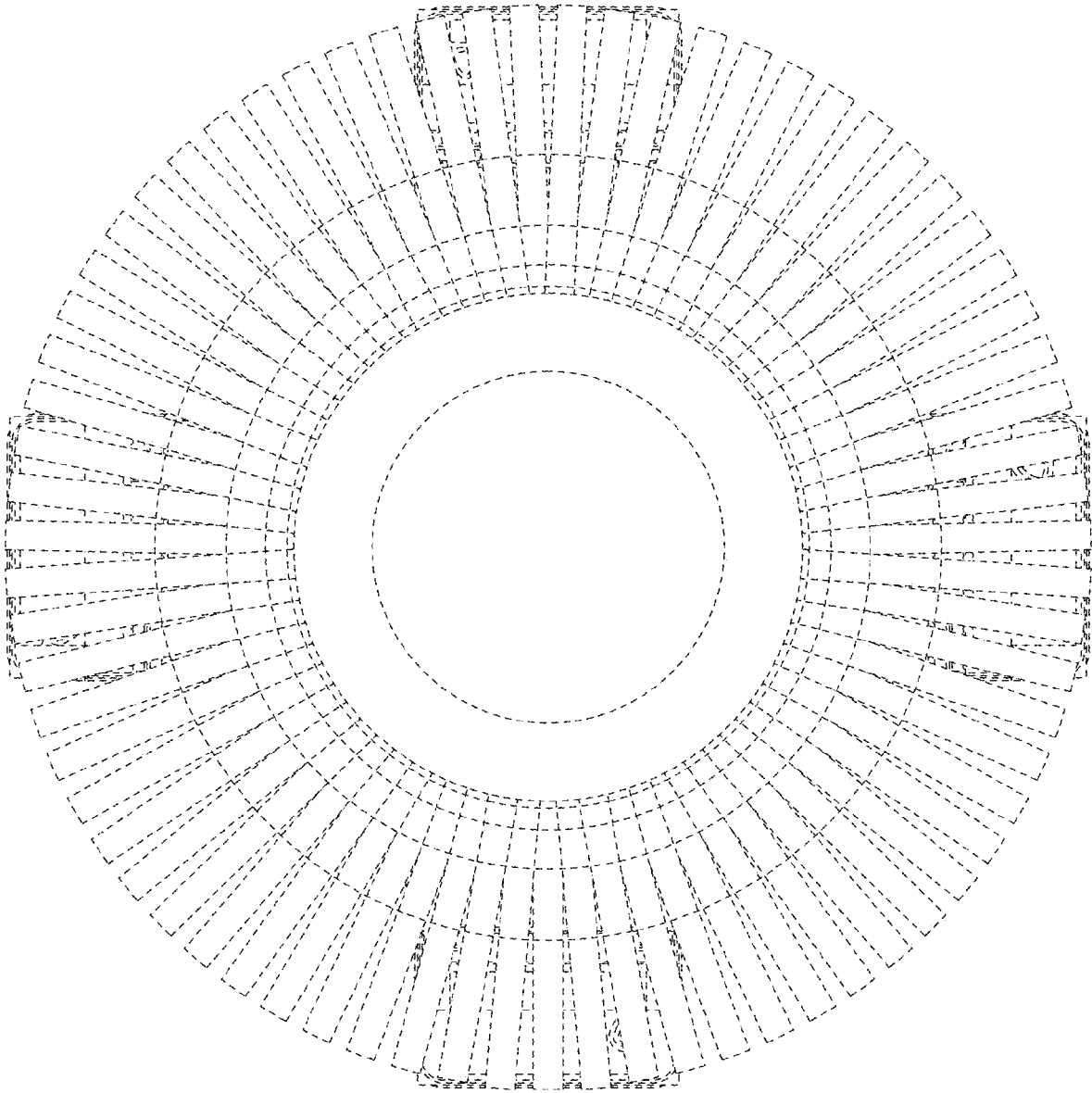

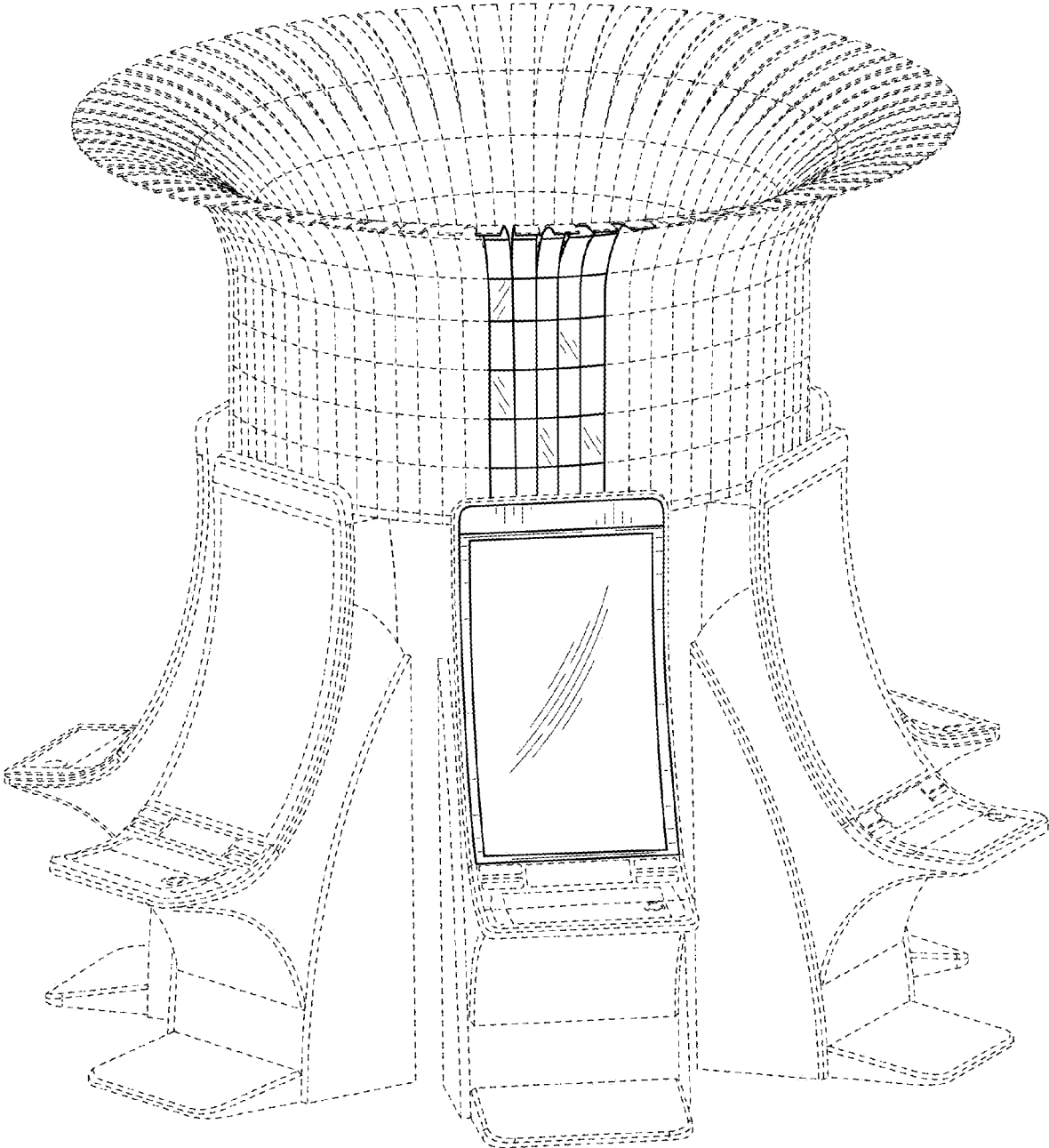

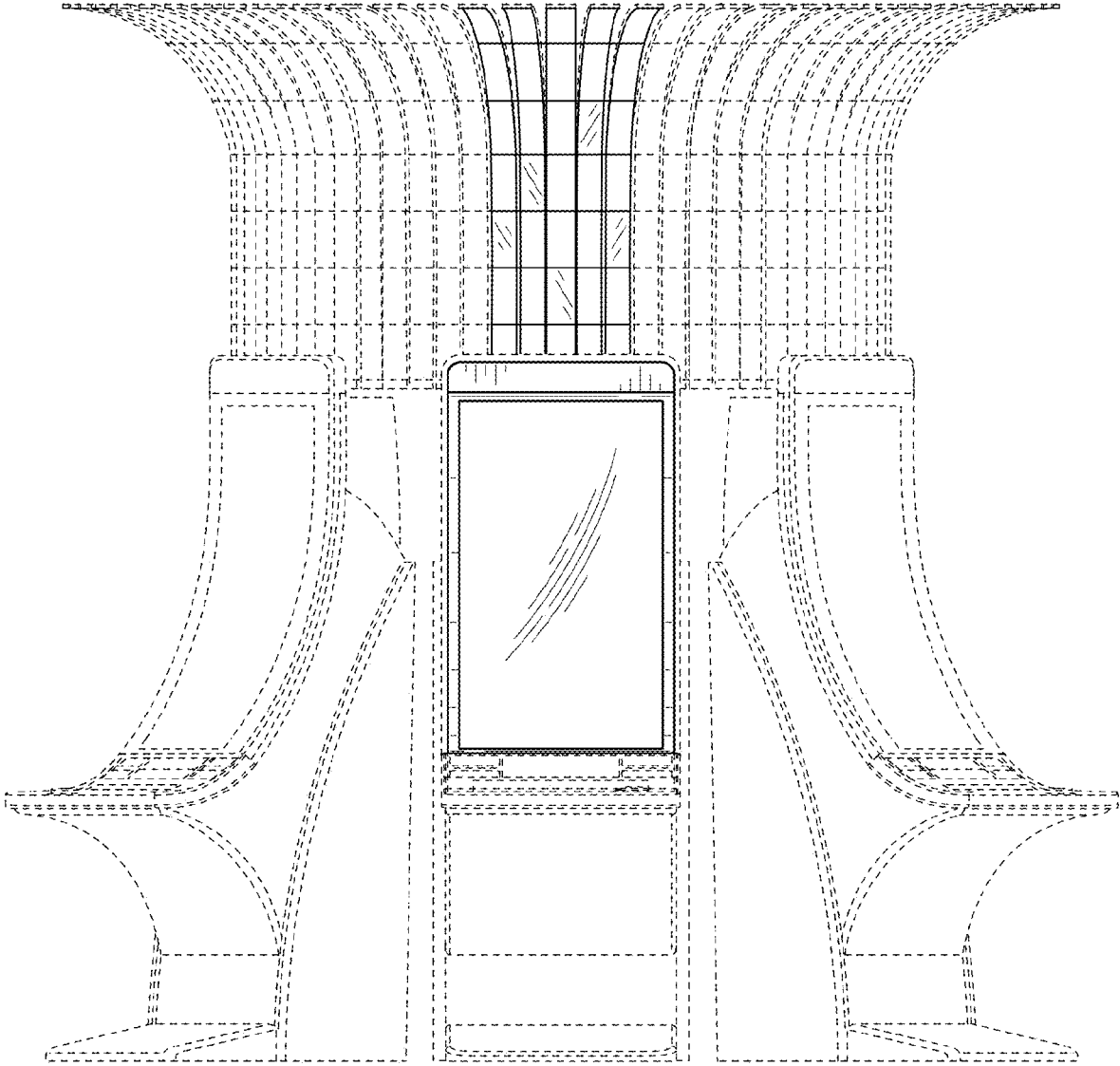

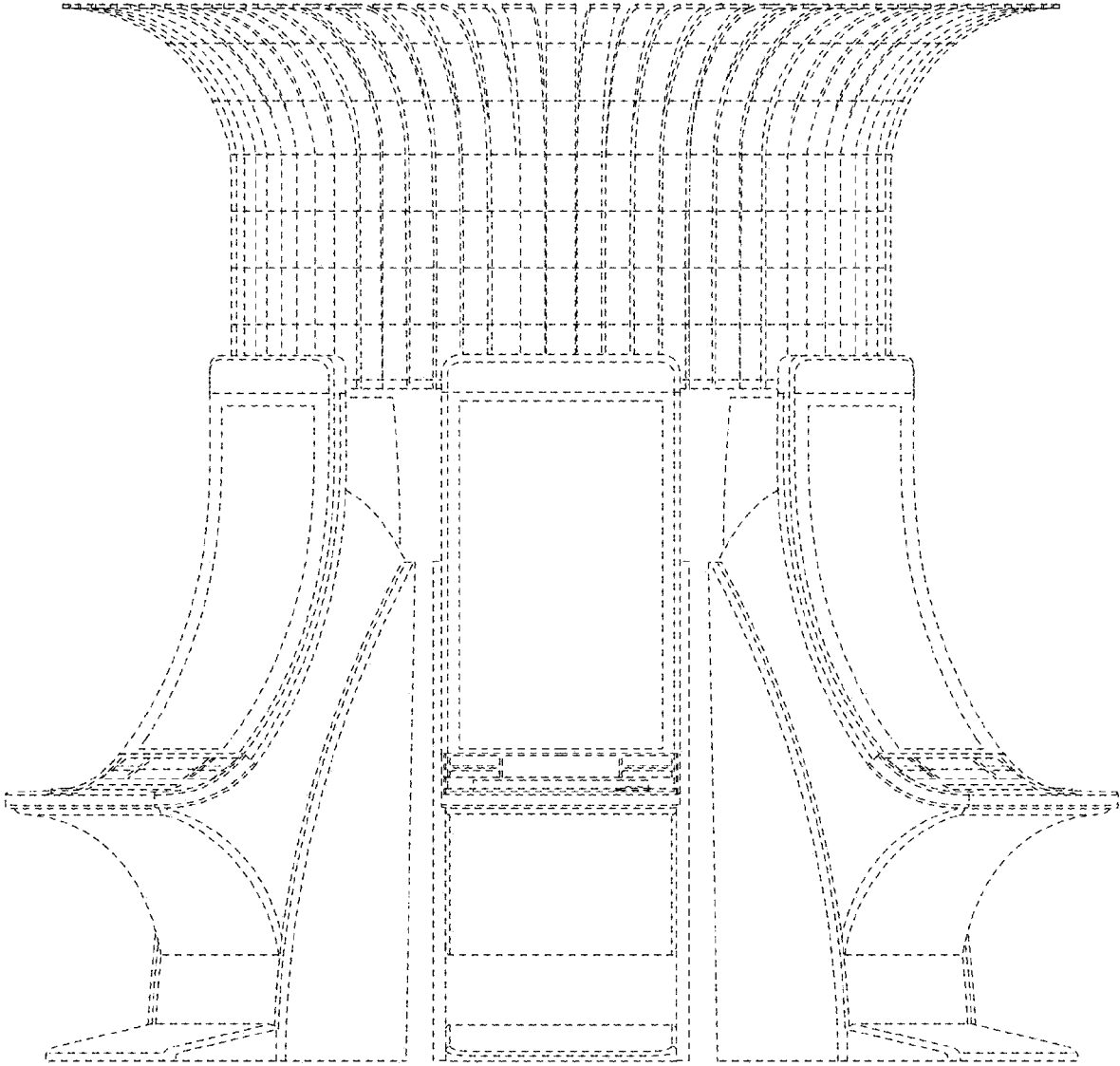

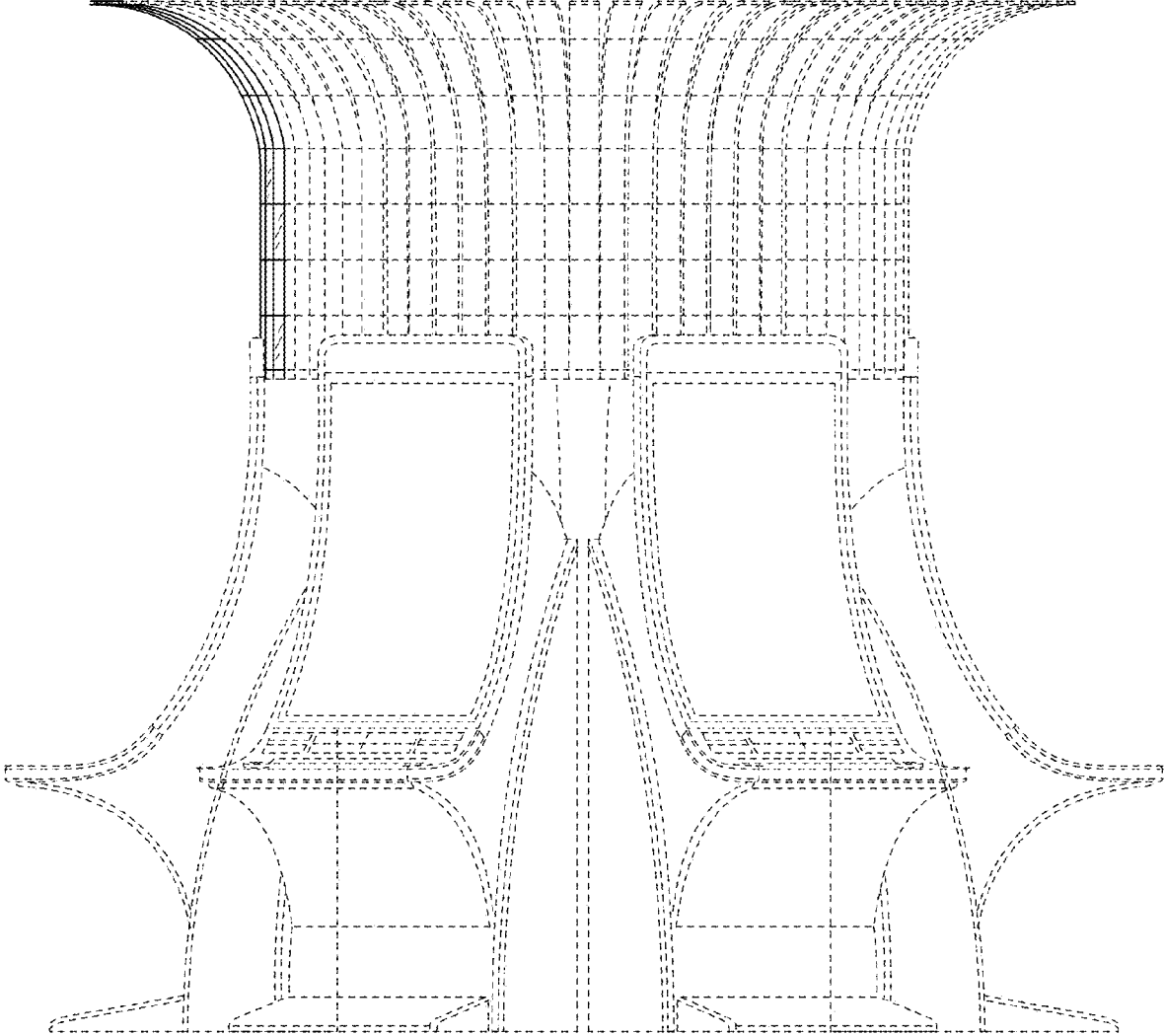

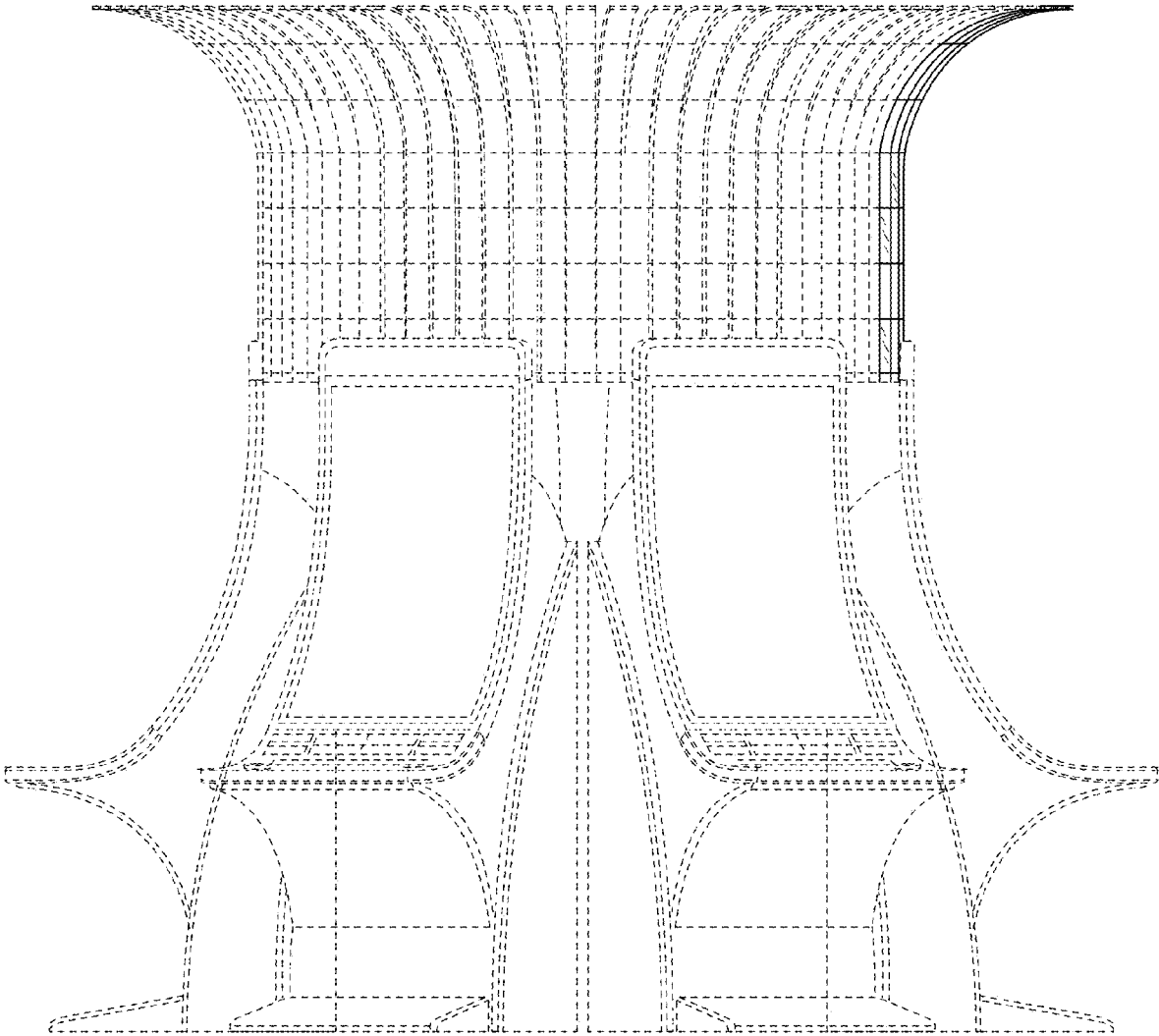

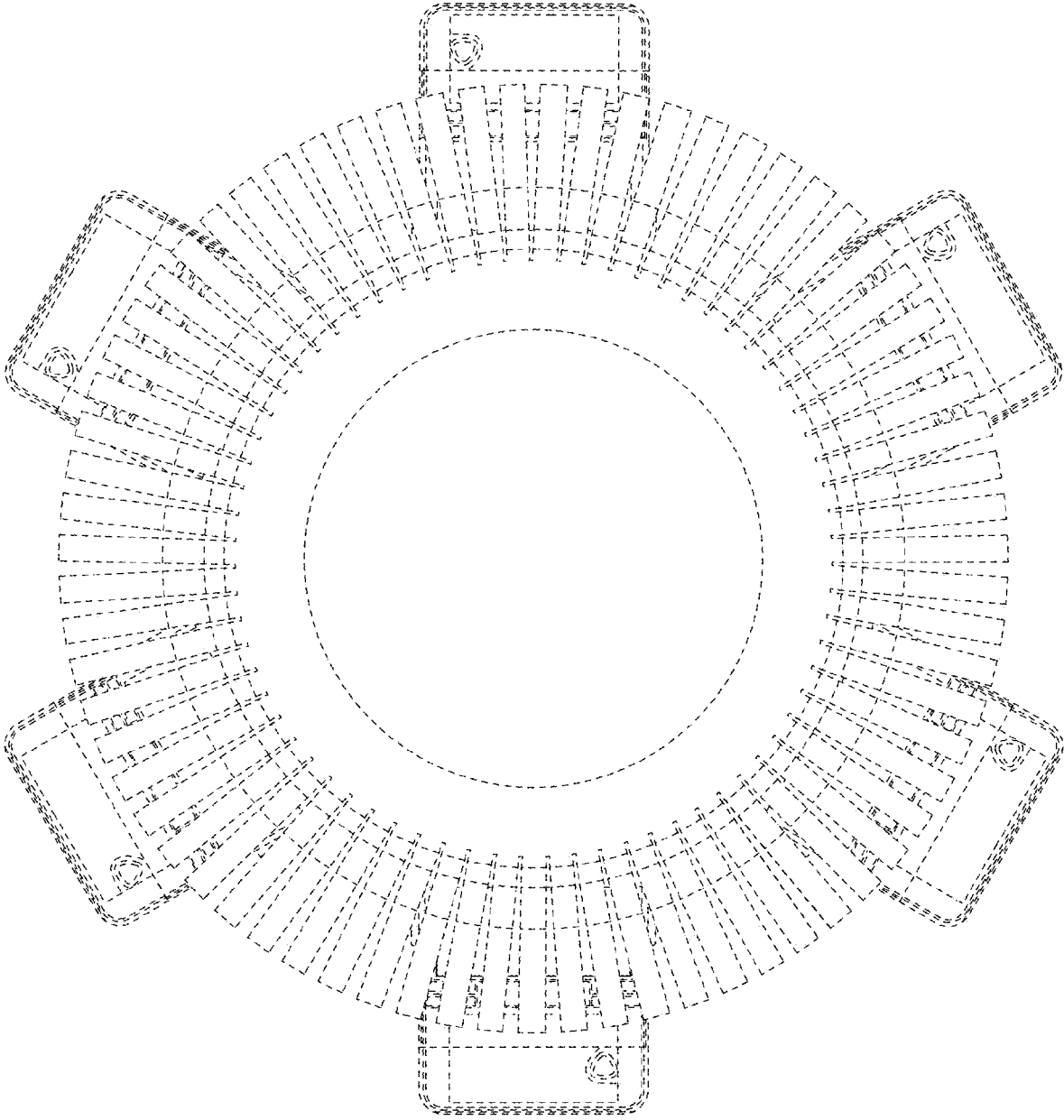
