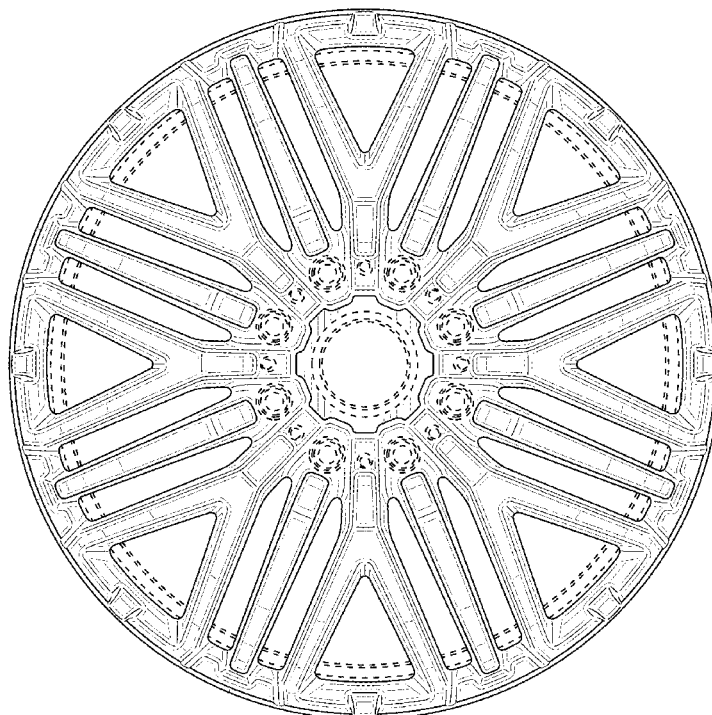
FIG. 1 is a front view of a wheel or wheel cover according to the design; and,

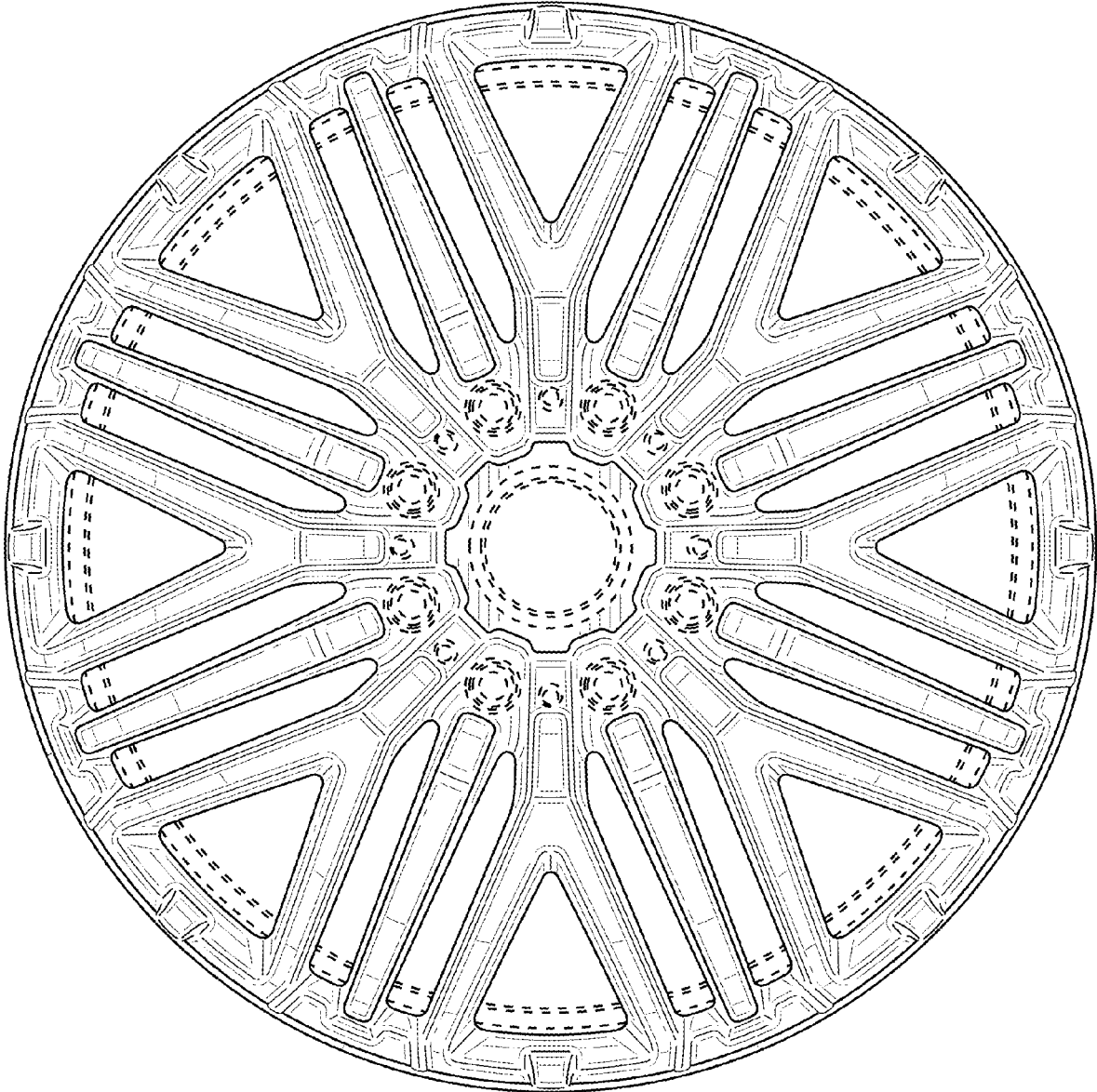

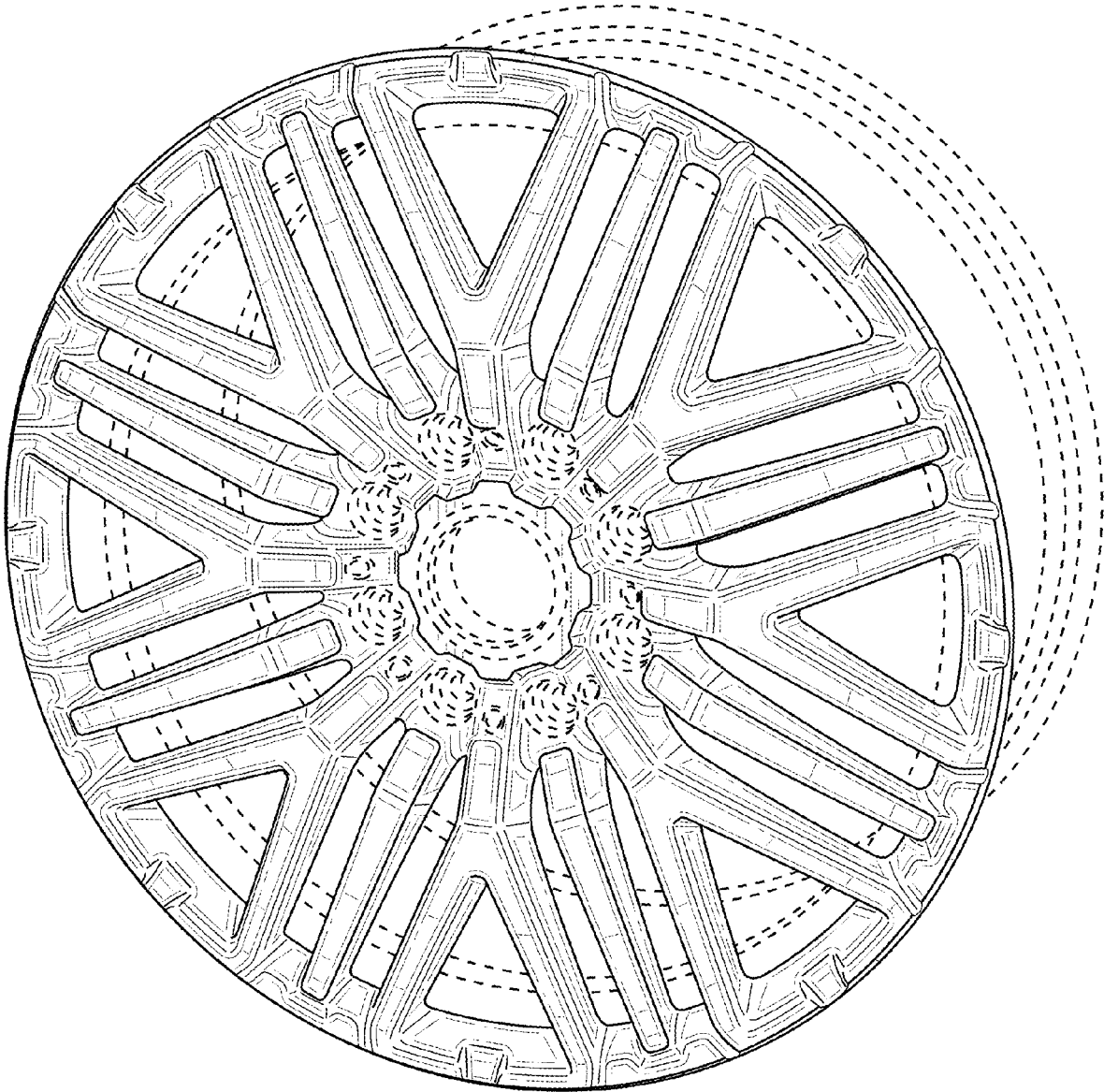
