FIG. 7 is a perspective front view thereof;

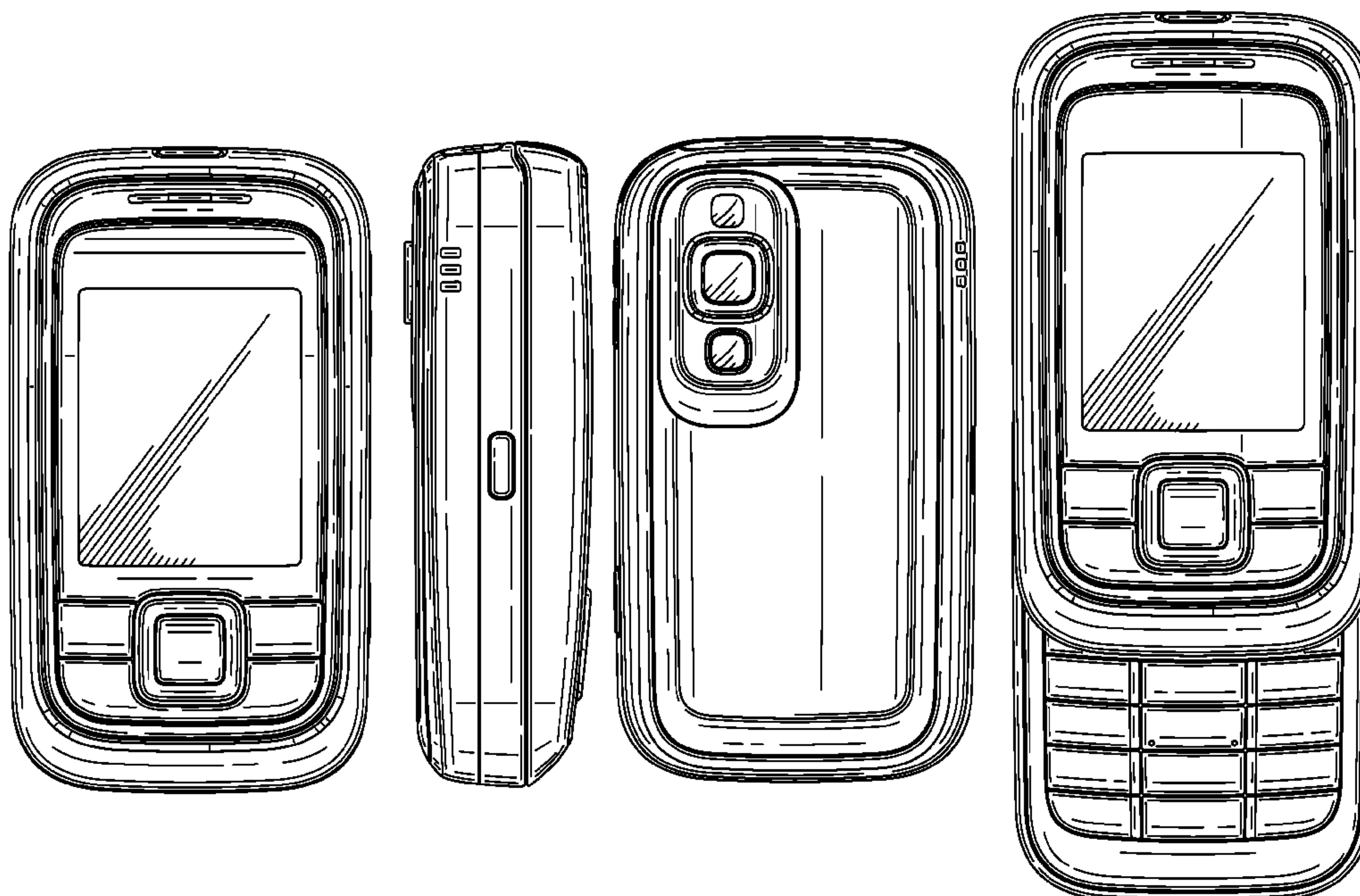
FIG. 8 is a perspective rear view thereof;

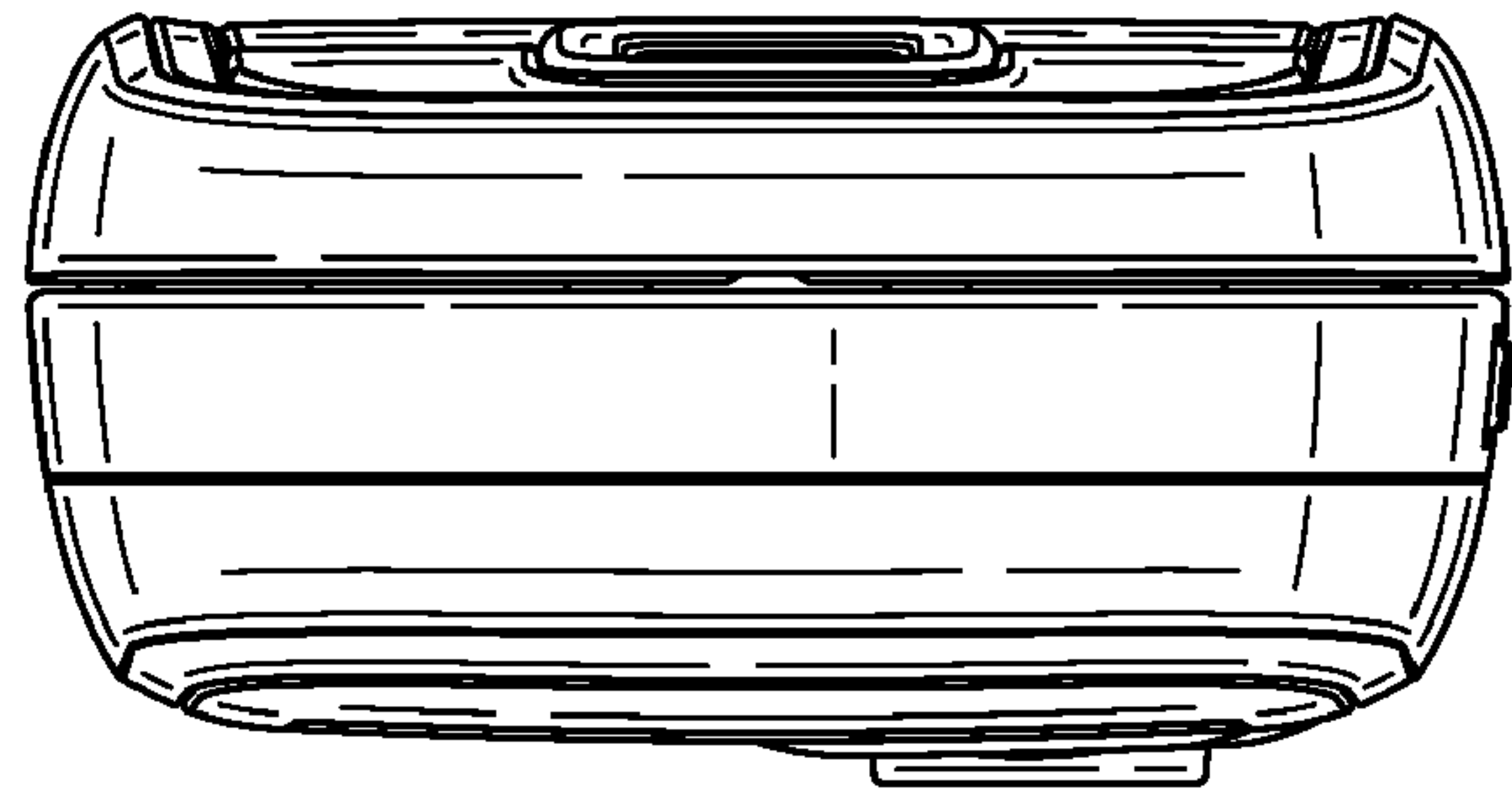

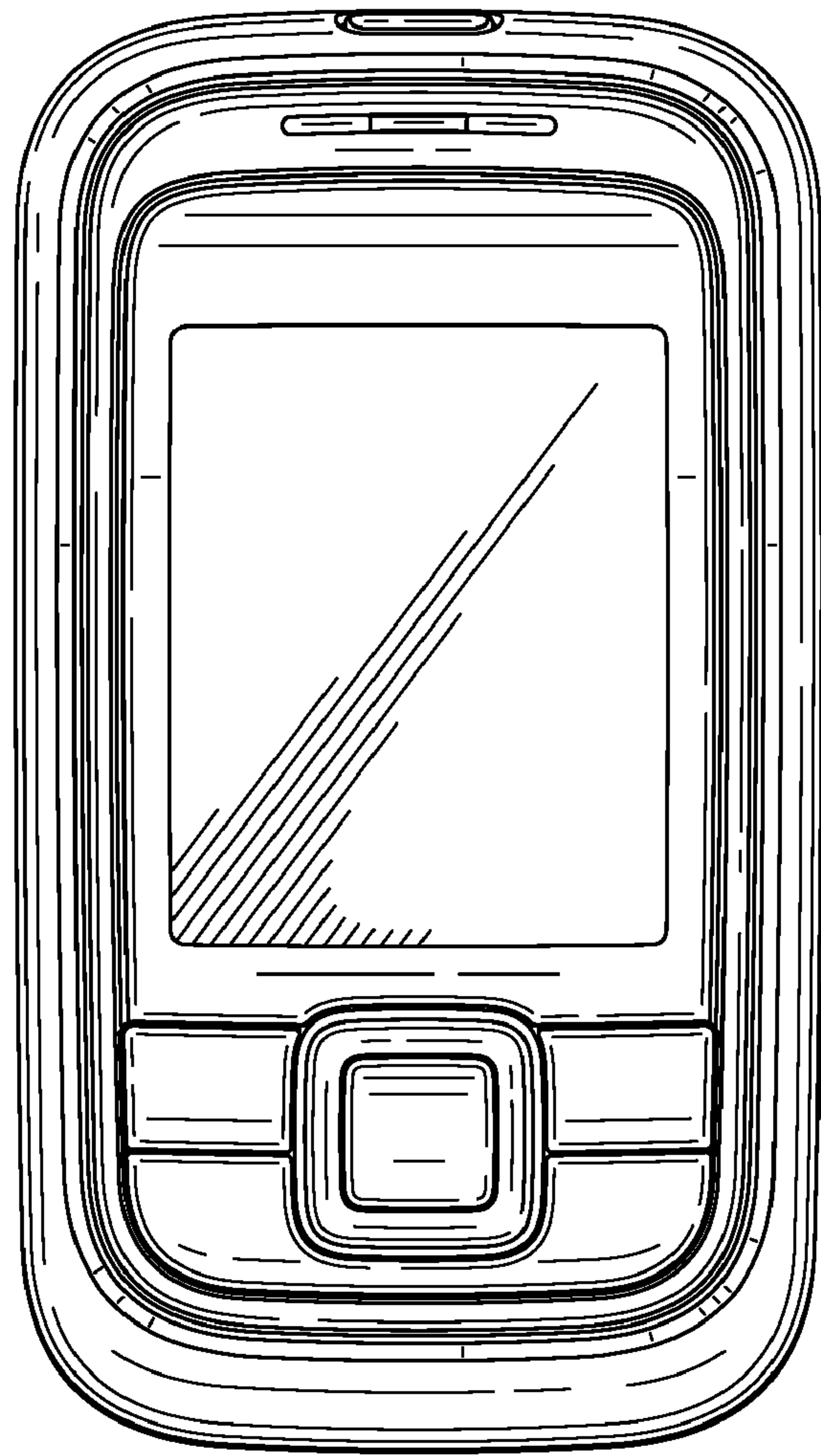

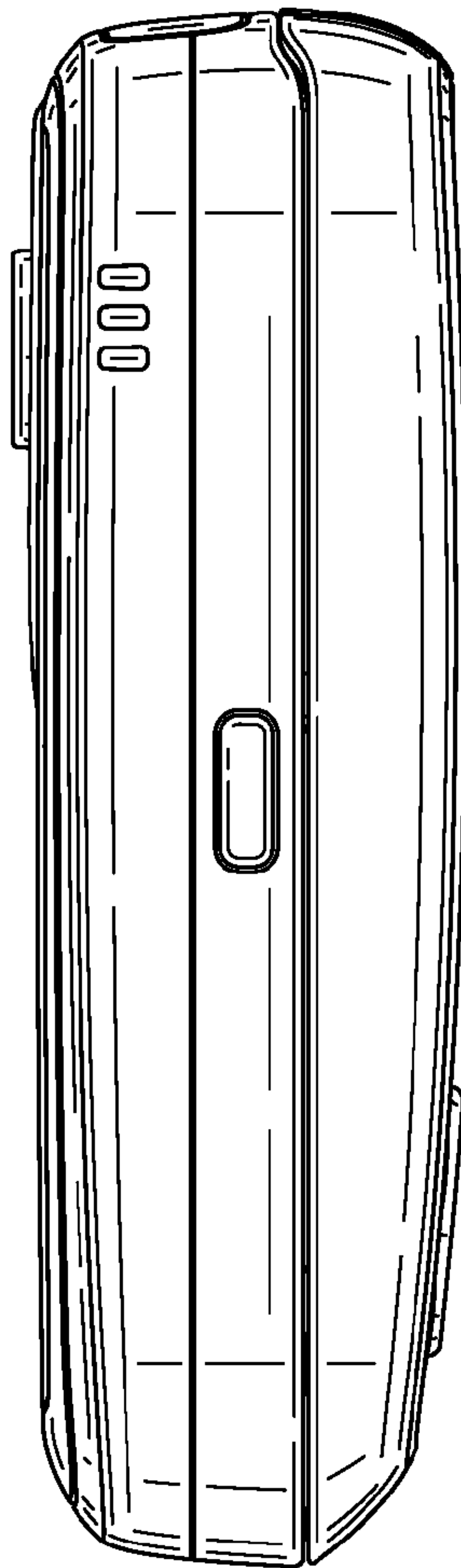

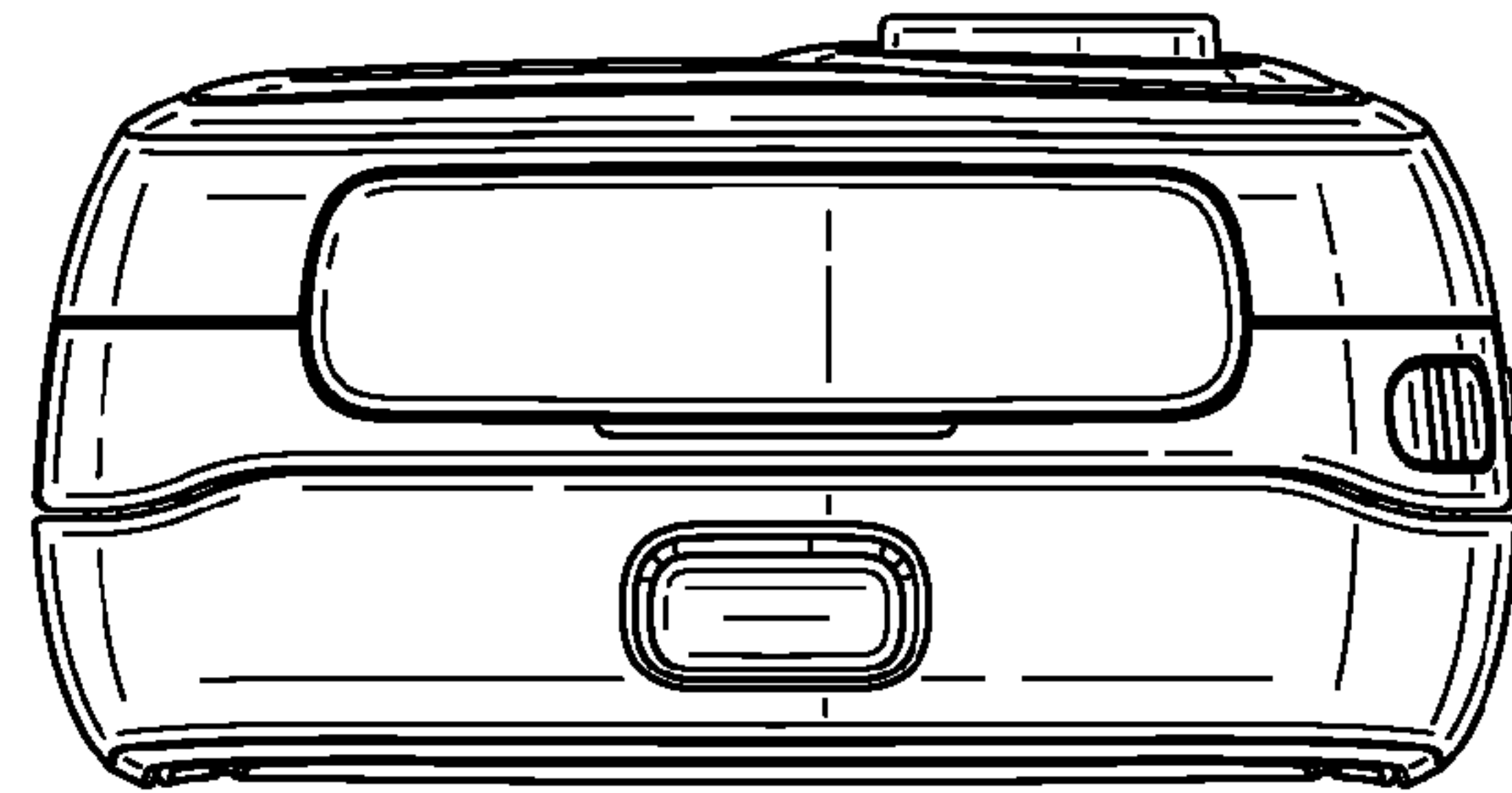

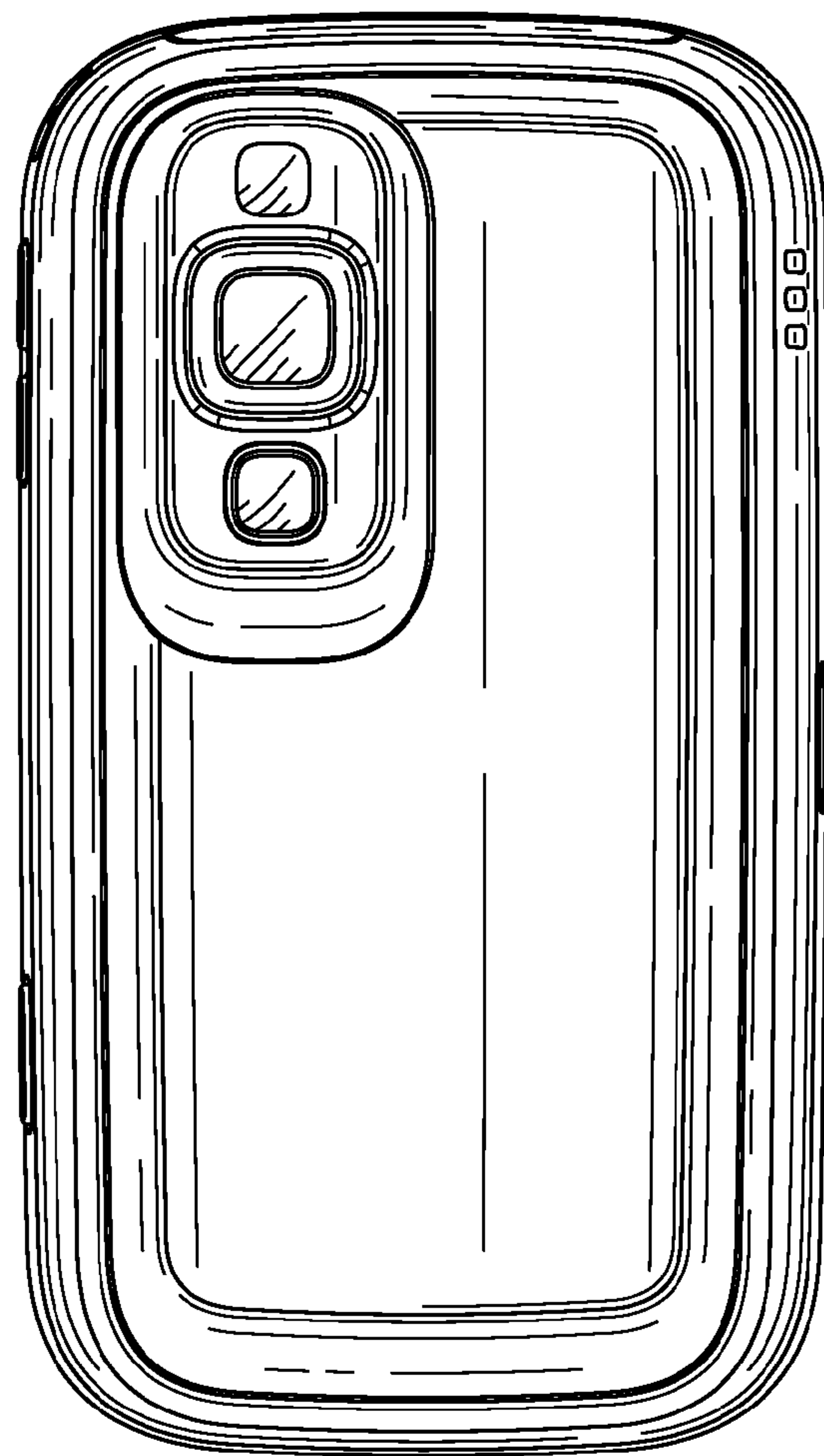

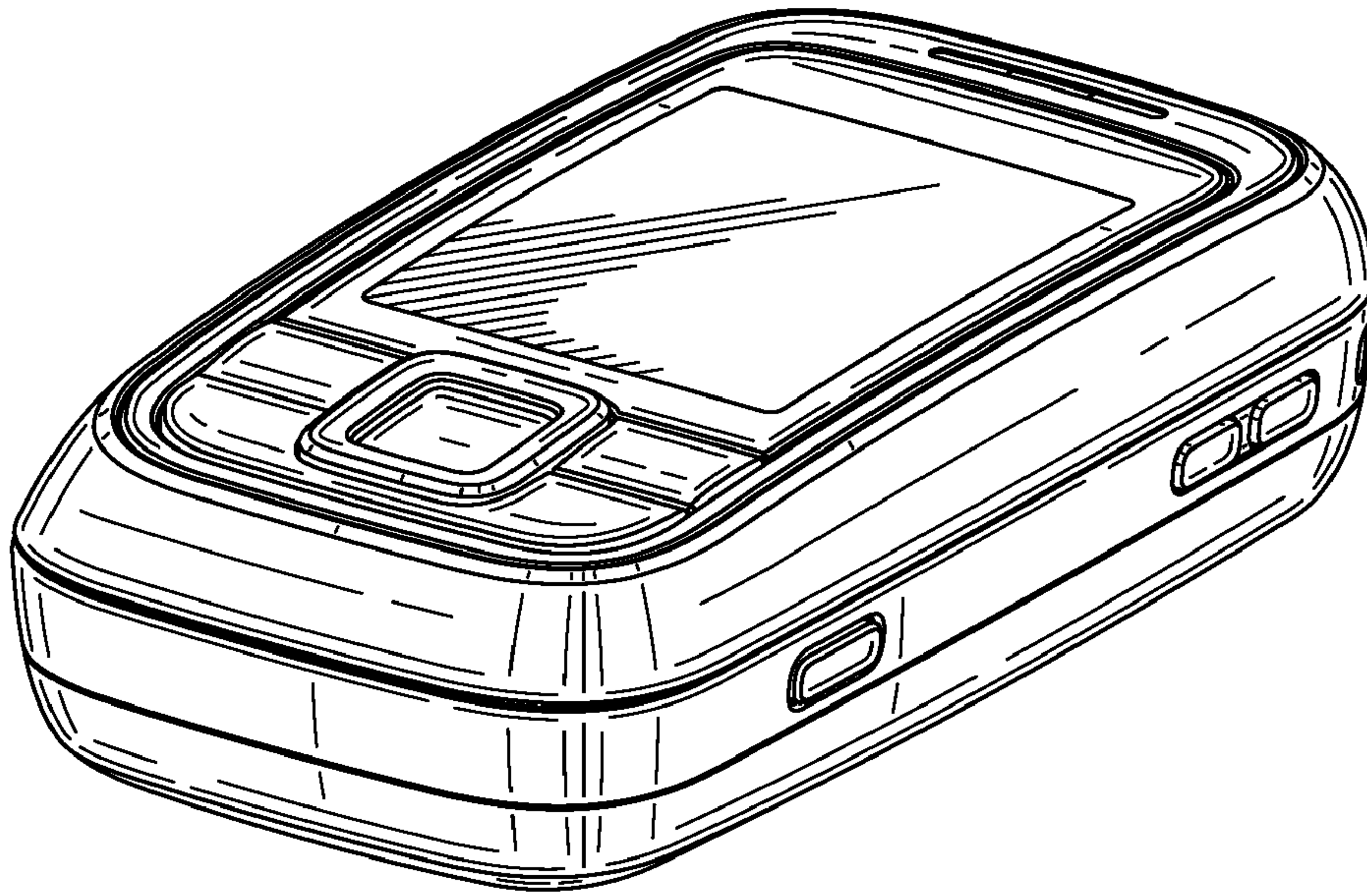

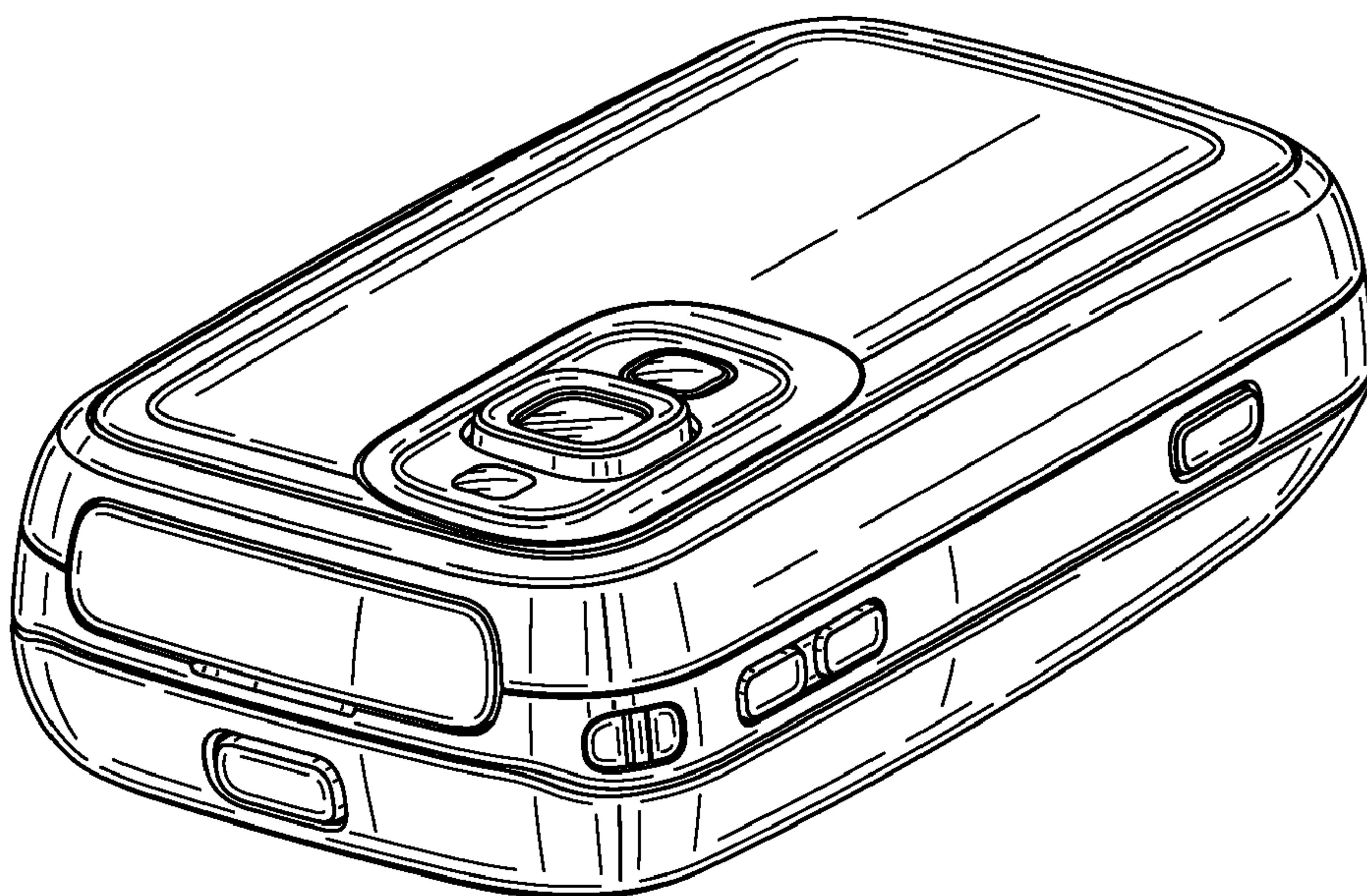

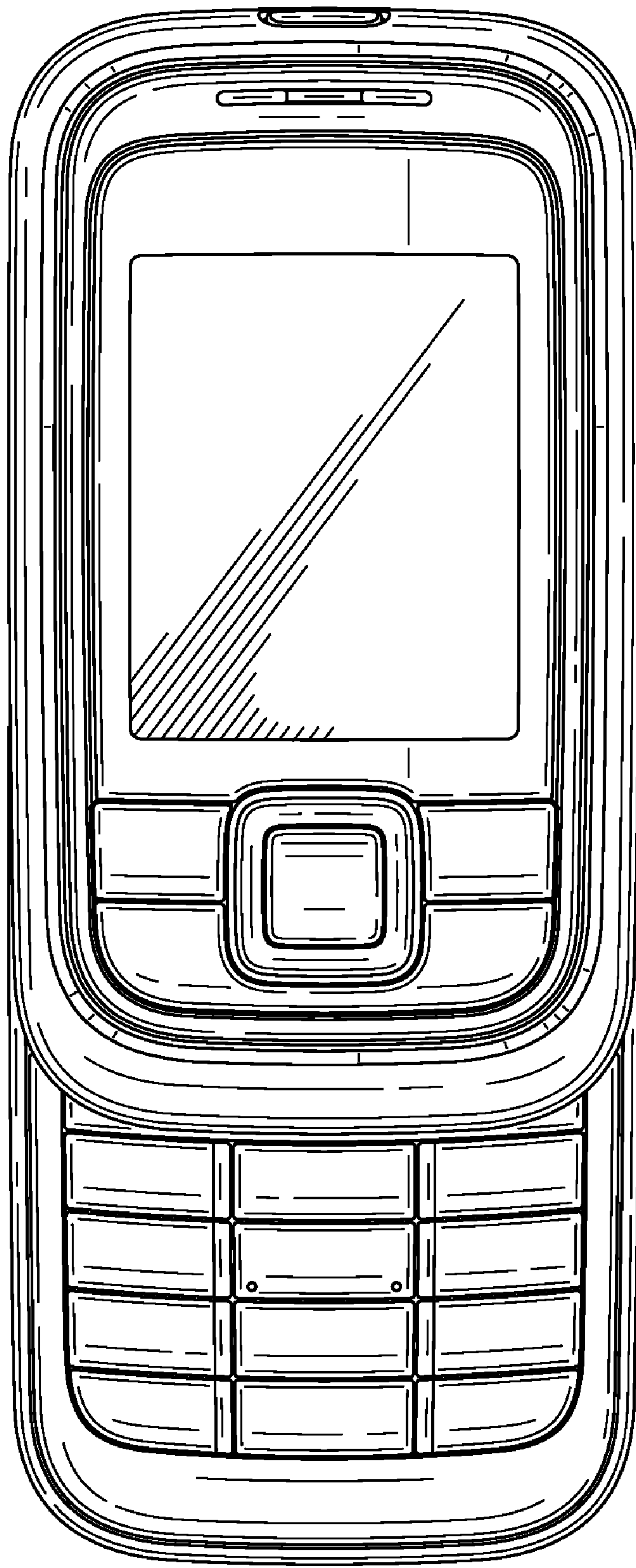

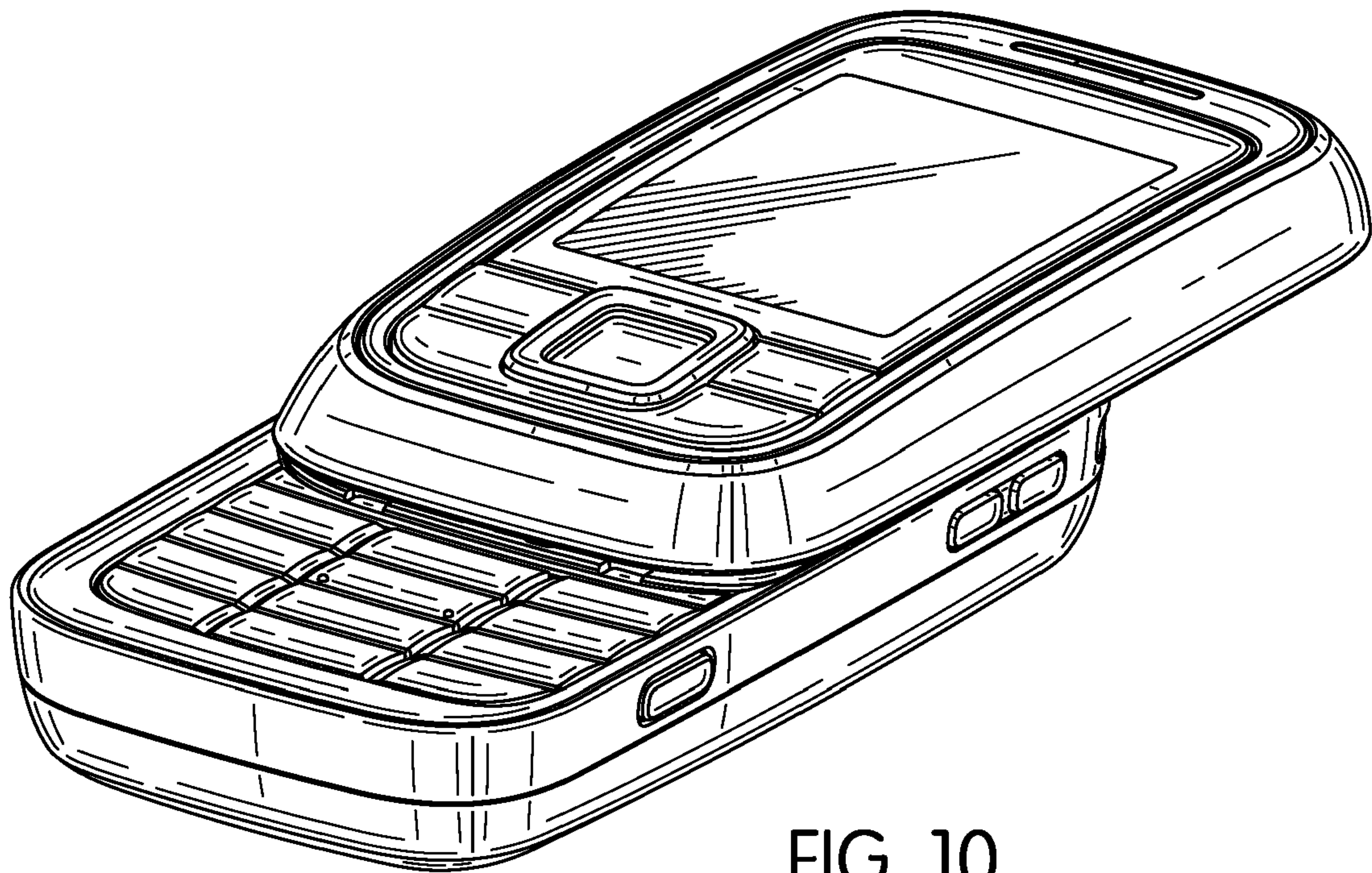

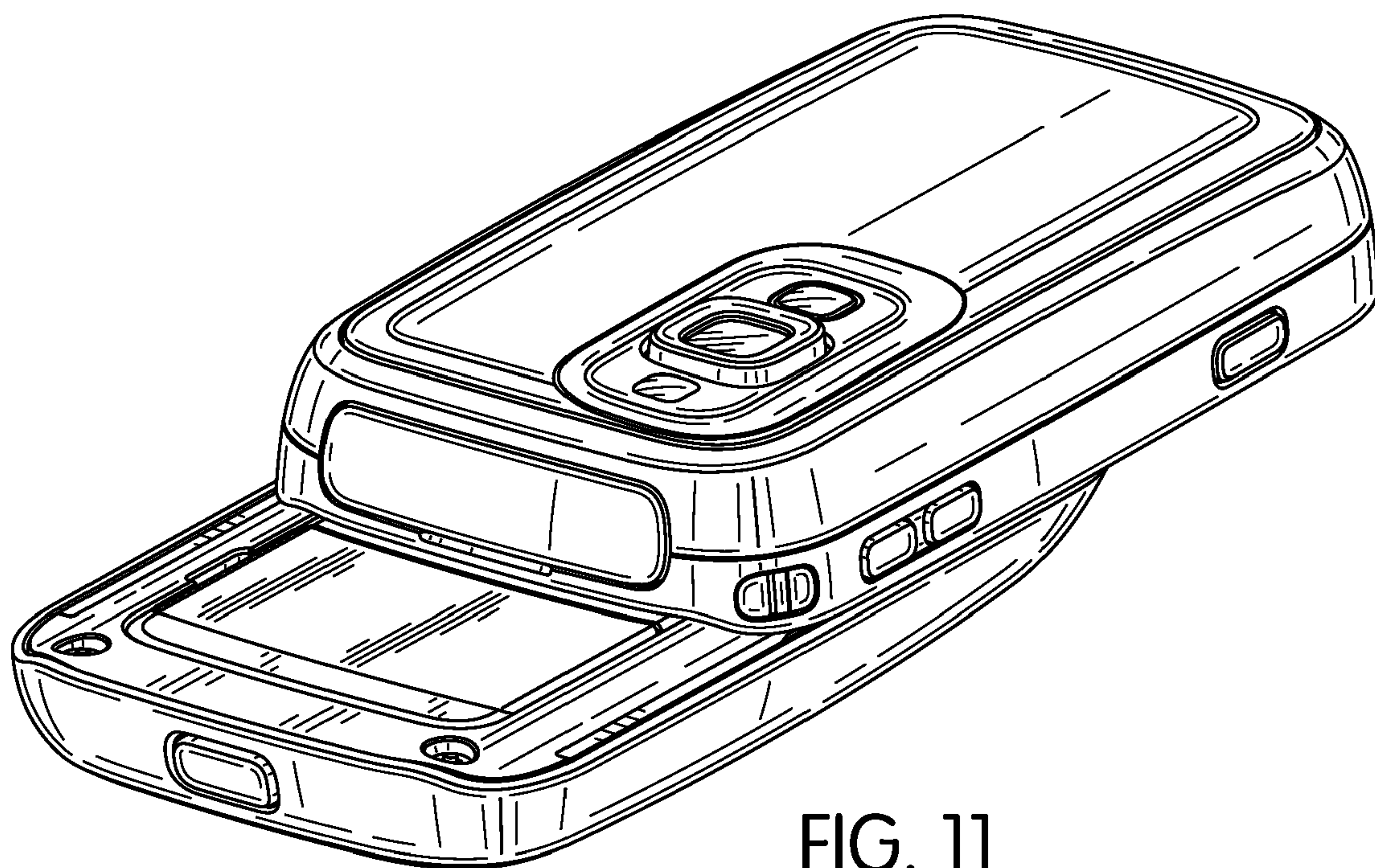
