(57) **CLAIM**

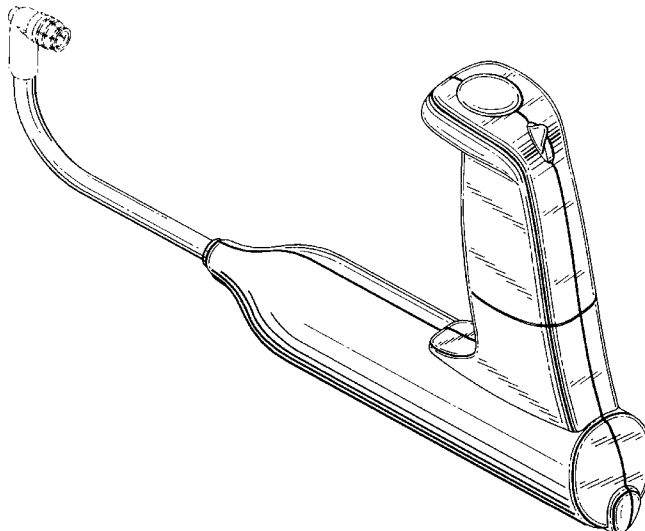
The ornamental design for a surgical instrument, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a surgical instrument showing our new design; FIG. 2 is a left side view; FIG. 3 is a right side view; FIG. 4 is a top view; FIG. 5 is a bottom view; FIG. 6 is a front view; and, FIG. 7 is a rear-end view.

The broken line showing of the end of the surgical instrument in FIGS. 1–5 and 7 is for illustrative purposes only and forms no part of the claimed design.

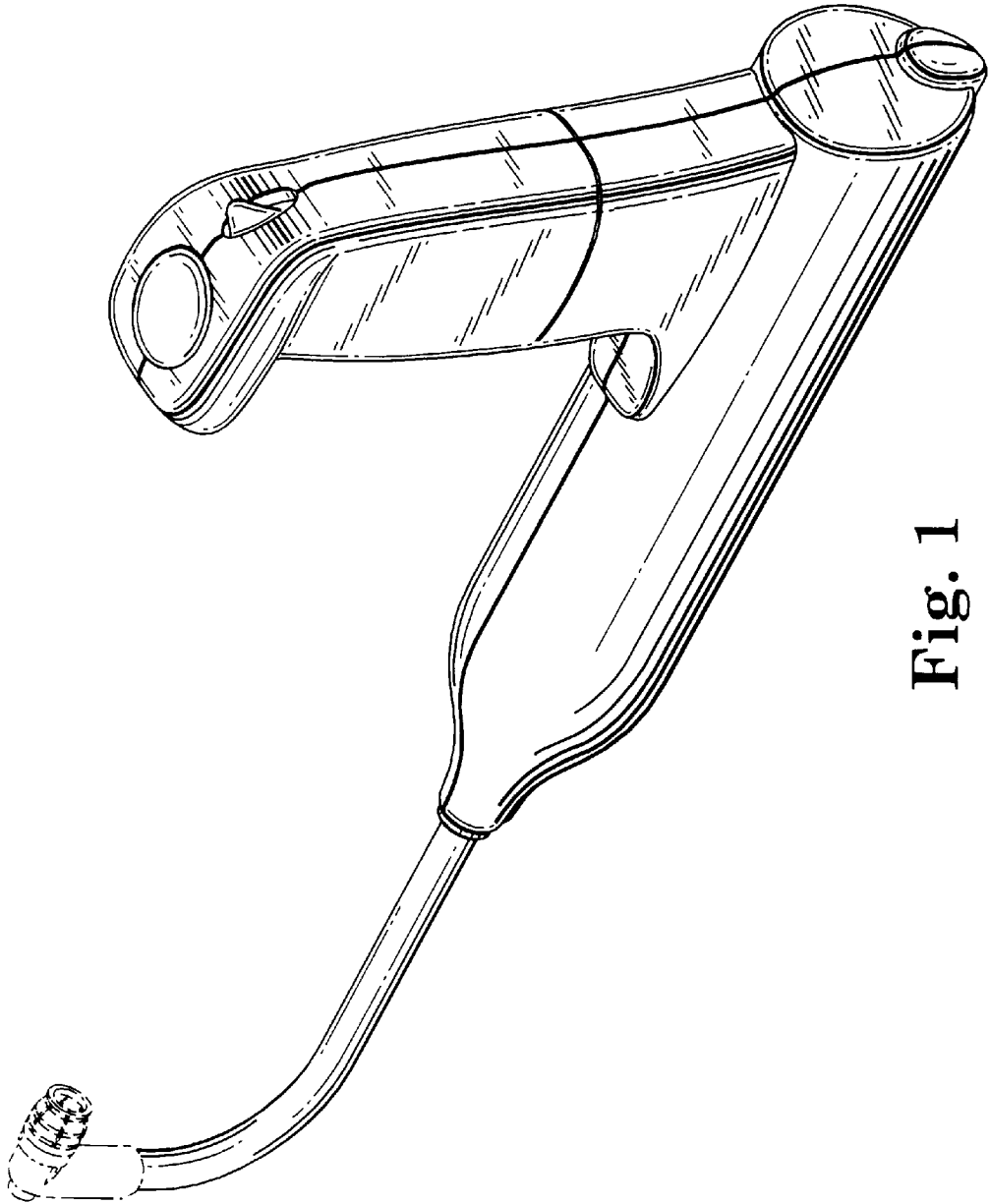

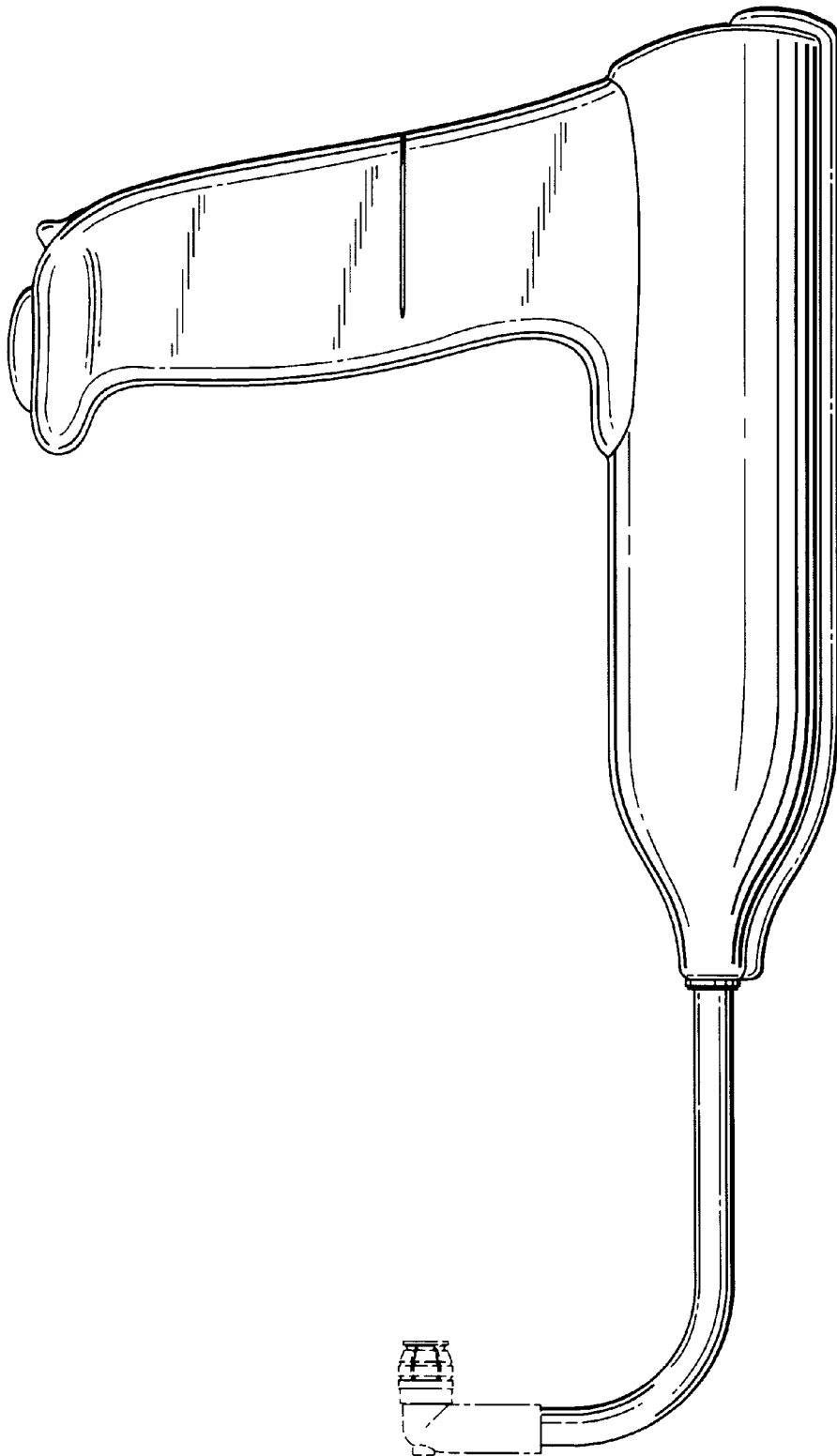

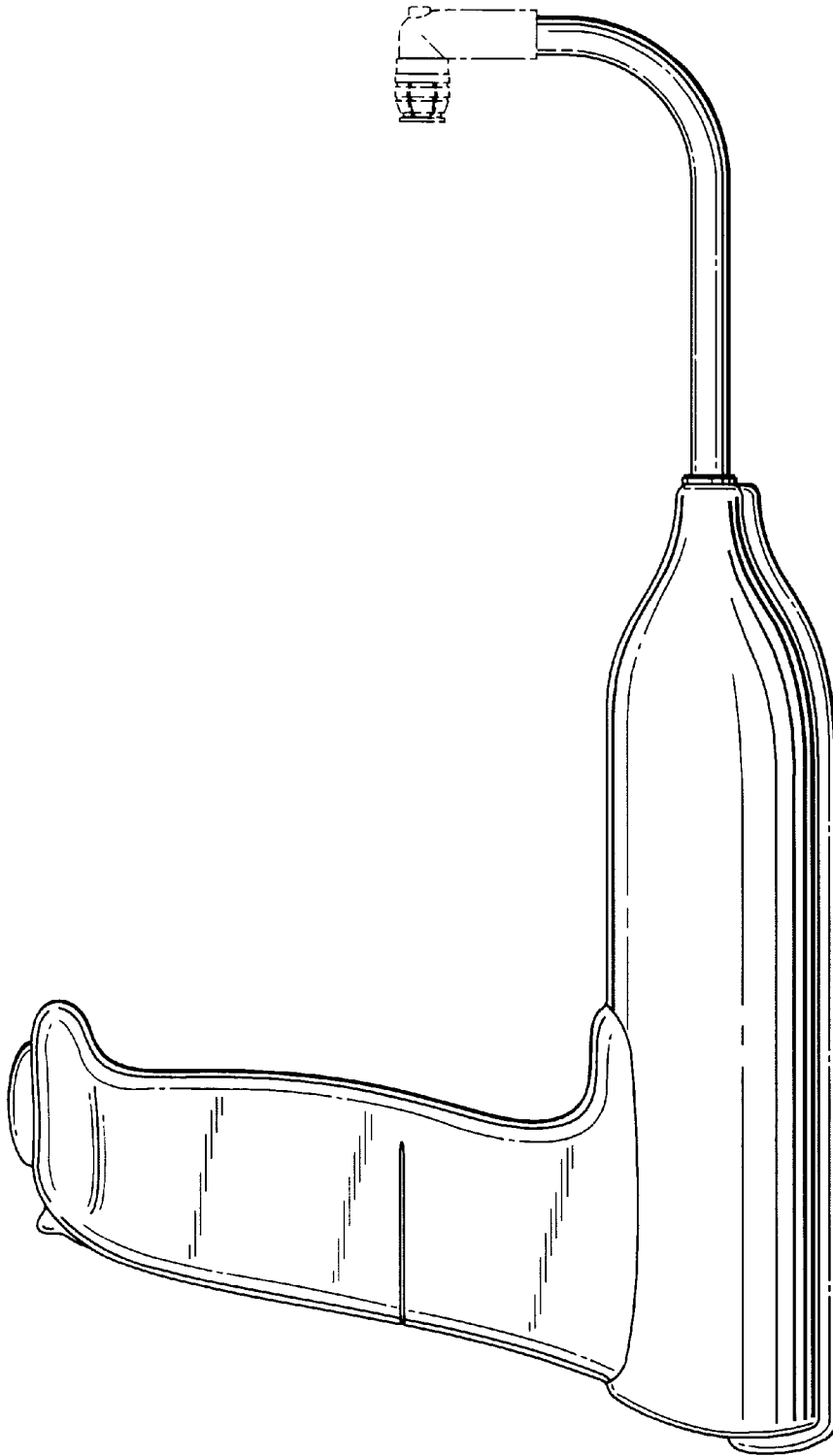

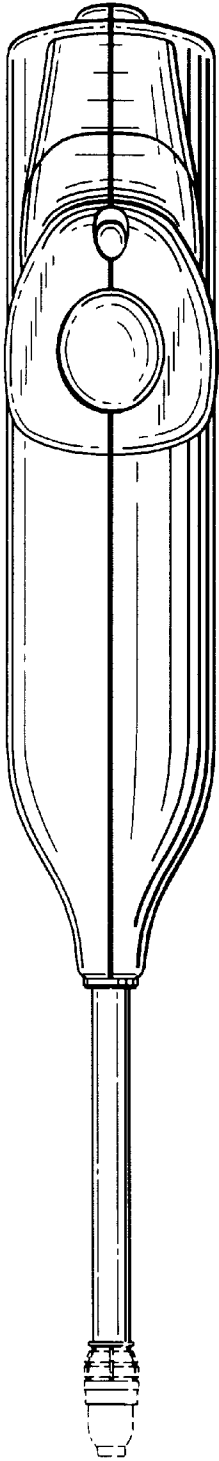

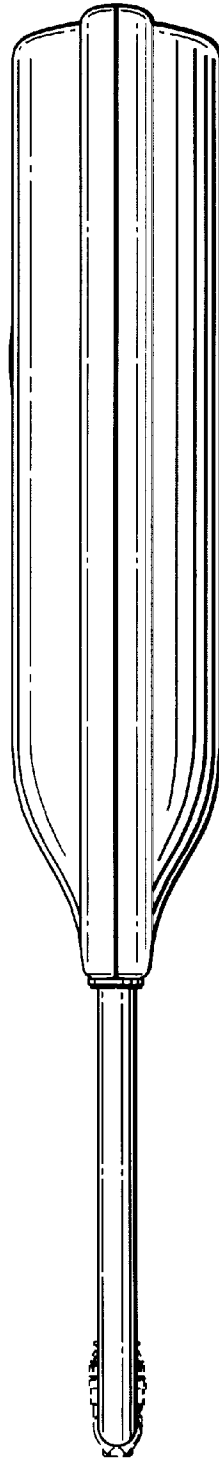

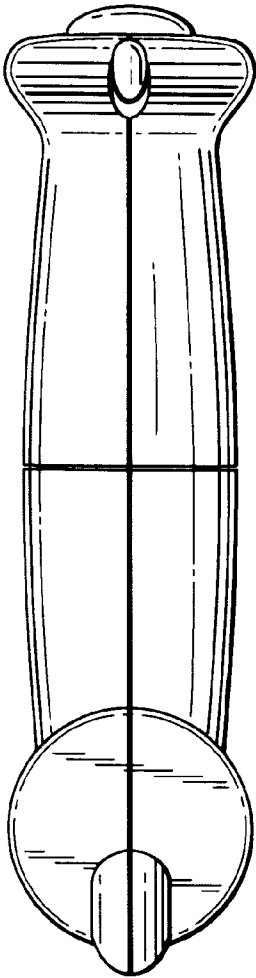

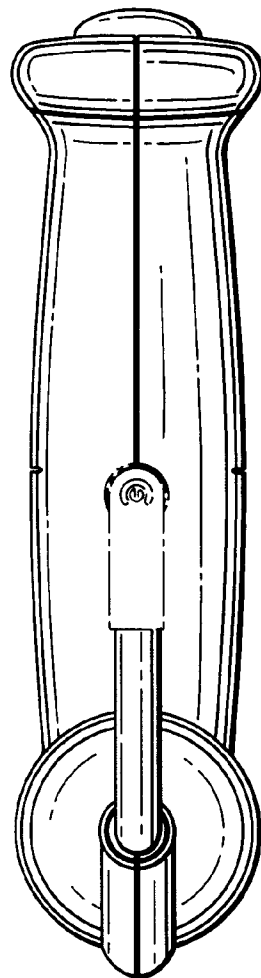
