The ornamental design for a vehicle front bumper, as shown and described.

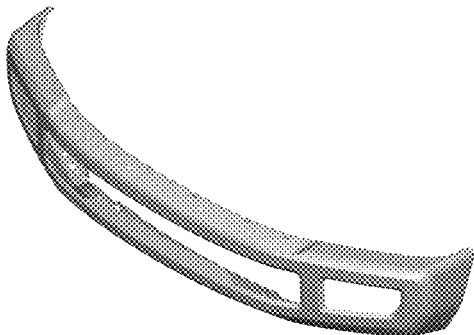
DESCRIPTION

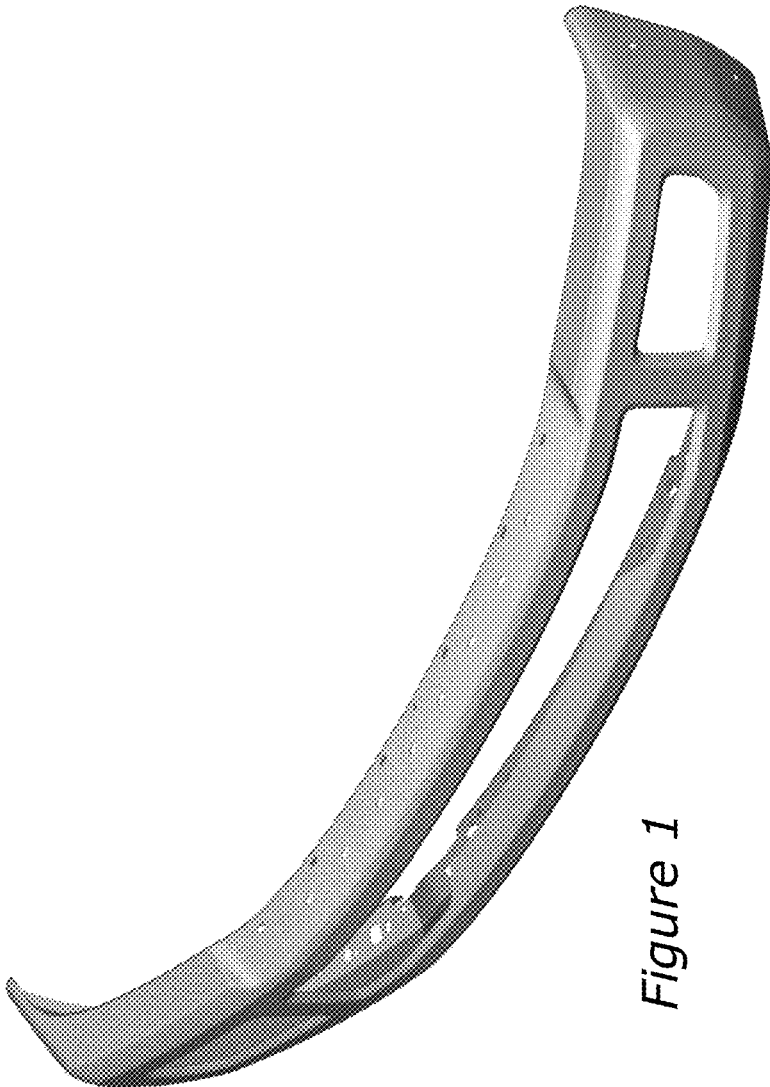

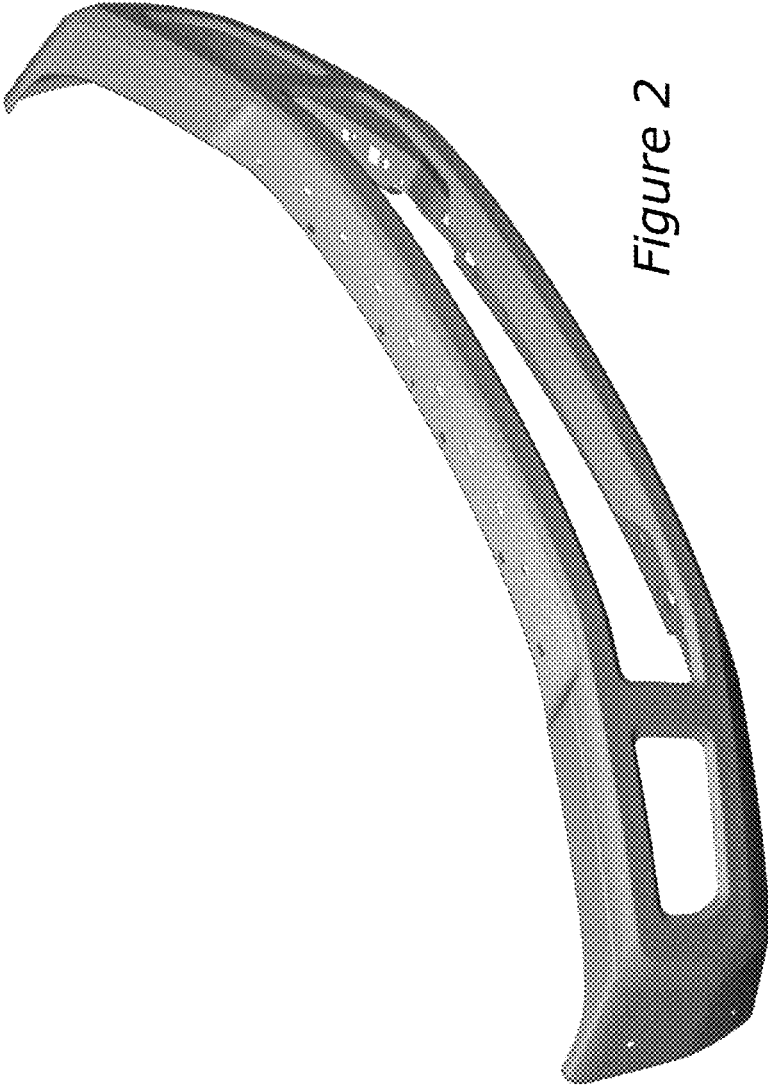

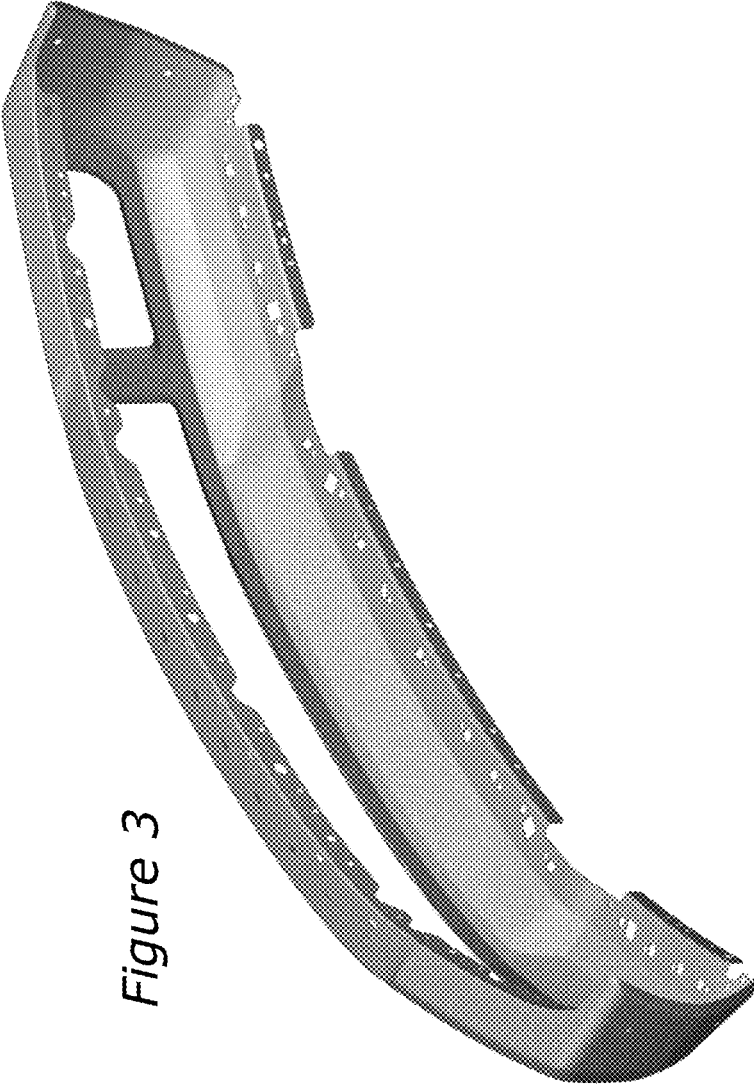

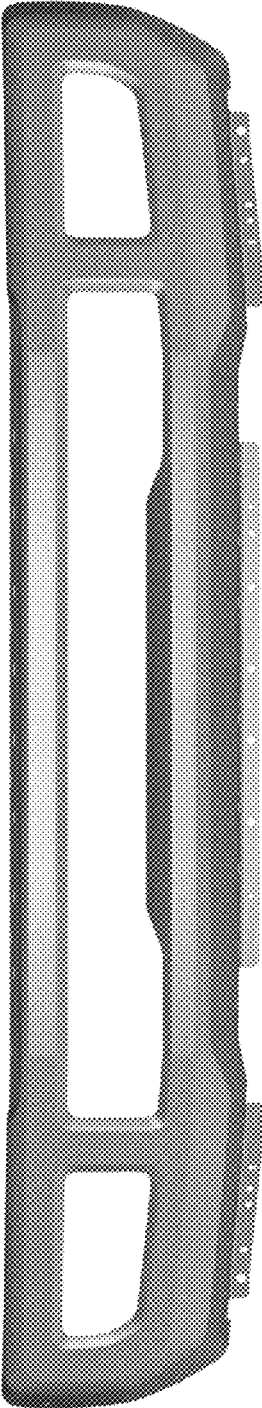

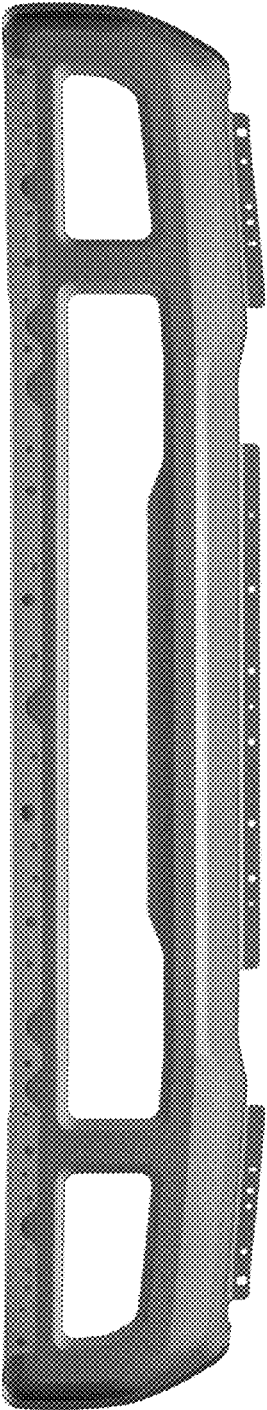

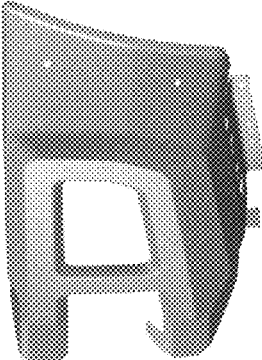

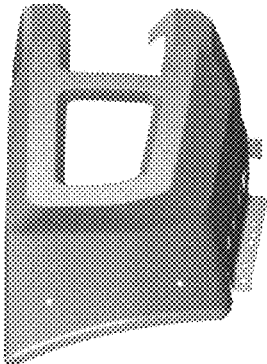

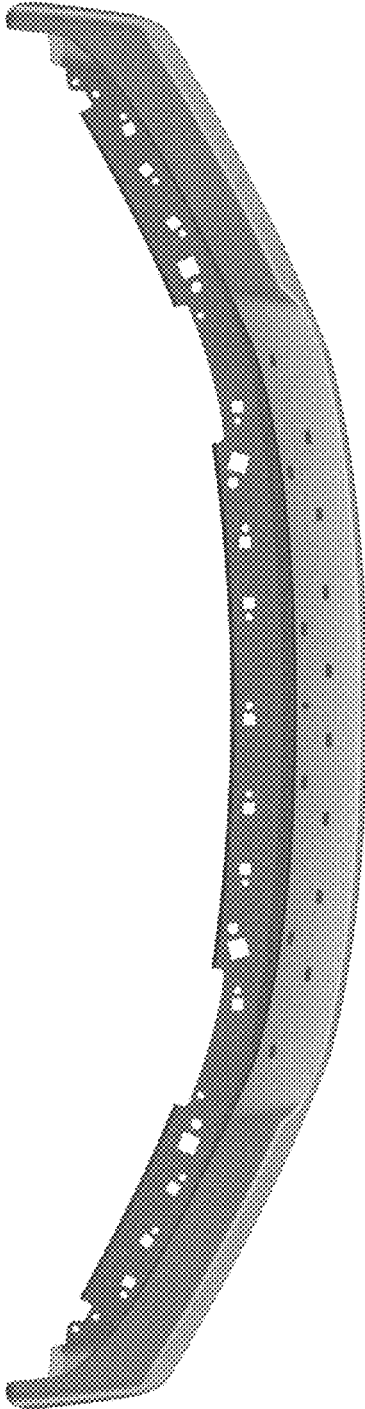
