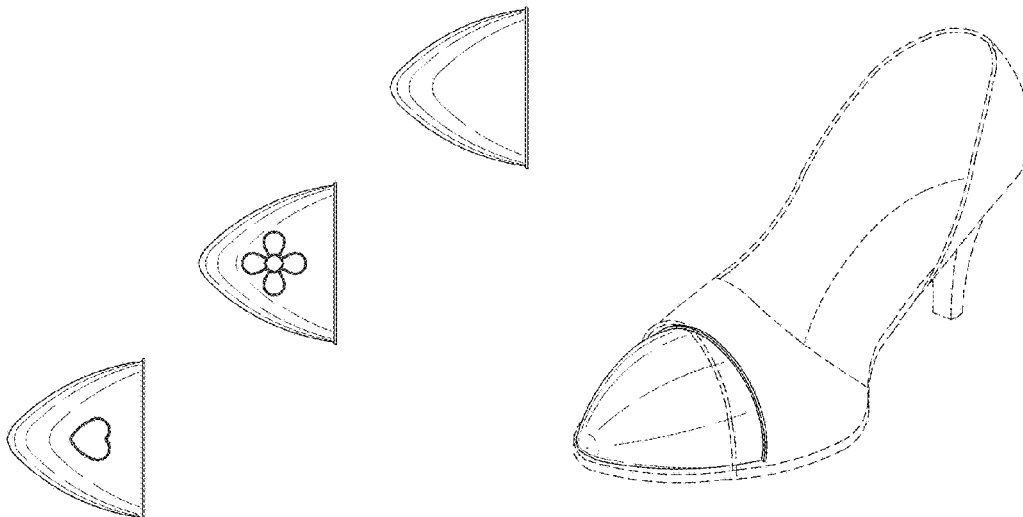
(57) **CLAIM**

The ornamental design for a women's open toe shoe insert kit, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a women's open toe shoe insert kit showing my new design, a rear view being a mirror image thereof;  
FIG. 2 is a left side view of the women's open toe shoe insert kit;  
FIG. 3 is a right side view of the women's open toe shoe insert kit;  
FIG. 4 is a top view of the women's open toe shoe insert kit;  
FIG. 5 is a bottom view of the women's open toe shoe insert kit; and,  
FIG. 6 is a top front side perspective view of one of the shoe inserts of the women's open toe shoe insert kit in use.  
The broken lines are illustrative of environmental structure and form no part of the claimed design.

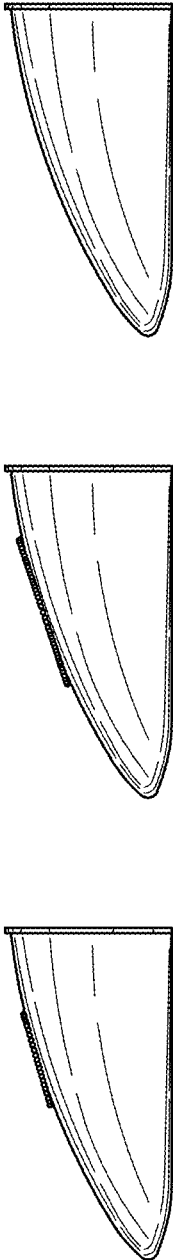

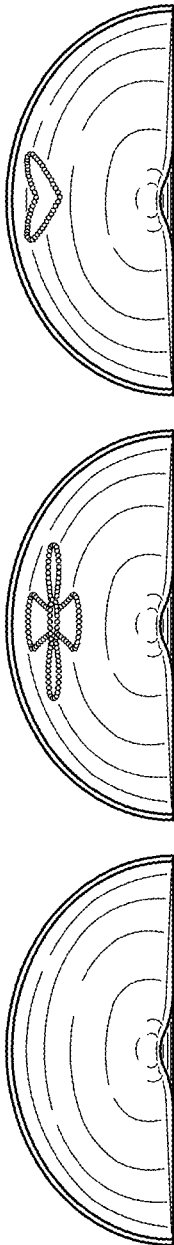

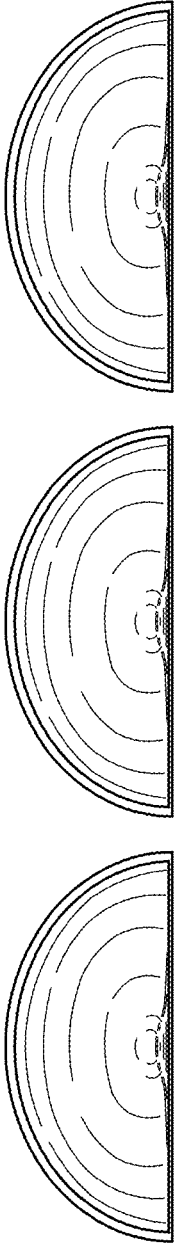

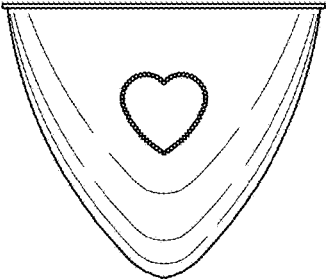
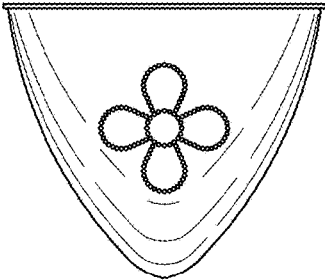
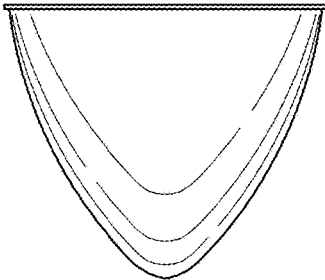

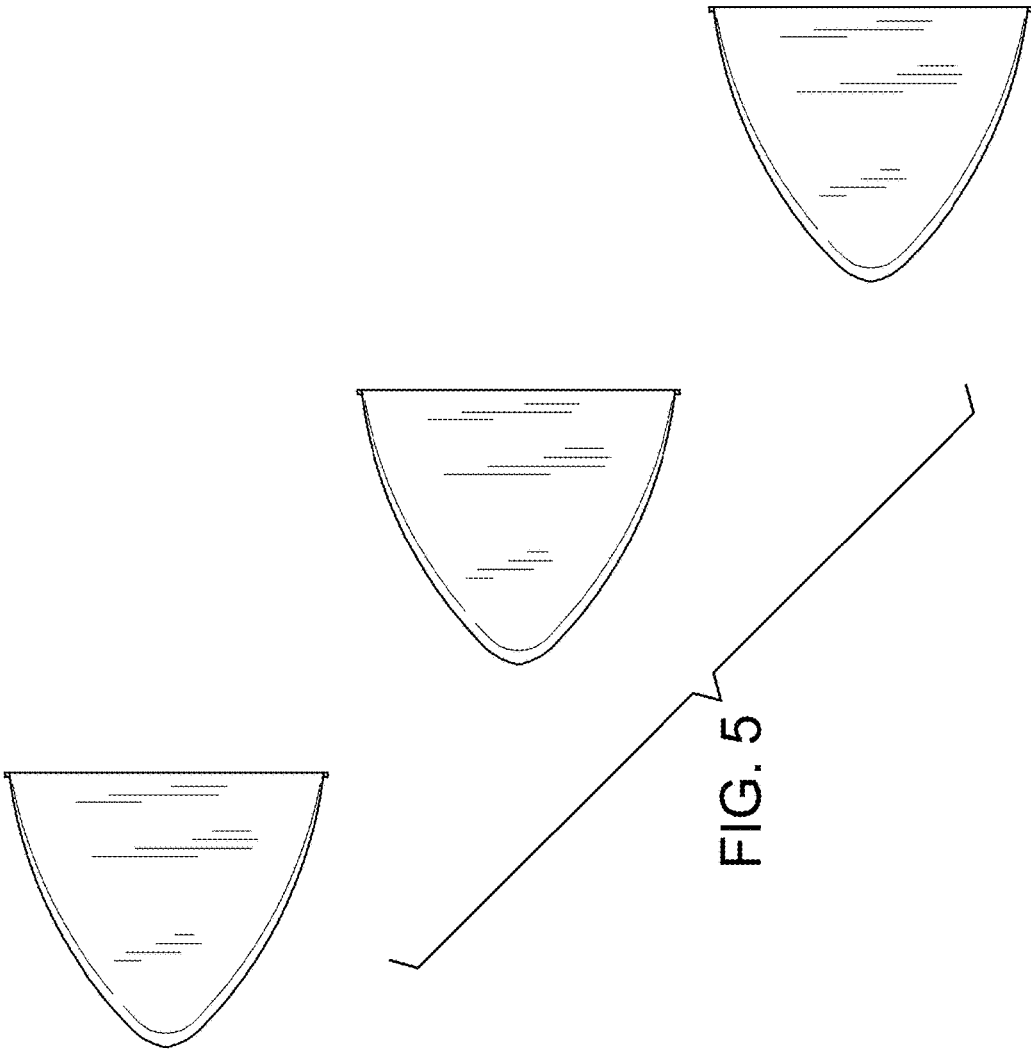

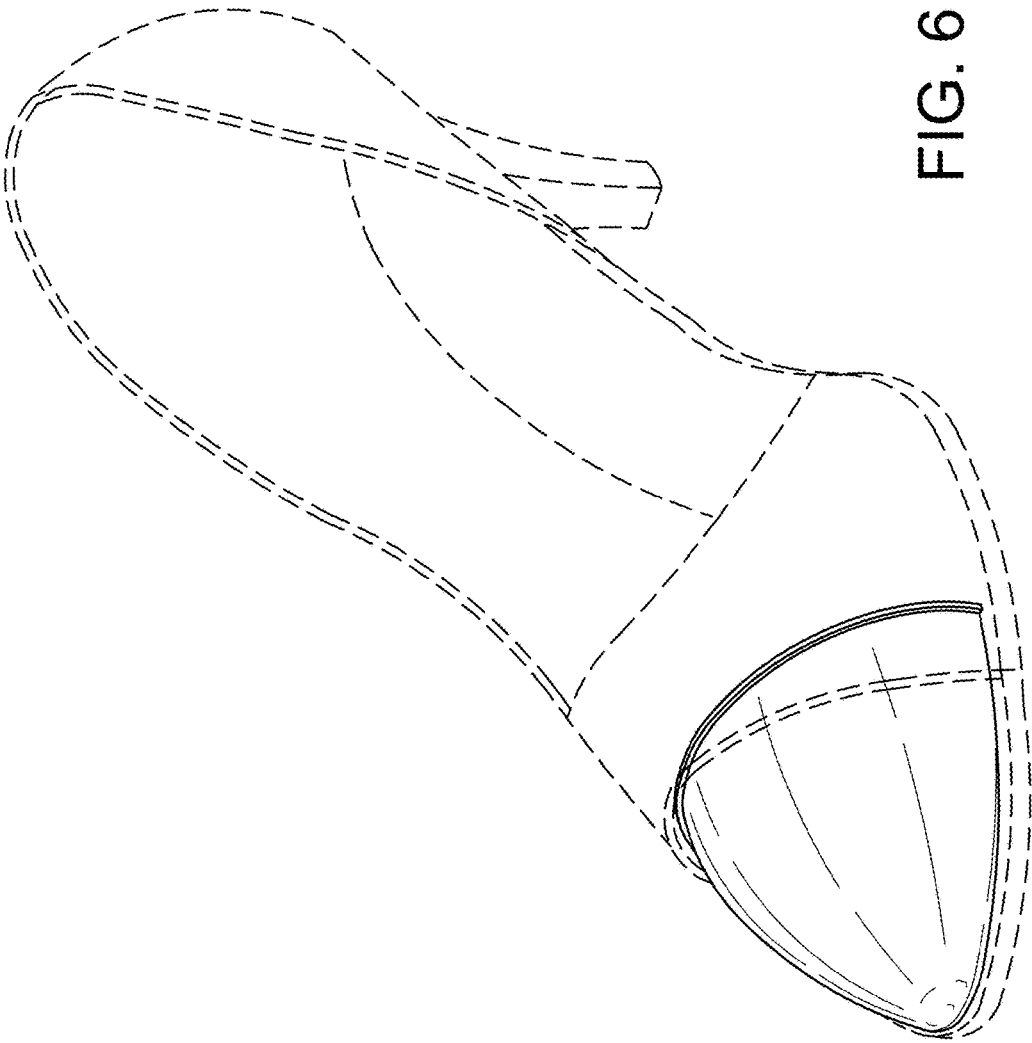
