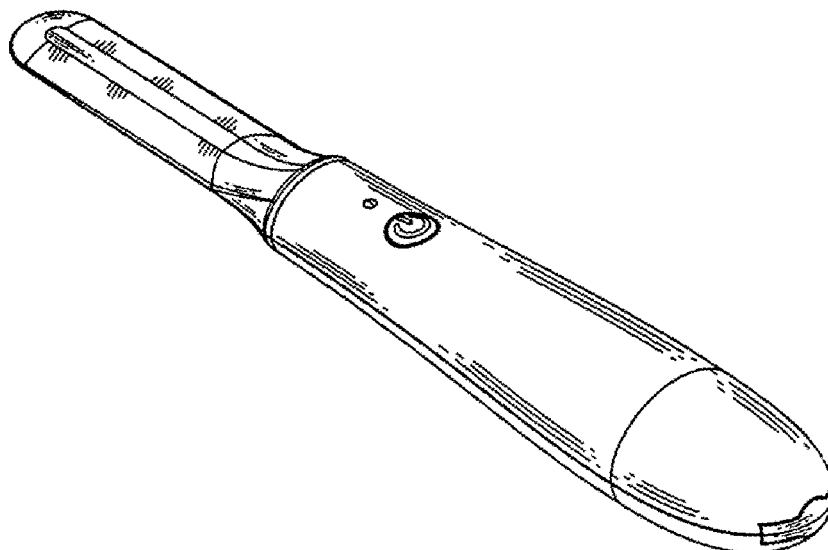
The ornamental design for cream knife, as shown and described.

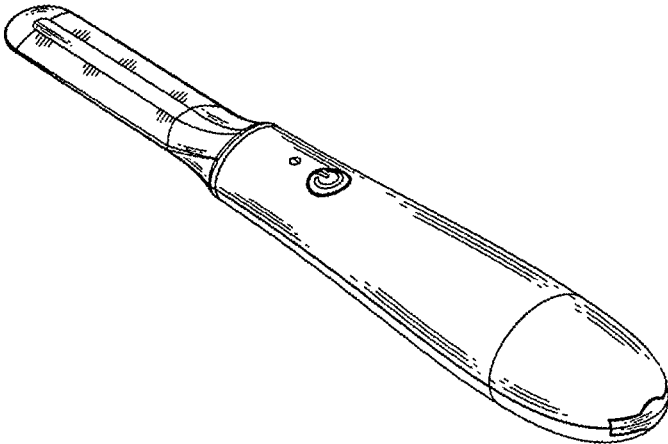

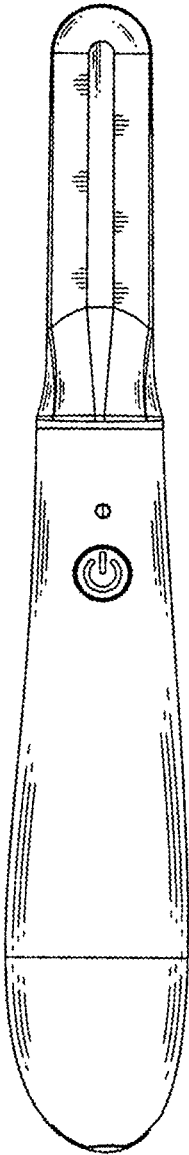

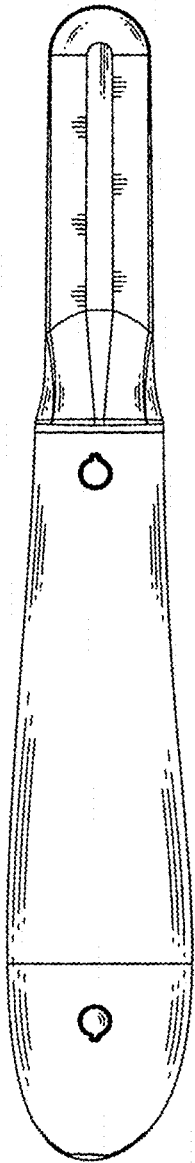

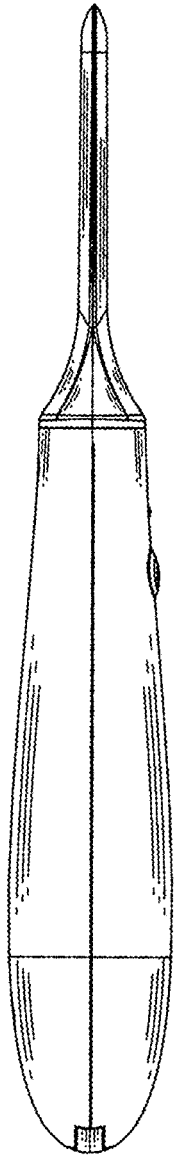

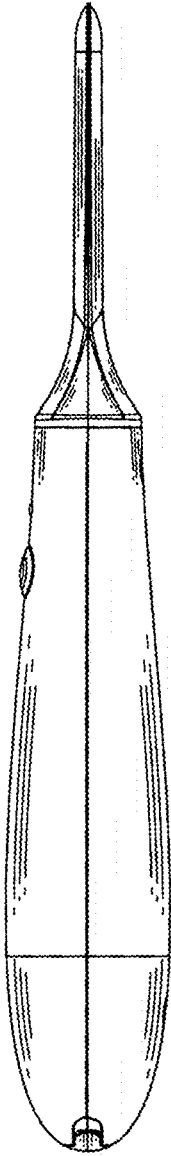

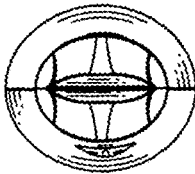

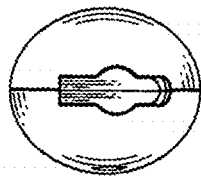
