(57) **CLAIM**

The ornamental design for a hand dryer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the hand dryer showing my new design;

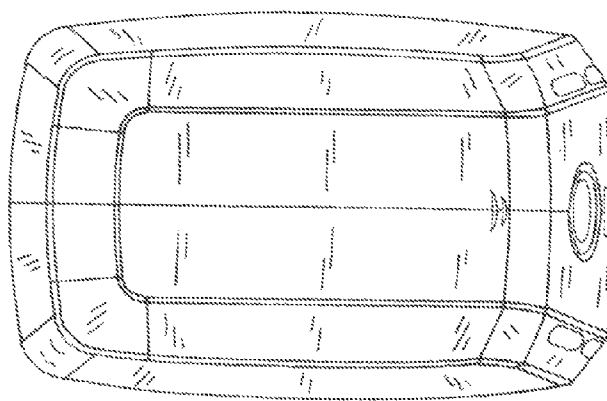
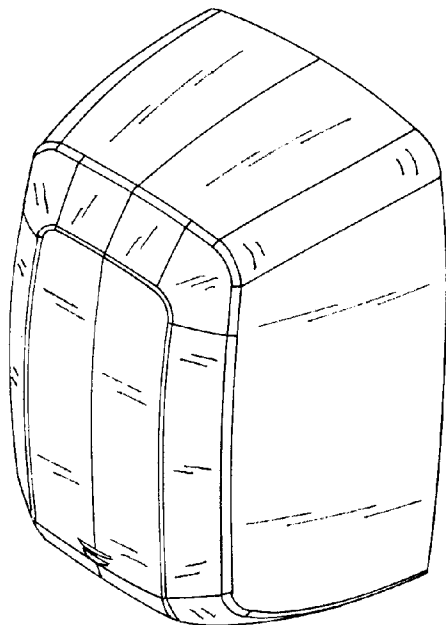

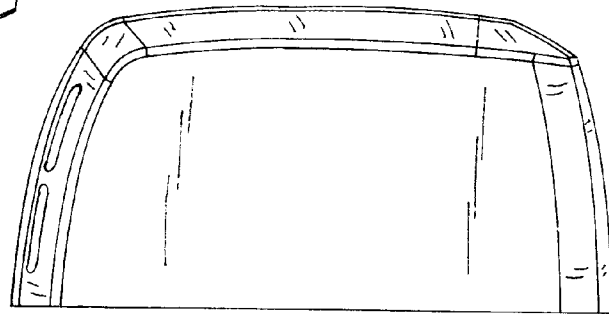
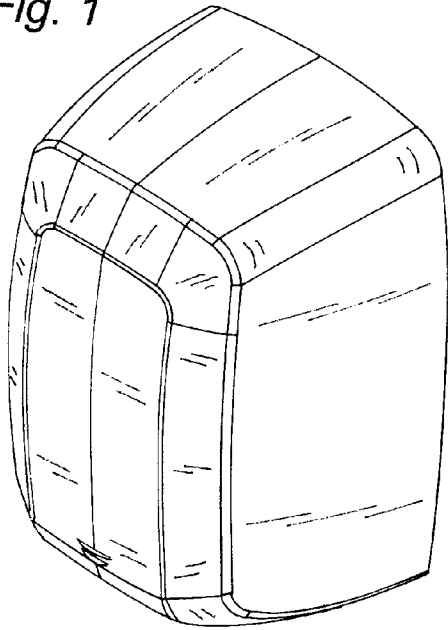

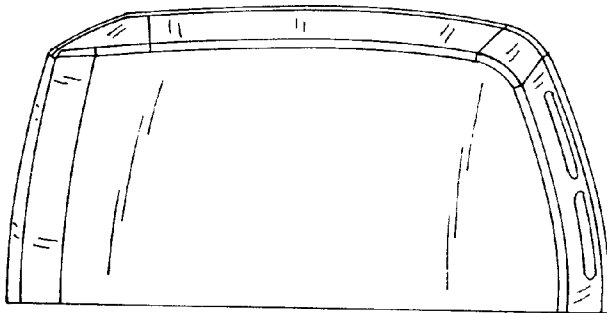
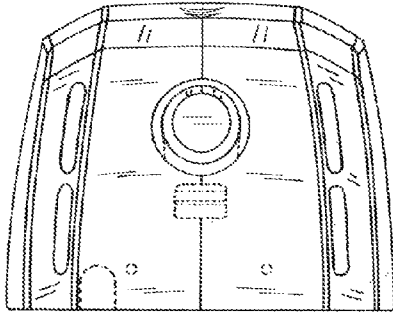
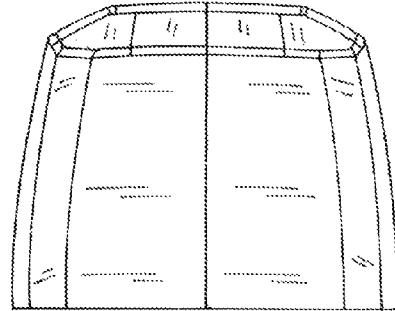


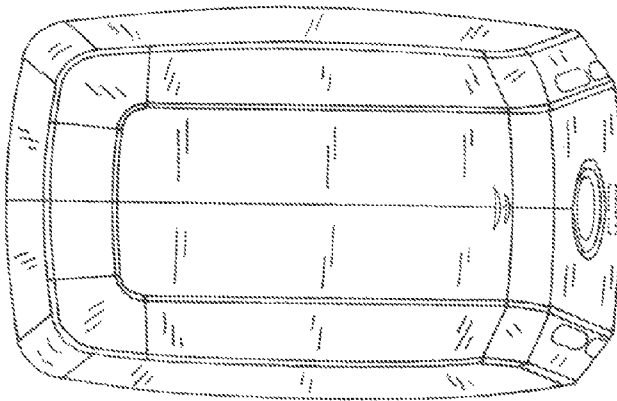

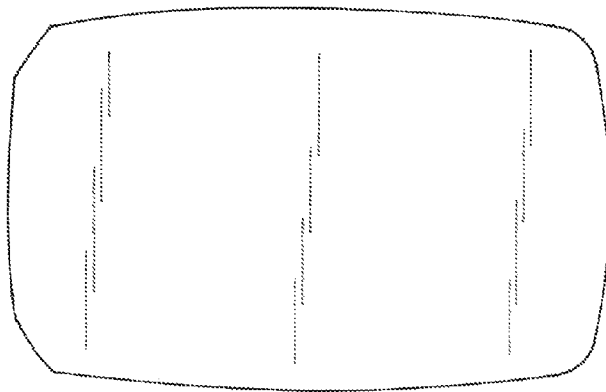
