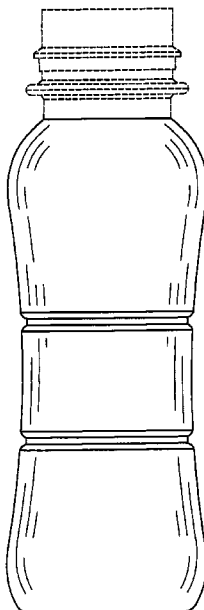
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a bottle of the present invention, all side elevation views thereof being identical. FIG. 2 is a top plan view of the bottle shown in FIG. 1; and, FIG. 3 is a bottom plan view of the bottle shown in FIG. 1.

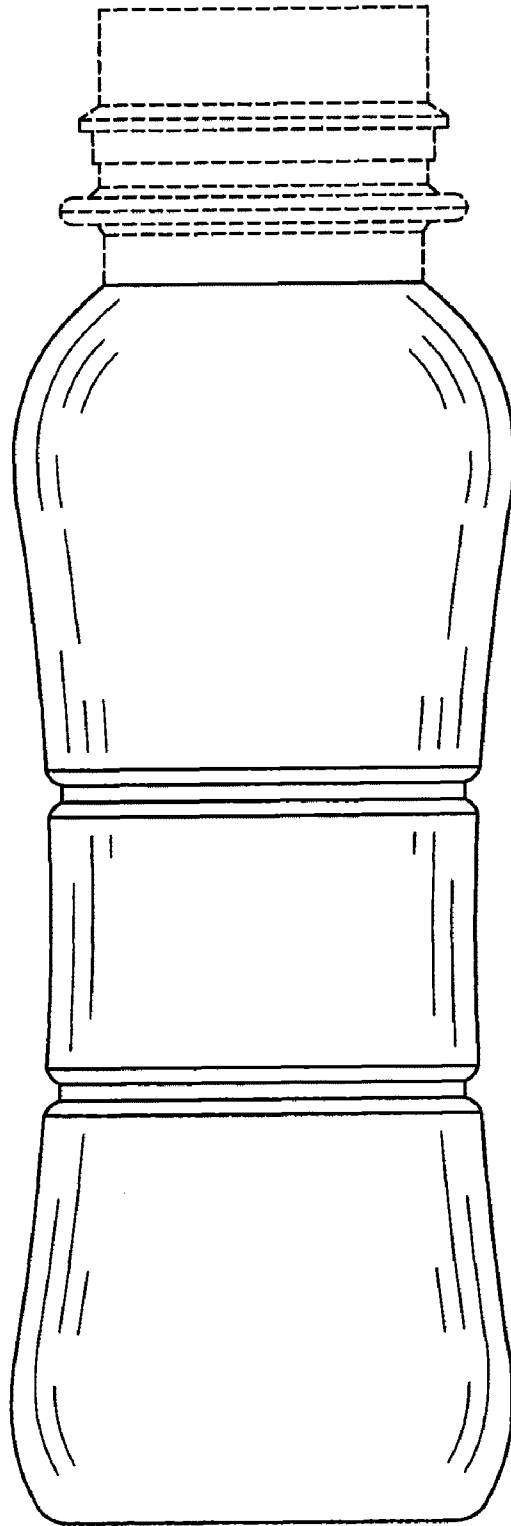

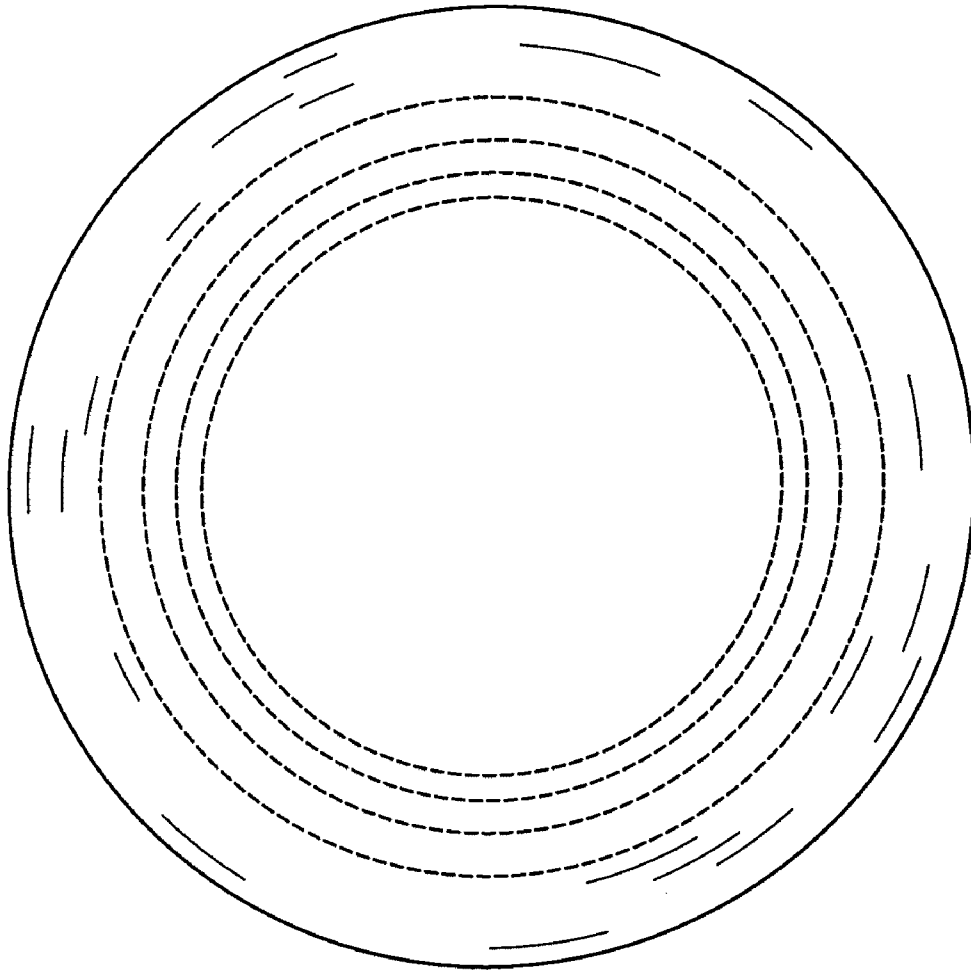

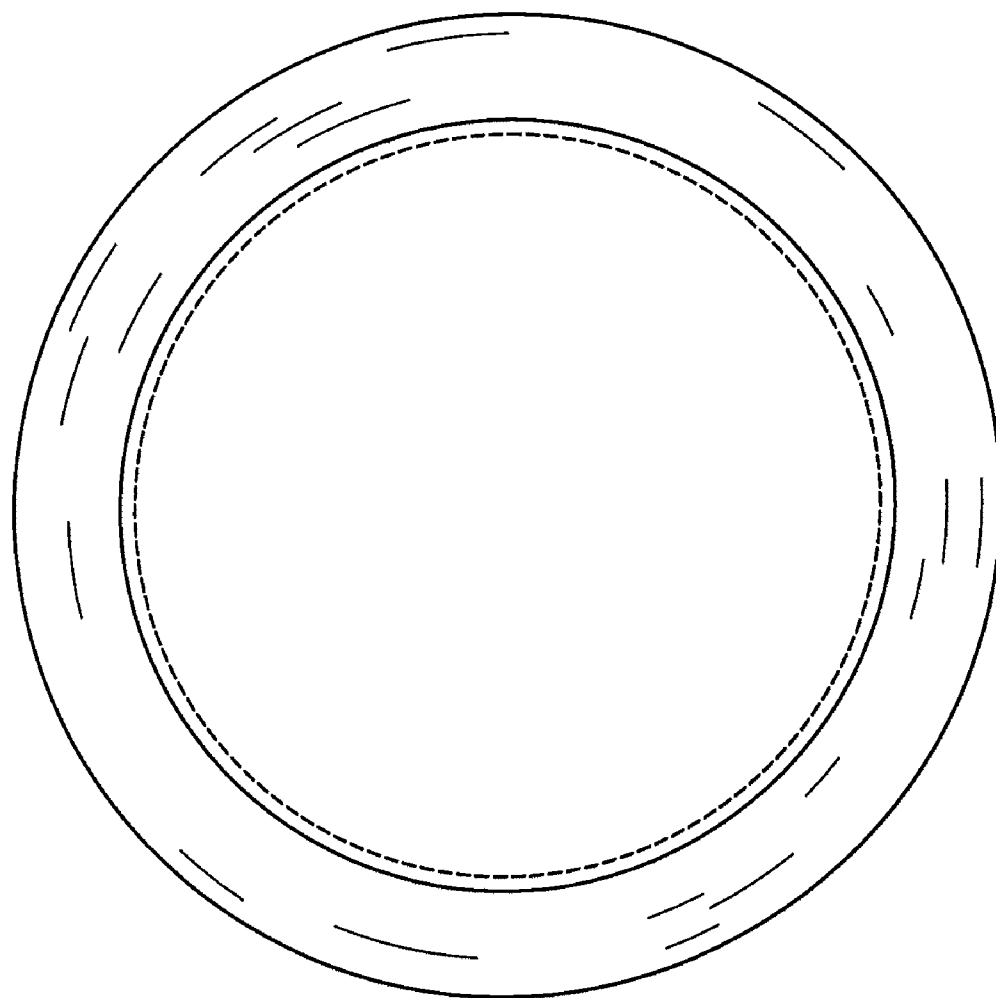
