[57] CLAIM

The ornamental design for a bottle carrier, as shown and described.

FIG. 11 is a view looking from the right of FIG. 10, the opposite side being the same in appearance;


FIG. 12 is a top plan view showing another modified form of my new design;


FIG. 13 is a side elevational view thereof, the opposite side being the same in appearance;

FIG. 14 is a view looking from the right of FIG. 13, the opposite side being the same in appearance;


FIG. 15 is a top plan view showing another modified form of my new design; and,

FIG. 16 is an elevational view thereof, the view from all sides being the same in appearance.






















