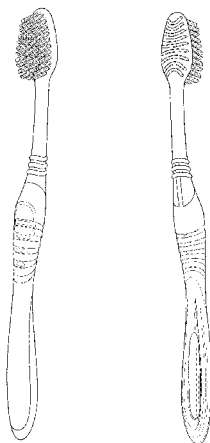
(57) **CLAIM**

The ornamental design for a toothbrush, as shown and described.

**DESCRIPTION**

FIG. 1 is a front-right side perspective view of a toothbrush according to a first embodiment of our design; FIG. 2 is a front-left side perspective view thereof; FIG. 3 is a rear-right side perspective view thereof; FIG. 4 is a rear-left side perspective view thereof; FIG. 5 is a front view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a left-side view thereof; FIG. 8 is a right-side view thereof; FIG. 9 is a top view thereof; and, FIG. 10 is a bottom view thereof.

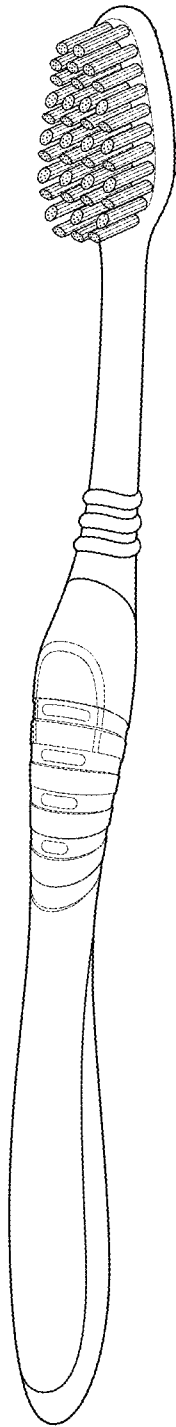

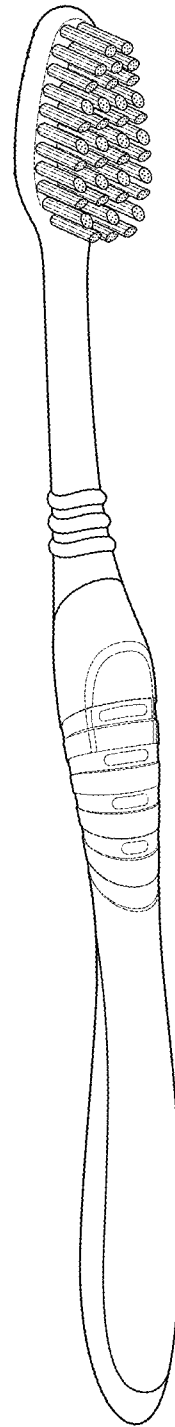

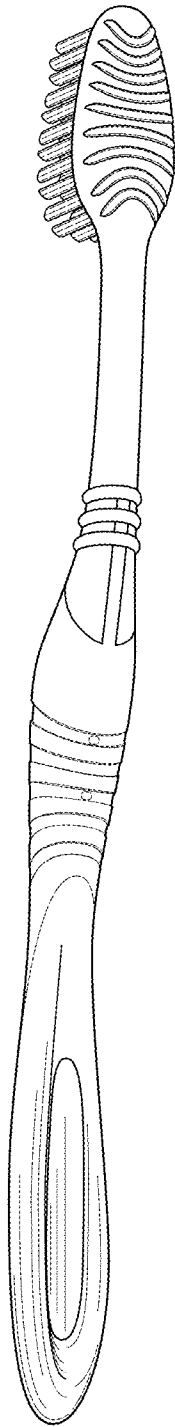

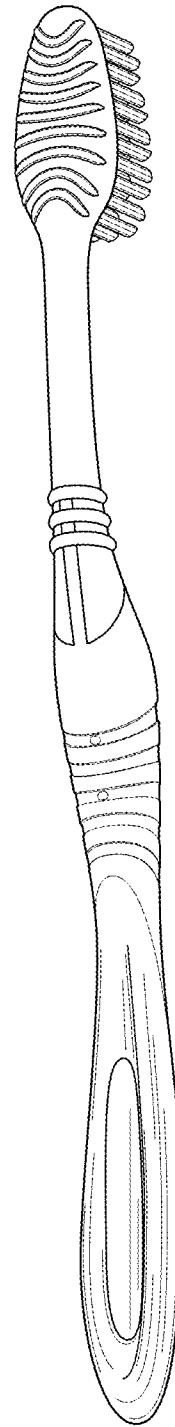

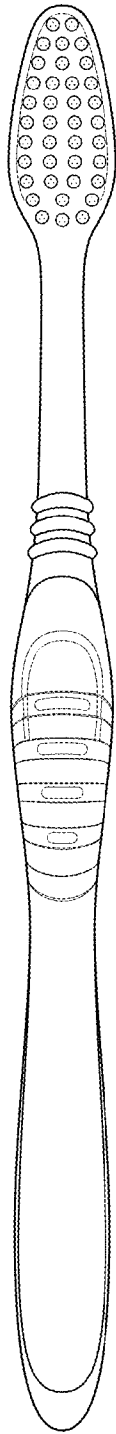

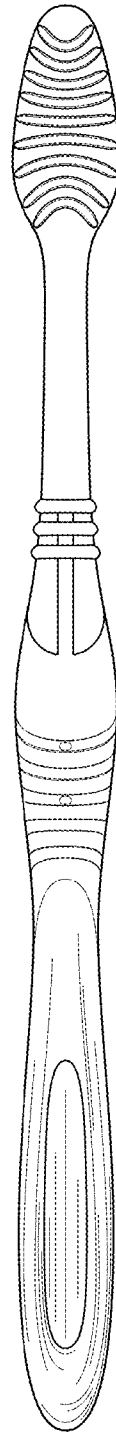

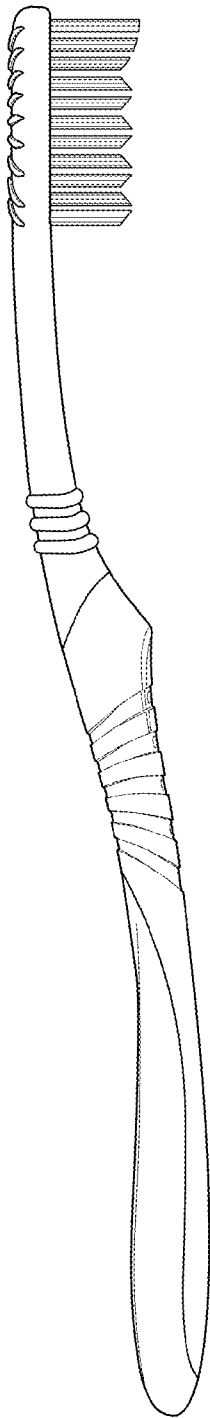

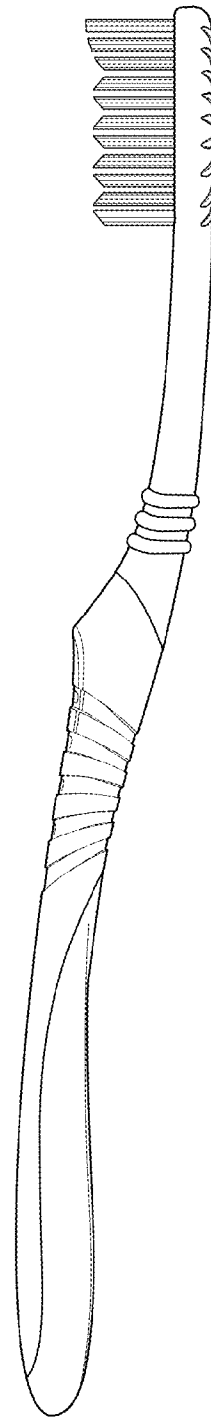

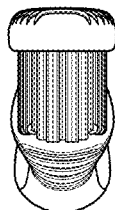

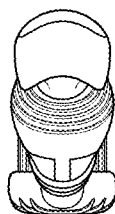
