(57) **CLAIM**

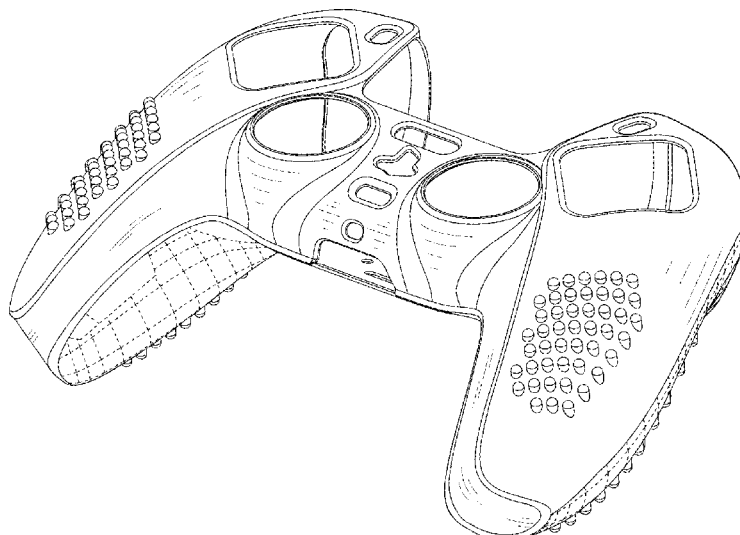
The ornamental design for a cover for game controller, as shown and described.

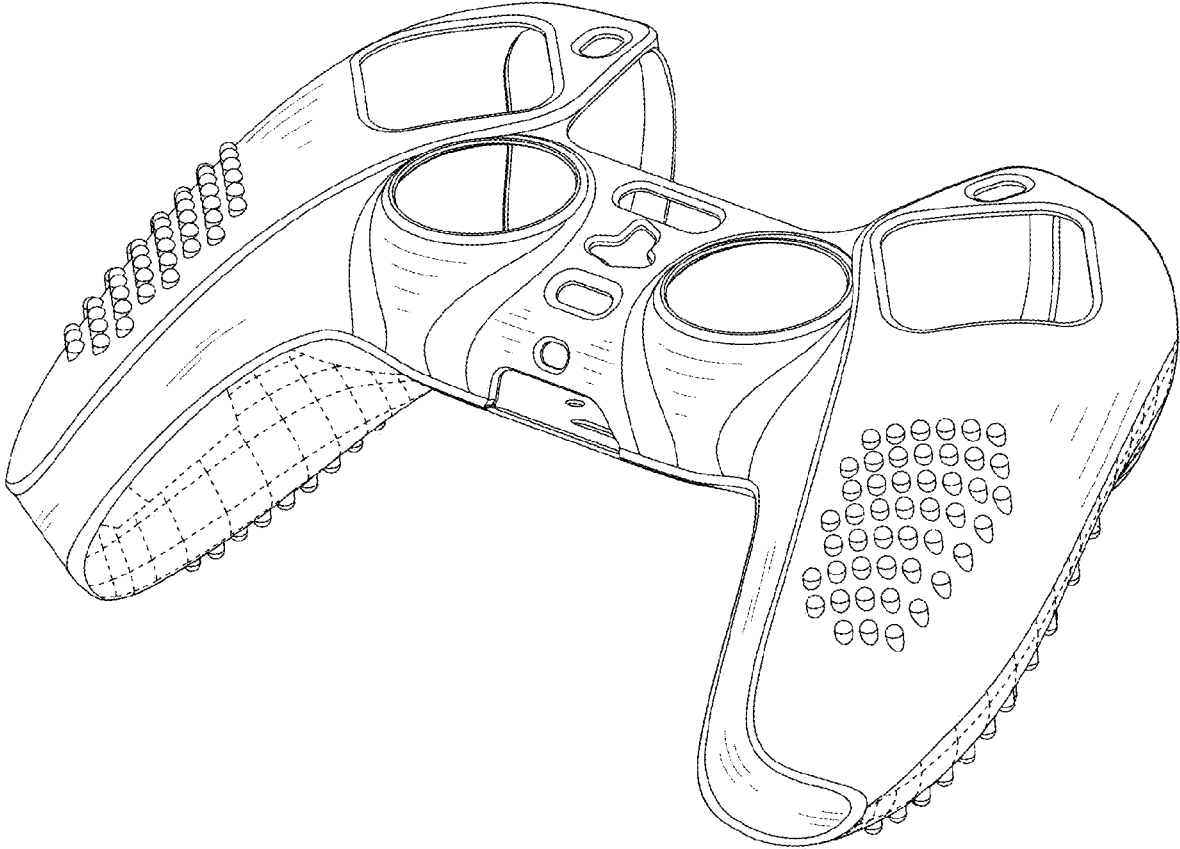

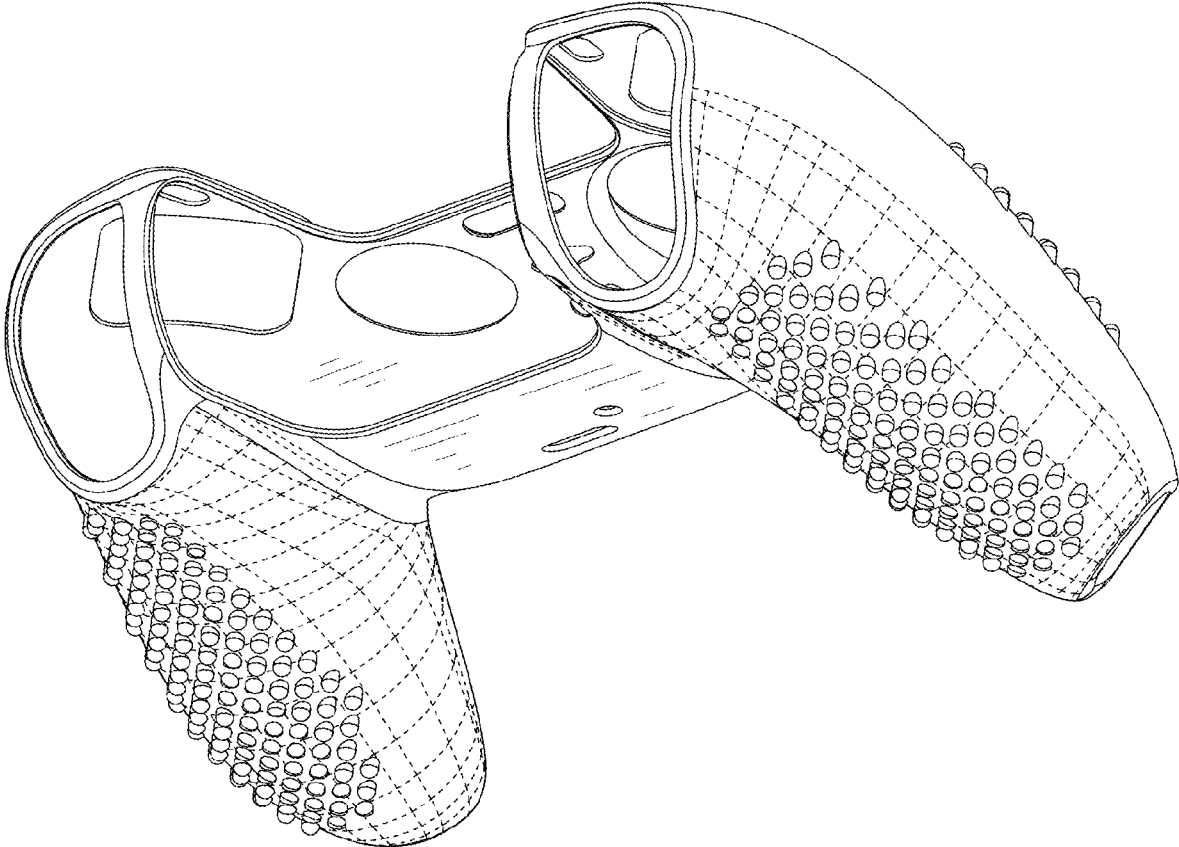

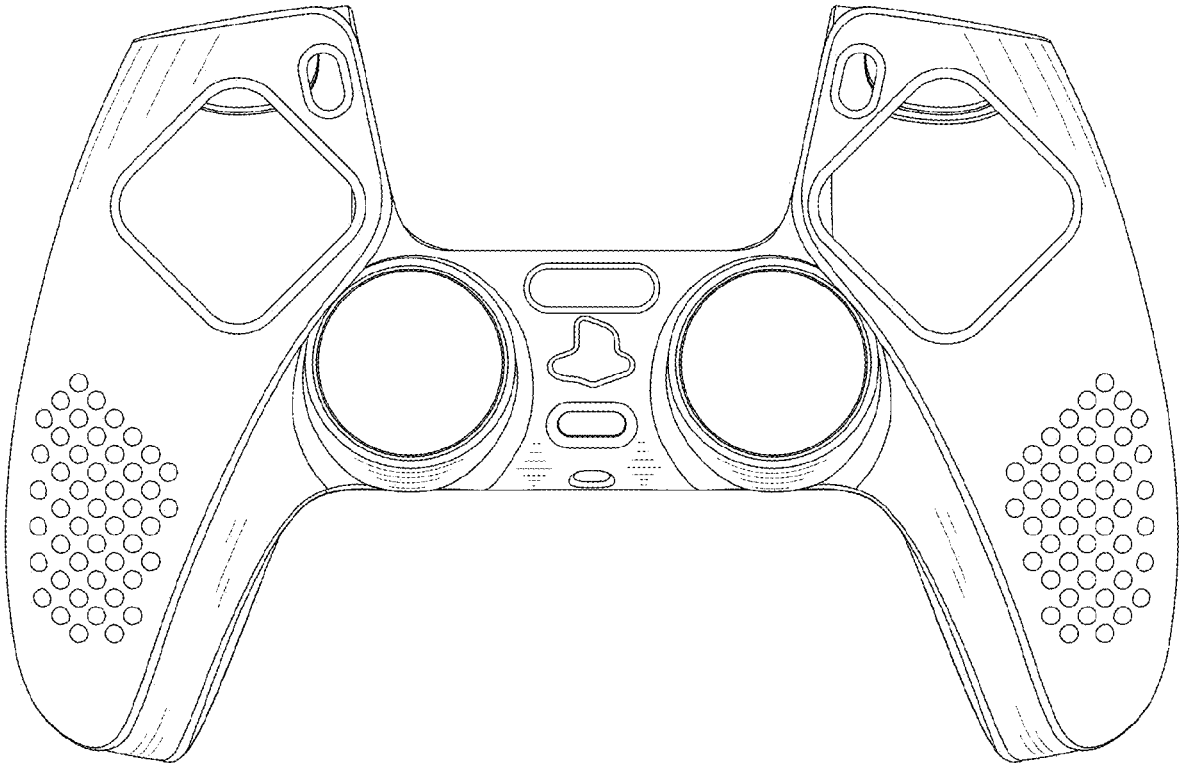

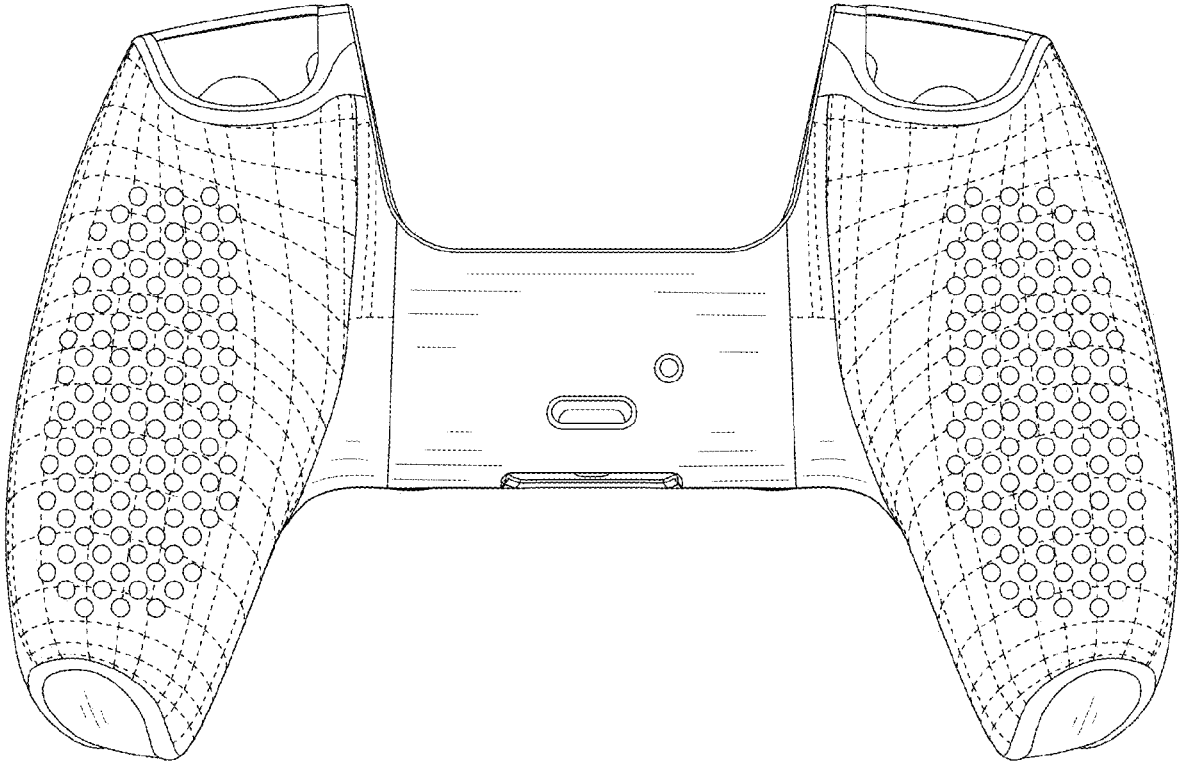

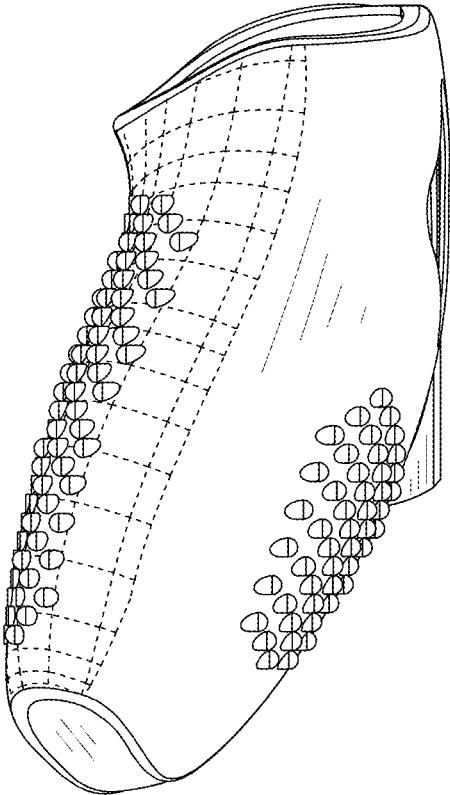

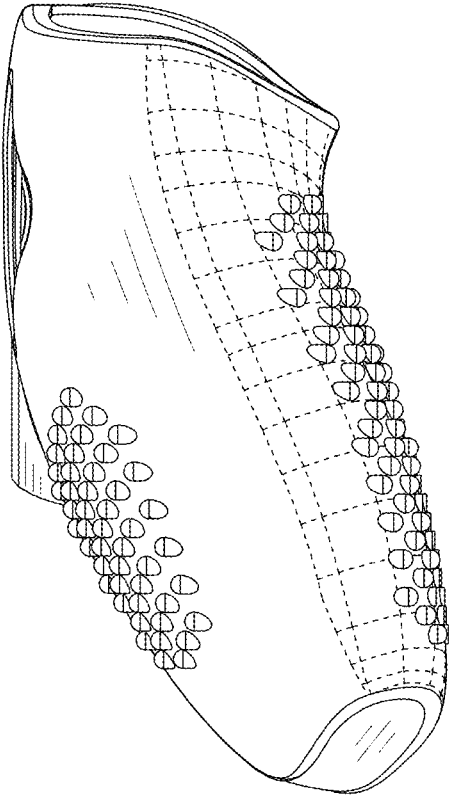

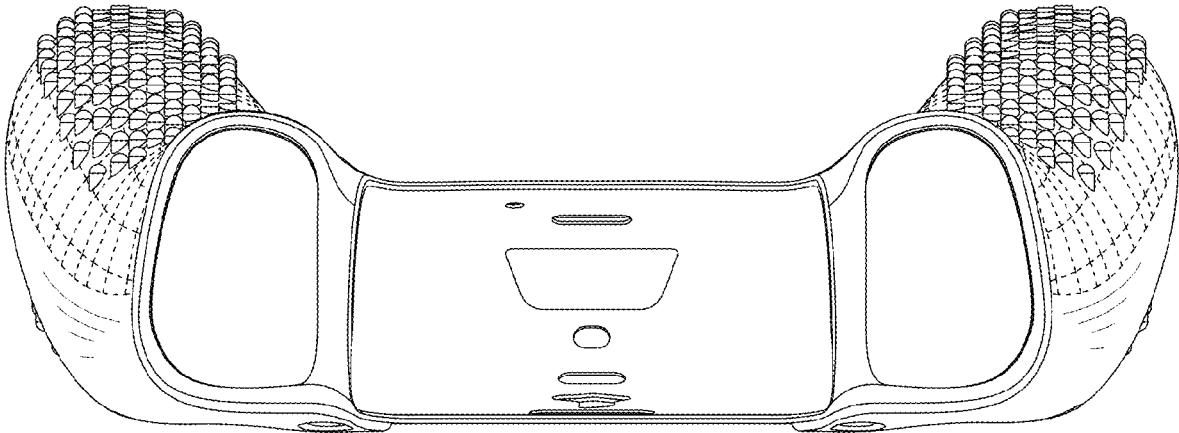

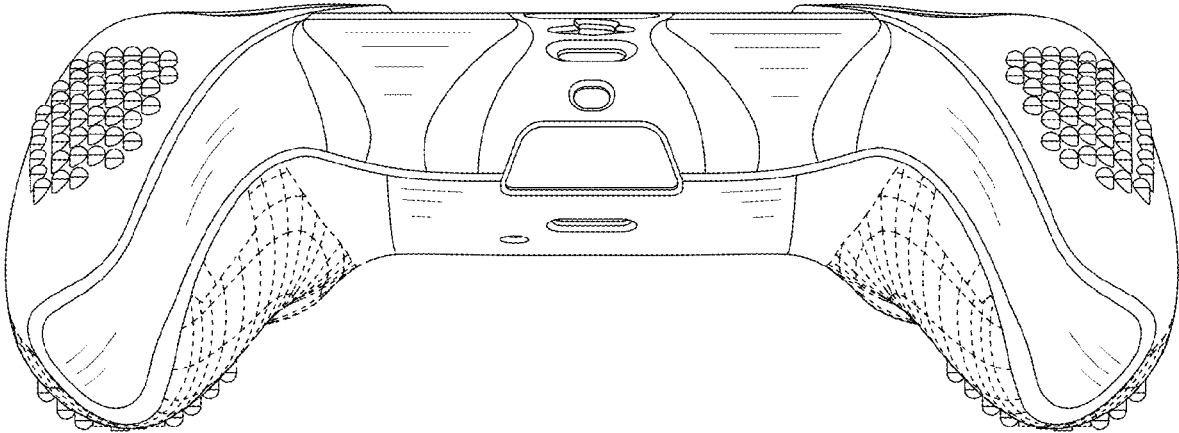
