FIG. 3 is a front view of a third image thereof; and,

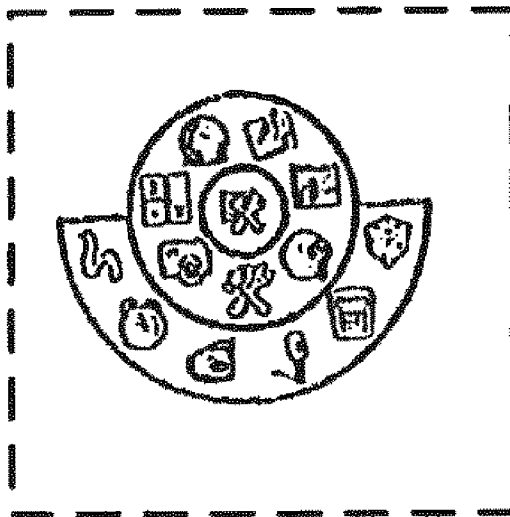
FIG. 4 is a front view of a fourth image thereof.

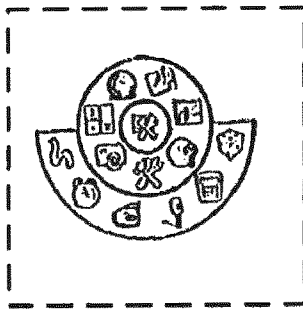

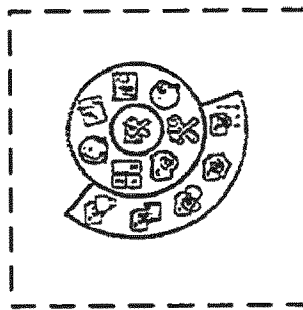

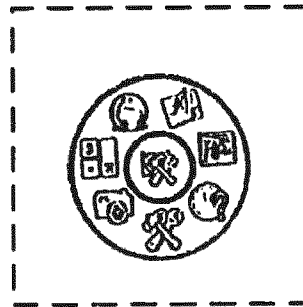

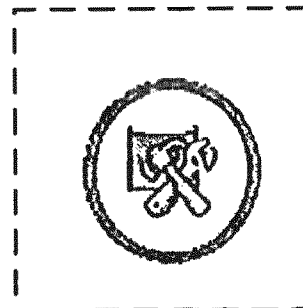
