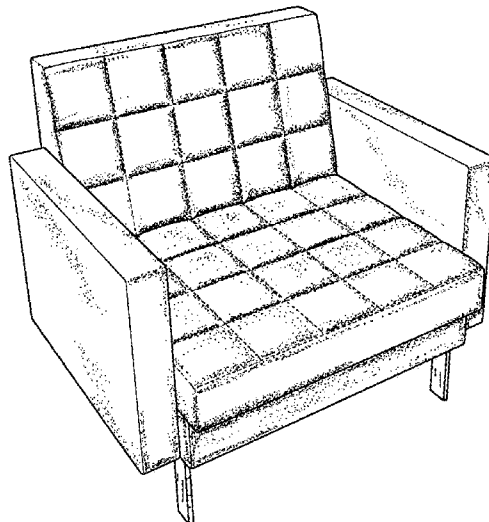
(57) **CLAIM**

The ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a left, top, front perspective view of a seat according to our new design, the bottom thereof is unseen in use;  
FIG. 2 is a top, rear perspective view from the right side thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a right side elevational view thereof, the left side elevational view thereof being a mirror image of the right side shown; and,  
FIG. 6 is a top plan view thereof.

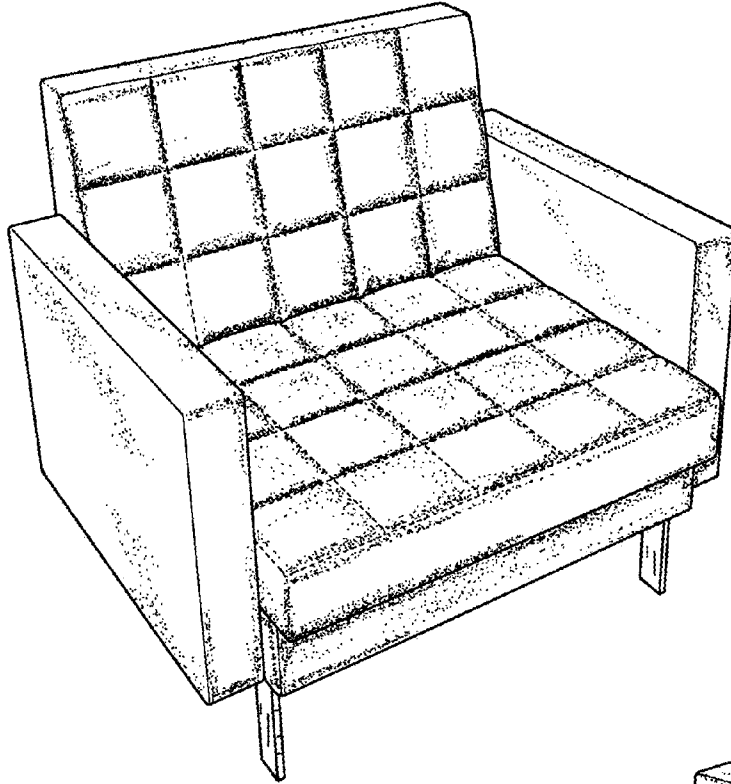

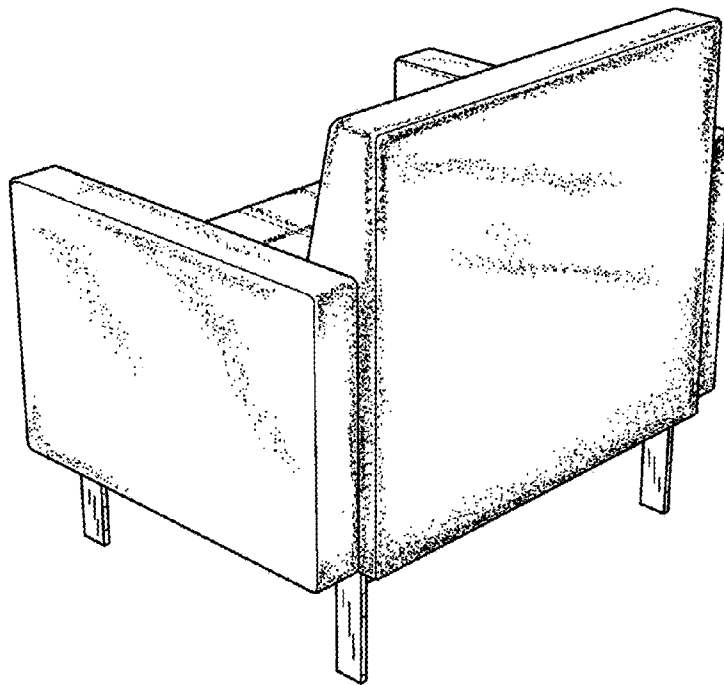

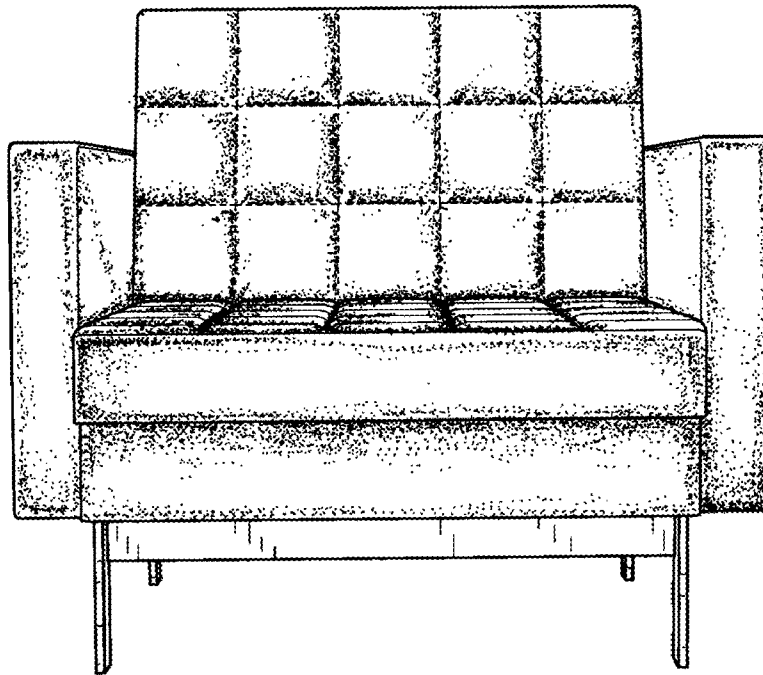

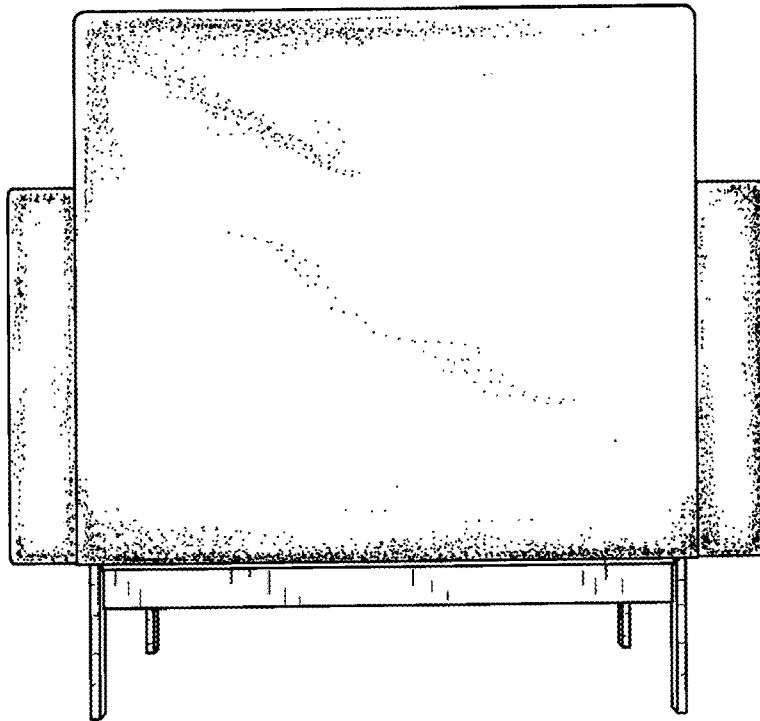

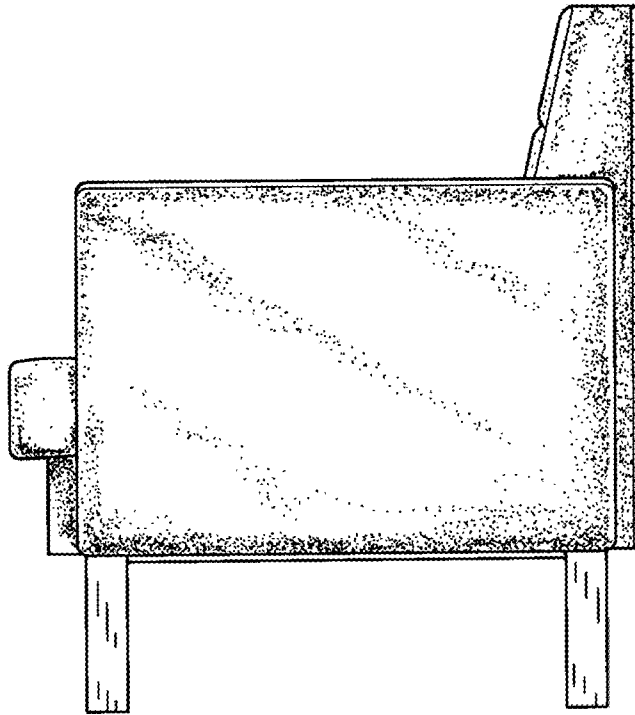

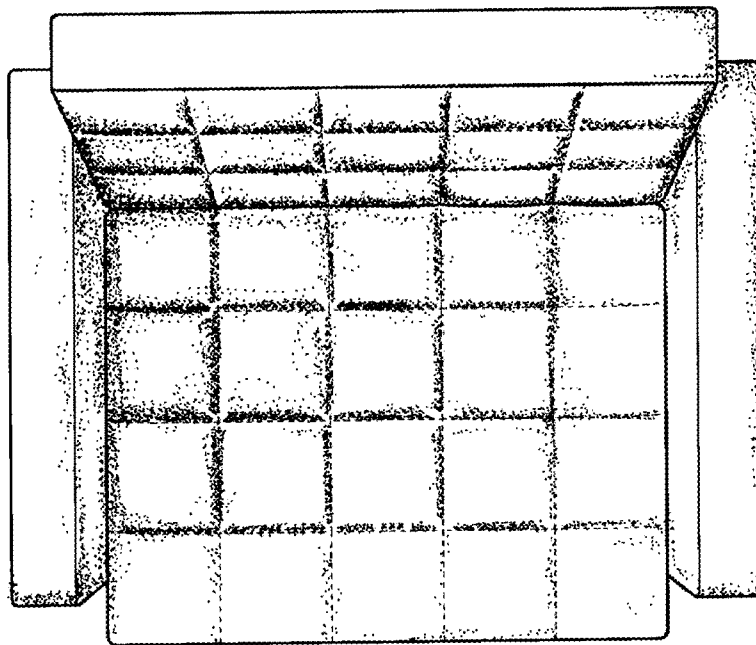
