The ornamental design for a color image for a portion of a display screen, as shown and described.

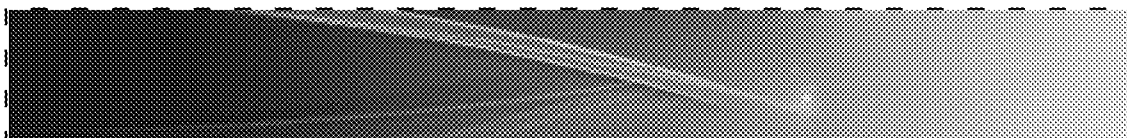
DESCRIPTION

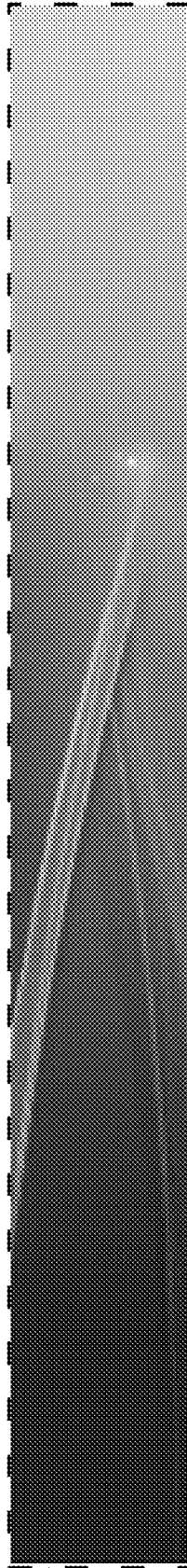
