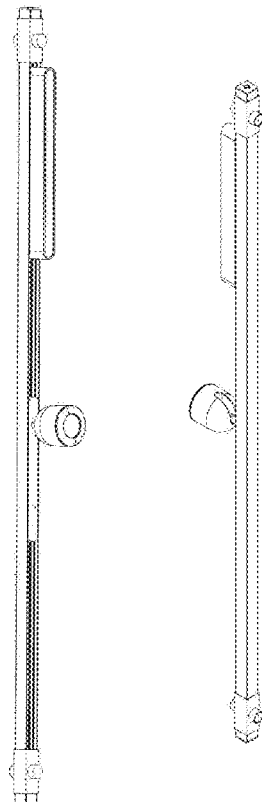
(57) **CLAIM**

I claim the ornamental design for a lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom / side perspective view of a lamp in accordance with the new design;  
FIG. 2 is a top / side perspective view thereof;  
FIG. 3 is a side view thereof, the opposite side view being symmetrical;  
FIG. 4 is a top view thereof; and,  
FIG. 5 is a front view thereof, the opposite side view being symmetrical.

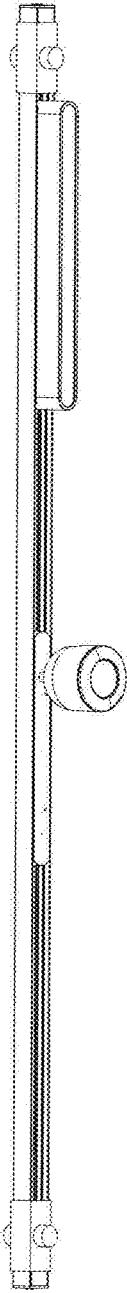

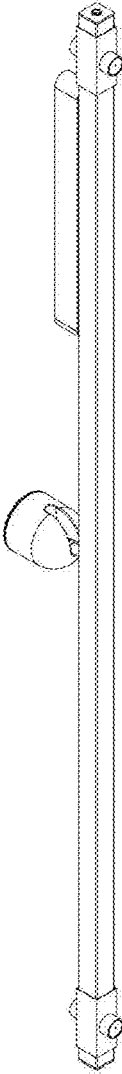

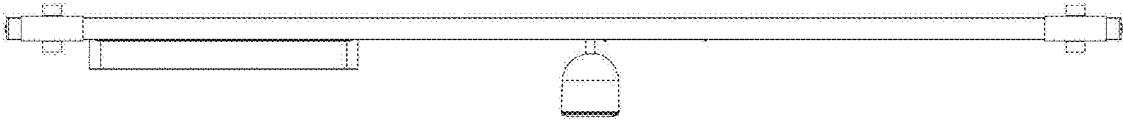

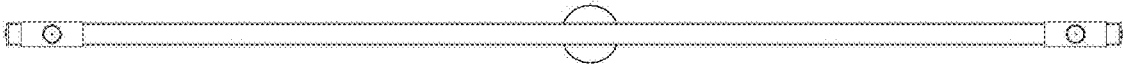

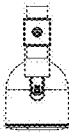
