(57) **CLAIM**

The ornamental design for a luggage, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a piece of luggage showing our new, original and ornamental design embodied therein, in accordance with the present invention;

FIG. 2 is a rear perspective view of the piece of luggage of FIG. 1;

FIG. 3 is an elevated front view of the piece of luggage of FIG. 1;

FIG. 4 is an elevated rear view of the piece of luggage of FIG. 1;

FIG. 5 is a top view of the piece of luggage of FIG. 1;

FIG. 6 is a bottom view of the piece of luggage of FIG. 1;

FIG. 7 is a first elevated side view of the piece of luggage of FIG. 1; and,

FIG. 8 is a second elevated side view of the piece of luggage of FIG. 1.

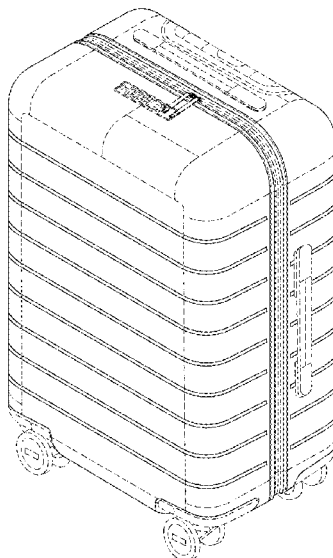

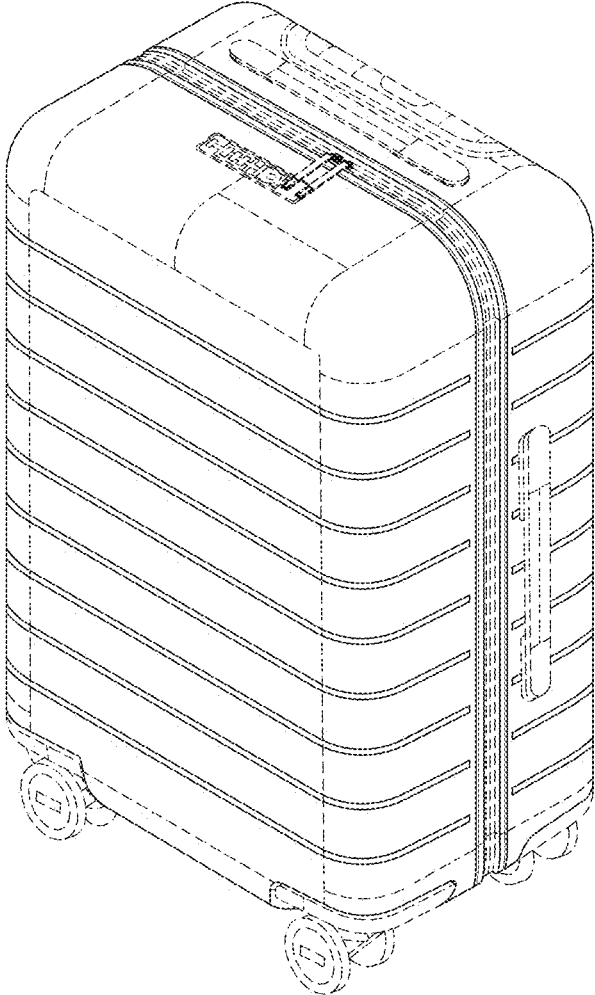

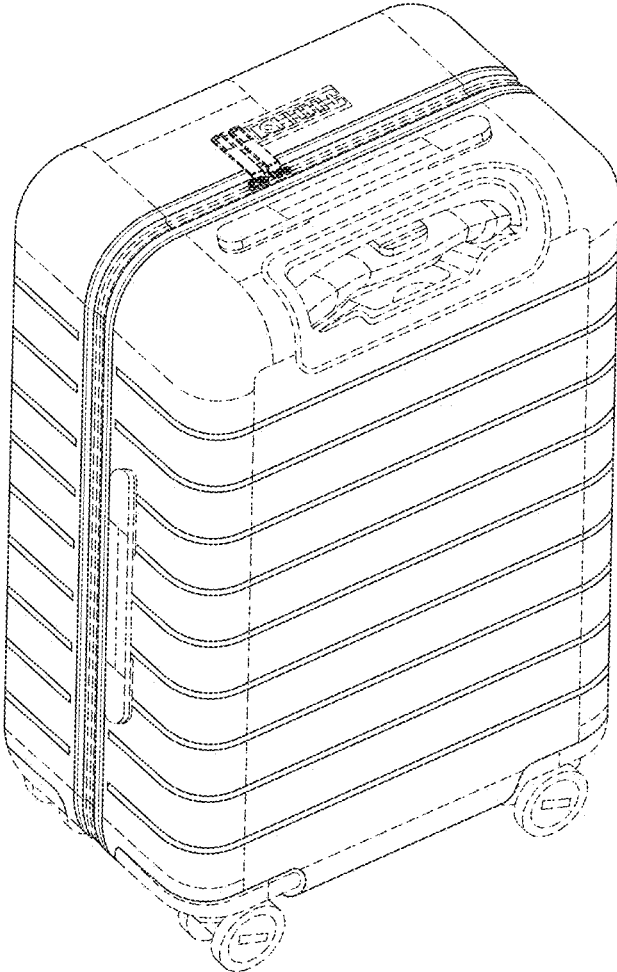

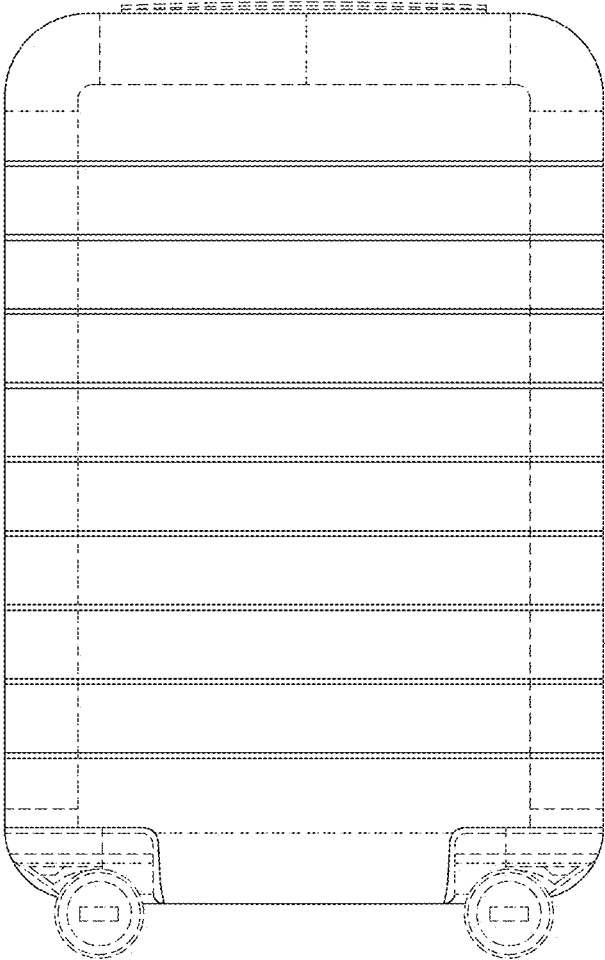

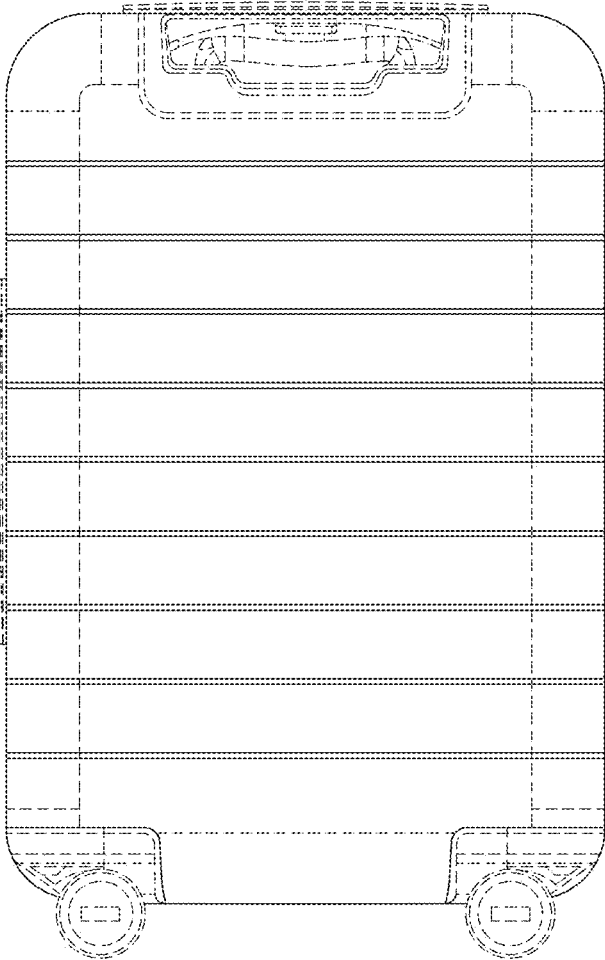

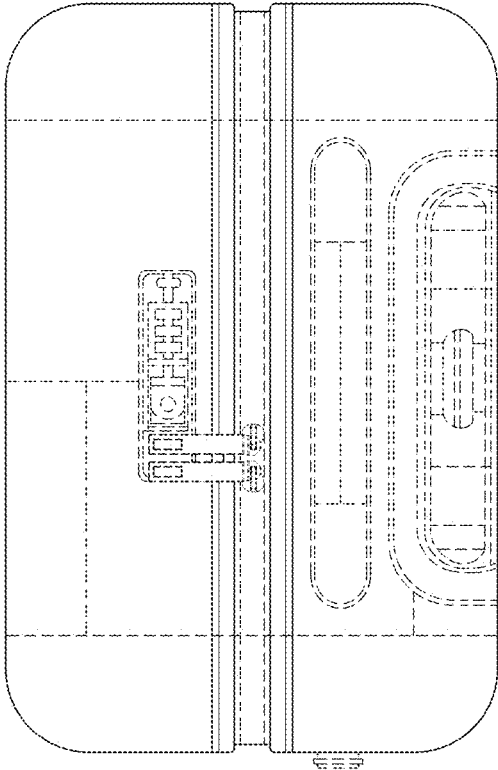

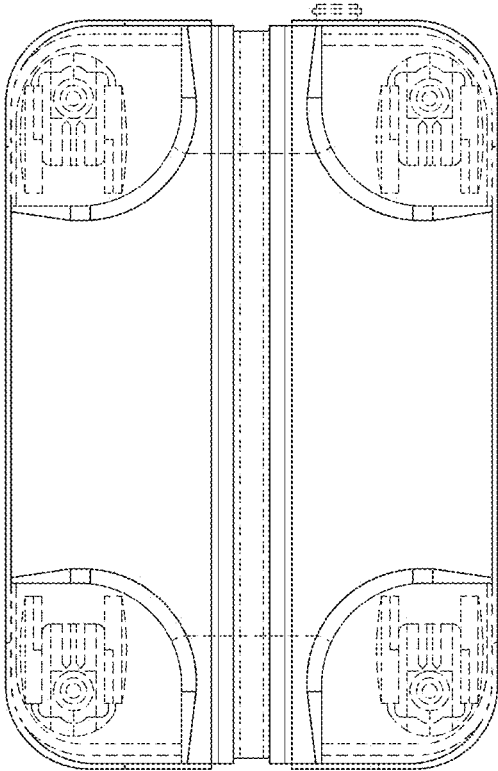

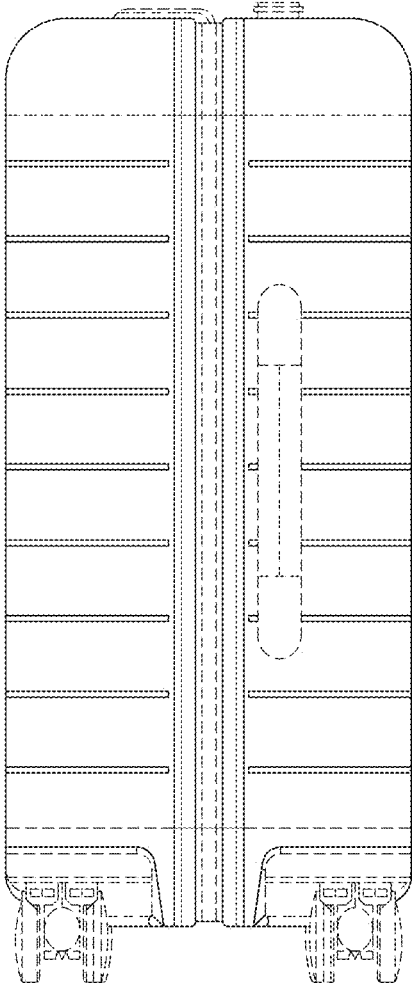

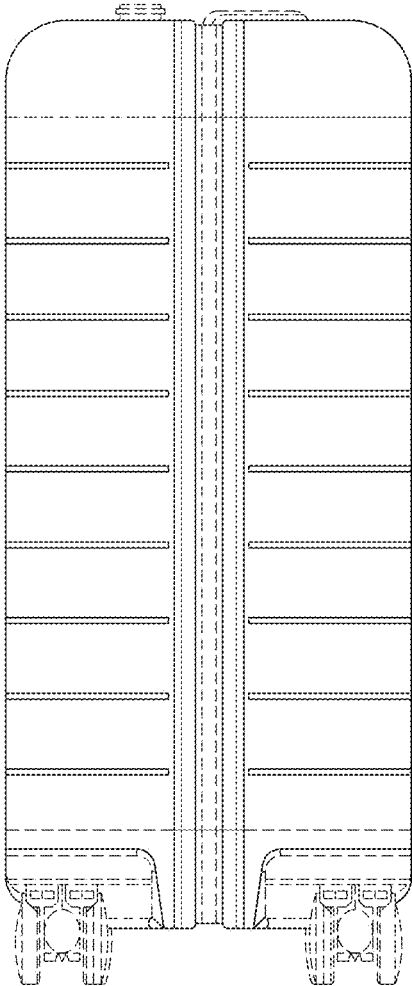
