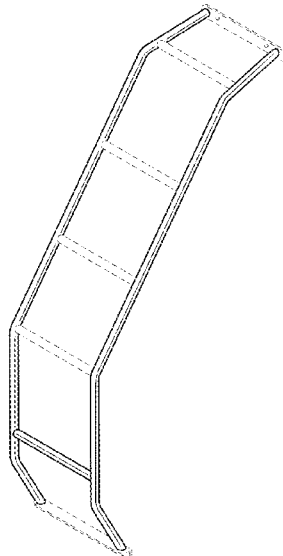
(57) **CLAIM**

The ornamental design for a vehicle ladder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the vehicle ladder, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right elevation view thereof;
FIG. 5 is a left elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front elevation view thereof shown in a condition of use.
The broken lines on the ladder depict portions of the vehicle ladder that form no part of the claimed design. The broken lines in FIG. 8 showing a vehicle, illustrate environmental structure that forms no part of the claimed design.

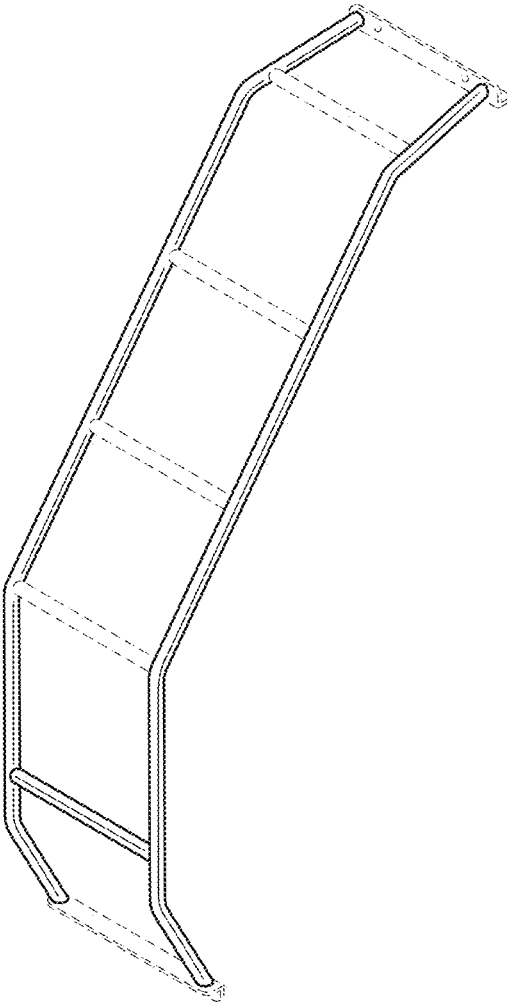

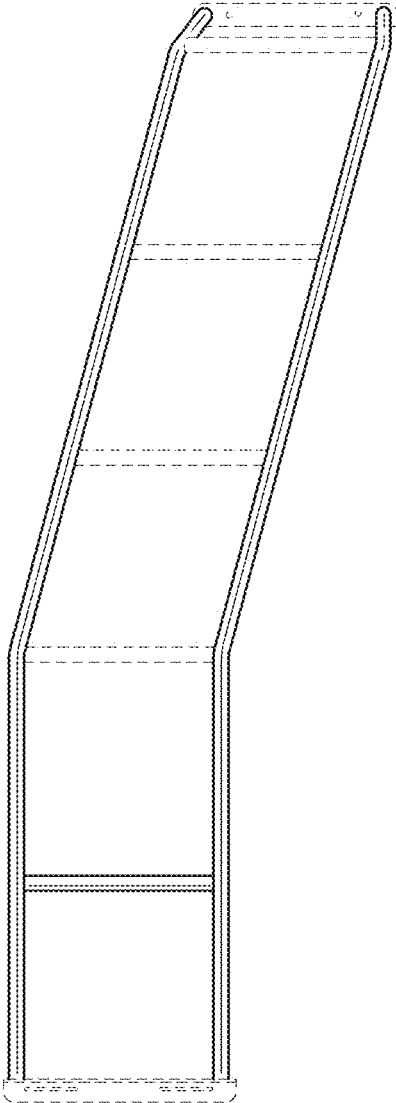

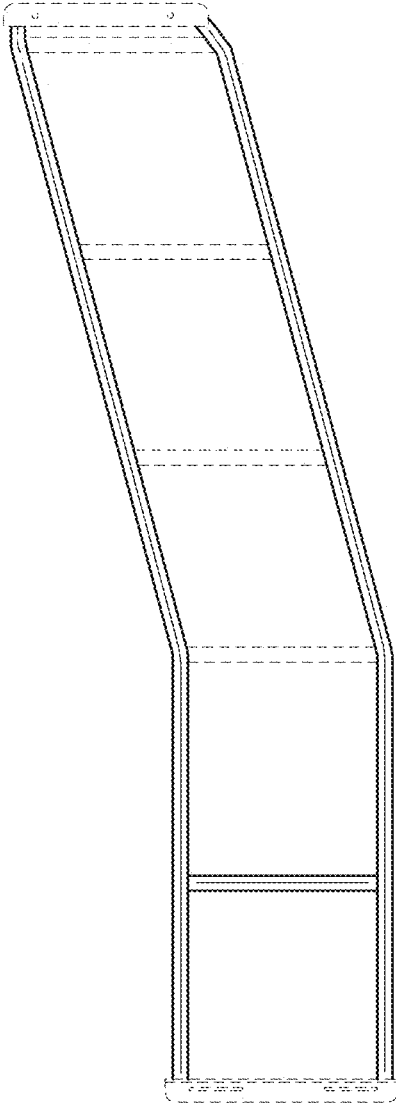

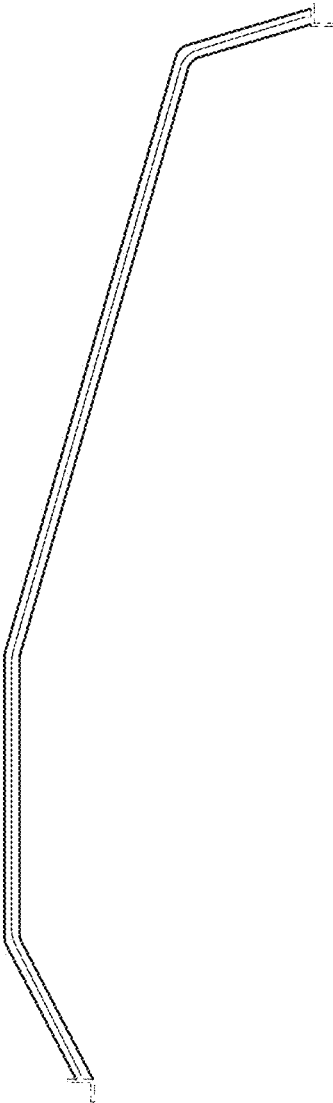

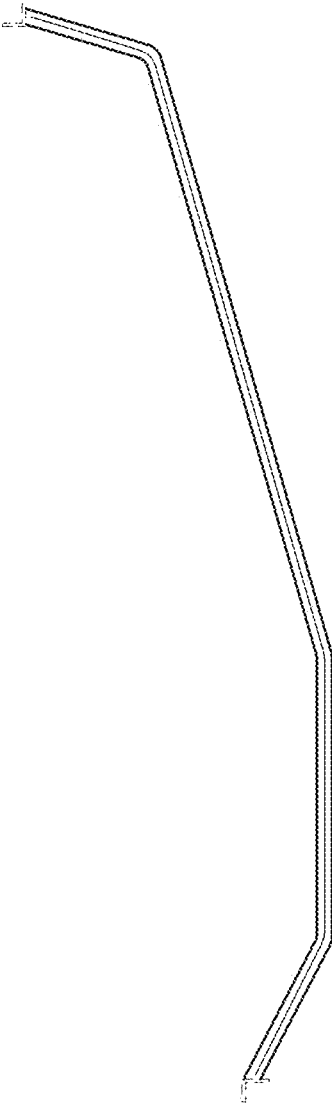

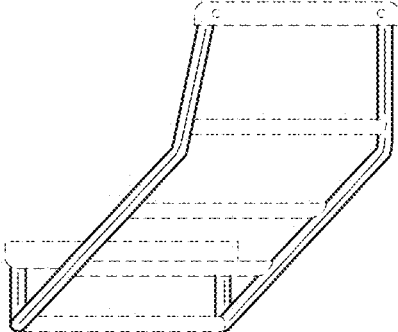

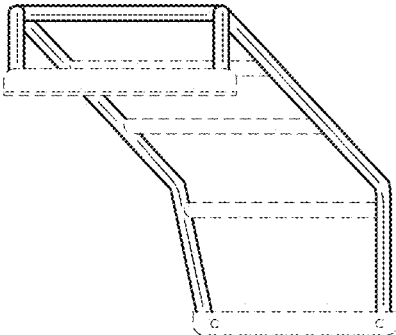

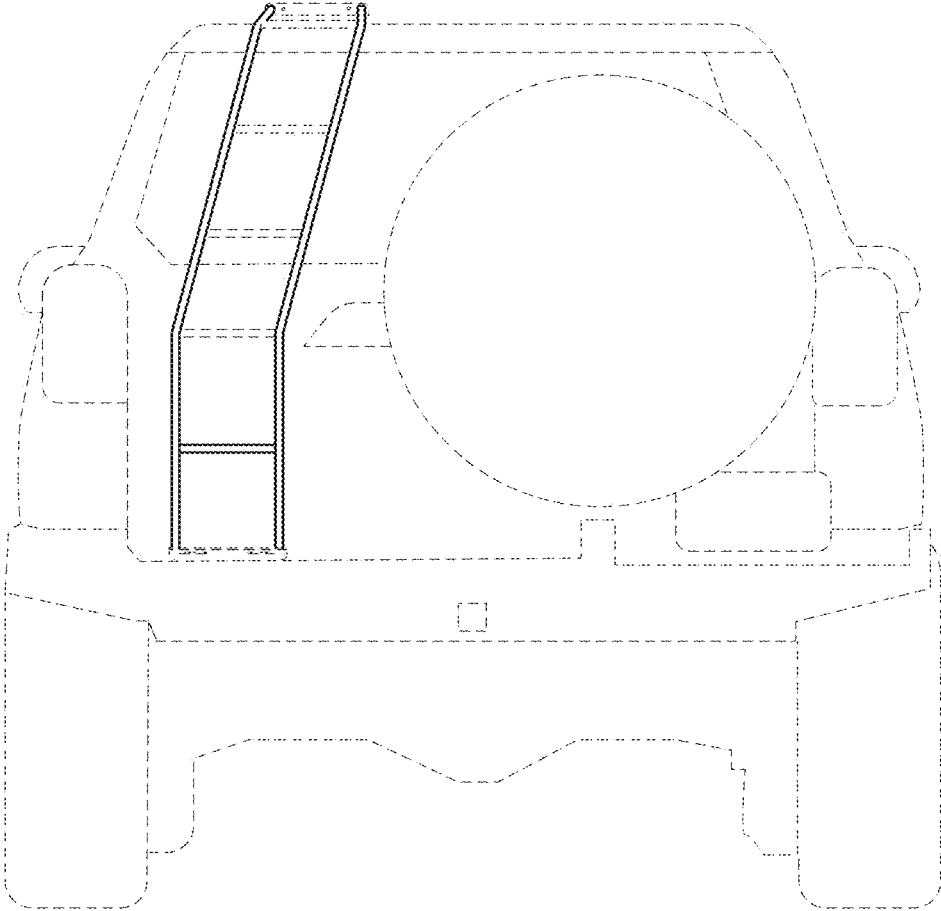
