DESCRIPTION

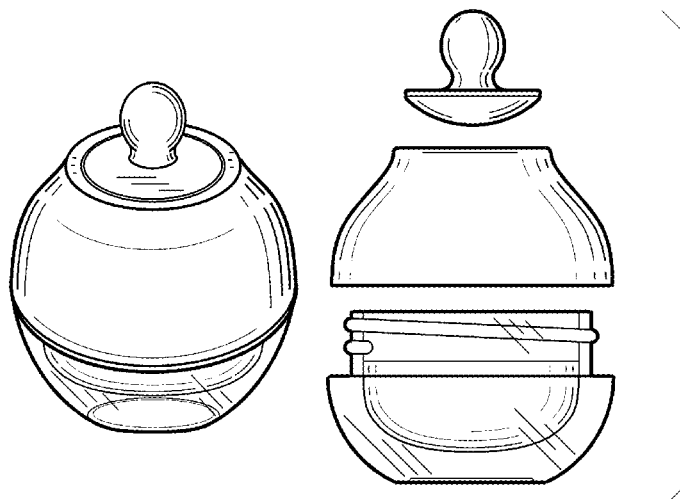
FIG. 1 is a perspective view of my new design for a cosmetic jar;

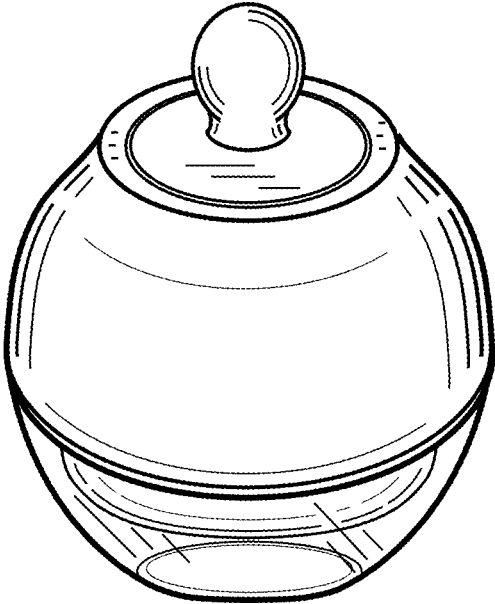

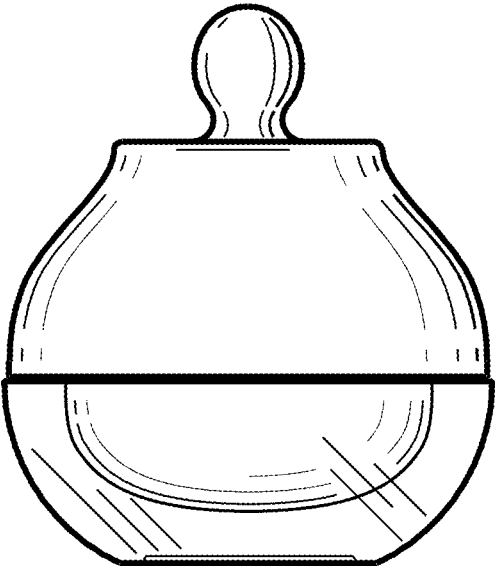

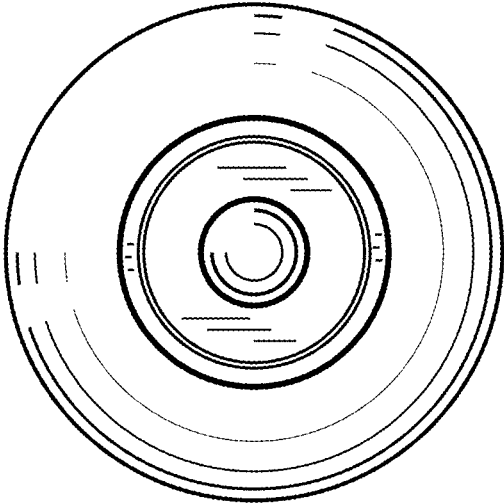

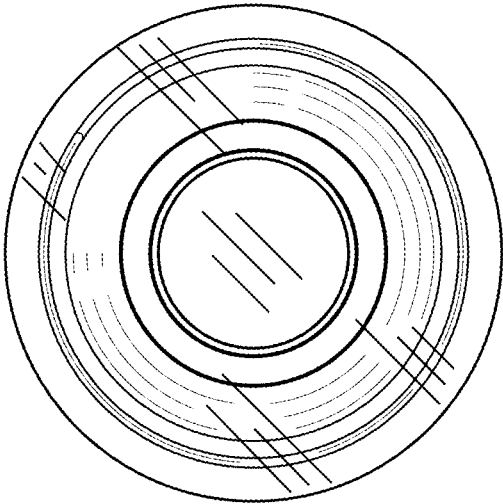
