54 **Wrapped coin roll and method and apparatus for forming same.**

57 A coin wrapping mechanism and method for wrapping rolls of coins and thus formed wrapped coin roll, the mechanism comprising coin stacking means (11,12) for forming a coin stack (10) containing a predetermined number of coins; means (20) for supporting the coin stack for rotation about its axis; means (21) for rotating the coin stack about its axis while pressing a wrapping material (30) against the coin stack, the wrapping material (30) having a coating of a pressure-sensitive, releasable adhesive (31) on the side facing the coin stack (10) so that the adhesive adheres to, and is wound around, the coin stack (10); and means (40,42) for removing the coin stack (10) from the rotating means (23) after the desired length of wrapping material (30) has been wound around the coins.

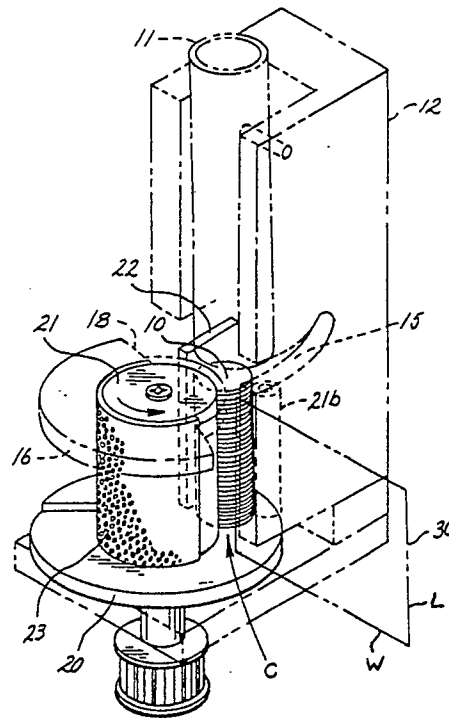

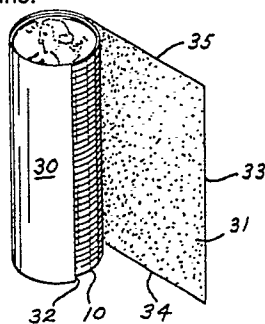
