FIG. 5 is an opposite side front perspective view thereof.

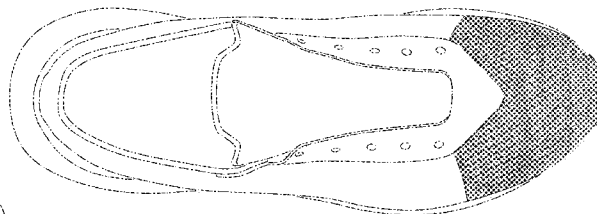
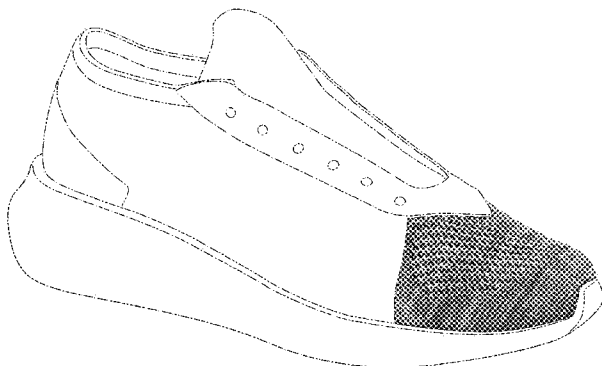

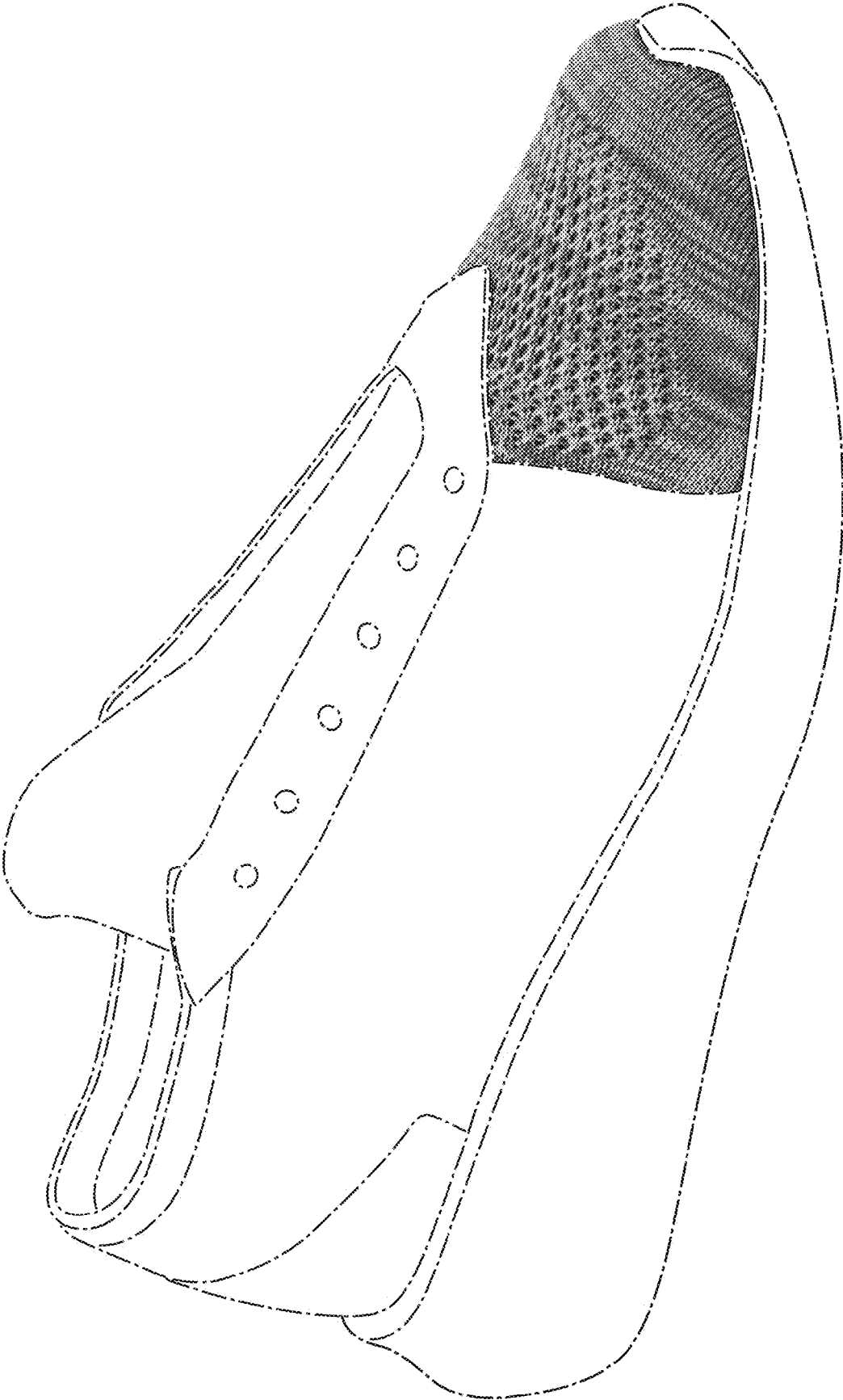

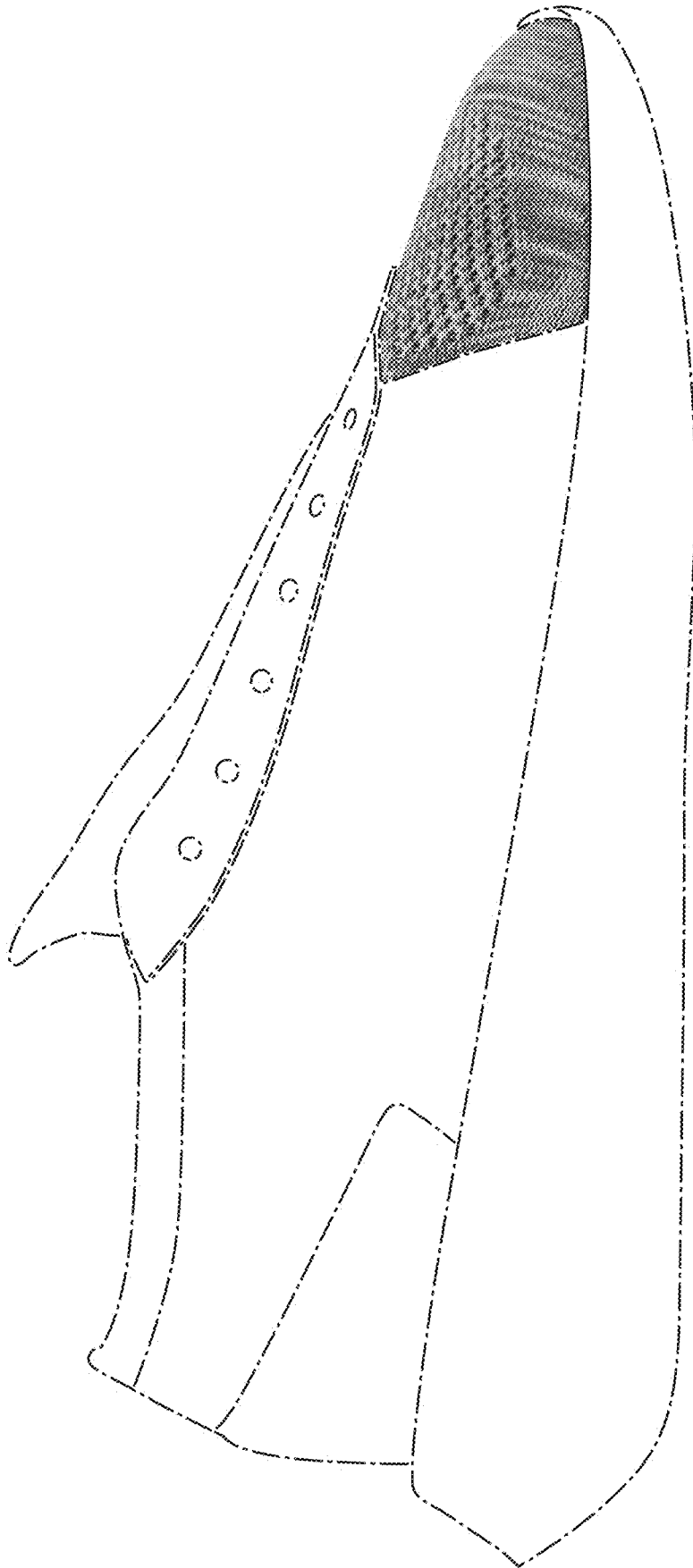

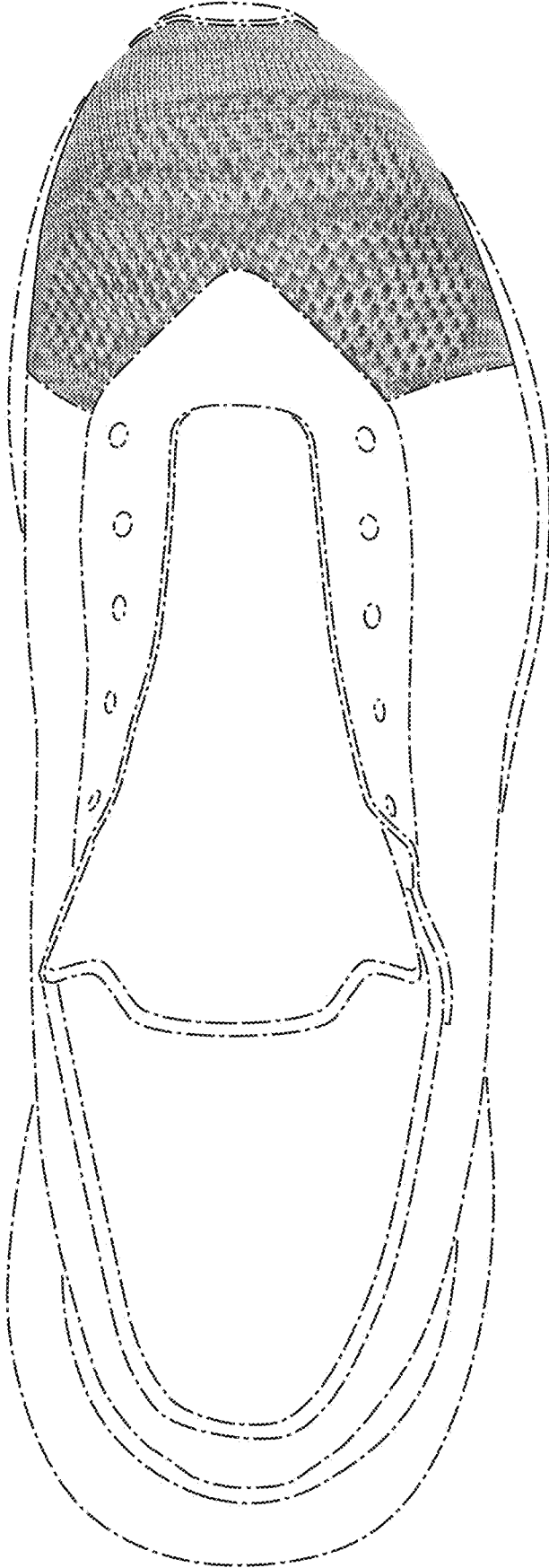

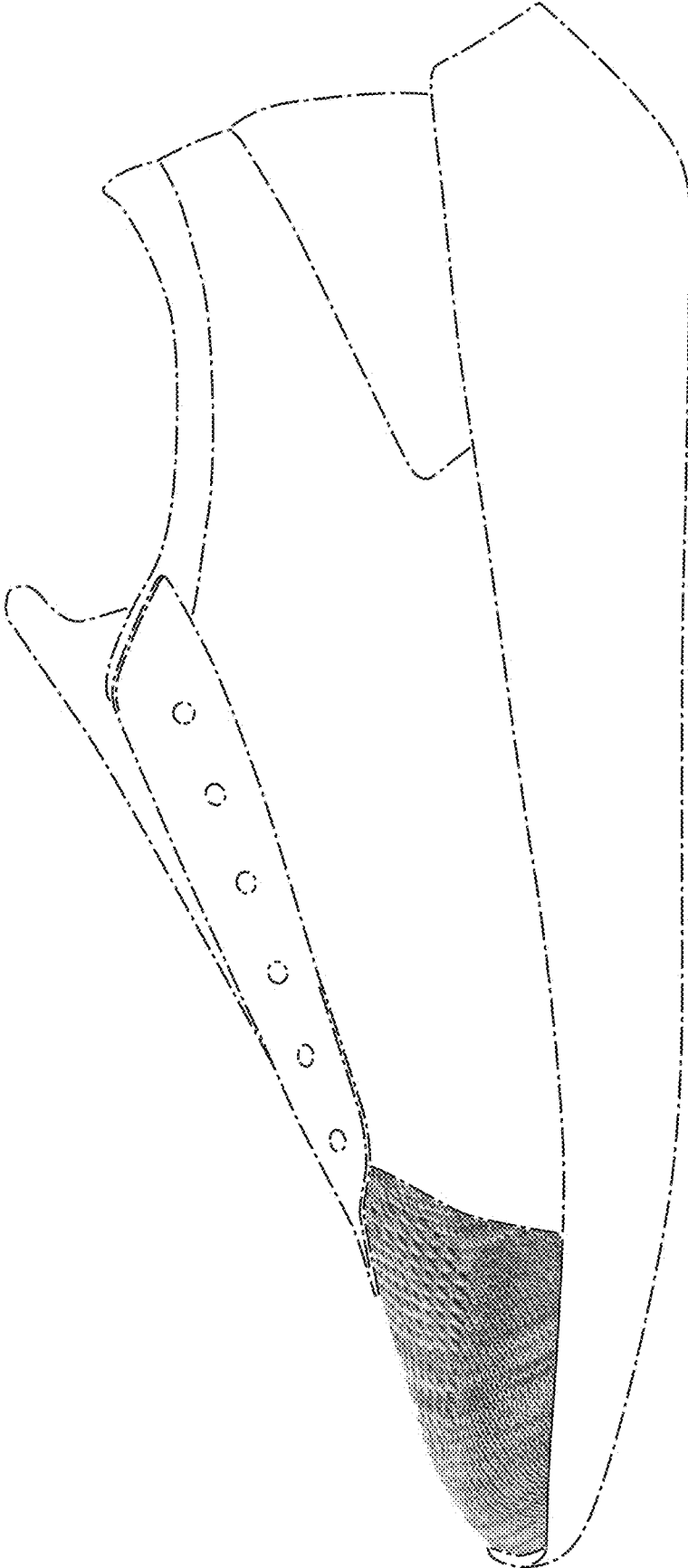

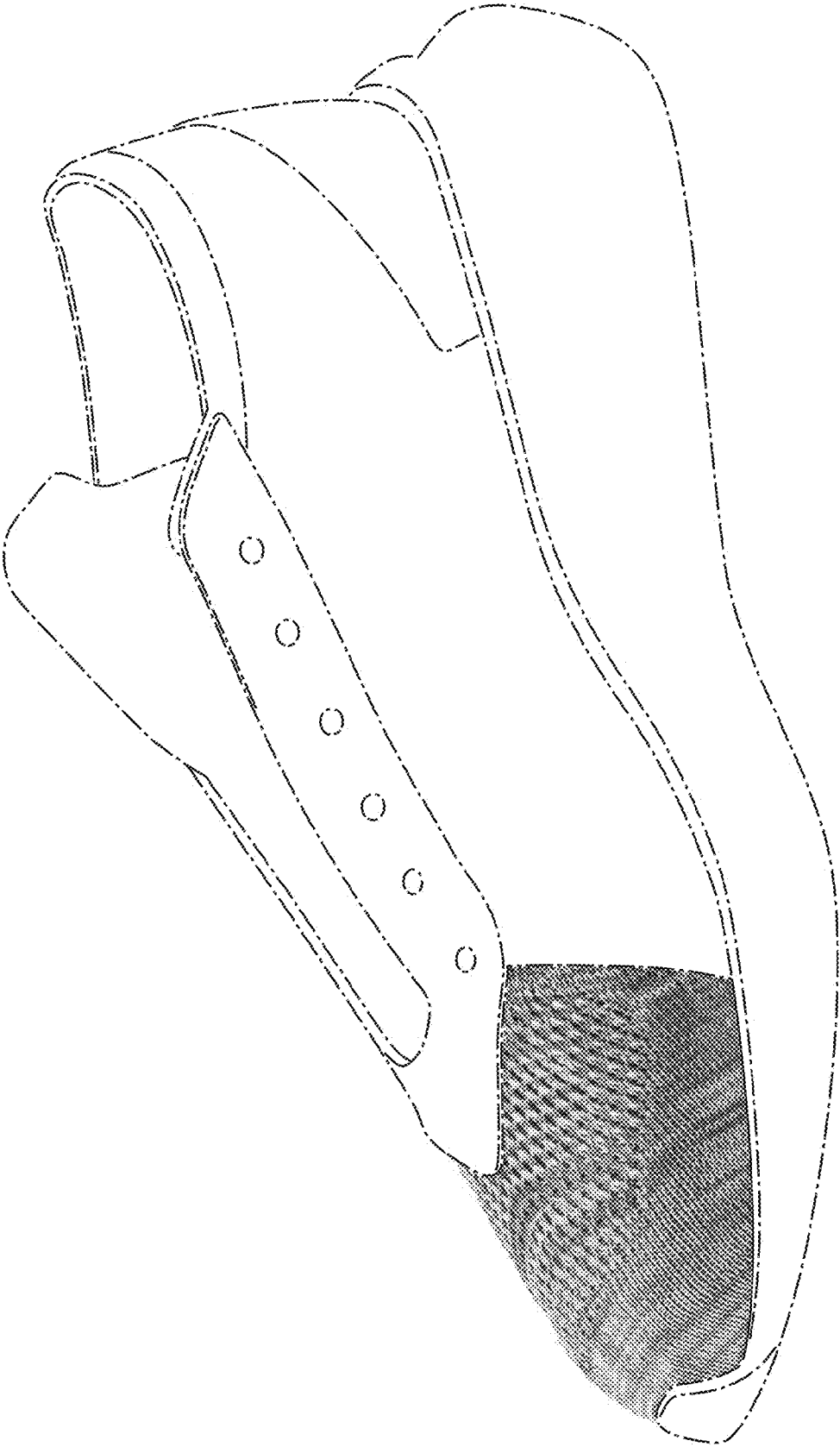
