The ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a toothbrush embodying the new design;

FIG. 2 is a front elevational view of the toothbrush of FIG. 1;

FIG. 3 is a rear elevational view of the toothbrush of FIG. 1;

FIG. 4 is a top plan view of the toothbrush of FIG. 1;

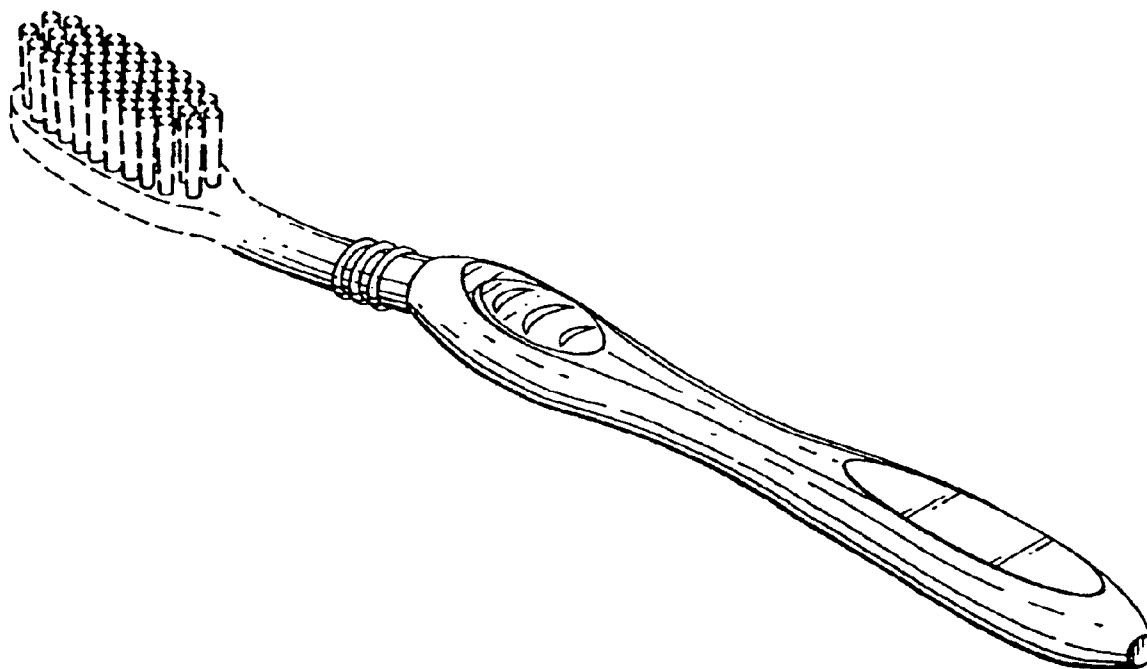
FIG. 5 is a bottom plan view of the toothbrush of FIG. 1;

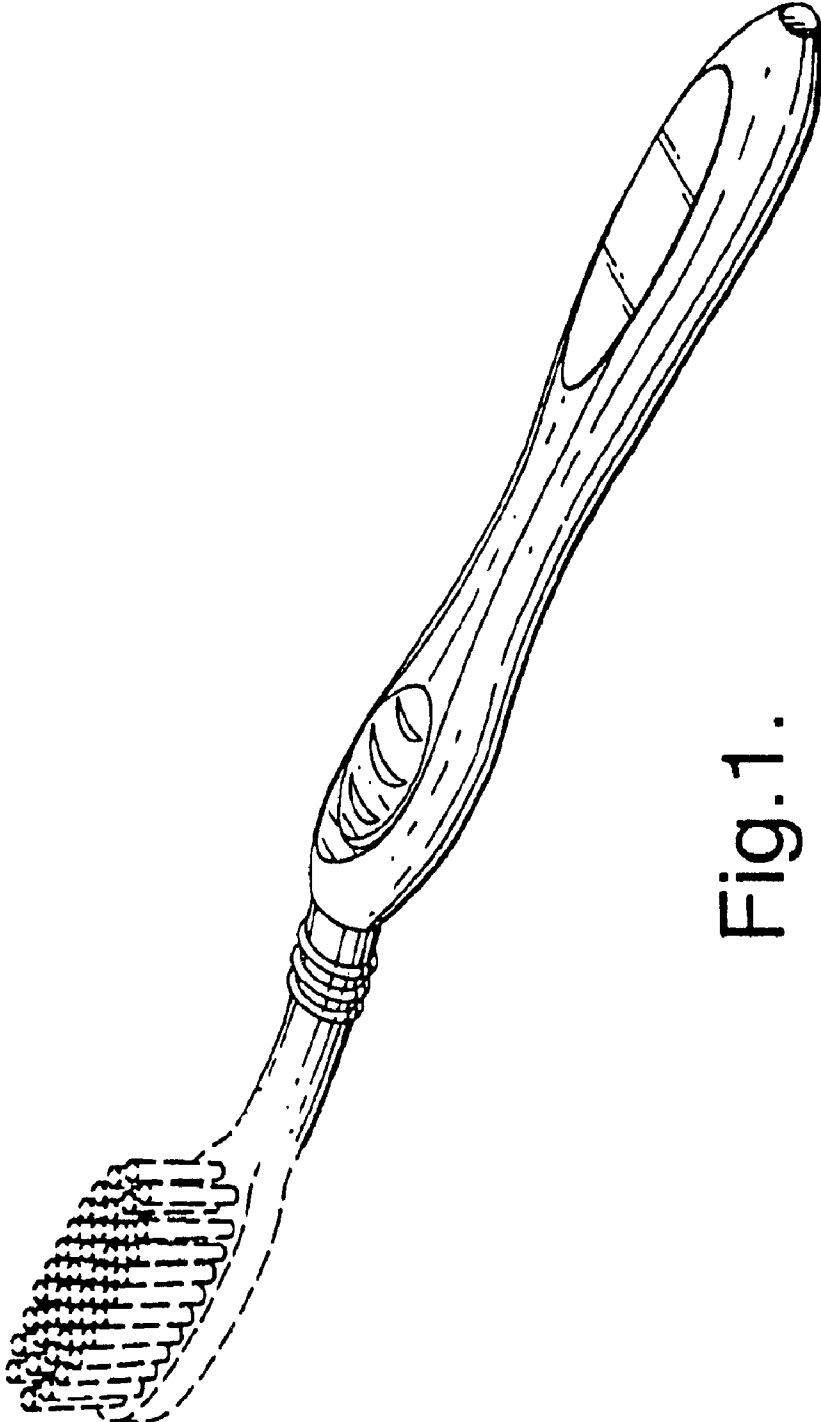

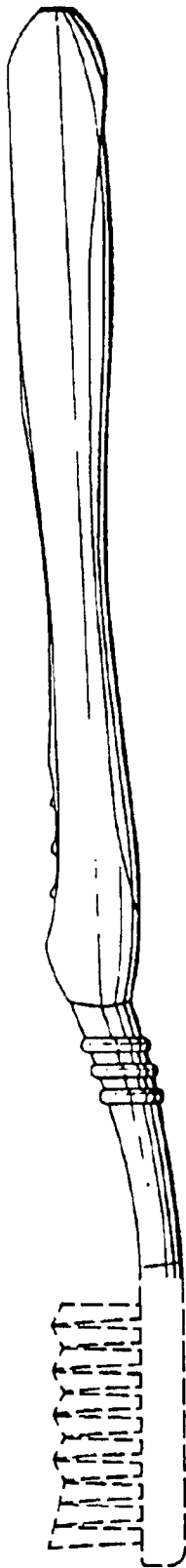

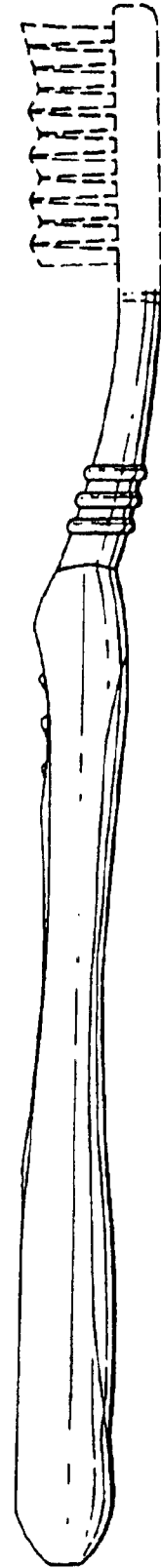

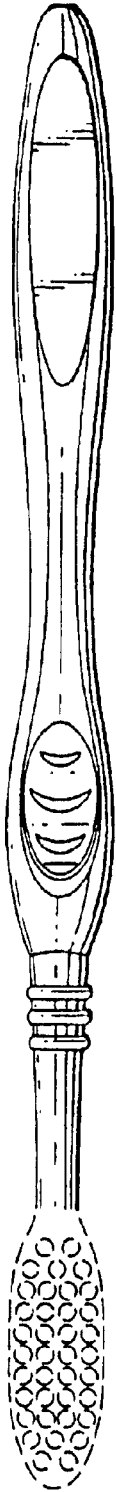

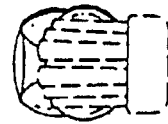

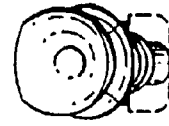
