FIG. 1 is a front view of a first embodiment of an electronic device with graphical user interface, showing the claimed design;

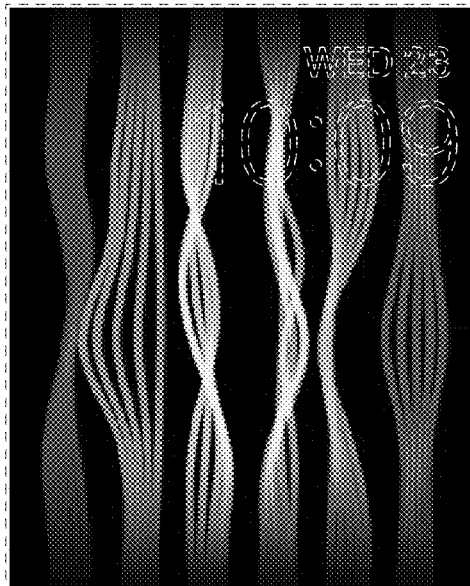

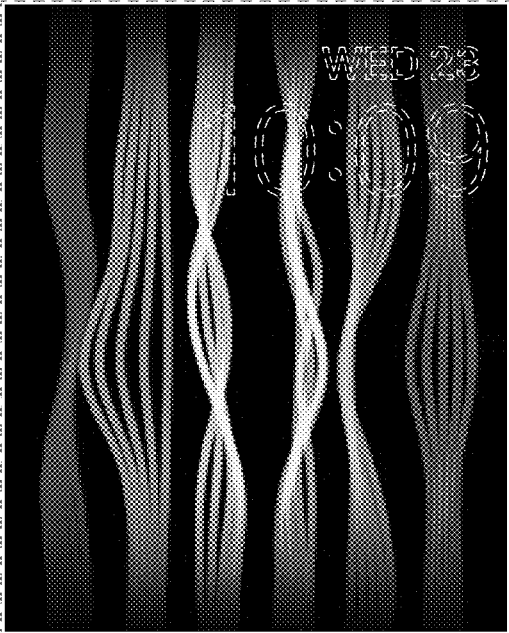

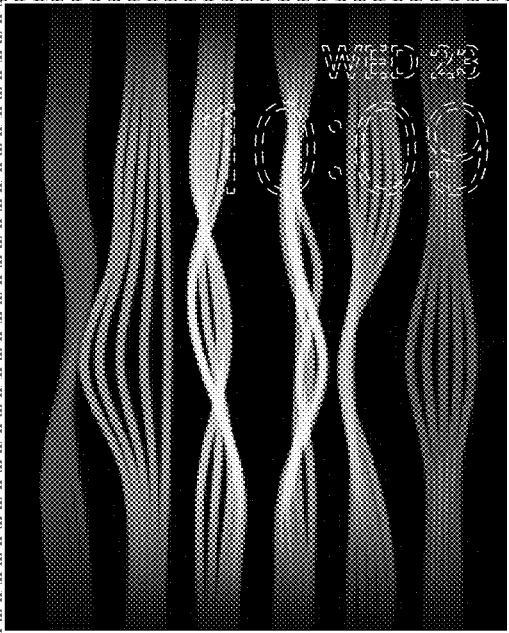

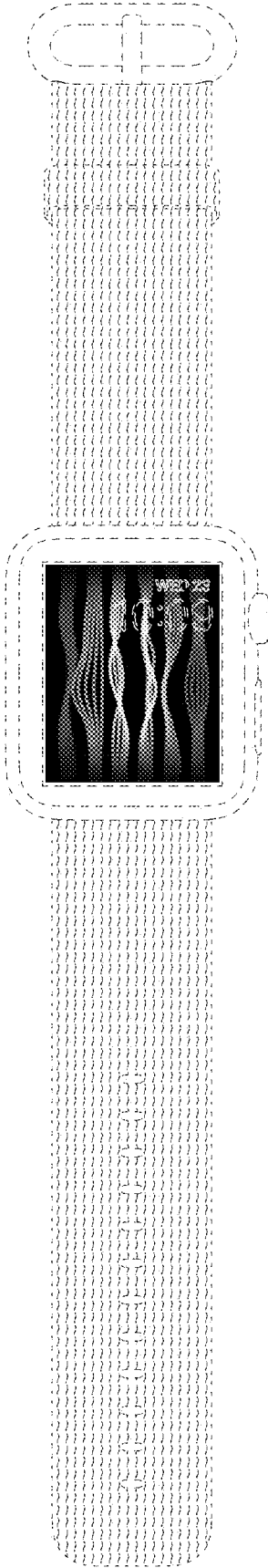
