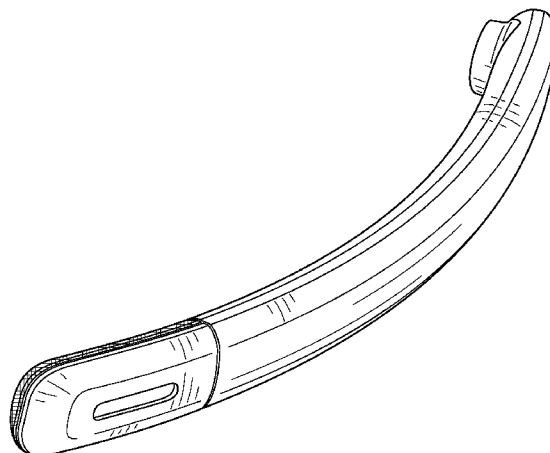
The ornamental design for a microphone boom, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a microphone boom showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a left side view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a top view thereof;  
 FIG. 7 is a bottom view thereof;  
 FIG. 8 is a perspective view of the microphone boom of FIGS. 1-7, shown attached to a disclaimed headset;  
 FIG. 9 is a perspective view of the microphone boom of FIGS. 1-7, shown without shading and with no disclaimed elements in broken lines;  
 FIG. 10 is a front view thereof;  
 FIG. 11 is a rear view thereof;  
 FIG. 12 is a left side view thereof;  
 FIG. 13 is a right side view thereof;  
 FIG. 14 is a top view thereof; and,  
 FIG. 15 is a bottom view thereof.

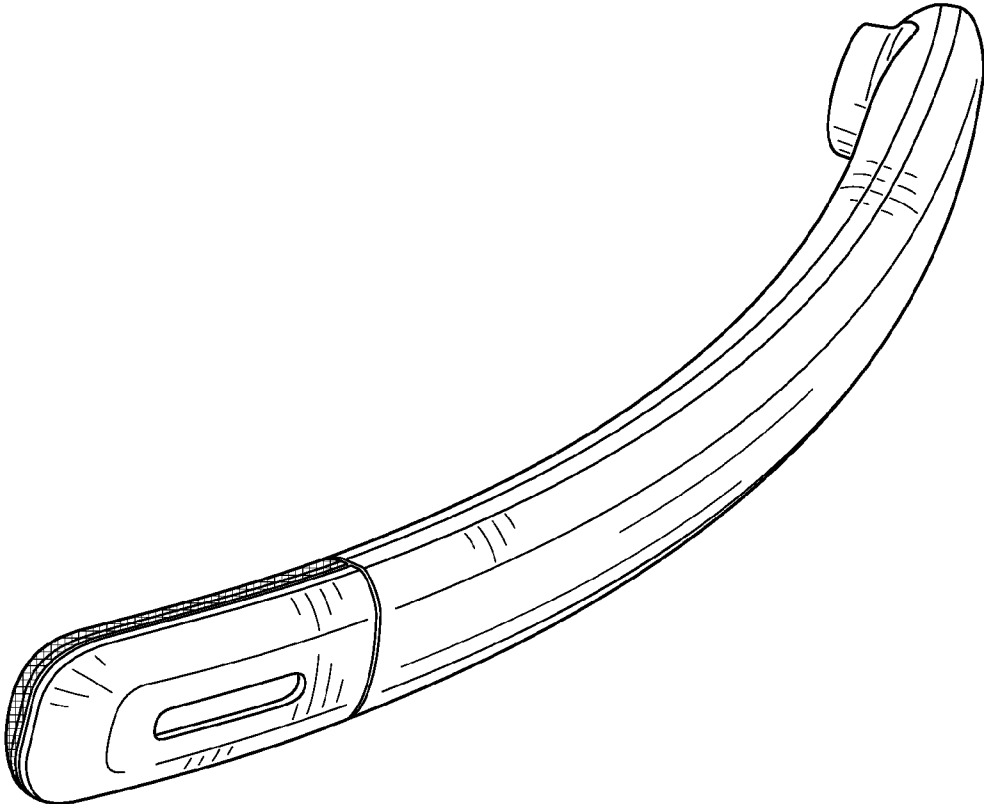

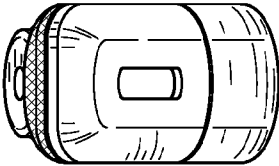

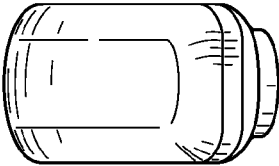

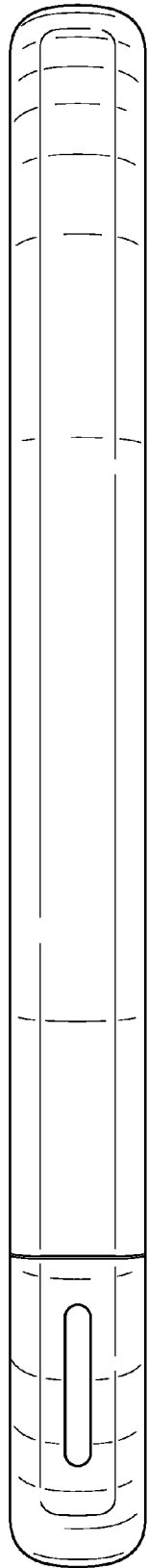

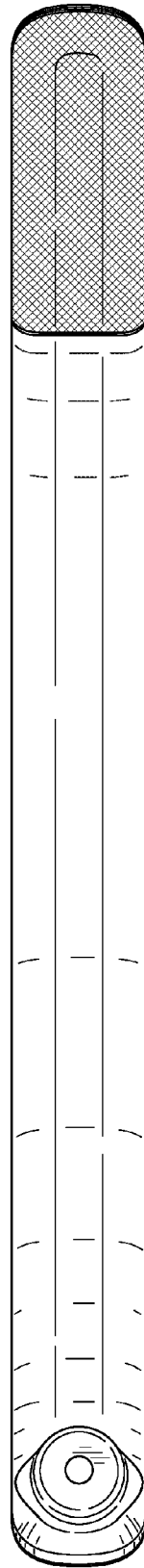

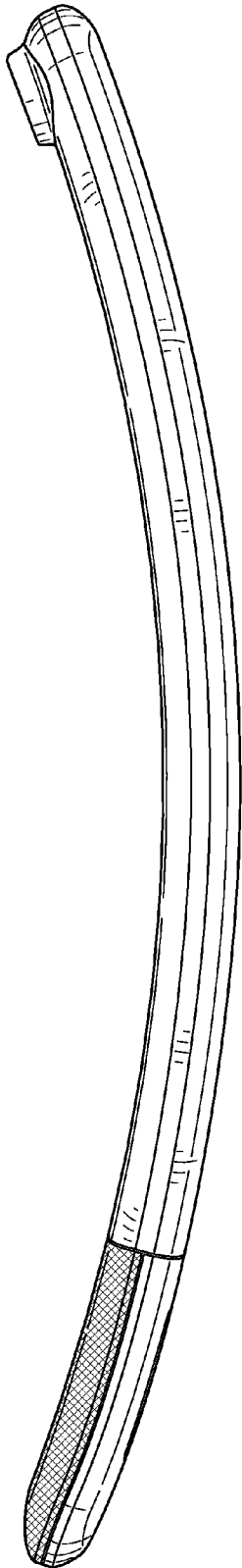

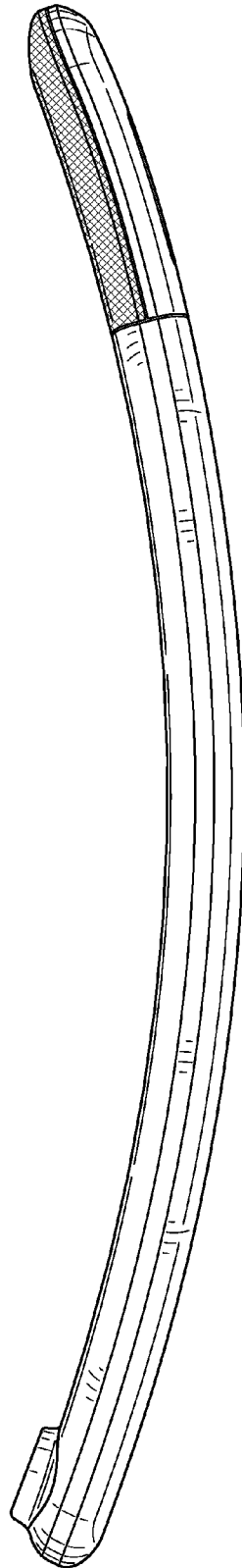

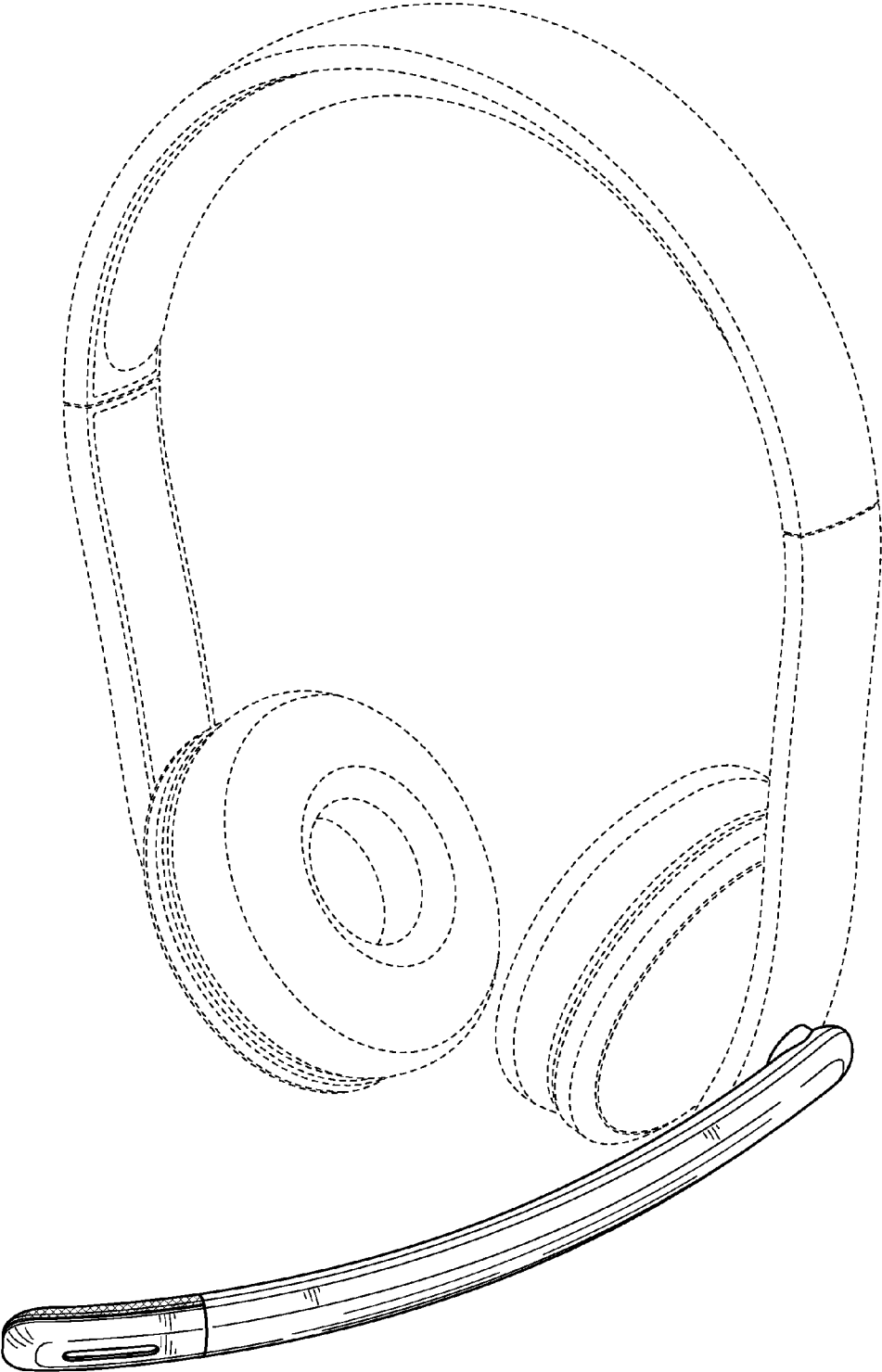

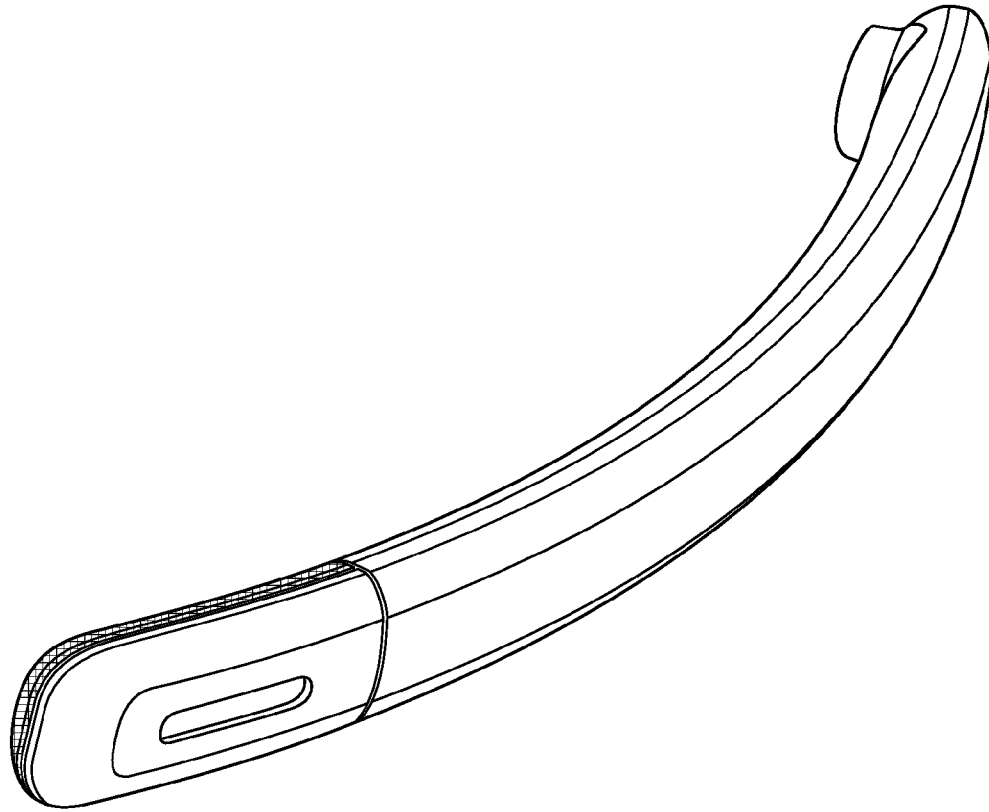

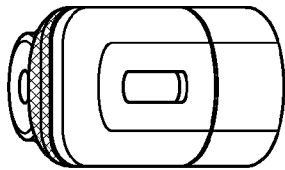

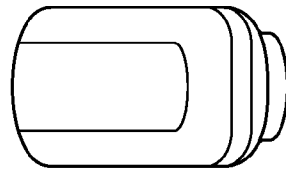

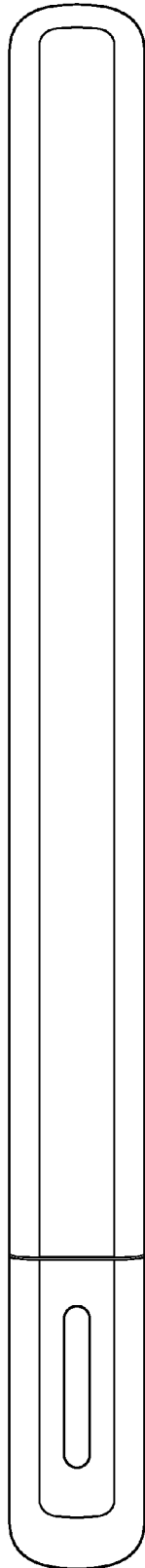

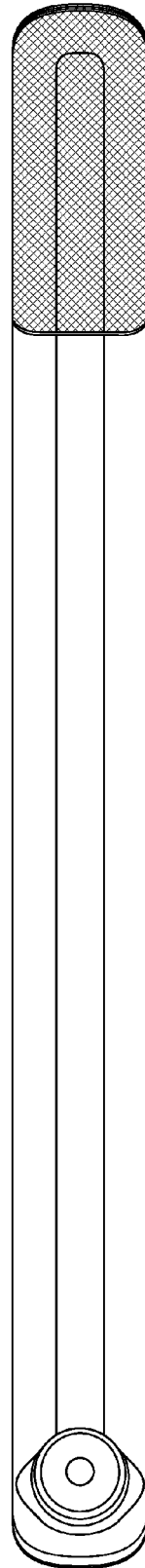

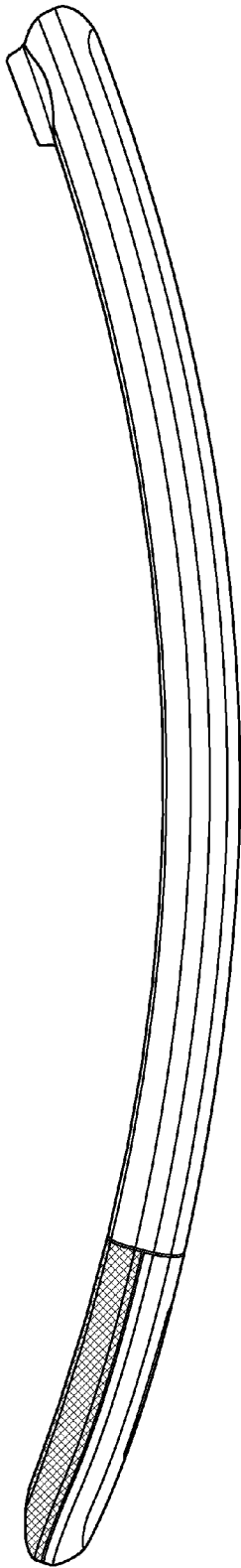

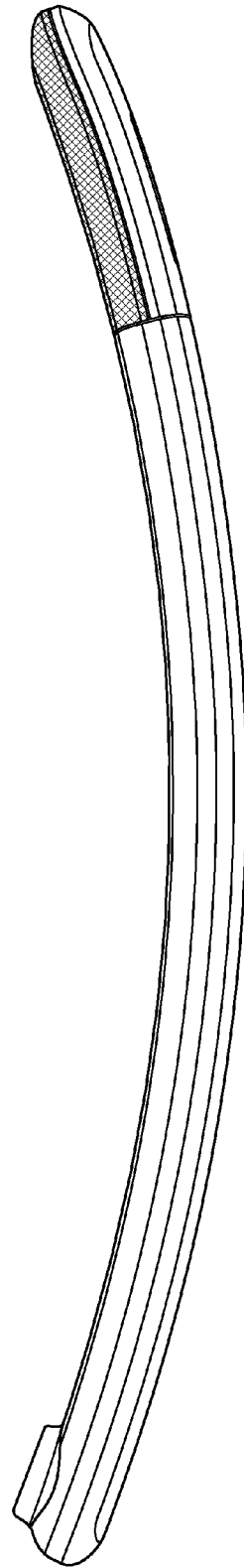
