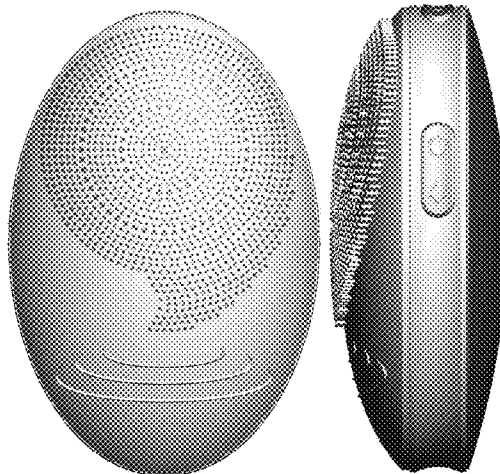
(57) **CLAIM**
The ornamental design for a sonic face brush, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a sonic face brush showing my new design;
FIG. 2 is a rear elevational view showing the design for the sonic face brush of FIG. 1;
FIG. 3 is a left side elevational view showing the design for the sonic face brush of FIG. 1;
FIG. 4 is a right side elevational view showing the design for the sonic face brush of FIG. 1;
FIG. 5 is a top plan view showing the design for the sonic face brush of FIG. 1; and,
FIG. 6 is a bottom plan view showing the design for the sonic face brush of FIG. 1.

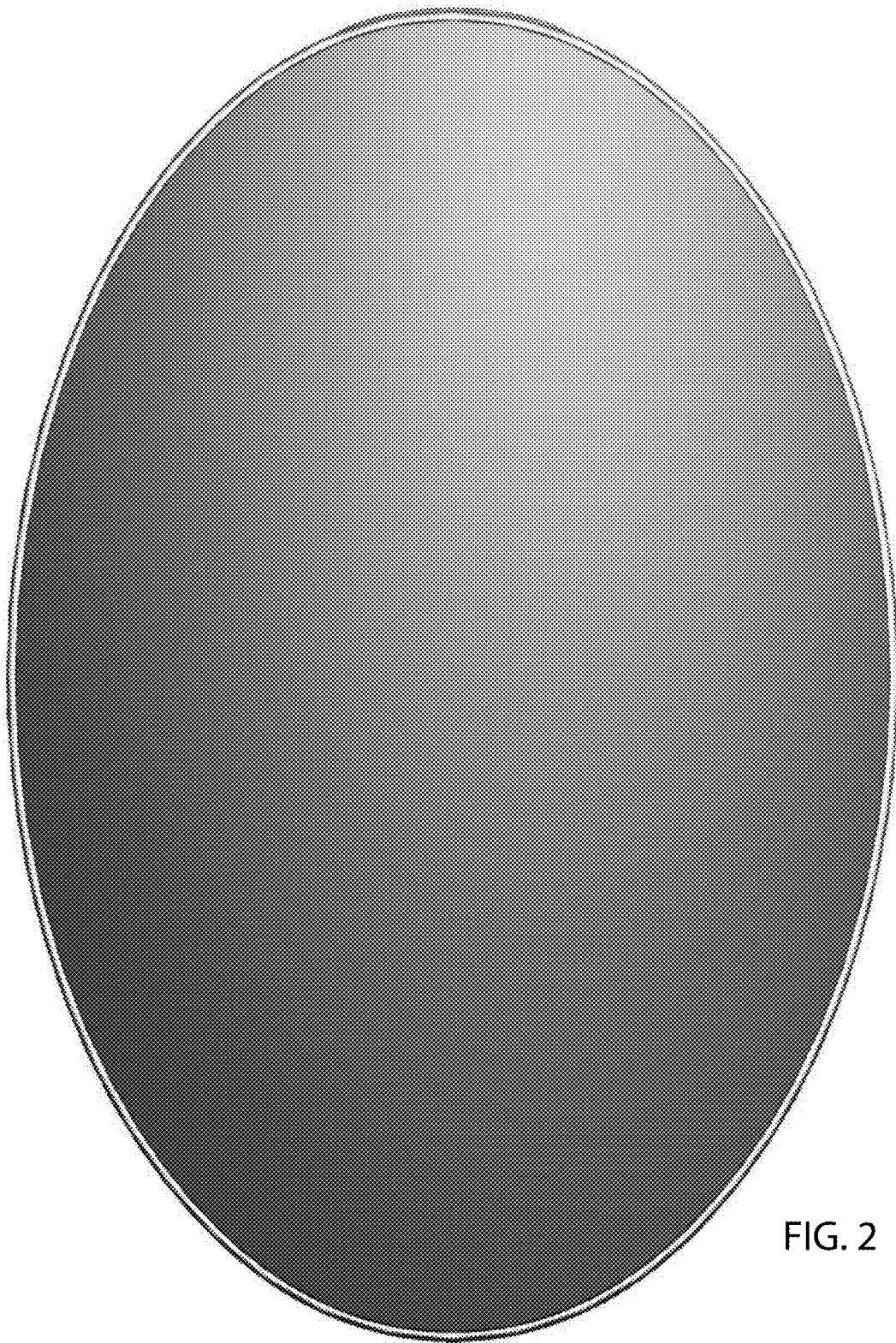

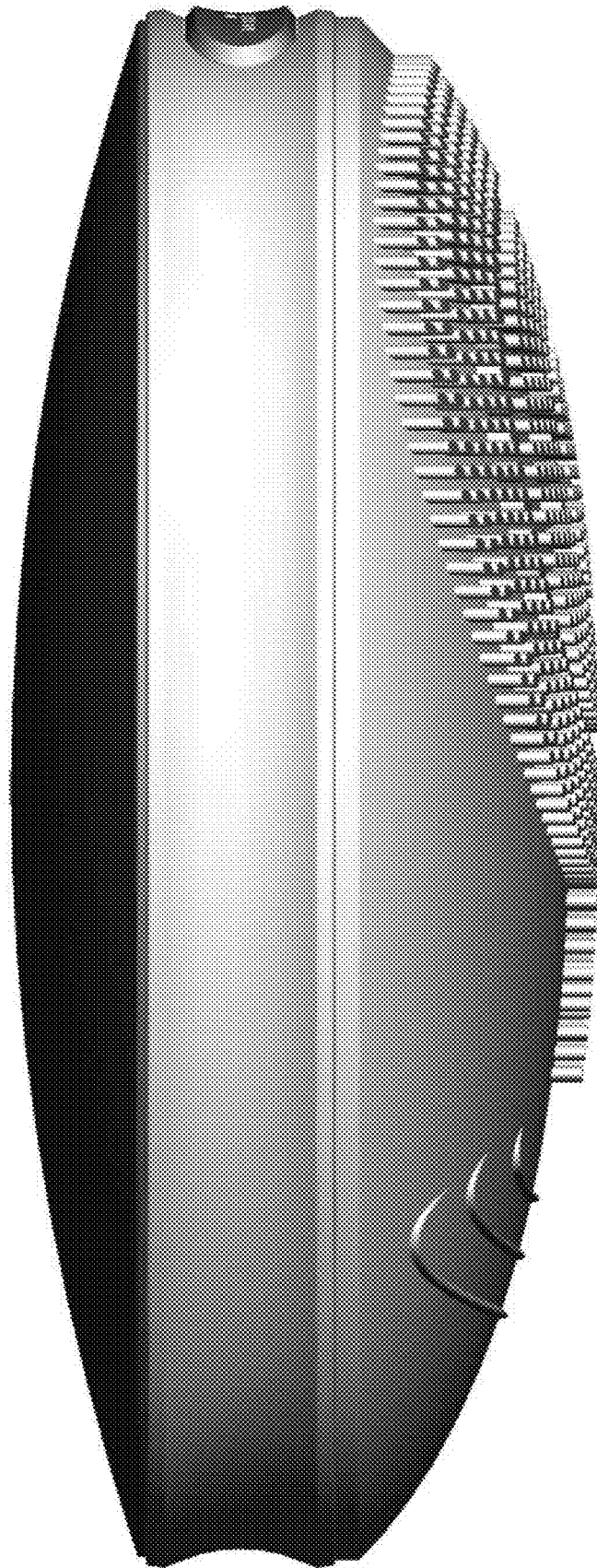

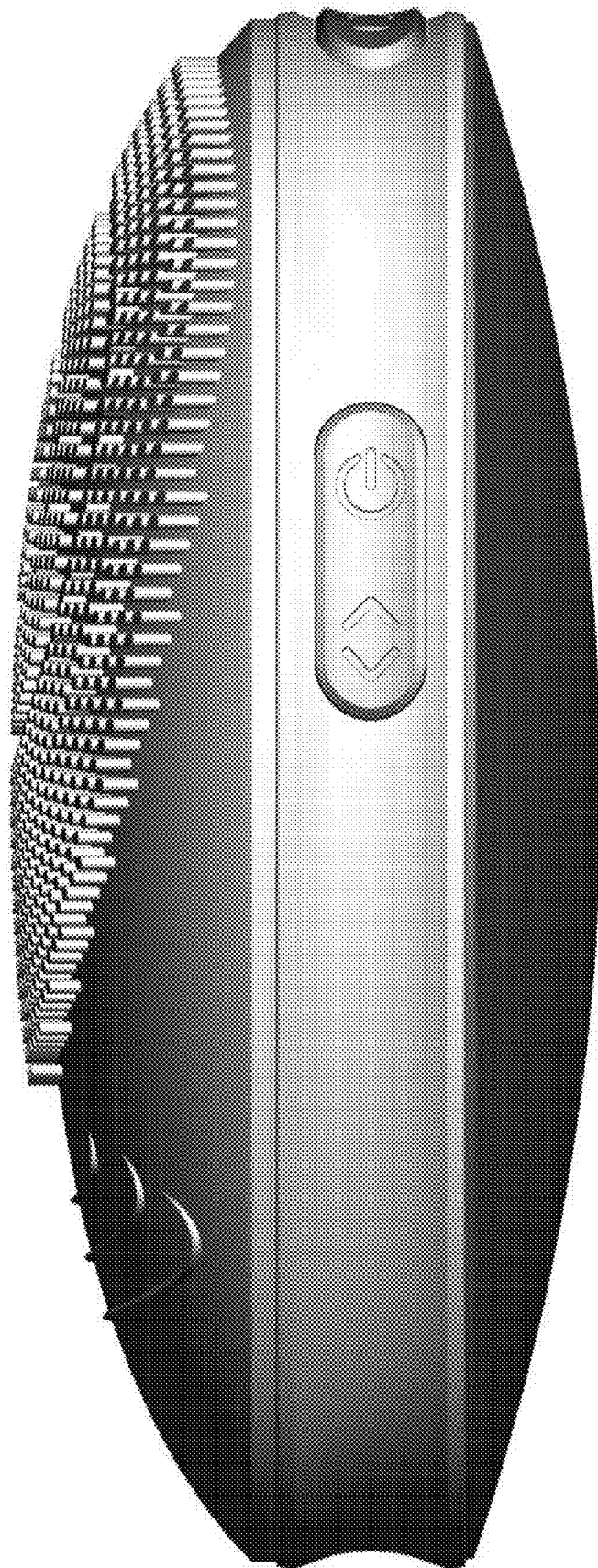

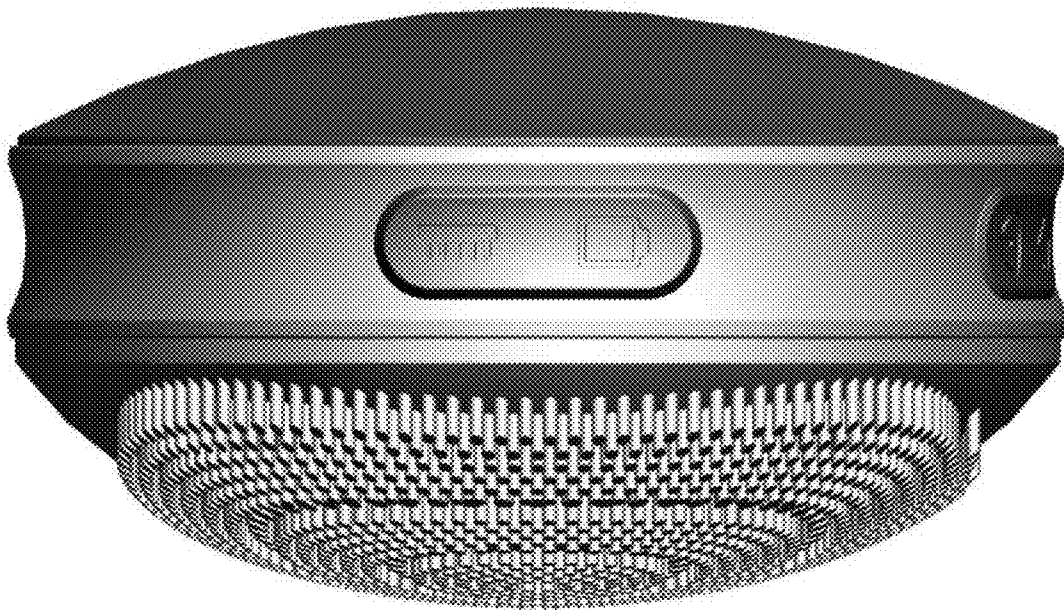

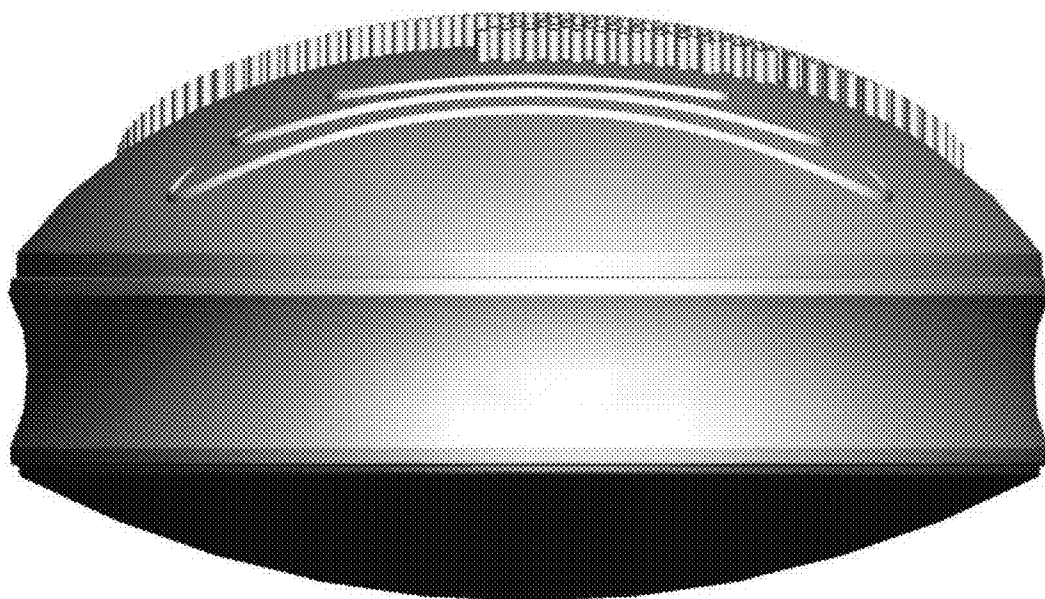
