(57) **CLAIM**

We claim the ornamental design for a hooded garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hooded garment showing our new design;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a rear elevational view of FIG. 1;

FIG. 4 is a right-side elevational view of FIG. 1, the left-side elevational view being a mirror image thereof;

FIG. 5 is a top plan view of FIG. 1; and,

FIG. 6 is a bottom plan view of FIG. 1.

The broken lines showing a person in FIG. 1 of the hooded garment are for the purpose of illustrating environment, and form no part of the claimed design.

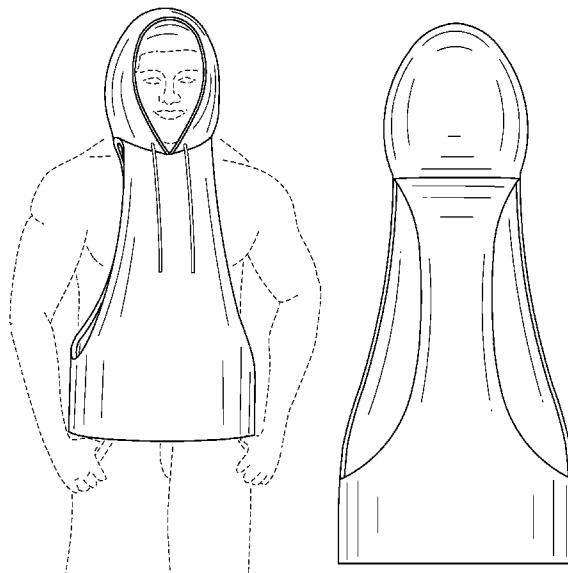

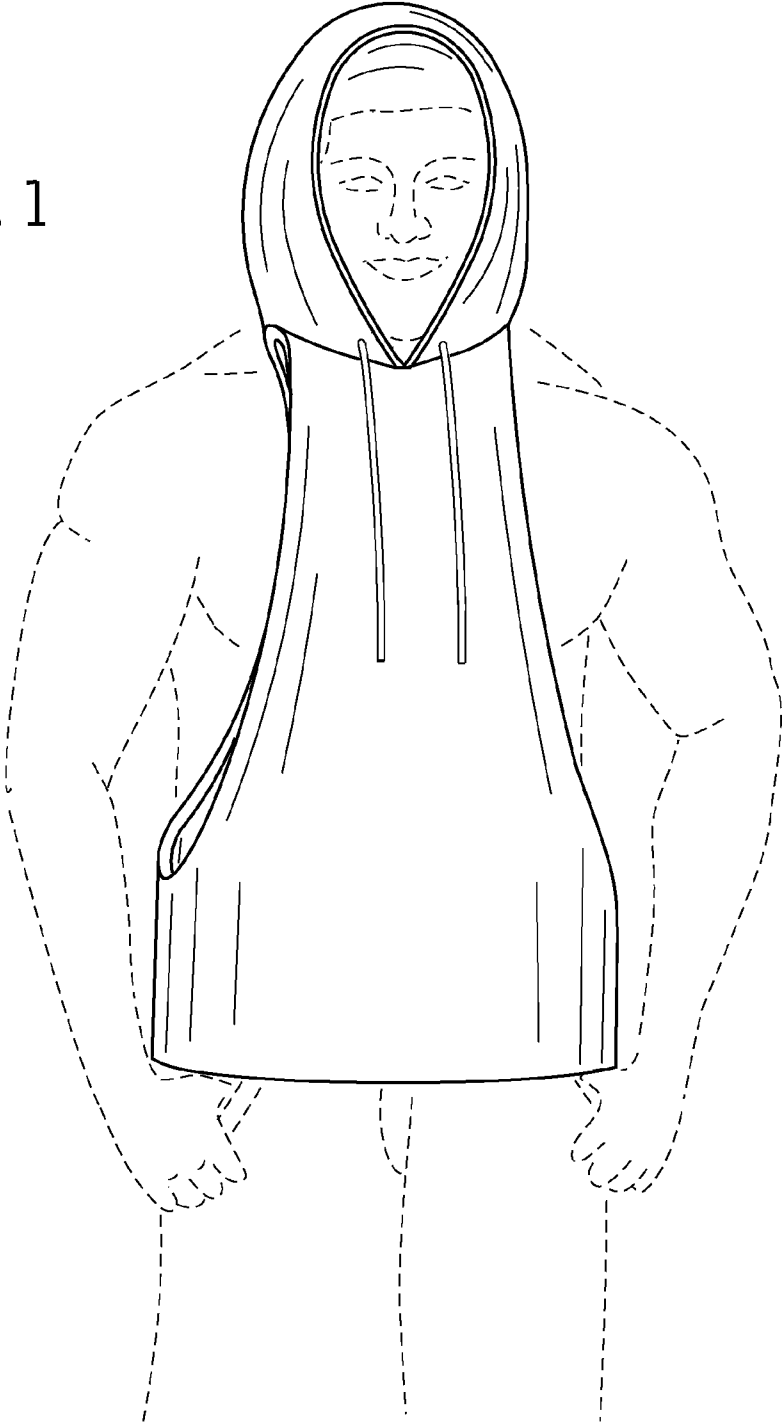

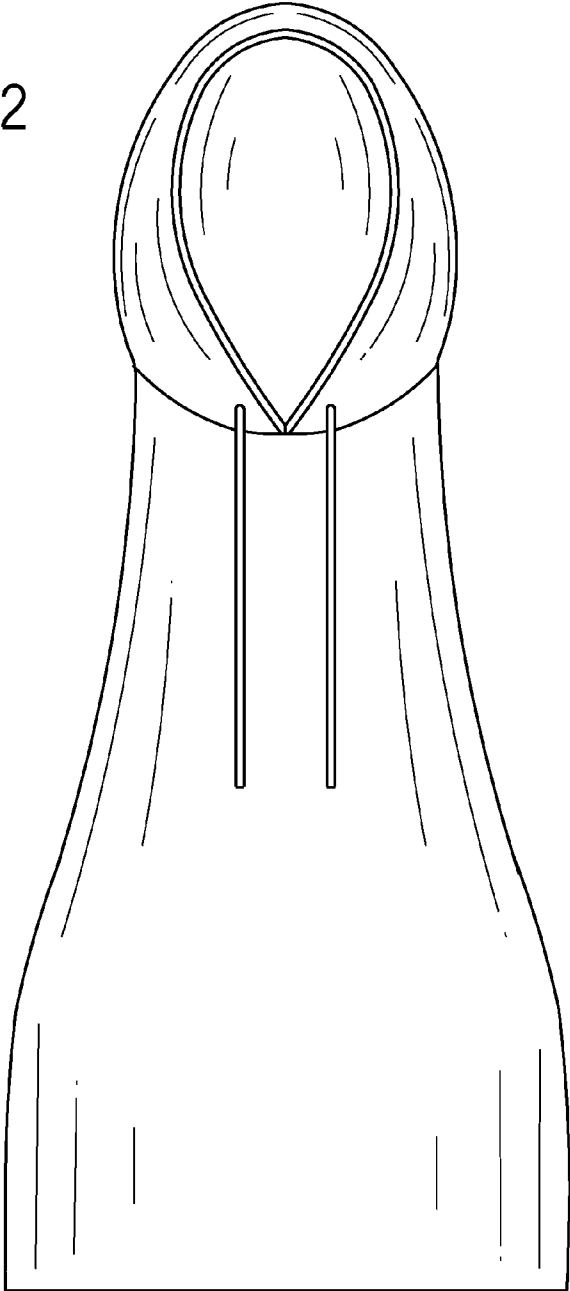

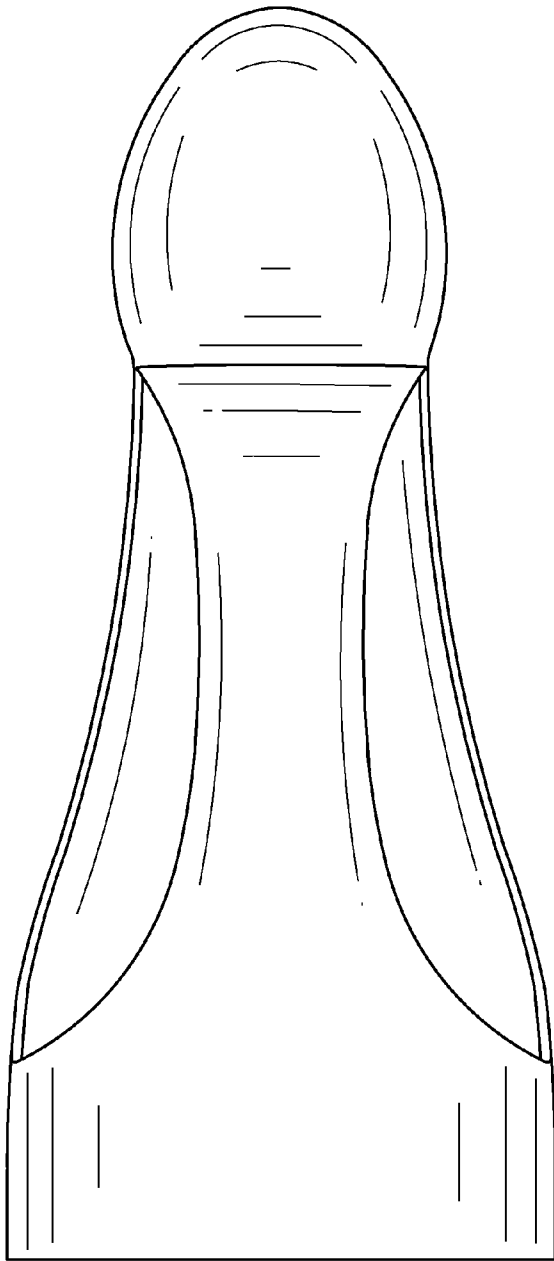
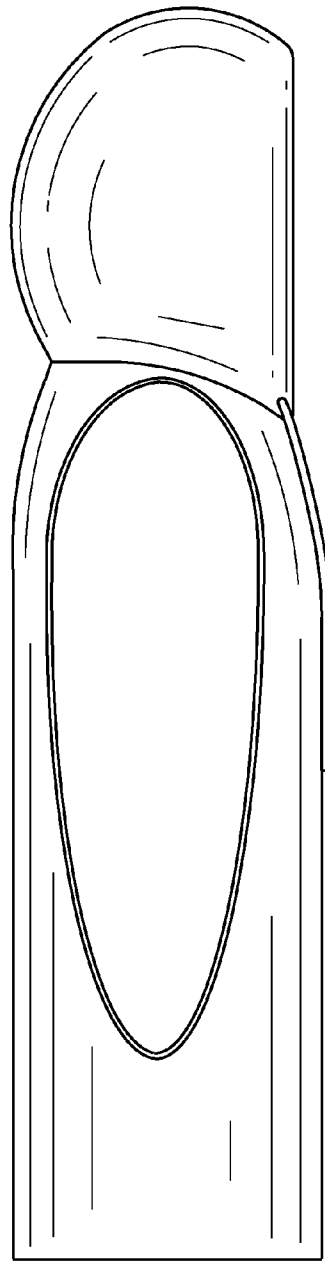

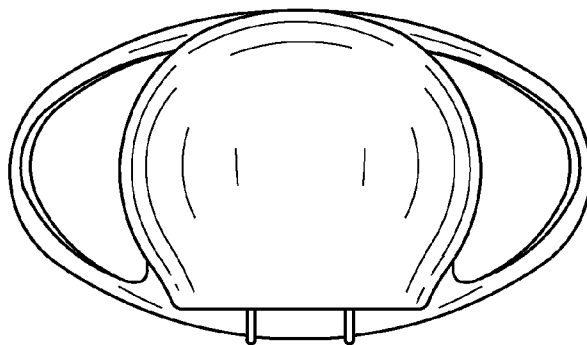

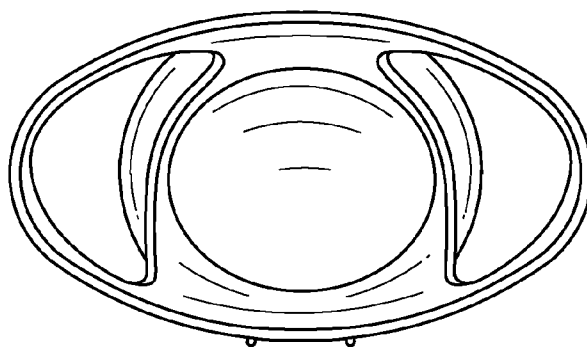
